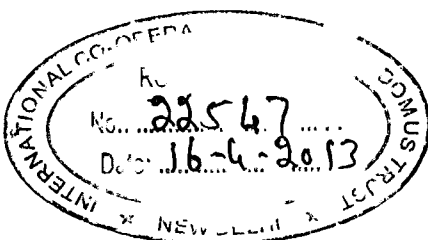

Message from Mr. Mu Li, ICA Vice-President for Asia and the Pacific

In 1998, when we had last Regional Assembly in Seoul, Korea, many countries in Asia and the Pacific still lay under the financial crisis, which started in 1997. This severe crisis has affected the national economies of almost all countries to a different extent. Some big enterprises sank in this financial storm, the same as the "unsinkable" Titanic. Meanwhile, Co-operatives were not either exempt from different sufferings caused by the crisis, some even collapsed. However, the majority of co-operatives, to our satisfaction, outlived this crisis, and further more, most co-operative enterprises suffered much less than the private enterprises.

One of the reasons is that co-operative enterprises, rooted in their local communities, are owned by and work for their members. Co-operatives hold together by co-operation among people and not merely by capital, which is the unique feature making co-operatives different from other types of economies and enduing co-operatives with stronger vitality.

At present, we are experiencing the process of the economic globalization. While facing unprecedented opportunities for development, we are also confronted with vital challenges of severe competition. Co-operatives with traditional behindhand operation of small scale and iso-



lation can no longer face the challenges of the competition from the increasing multi-national enterprises. Therefore, co-ops, for survival and development, must undertake thorough reforms, maintaining our own identity, and learn the strong points from other type of economies to offset our weakness. We must not only enhance our individual economic strength through all possible means, but also expand our scale of operation through co-operation in various ways and aspects so that we will be able confront the multinationals with our combined force and achieve sustainable development.

We, as co-operators, have had many in-depth discussions on the development of co-operatives in the new millenium at both global and regional meetings. Many co-operatives have made active attempts and explorations.

The 5th Asia and Pacific Ministers' Conference held in Beijing and the related Consultation in Singapore and seminars respectively in Vietnam, Nepal and

Message from Mr. Churli Hee Won Chairman of the ICA Regional Assembly for Asia and the Pacific

1999 has been a better year. Judging by the reports published in journals and in the documents of multi-lateral agencies, Asia is on the recovery path and the economic growth is picking up. Many countries of the Region are entering into the second phase of reforms to integrate their national economies with global economy. Thus globalisation process is going to stay. However, financial crisis that visited has also shown that globalisation and competition may go haywire, if management of economy is not efficient enough to focus on the development of common man.

In spite of its overall economic growth, Asia-Pacific Region has the largest number of people below poverty line. Mere pumping of investment either by domestic or foreign investors is not a guarantee for poverty alleviation. Unless the poor are organised to be self-reliant, poverty will continue to afflict the humanity. Co-operatives may provide an effective and responsive institutional framework to organise the poor. The governments in this region should harness this potential of co-operatives by creating enabling environment in Asia-Pacific Region.

Another important challenge of globalisation and competition before co-operatives is how to preserve and strengthen their iden-



tity at a market place. Imbibing value-based professional management in co-operatives will, therefore, be a crucial input to ensure sustainability in an environment of competition.

ICA Regional Office for Asia and the Pacific (ICA ROAP) under the dynamic leadership of Mr. Robby Tulus and with the support of its committed staff has been making earnest efforts to bring these strategic issues to the notice of ICA member organisations.

Successful organisation of the 5th Co-operative Ministers' Conference and a number of seminars on current problems of co-operatives has demonstrated the collective resolve of our member organisations to strengthen and sustain the co-operative movement in the region.

I hope ICA Regional Assembly in its next meeting in Singapore – June 2000, will further intensify this process which we initiated them in Korea during October, 1998. I wish them good luck.

Burma are merely a few examples of efforts made in our region. On the 5th Ministers' Conference in Beijing, 163 participants from 24 countries and 8 international organizations, including 16 co-operative ministers and high ranking government officials had lengthy and in-depth discussions on issues of importance for the development of co-operatives under the theme "Sustainable development of co-operatives into the 21st century" and come out with a Joint Declaration. Quite a few countries took immediate follow-up actions, for instance, Indonesia, the Philippines, Singapore, Burma and Iran have had their co-op legislation amended and improved to have fostered a more enabling environment for further development of co-operatives.

Today, co-operatives, as a third option besides state and private businesses is recognized for its significant role and value by more and more governments and peoples. The world is developing and so must be the co-operatives. Only by active exploration and prompt adjustment while adhering to our identity, can we be better adapted to the needs of development and get further strengthened, so that we may have co-operatives, known for its outstanding contributions to the social and economic development over the last 150 years, make more and greater contributions to the members and the whole society.

Message from Mr. Robby Tulus ICA Regional Director

The gloomy economic clouds in the region in 1998, which still lingered over our Third ICA Regional Assembly for Asia and the Pacific in Korea, are gradually clearing at this point, and the rays of optimism and confidence are rapidly emerging on the horizon of the new economy in Asia. While many countries in Asia took a beating from the economic crisis, it has nonetheless taught a positive lesson to co-operative movements all over the world. People-based co-operative organizations could remain strong if they stay focused on serving member needs and use their members' advantage to rebuild local communities.

Inspired by the spectacular resilience of member-based co-operatives during the crisis, ICA Regional Office for Asia and the Pacific intensified its efforts to keep the momentum by creating forums where members can learn and act together.

The Regional Consultation, followed by the 5th Co-operative Ministers' Conference organized in collaboration with Singapore National Co-operative Federation (SNCF) and All China Federation of Supply and Marketing Co-operatives (ACFSMC) respectively in 1999, formulated practical guidelines to create a more enabling environment for co-ops as they aspire for greater sustainability. The Joint Declaration adopted by the Ministers' Confer-

ence focused on two imperatives - first, the need to create and sustain an enabling policy and legal environment conducive to co-operative development, and secondly, the need to establish new forms of co-operation between governments and co-operatives.

Encouraged by our member organizations, we have resolved to give the imperatives a more concrete shape. Our Strategic Development Plan for the year 2000-2004 reflects it.

There were also a number of key result areas of ICA ROAP in 1999 that were critical to strengthening co-operative movements in the region. First we made special efforts to focus on Central Asia, as well as countries in transition, by way of creating empowering instruments such as training tools and self-help capital formation, to help reduce poverty in these countries. We continue to seek ways to strengthen financial co-operatives, and the enlargement of women and youth involvement in co-operatives.

We are also seeking ways to reposition co-operatives in the social sector, and formulate HRD strategies by employing information technology as cooperatives cannot be left behind in their attempt to provide business and service excellence in the face of new challenges in the 21st century.

Our efforts in the year 2000 will, therefore, be further enhanced and directed to



pursue new synergies among with our members and international development partners. We have opened the new Business Office in Singapore, thanks to the kind support of SNCF, while at the same time consolidating our good offices in New Delhi.

Executing the big mandate with limited funds is a challenge by itself. But our determination and confidence remain firm because of the positive direction given by both the global ICA Board as well as the Standing Committee for Asia and the Pacific.

Our ICA ROAP staff, be they small in number, are hardworking, dedicated and resourceful. Also, our main International Partners from Canada and Japan have provided not just money but also prudent development ideas, whereas our partnership with the UN agencies, and more recently with the ADB, have given us greater impetus to act together in building local communities that have yet to benefit from the surge of globalization. Optimism is our strength, but results-based actions will be key to our success.

Fifth Asia-Pacific Co-operative Ministers' Conference

The most important event of ICA Regional office for Asia and the Pacific during 1999 was the successful holding of the 5th Asia-Pacific Co-operative Ministers' Conference in Beijing – 11 to 16 October, 1999.

As precursor to this main event, a sub-regional workshop on 'Policy Reform' was held in Kathmandu, Nepal during January, 1999, another sub-regional workshop on 'Advancement of Legislative and Co-op Policy Reforms' was held in Bangkok, Thailand during February, 1999, a symposium on 'Co-operative Legislation in Economies in Transition' during May, 1999 in Hanoi, Vietnam and a Regional Consultation in Singapore during 6-9 July, 1999.

The Kathmandu sub-regional workshop was hosted by the Ministry of Agriculture of his Majesty's Government of Nepal and the National Co-operative Federation of Nepal. 19 representatives from co-operative movements and governments from Bangladesh, India, Iran, Israel, Nepal and Sri Lanka and some international organisations participated at this workshop. The workshop was inaugurated by His Excellency Hon'ble Girija Prasad Koirala, Prime Minister

of Nepal. The Bangkok workshop, where 41 delegates from ten countries and seven international organisations participated, was inaugurated by H.E. Hon'ble Pongpol Adireksarn, Minister of Agriculture and Co-operatives, Government of Thailand. The Co-operative Promotion Department of Thailand hosted the workshop in collaboration with the Co-operative League of Thailand.

The symposium in Hanoi was attended by more than 40 delegates from co-operative movements in the

developing and transitional economies in the region as well as UN-ESCAP, ILO, CCA and DID.

The Regional Consultation in Singapore 88 delegates from 19 countries and six international organisations participated.

The overall aim was to assist member organisations and their governments to foster an enabling environment for co-operatives through proper laws and regulations. Representatives of the participating countries prepared country action plans in regard to advancement of legislative and co-operative policy reforms. At the Singapore consultation, after lengthy and in-depth discussions, a number of relevant recommendations to the 5th Co-operative Ministers Conference were made.

Culminating these efforts, the Beijing Ministers' Conference formulated specific recommendations on (i) autonomy and independence; (ii) recognition; (iii) fair-playing field; (iv) legal existence; (v) self-regulation; (vi) capitalisation; and (vii) official development assistance. The Conference constituted a Steering Committee, which will monitor the progress of implementation of these recommendations and will report to the next Ministers' Conference. □

The National Co-operative Union of India (NCUI) has constructed a new co-operative complex, which was inaugurated by Roberto Rodrigues, ICA President, on April 19, 1999.

The new complex is a 5-storeyed structure, which also houses an auditorium which can seat up to 650 delegates. Several co-operative leaders and dignitaries from the movement and the government participated at the inauguration.

Positioning of Co-op Financial Intermediation in Post-crisis Capital Markets and Financial Sector in the Region

Another activity of topical importance is a seminar organised by the Regional Office, in collaboration with Developpement International Desjardins and Rabobank of Netherlands, on 'Positioning of Co-operative Financial Intermediation in Post-crisis Capital Markets and Financial Sector in the Region'. The seminar was held in Singapore from 12-15 July, 1999.

63 participants from 12 countries attended the seminar. The objectives of the seminar were mainly to critically examine and review the status, role and positioning of co-operative credit and banking institutions in the

The office was officially inaugurated by H.E. Abdullah Tarmugi, Minister for Community Development, Government of Singapore. Roberto Rodrigues, ICA President was also present on this occasion.

More than 120 delegates representing co-operative and government organisations in different countries and international organisations participated at the inaugural function.

The Singapore National co-operative Federation (SNCF) which is ICA's national member organisation from Singapore has been very supportive to the ICA Regional office in this effort.

The ICA Regional Office will set up co-operative trade-related activities from this centrally placed city.

The business office will be able to assist its member organisations in enhancing their co-op trade activities between co-operatives and others on a global basis. The ICA ROAP plans to set up an ICA Regional Website from this office, which will carry important information about co-op products and opportunities available for marketing co-op products.

The ICA hopes to organise a global trade exhibition in Singapore in the year 2002.

ICA/Japan Training Course on Strengthening the Management of Agricultural Co-operatives in Asia

Another important activity was the 13th ICA/Japan Training Course on Strengthening the Management of Agricultural Co-operatives in Asia. This course commenced on 15th January, 1999 and concluded on 24th April, 1999. This 5 month course is being conducted by the ICA Regional Office in collaboration with JA-Zenchu (Central Union of Agricultural Co-operatives, Japan) and the Institute for Development of Agricultural Co-operation in Asia (IDACA), with financial assistance from the Ministry of Agriculture, Forestry and Fisheries of the Government of Japan.

15 managers of agricultural co-operatives from 11 Asian countries underwent this 5-month course, which was conducted in India and Japan. The course participants had extensive study visits in India, Nepal and To-

kyo, Kochi and Gunma prefectures of Japan. A part of the training was conducted at the Fertiliser Management Training Institute (FMDI) Indian Farmers Fertiliser Co-operative (IFFCO) at Gurgaon, near Delhi. The training sessions started in India after a 50-day

home country assignment during which the participants produced draft proposals for agricultural projects in their respective countries. These proposals were thoroughly studied and finalised during the concluding sessions of the training at IDACA.

The 9th Training Course on Rural Women Leadership Development in Agricultural Co-operatives was organised from August, 23 to Sept., 11, 1999.

Six women leaders from Myanmar, Philippines and Thailand participated in the training. The participants were taken on extensive study visits to agricultural co-operatives and farmers' homes in Japan.

They were also able to participate at the 4th International Conference on Women in Agricultural Co-operatives in Asia during 24 to 29 August, 1999.

Conference of Women Leaders in Agricultural Co-ops in Asia and Africa

The fourth International Conference of Women Leaders in Agricultural Co-operatives in Asia and Africa was conducted at IDACA, Tokyo from 24-29 August, 1999. This conference was jointly organised by the ICA Regional Office, JA-Zenchu, Afro-Asian Rural Development Organisation (AARDO), and IDACA. 32 delegates representing 16 Asian and African countries and three international organisations attended. The conference discussed and defined more concrete measures for building up concrete measures on food security issues, equality for women farmers, and better institutional support for them.

ICA Committee on Agriculture for Asia and the Pacific

The 32nd meeting of the ICA Committee on Agriculture for Asia and the Pacific was held at Hotel Grand Plaza Parkroyal, Singapore on July 11, 1999.

20 participants from 11 countries and 1 international organisation (FAO-NEDAC) attended the meeting. The Committee has agreed with NEDAC to undertake a joint collaborative action plan to strengthen agricultural co-operatives in the region.

A joint statement on Food Security and Sustainable Agricultural Development through Co-ops was adopted and six countries agreed to conduct studies on Food Security and Sustainable Agricultural and Rural Development through Co-operatives.

12 participants attended the meeting. The Forum, chaired by Mr. Akira Kurimoto, Chairperson, decided to form a core group that will organise the First Co-operative Research Conference on June 24-25, 2000 in Singapore to coincide with the ICA Regional Assembly.

Co-operative Researchers from Asia-Pacific and other regions are expected to participate. This Forum fulfills the research need of the co-operative movement in this Region.

The year 1999 was very important for Asia-Pacific Health Co-operative Organisation (APHCO) as several meetings of the Board, General Assembly and Seminars were organised by the APHCO during this period.

The 2nd meeting of APHCO was held on January 24, 1999 at Kuala Lumpur, hosted by Koperative Doktor Malaysia (KDM). Nine delegates attended this meeting and discussed 'organisational development of APHCO' and the 'impact of economic crisis to the health co-ops'.

The 3rd Meeting of the APHCO Board was held on October 9, 1999 at Kuala Lumpur, Malaysia. Seven members from Japan, Nepal, Sri Lanka and India attended the meeting. A regional seminar on the 'Co-operative Healthcare in the new Millennium' was also held. The seminar was very successful, which attracted 80 participants from seven countries.

The 2nd APHCO General Assembly was held, on October 10, 1999, at the Armada Hotel in Kuala Lumpur, where 22 delegates from six countries participated.

Regional HRD and Research Committee

The ICA Committee on Human Resource Development and Research held its 11th meeting at the Grand Plaza Parkroyal, Singapore on July 11, 1999.

Royal Prof. Ungku A. Aziz chaired the meeting, attended by 28 participants.

The meeting reviewed the MATCOM materials for updating and sought to strengthen the network among co-operative colleges and 'co-op minded' universities.

Consumer and Youth Co-operative Development activities

Bali (Indonesia) was the venue of the 32nd Meeting of ICA Committee on Consumer Co-operation for Asia and the Pacific on 30 November, 1999. 31 members and observers from 9 countries attended this meeting.

The Committee finalised the work plan for 2000-2001 of the consumer-related activities of ICA Regional office.

A Consumer Co-operative Forum was also organised on December 01, 1999 on the theme 'What is value of the Consumer Co-operatives in Asia'.

The Committee will hold its next meeting in Singapore in conjunction with the Fourth ICA Regional Assembly.

Sub-Committee on University and College Co-ops

Bali was also hosted the 5th meeting of ICA Consumer Sub-Committee on University and College Co-operatives for Asia and the Pacific, which was held on 29 November, 1999. 22 members and 30 student observers from member countries and the host country Indonesia participated and deliberated at the meeting.

The ICA, in collaboration with the National Federation of University Co-operative Associations of Japan (NFUCA) organised two university co-operative seminars in Vietnam.

The first one was at the Danag University on 27-28 July and the second at Thai Nguyen on Dec. 6-7, 1999.

Both these seminars were attended by teachers, students and representatives from the Ministry of Education, Government of Vietnam and the local city governments and affiliates of Vietnam Co-operative Alliance.

These seminars gave general orientation to student co-operators to appreciate the idea of setting up university co-operatives and improve the operations of these co-operatives.

The seminar also helped the students and teachers to set up university co-operatives in universities and schools. The ICA will continue to support such

efforts in the region. Mr. Juku Ozawa, Director – Special Programmes at the ICA Regional Office, facilitated these seminars.

Regional Youth Seminar

The ICA Regional Office for Asia and the Pacific organised the Second Regional Campus/Youth Co-operative Seminar at Quezon City, Philippines, from April 15-18, 1999. The main theme of the seminar was 'Future Leaders Leading Now'.

The seminar was jointly organised by the ICA Consumer Sub-Committee on University/College Co-operatives, the National Federation of University Co-operative Associations in Japan, the National Confederation of Co-operatives Inc., Philippines, the Metro Manila Federation of Consumers Co-operatives, and the Co-operative Education and Development Center, Inc., Philippines.

The seminar, attended by more than 150 delegates and observers from Indonesia, Japan, Philippines, Singapore, Thailand and Canada, was coordinated by Romulo Villamin, Director – SEA of the ICA Regional Office.

Keynote addresses were delivered by Prof. Solita Monsod of the University of the Philippines' School of Economics and Mr. Tatsuya Nakajima, Student Chairperson of the Kansai Regional Association of NFUCA, Japan.

Women's Co-operative Activities



First Regional Women's Forum in Seoul, Korea

The ICA Regional Women's Committee has been very active throughout 1999. A meeting of the office-bearers of the Committee was held in Bangkok on February 22, 1999. The meeting discussed the activity plan of the Women's Committee and the Gender Integration activities of the ICA ROAP for the years 1999-2000. The meeting chalked out strategies to promote women's participation in decision-making in co-operatives.

The meeting also discussed the proposed Second Regional Women's Forum to be held in Singapore during June, 2000.

Another point for discussion was the preparation of a Training Manual for Co-operative Women Leaders Development. The original draft manual prepared by a Consultant was discussed with the ILO Coopnet representatives who are collaborating with the ICA Regional Office for preparing this manual. The draft prepared by the consultant was not found satisfactory.

It was decided to share the responsibility between ICA ROAP and ILO Coopnet, both of whom will prepare 3 modules each. The Regional Office has since been able to identify a new consultant and contracted with her to write the 3 modules. Once

these modules are ready, the modules prepared by the ICA ROAP and ILO Coopnet consultants will be combined and a validation workshop will be held sometime during 2000.

Another meeting of the office bearers of the Committee was held in Kuala Lumpur on October 27, 1999, which was attended by Ms. Rahiah Baharen, Chairperson of the Committee, Ms. Hatsuko Omori and Ms. Rameshwari Ramachandra, both Vice Chairpersons. Robby Tulus, Regional Director, Romy Villamin, Director (South East Asia) and Juku Ozawa, Secretary to the Committee

also attended this meeting. The meeting discussed on the Second Regional Women's Forum to be held on June 26, 2000 in Singapore. It was also decided that the 2nd Meeting of the Committee will be held in Singapore on June 25, 2000.

During the year, the ICA Regional Office Gender Integration Project and the Regional Women's Committee were able to do quite a lot of work on this sector.

We have been able to appoint a number of contact persons in the member organisations. A number of member organisations organised national level women's forums. A few others

have planned these activities later this year.

The participation of women in co-operative activities, especially in decision making positions have increased substantially, though still not very satisfactory. Even the participation by women in ICA meetings and seminars have improved over the years.

We, at the ICA Regional Office, are aware that there is still a long way to go before Gender Equity is attained in co-operatives in the Region. The operationalisation of the women leadership training manual will be of much help in this direction.

Co-operative Information and Resource Centre activities

ICA ROAP maintains the world's largest collection of co-operative literature.

The library is recognised by the UGC of India and the I.C.S.S.R. for Co-operative Research. The collection comprises of publications on co-operatives (world wide) and allied subject i.e. environment; gender; health; management; social sciences, psychology; agriculture; fishery; forestry; dairy; economics; law; education; industry; public administration etc.

The collection of magazines, newsletters; annual reports from various member organisations contain information supporting the activities of this region and our organisation.

With the ICA Vision statement, the Co-operative Identity Statement, and the ICA Mission statement (Promote and strengthen the Co-operative Movement in the region) as the guide post, the CIRC shall serve as the "Clearing House of Knowledge" to meet the regional Member Organisations' information needs.

CIRC will also support the national capabilities by developing expertise in collection and dissemination of information and networking to meet the future requirements of its users.

The year 1999 brought about a change in the information dissemination methods which were focused on:

- Resource sharing & Networking
- Electronic dissemination of information
- Disseminate co-operative information to member organisations; current and potential members; institutions engaged in socio-economic co-op research; HRD institutions; NGOs; and UN Organisations using New Technology.

Due to budgetary constraints there is a slight delay in making the library fully automated. However E-mail facility, which is an essential tool for user education, is available and the

information stored in library computer is being used for both housekeeping activities and dissemination to our member organisation.

Apart from the normal users of the library, a number of co-operative leaders, students of various universities where co-operation is taught as a subject, visit our library individually and in groups. Several overseas users are being provided with co-operative bibliographies, statistical information through our networking services.

CIRC has a separate publications marketing/sales division which is growing stronger year after year and has one hundred seventy seven publications to its credit. These are widely purchased /distributed during co-operative conferences for use as reference tools and contains up to date information.

To standardise these literature in the world market they are assigned ISBN for books and ISSN for journals.

Considering the needs of the 21st century the library is being re-organised and taking into consider-

member organisations, apex organisations within the country and other resource centres where they could be stored for future use.

The mission of CIRC is directed towards the goal of ICA ROAP becoming a 'Centre of Co-operative Excellence' which will be recognised and sought after by co-operatives and other organisations world wide.

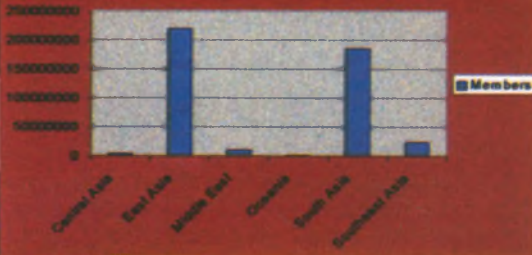

ICA Asia and Pacific Region - Member Co-op Societies

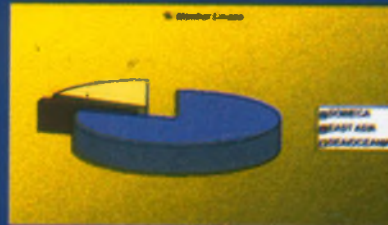

ICA President inaugurates the Jawaharlal Nehru Co-op Complex – calls for inter-sectoral alliances

Roberto Rodrigues, ICA President, inaugurated the newly built co-operative complex of the National Co-operative Union of India in New Delhi on 19 April 1999.

The complex has been built adjacent to the existing premises of the National Co-operative Union of India in New Delhi.

The new complex which is a 5 storeyed structure has an auditorium which can seat up to 650 delegates and has most modern audio-visual equipments. It has been aptly named at the first Prime Minister of India, late Pandit Jawahar Lal Nehru, who was very supportive to Dr. Moritz Bonow in setting up of the Asia-Pacific Regional Office of the ICA. Mr. Nehru had always been an ardent advocate and supporter of the co-operative movement and he even declared "I want to convulse India with co-operation".

The President also inaugurated a National Seminar on 'Women and Youth' at the same venue, in the afternoon.

Several dignitaries were present including the Minister of State for Agriculture, Mr. Som Pal Shastri, Minister for Commerce Mr. R.K. Hegde, Minister of State for Environment Mr. Suresh Prabhu, former Minister for Agriculture Mr. Çhaturan Mishra, Mr. Shivaji Rao Patil, President of the National Federation of Co-operative Sugar Factories, Dr. S.S. Sisodia, President of the National Federation of Urban

Co-operative Banks and Credit Societies and several other distinguished co-operators. Robby Tulus, Regional Director of ICA for Asia and the Pacific was the Guest of Honour and also spoke on the occasion.

Speaking at the function the Mr. Rodrigues mentioned that strategic alliances between the various sectors of co-operatives and even between co-operatives and private sector are essential, to become effective partners of productive chains.

He mentioned that while specialization and sectorization are a natural trend, integration among the various sectors and segments are

very important so that the co-operative movement does not lose its strength. He also mentioned that the relations between the co-operatives and the state has to be one of partners, without the co-operative movement losing its control over decision making and democracy.

Earlier during his inaugural address, Mr. B.S. Vishwanathan, President, NCUI, highlighted the major pending issues for the co-operative sector before the Union Government, especially the amendment to the multi-state co-operative act, license to the Co-operative Bank of India, strengthening credit co-operative banks and a rehabilitation package for sick co-operatives.

In his presidential address, Shri Sompal Shastri, Minister of State for Agriculture stated that the co-operatives have to face the evils emanating from the working of liberalised market forces.

In the current market conditions, the producer gets hardly 25% return of his produce while as much as 75% has been cornered by the middlemen. It is therefore imperative that the co-operatives play their true roles, in the face of privatisation and liberalisation, of harmonising both the producers' and consumers' interests. He said in future there will be very less or no domination or interference from the government in co-operative affairs and as such the co-operatives will have to become more business-oriented and viable.

At the function several past presidents, secretaries, etc. of National Co-operative Union of India was felicitated, including Mr. B.D. Sharma, former Chief Executive of NCUI, who is now working as a Director at the ICA Regional Office.

Prior to the inauguration ceremony, a comprehensive documentary film on the Indian co-operative movement was also shown to the audience.

ICA President inaugurates the National Conference on Women Youth

A National Conference on Women and Youth has been organised in New Delhi on 19-20 April, 1999. More than 200 women and youth from all over India participated in the event. The Conference on Women was a sequel to ICA's request to its member organisations in the Region to hold national level women's conference to increase participation of women in decision making in co-operatives. This was the largest ever such conferences organised in the Region.

Inaugurating the Conference, Roberto Rodrigues, President, ICA mentioned that the ICA attach great importance to Gender Integration and the Role of Women in Leadership. He said that he is very pleased to report that the ICA Board now has four women members, as against only one woman two years ago. He said he was happy to learn that as early as 1987, the Indian co-operatives have organised a national convention on the involvement of women in co-operatives.

He also said that he was much happy to read that in the State Co-operative Societies Acts of Rajasthan and Tamil Nadu, there is a provision for 30% reservation for women in the management of all types of co-operatives.

He said it is very necessary to break the 'glass ceiling syndrome' as men usually find ways to keep their domination in place. He said the co-operatives should follow the important guidepost of the ICA Co-operative Identity Statement, where the first principle is 'Voluntary and Open Membership, without gender,

social, racial, political or religious discrimination', combined with the seventh Principle, 'Concern for Community'.

He congratulated Ms. Anita Manchanda from the National Co-operative Union of India who has worked very hard to make the Conference a success, working closely with Madam Rahaiah Baheran, who is the Chairperson of ICA Regional Women's Committee and also a member of the ICA Board. He also appreciated the efforts and motivation



given by Mr. Vishwanathan, President of NCUI, in furthering the cause of increased participation of women in co-operative affairs.

Several speakers including the Minister of State for Environment, Mr. Suresh Prabhu exhorted the co-operators to recognise women and youth, who are more than half the strength of any co-operative movement and there can not be any progress without associating this large percentage of co-operators in the affairs of co-operatives.

ICA to have a new Vision : ICA President

Roberto Rodrigues, the ICA President, was in Delhi during 19-20 April '99 for the inauguration of the new Co-operative Complex (the Jawahar Lal Nehru Co-operative Complex) of the National Co-operative Union of India. During this short period, he found some time to talk to your editor, when he gave his views on various issues relevant to the co-operative movement in view of the ever-changing economic scenario in the world. We reproduce the interview here.

Q. Mr. President, do you think that the ICA is on the right track, in tackling the growing insecurities faced by the co-operative movement globally, in face of multi and trans-national competition from the private sector corporations, the rapidly worsening financial situation, especially in the Asia-Pacific Region? And what are the results of your leadership initiative to have an organisational review of the board and membership?

A. No. We have just discussed about the changes in the organisation of ICA in the Stockholm meeting. We will not change the rules or

the mission, but we will have to change our 'Vision', because of the recession in the markets, because of the competition in the market in the light of the globalization of economy. Globalisation of economy is not making people happy and co-operatives have a big responsibility to help its members and ICA must change its operations to closely serve the

members in this respect. We expect that we will be able to finalise our changed 'Vision' statement at the next Congress in Quebec city in August '99 and change our way of working.

As for the Asia-Pacific Region, this is the largest Region of the ICA and most important need is for education and training. I know this Regional Office has been very effective in promoting education and training, especially to women and youth, who are half the members. So I feel this Regional Office is working in the right direction and with the active participation of women and youth in co-operative affairs, the co-operative movement in this Region will survive and flourish.

Q. From the various surveys and consortia in the Region, we in the Region, have been able to get some solace from the fact that co-operatives still stand a chance and that the co-operative form of business has more survival factors than any other form of enterprises. What are your views on this?

A. I agree. Co-operatives will survive better as realised after the Co-operative Think Tank Consortium organised in Manila, Philippines last year, which concluded that the co-operatives has less impact from the financial crisis. At least in the banking sector, it has been seen that co-operative banks have fared much better, may be because the co-operative banking sector does not go for much speculation and the co-operative banks registered a much better result than the other banks.

Yes, in a globalized economy, small enterprise can grow. But there is some problem. In a globalized economy, the ultimate thing is the market share. So in such a scenario, the enterprise also has to grow. If you do not grow and the neighbours grow, then it is business lost for you or you are dying.

In the co-operative sector this is a very big limitation as the co-operatives have a limited operational area and then, they again, are limited by the number of their members. Then how can you grow? The only way is to merge and amalgamate. By mergers, you reduce the cost of operations. There will be one President, and only one CEO instead of several Presidents and CEOs. Thus, the only way for the co-operatives to grow in the global scenario is to merge.

Q. Governments have all along been involved with co-operative development in most part of the world and particularly in the Asia-Pacific and African region. While the involvement of government has negative aspects, there is also a positive side to this phenomenon, inasmuch as co-operatives, which are very small business enterprises, get the support in the form of much needed funding and other legislative support

from the government. Several Ministers' Conferences were held in the Asia-Pacific and African Regions to improve government-movement relations. What are your views on this approach?

A. Yes. The co-operatives can be ideal partners with honest and democratic governments. What is an ideal government? One which promises justice, employment to every one, social services, reduce inequalities, provide good infrastructure, proper distribution of the national resources, environmental protection, food security. All these are issues tackled by good governments and these are the same ethos on which co-operatives operate and so the co-operatives can be ideal partners with honest and democratic governments.

Furthermore, co-operatives are the economic arms of society. The governments can help the society through co-operatives in providing ideal services to the society. So the government and co-operatives should work together at all times. This means the government should not treat the co-operatives as some kind of family members or emplo-

yees but work as partners, providing equal status and autonomy. The co-operatives cannot afford to alienate themselves from the governments but work as equal partners in the development of the community, economy and progress.

Q. Some time ago, when the Kenyan co-operative movement has been targeted by bombing, you had issued a call to support the beleaguered Kenyan movement. What has been the response from the global co-operative movement to this?

A. It has been a fantastic example of co-operative solidarity. The fund which ICA set up in Geneva has attracted more than 140,000 Swiss francs in contributions - mostly from ICA members, but also from individual co-operators. Co-operatives in the United States and Canada have also made their own contributions. And our members have lobbied their governments - especially in Britain and the United States - in order to encourage them to make large scale contributions towards the rebuilding of the financial co-operatives in Kenya.

Q. What are the results of your leadership initiative to have an organisational review of the board and membership?

A. The ICA Board completed its work on the Organisational Review at its recent meeting in Stockholm in April, and the recommendations will be sent to the members of the General Assembly at the end of June, in preparation for the meeting in Quebec City. If I can summarise the results of this extensive consultation process, which involved all the regions and sectors of ICA, I would say that people do not want to change the basic ICA structure, which is based on a combination of global, regional, and sectoral activities, but they would like all parts of this structure to work in a more co-ordinated, efficient way. This means, for example, a much closer working relationship between ICA and the sectoral organisations. At the beginning of the review, some people were suggesting that ICA should reduce emphasis it places on promoting co-ops and instead should work harder on helping co-operatives improve their business performance - but the results of the consultation

have shown that promotion and defence of the co-operative identity remains the first and most important task of ICA in the minds of its members. We need to strengthen our capacity to do this, both at the Head Office and in the Regional Offices.

Q. We know your views on the communication revolution and the role it plays in developing business globally. With your knowledge of the global co-operative movement, do you

think that the co-operatives have been using it satisfactorily?

A. Like most enterprises, co-operatives have only scratched the surface regarding the potential of Information Technology. But they are moving quickly. When our Board met in Stockholm in April, we were informed that the consumer co-operatives in Sweden have set up a new programme for selling via the Internet, and they estimate that within a few years around five per cent of their total business will be done electronically.

In Geneva, we are discussing, in collaboration with the World Trade Organisation, the possibility of setting up a data bank that would allow co-operatives to exchange information about their import and export interests, and might also allow ICA to become involved in selling certification rights for these transactions.

More generally, the Internet allows co-operatives to improve their internal communications capacity, which is a tremendous benefit for organisations which are by their very nature decentralised and independent.

ICA Regional Director participates in an OECD-sponsored workshop

The Regional Director of ICA, Mr. Robby Tulus, attended an OECD Workshop on 'Financial Systems for Sustainable Resource Mobilisation in less Advanced Developing Countries', organised by the DAC/OECD together with the World Bank, held at the OECD Headquarters in Paris on March 11 and 12, 1999.

He presented a paper entitled 'South-south co-operation for co-operatives development', with reference to Financial Sector development.

The purpose of the Workshop was for bilateral and multilateral donors to share experiences and lessons learned from their activities in financial sector strengthening in order to promote and disseminate good practices including, in particular, in the area of co-ordination of efforts.

With a focus on the less advanced developing countries, the workshop will not duplicate efforts towards financial sector reform in crisis countries. But it provides a timely occasion for reviewing approaches and applying lessons learned to the financial sector in the less advanced countries.

The paper presented by the ICA Regional Director focused on Resource Mobilisation in the co-operative sector that comes primarily from members, so that equity is built over time and that accountability structures are also set in place to withstand misappropriation and sudden hostile take-overs.

Stress was also given on the dominant role still played by governments in co-operative development in less advanced developing countries, and how ICA

intends to bring more autonomy and independence towards strengthening member-driven activities, and positive dialogue with governments. There was unfortunately not enough time to elaborate in more detail on the South-South links and new initiatives.

The Workshop was attended by seventy-five delegates, mostly from Bilateral donors and Multilateral Agencies, and only a select number from non-government Organisations.

The World Bank, IMF, and all Regional Development Banks were represented, including some Finance Ministers and Central Bank Governors.

The tone of the Workshop was overwhelmingly inclined towards MICRO FINANCE, and it was an eye opener for the ICA to note how little is known about the work done by Co-operatives in this field, and for some attendees Co-operative is still an unfamiliar entity, or perceived as a government-dominated structure.

The Workshop, therefore, provided an excellent opportunity to promote the work ICA and its members are doing in the Financial Sector development, and also how sound financial systems can be designed and created through member-based organisations in less developing countries in the South.

Network opportunities was also captured by the Regional Director of ICA ROAP to seek possible synergies with organisations such as Women World Banking, the International Finance Corporation (of the World Bank), and to renew ties with known associates such as CIDA, ADB, and BMZ.

ICA holds Regional Youth Seminar In Philippines

The ICA Regional Office for Asia and the Pacific held the second Regional Campus/Youth Co-operative Seminar for Asia and the Pacific at Quezon City, Philippines from April 15-18, 1999. The main theme of the Seminar was 'Future Leaders Leading Now'.

The seminar was jointly organised by the ICA Consumer Committee on University/College Co-operatives for Asia and the Pacific, the National Federation of University Co-operative Associations in Japan (NFUCA), National Confederation of Co-operatives, Philippines, Metro Manila Federation of Consumers' Co-operatives (MMAFECCO), and the Co-operative Education and Development Center, Inc., Philippines.

More than 150 delegates and observers from Indonesia, Japan, Philippines, Singapore, Thailand and Canada participated at the seminar.

Keynote addresses were delivered by Prof. Solita Monsod of the University of the Philippines' School of Economics (Socio-Economic Realities and the Role of Youth and Co-ops) and Mr. Tatsuya Nakajima, Student Chairperson of the Kansai Regional Association of NFUCA, Japan (Youth and the Co-operatives of the Future).

There were group discussions in small groups to discuss questions deriving from the keynote addresses. Six country presentations were made.

On the second day of the seminar, Mr. Kisabaro Okayasu, Vice President of NFUCA, Ms. Teresita de Leon, NATCCO General Manager, Mr. Toshifumi Kuriki, Int'l Relations Manager of NFUCA, Ms. Cindy Murray of CCA and Mr. Romulo Villamin, Director- SEA of ICA gave lectures to the delegates.

ICA holds Sub-Regional Workshop on Co-operative Policy Reforms

The ICA Regional Office for Asia and the Pacific held a Sub-Regional Workshop on Co-operative Policy Reforms in Kathmandu, Nepal from 13-16 January, 1999.

The workshop was a precursor of the Regional Consultation scheduled to be convened in Singapore during July, 1999, to prepare for the 5th Asia-Pacific Co-operatives Ministers' Conference which will be held in October, 1999 in Beijing, China.

The workshop was inaugurated by His Excellency Rt. Hon'ble Giriya Prasad Koirala, Prime Minister of Nepal, who emphasized that globalization and liberalization as concepts have dominated the world trade and industry. He said that Co-operatives, as business enterprises should be able to operate in tune with these concepts and work like other players in the business to attain the development goals and serve its members' economic well-being.

The workshop deliberated on

'Enhancing Co-operation between Government and Co-operative Movement in the Spirit of Partnership', 'Co-operative Governance vis-a-vis professional management within co-operatives', 'Capital Formation Strategies for Co-operatives' and 'Co-operatives and the Social Sector'.

A special paper on 'Rediscovery of Co-operatives in Development Policy' was presented by Dr. Hans H.

Munkner and another by Mr. Kiran Pyakuryal 'Co-operatives and Social Safety Net' were also presented. Robby Tulus, ICA's Asia-Pacific Regional Director suggested strategies for the reform.

The workshop was participated by representatives from co-operatives and governments in Bangladesh, India, Iran, Israel, Nepal and Sri Lanka participated at the workshop.

The workshop recommended that traditional approach of the Government to treat co-operatives at par with public sector enterprises needs to be replaced by a more forward looking attitude that respects autonomy and freedom of enterprise of co-operatives to serve their members effectively and efficiently and to formulate clear public policy defining their perception in regard to co-operative development in the context of market economy and values enunciated in the ICA Co-operative Identity Statement.

The workshop also felt that in order to build up competitiveness and to strengthen their identity, co-operatives must reform their governance and management systems and implement policies by eliciting greater involvement of members in economic participation and decision making process.

Workshop identifies important co-operative legislation issues

Two new principles included in the Co-operative Identity Statement – *autonomy & independence* and *concern for community* – are not reflected in most co-op laws in Asia and the Pacific. At the same time, there is a need to set norms and standards by which to assess the “co-operative basis” of an enterprise. There is also a need to examine the development and regulatory roles that government now plays in relation to co-operatives.

These were among the important issues identified during the Sub-Regional Workshop on the Advancement of Legislative & Co-operative Policy Reforms, held in Bangkok, Thailand from 23 to 26 February 1999.

The workshop, which was participated in by 43 government and co-operative movement representatives from 9 Asian countries and international organisations, also discussed the need for affirmative action to increase women’s participation in leadership and decision-making in co-operatives.

The workshop is part of the ongoing process ICA ROAP is undertaking in preparation for the 5th Asia-Pacific Co-operative Ministers’ Conference to be held in Beijing, China from 11 - 16 October 1999.

The issues discussed during the workshop will be included in the consultations the participants will be conducting in their respective countries.

Other issues identified were: “one general law Vs sectoral laws governing co-operatives,” the issues of “deofficialization” and “politicization of co-operatives,” double taxation, co-op access to outside capital, minimum number of members to organize different types of co-ops, and membership of co-ops in secondary and apex organizations.

The sub-regional workshop was officially opened by Thailand’s Minister of Agriculture, Mr. Pangpol Adireksarn.

Countries represented were: Fiji, Indonesia, Malaysia, Mongolia, Philippines, Singapore, Thailand, Vietnam and China.

ICA to open Business Office in Singapore

Considering the business interests of ICA’s member organisations in Asia-Pacific and other regions, the idea of opening a business office in Singapore was first expressed during the visit of ICA President Roberto Rodrigues and Director General of ICA, Bruce Thordarson to Singapore in April, 1998. Since then, the Regional Director has taken necessary followed-up action on this.

The office will be officially opened on 10 July ‘99 by H.E. Abdullah Tarmugi, Minister for Community Development, Government of Singapore, in conjunction with the Regional Consultation Meeting to be held from 6-10 July, ‘99. The ICA President will preside over the opening of operations. The office will have a soft opening in June, 1999.

Several other meetings will also be proposed to be held during this period, which include a meeting of the ICA Regional HRD & Research Committee, meeting of the ICA Regional Agricultural Committee, a seminar on ICA Regional Banking and also a meeting of the office-bearers of ICA Regional Women’s Committee.

The ICA Regional Office hopes to serve its member organisations in the region from this office on inter-co-operative trade and matters relating to trade and business. The ICA ROAP also hopes to organise a trade exhibition in Singapore in the year 2002 to serve the interests of ICA members globally.

The regional consultation will define these issues in the context of objective conditions obtaining in the region and recommendations will then be formulated for review and adoption by the Fifth Co-op Ministers' Conference in Beijing, China from 11-16 October, 1999.

The 3 sub-regional workshops were held in Kathmandu, Nepal, 13-16 January, in Bangkok, Thailand, 23-26 February, and in Hanoi, Vietnam, 25-28 May, 1999.

The first phase of the course consisted the Home country assignments from November 16, 1998 to January 13, 1999, and programmes in India with the support and collaboration of ICA member organisation in India during January 14 to March 05, 1999. This part of the course was held with technical collaboration of Institute of Rural Management (IRMA) and cooperative organisations in the State of Gujarat, India.

The next leg of the programme was a study visit to Nepal, in collaboration with the National Co-operative Federation of Nepal. The second phase of the programme was held at IDACA, Tokyo with study visits in and around Tokyo and in Kochi and Gunma prefectures in Japan. The course concluded on 24th April.

An exclusive and comprehensive end-of-the course evaluation was conducted at the conclusion and certificates of participation were awarded to the participants.

Message from the President of the International Co-operative Alliance

To the Heads of Governments of the Member States of the United Nations

Geneva, September 19, 1999

Your Excellency:

I write as the elected President of the International Co-operative Alliance (ICA), the international association which represents national co-operative business organisations in some 100 countries around the world, with more than 700 million individual members. ICA is one of the oldest international non-governmental organisations, founded in 1895, and was one of the first NGOs to be granted top consultative status by the United Nations in 1946.

At our recent Congress in Québec City, Canada, some 1,000 co-operative leaders from all continents discussed not only our regular business issues but also the concerns which we all have as citizens of our individual countries and as citizens of the world. We know that globalisation is an inevitable trend in today's market economy, that many of its results are positive, and that co-operatives are playing their full role in the various economic sectors in which they operate.

But we also know that there is another side to globalisation. If one of its results is concentration and the growth of economic giants around the world, the other result is 'exclusion'. Its worst consequences are unemployment. But this is not the only one. Without any hope to improve his or her salary or quality of life, a person cannot go to the cinema or the football match, cannot go out with friends for a good time, cannot buy the CD or magazine, and cannot send their children to a good school. This kind of exclusion deepens the social abyss. It leads to bigger and bigger problems, whether they be crime, drug trafficking, terrorism, or guerrilla warfare. Above all, 'exclusion' is a great enemy of democracy.

Our Co-operative Congress in Québec City took place just after the release of this year's Human Development Report of the United Nations Development Programme. Again this year, the report confirmed that the gap between rich and poor is growing, not only between countries but also within countries. As the report said,

"We need a new approach to governance, one that preserves the advantages offered by global markets and competition while allowing for human, community and environmental resources that will ensure globalisation works for people and not just for profits."

I would like to suggest, for the consideration of your government, that the co-operative form of enterprise - businesses owned by local people who use their services - is one of the answers to the problems of exclusion facing all countries around the world, both developed and developing.

As businesses rooted in local communities, co-operatives can never relocate to countries where wages are lower or environmental restrictions are less demanding. Around the world today we see examples of new forms of co-operative enterprises - health, transport, social service, elderly care, employment, privatised government services, and others - creating thousands of new jobs. At the same time, the strong co-operative enterprises in financial services, agriculture, consumer retailing, and housing continue to be major employers in almost all countries.

For this reason, I believe that co-operatives are natural allies of good governments. We believe in the same objectives - employment, food security, environmental protection, community development, fair prices, and non-exploitation of people.

In this connection, may I draw your attention to the recent report of the UN Secretary-General to the General Assembly (A/54/57) on the importance of good public policy and legislation for the development of the co-operative movement. The report notes that the characteristics of co-operatives should be recognised by public authorities and that they should be assured real equality with other forms of enterprise.

May I respectfully request that your government, through its Ministry of Foreign Affairs, support this report of the UN Secretary-General when it is presented to the General Assembly later this year, and that your government support the important role which co-operative enterprises play in economic and social development of your country.

As we enter the new millennium, exclusion is a potential danger to all countries. Co-operatives, economic organisations with a social concern, can help to reduce the negative effects of globalisation through their efforts to serve their members and their communities.

I thank you for your government's consideration.

A new Vision Statement for ICA

ICA's Mission Statement says that, "The International Co-operative Alliance is an independent, non-governmental association which unites, represents and serves co-operatives worldwide." From this starting point, and on the basis of the feedback received from the Organisational Review, it is possible to establish a description of what ICA can realistically be expected to accomplish.

For this purpose a **Vision Statement** has been prepared of what ICA should be like by the year 2005. It is not an idle dream, but rather an indication of what is both desirable and feasible given the current and projected environment. It represents the goal towards which all components of the "ICA family" should be striving.

By the year 2005, ICA should be an organisation which, in collaboration with its members:

- i) Promotes the co-operative values and identity, and helps to defend co-operatives when they are under attack, by influencing public policy and by demonstrating the co-operative difference in the market through an effective communications policy;
- ii) Supports and facilitates the development of co-operatives as efficient businesses in all countries, giving particular attention to the needs of co-operatives in developing countries and countries in transition, and to the development of co-operatives in new areas of economic and social activity;
- iii) Assists and supports the sectoral organisations within the ICA in their efforts to provide useful business and other services to their members, and promotes mutually-beneficial collaboration between sectors while respecting the principle of subsidiarity;
- iv) Maintains effective Regional Offices, working closely with and assisted by Head Office, which are the focal points for supporting and providing tailor-made services to ICA members in the regions;
- v) Is led by the Board, which determines global policy and provides strategic guidance for the entire ICA family of organisations;
- vi) Represents in its membership all major co-operative movements and sectors which conform to the ICA's Co-operative Identity Statement;
- vii) Is a "learning organisation" which facilitates and supports the development and exchange of information about best co-operative practices, innovative activities, and new forms of co-operative development;
- viii) Is a centre of information and expertise for and about co-operatives around the world;
- ix) Plays a leading role within civil society by influencing major global issues and international agencies in areas of importance to the ICA's members; and
- x) Has adequate resources to achieve its goals.

NCDC donates Rs.2.7 million to Army Welfare Fund

The National Co-operative Development Corporation of India and its employees have donated Rs.2.7 million to the National Defence Fund, for the brave soldiers who lost their lives in the Kargil battle.

Mr. P.K. Mishra, Managing Director of NCDC and Mr. Som Pal, Minister of State for Agriculture and Chair of NCDC presented the cheque to the Prime Minister of India, Mr. Atal Behari Vajpayee.

New software for Co-operative Banks

The Institute of Co-operative Management, Thiruvananthapuram, Kerala developed a software PACSOFT 1999.

The on-line banking software developed in Visual Basic and SQL server will modernise the operations of co-operative banks in the State and elsewhere.

Juku Ozawa visits Sahakari Bhandar

Juku Ozawa, Director (Special Programmes) at the ICA Regional Office for Asia and the Pacific, visited Sahakari Bhandar and Apna Bazar in Mumbai, July this year to study about the consumer co-operatives in western India.

ICA Committee on HRD and Research for Asia and the Pacific meets in Singapore

ICA Committee on HRD and Research for Asia and the Pacific met at the Grand Plaza Park Royal Hotel in Singapore on 11th July, 1999.

The meeting, chaired by Royal Professor Ungku A. Aziz, reviewed the MATCOM materials on training and suggested that the ICA should get this material updated for training activities in the region.

The meeting also sought to strengthen the network among co-operative colleges and 'co-operative-minded' universities.

CCA organises Partners' Education Outreach Programme and Youth Forum

The Canadian Co-operative Association organised a Partners' Education Outreach Programme and Youth Forum in Guelph, Ontario, Canada during 23-24 August, 1999.

About 40 participants from Asia, Africa and the Americas participated at this Forum.

Of special interest was the Youth Forum, where 12 young delegates got together and shared their ideas on co-operative enterprise and development. The Youth Forum culminated in a wrap up meeting at Québec and presented a paper to the ICA Congress there.

The participants to the Partners Education Outreach Programme and Youth Forum were able to attend the various business sessions of the ICA Congress, enriching their knowledge and networking with a wide variety of delegates from countries all over

A total of 28 participants attended this meeting.

Immediately on the conclusion of this meeting, a meeting of Asian Co-operative Research Forum was held at the same venue, which was attended by 12 participants.

The meeting decided to form a core group of co-operative researchers, chaired by Akira Kurimoto of Japan, and organise a Co-operative Research Conference in the year 2000, in conjunction with the ICA Regional Assembly in Singapore.

Regional Consultation on Co-op Legislation

ICA Regional Office for Asia and the Pacific held a Regional Consultation on Co-operative Legislation and Policy Reforms in Singapore - July 6-9, 1999.

Eighty-seven participants from 18 countries and 8 international organisations participated at the Consultation and endorsed 'Recommendations' for discussion at the Fifth Co-operative Ministers' Conference to be held in Beijing, China, October 12-16, 1999.

Prior to this Consultation a symposium on Co-operative Legislation in Economies in Transition was held in Hanoi, May 25-28, 1999.

These activities and two sub-regional workshops held in Kathmandu and Bangkok during January and February, 1999 respectively were precursors to the Fifth Ministers' Conference.

Conference on Women in Agricultural Co-ops in Asia & Africa

The Fourth International Conference on 'Women in Agricultural Co-operatives in Asia and Africa' was held in Tokyo during August 24-29, 1999. The conference was organised jointly by the ICA ROAP, JA-Zenchu, IDACA and the Afro-Asian Rural Reconstruction Organisations.

32 delegates from 16 countries and 3 international organisations attended the conference.

Some of the problems faced by rural women vis-à-vis their participation in co-operative activities identified by the conference were: widespread illiteracy among women in rural areas; multiple role of women and lack of time; inadequate nutrition, sanitation and safe drinking water; limited access to credit; stiff competition and marketing problems; lack of training and education opportunities; low representation of women in national co-operative bodies and in the process of decision-making; customs, traditions and superstitions; and lack of access to technology. The

conference suggested the following possible solutions:

- i) strengthening existing institutions;
- ii) encouraging role of NGOs in the field of women development;
- iii) transparency and accountability in the operation of co-operatives,
- iv) easy accessibility to financial resources;
- v) development of self-help groups and pre-co-operatives;
- vi) better health-care for women.

Besides classroom studies, the participants also visited Japanese primary agricultural co-operatives in Iwate prefecture and in and around Tokyo and observed the organisational structure and activities of Women's Associations.

Co-operative Financial Intermediation in Asia and the Pacific

Asia-Pacific Seminar on Positioning of Co-operative Financial Intermediation in Post-Crisis Capital Markets and Financial Sector was convened by the ICA Regional Co-operative Banking Association during July 12-15, 1999 in Singapore.

The main objectives of the seminar were to critically examine and review the status, role and positioning of co-operative credit and banking institutions in the liberalised and globalised financial sector and to recommend measures for strengthening competitiveness of financial co-operatives.

More than 60 participants from 11 countries of the Asia-Pacific Region and international organisations like Asian Development Bank, Development International Desjardins (DiD) of Canada, Rabo Bank Foundation of Netherlands, Asian Confederation of Credit Unions (ACCU) and National Bank for Agriculture and Rural Development (NABARD) of India, participated in the seminar.

The Rabo Bank Foundation and DiD provided financial support for the seminar.

The seminar focused on the following subjects to formulate suitable recommendations to strengthen co-operative financial intermediation in the region:

- i) co-operativising micro-credit;
- ii) strategies for recapitalisation of co-operative credit and banking institutions;
- iii) Effective supervisory mechanism for co-operative, credit and the banking sector;
- iv) information technology and management information system;
- v) human resource management and development.

credit and banking sector in selected countries of the region was presented, to undertake an objective analysis of trends in the sector during the post-crisis period.

Fifth Asia-Pacific Co-operative Ministers' Conference, Beijing, China

The 5th Asia-Pacific Co-operative Ministers' Conference was convened by ICA ROAP – October 11-16, 1999 in Beijing, China.

The Conference was hosted by the Government of People's Republic of China and the All China Federation of Supply and Marketing Co-operatives. 163 participants, including 15 Co-operative Ministers and high ranking government officials and 139 co-operative leaders from 24 countries and 22 participants from eight international organisations (ACCU, AARRO, CCA, CICOPA, DID, FAO, ILO, ICA) participated in the Conference.

The Conference was inaugurated by His Excellency Wen Jiabao, Vice Prime Minister of the People's Republic of China. In his inaugural address, Hon'ble Wen Jiabao mentioned that it is of great benefit and importance that such a Conference is taking place in Beijing. It is also significant that celebrations marking the 50th anniversary of the founding of the People's Republic of China took place during this period. He said that the Chinese government has always attached great importance to the co-operative movement. He felt confident that this Conference will help furthering the government-co-operative relations and also pave the way for promotion of exchanges and co-operation among countries in the Asia-Pacific region.

Roberto Rodrigues, ICA President, thanked the Government of the People's Republic of China and the All

China Federation of Supply and Marketing Co-operatives for hosting the conference. Comending the development of co-operative movements in Asia and the Pacific Region, he identified positive support of the State to co-operatives as one of the crucial factors in this growth process. He however felt that with the fast changes taking place in global economy due to structural adjustments and opening up of national economies, the role of the State in co-operative movement needs to be reoriented to create an enabling environment, facilitating a pragmatic fusion of Co-operative Identity and business efficiency.

Mr. Bai Lichen, President of the All China Federation of Supply and Marketing Co-operatives said as stressed

in the ICA Co-operative Identity Statement (ICIS), people set up co-operatives out of their common needs and desires in economic, social and cultural spheres, with self-reliance, responsibility, democracy, equality, justice and unity. Though the co-operative movement in China has a history of 80 years, it was after the founding of the People's Republic of China fifty years ago that the co-operative movement started having rapid development, playing important roles in the social and economic life of the people of China. He felt that the ICA is doing a commendable job in holding these conferences and hoped that it will promote understanding and co-operation among co-operatives and governments in this region.

Mr. Mu Li, ICA Vice-President for Asia and the Pacific and Vice-President of the Board of Directors of All China Federation of Supply and Marketing Co-operatives, in his speech said that it is of great significance to define the theme of this conference as 'Enhancing Sustainable Development of Co-operatives in the 21st Century'. He hoped that the Conference will help the co-operative movement to accomplish new achievements in the twenty-first century, promoting peace, prosperity and stability in the region, with the constructive support of the governments.

During the Conference, Ministers, Heads of delegations, Chairmen of apex organisations, ICA President, Director-General and Regional Director called on the Prime Minister of People's Republic of China and exchanged the views on co-operative development.

The Conference was the culmination of the long efforts by the ICA Regional Office, which conducted issue-based workshops in Kathmandu, Nepal (January 99), Bangkok, Thailand (February 1999), Hanoi, Vietnam (May 99) and a Regional Consultation in Singapore during July, 1999.

Based on the recommendations of the Regional Consultation, the 5th Co-operative Ministers' Conference deliberated and formulated specific

recommendations on the following issues: (i) Autonomy and independence; (ii) Recognition; (iii) Fair playing field; (iv) Legal existence; (v) Self-regulation; (vi) Capitalization; and (vii) Official Development Assistance.

Besides, the Conference also made specific recommendation on Networking as an important element in maximizing effectivity of development assistance.

Deliberations of the Conference culminated into a Joint Declaration highlighting a new approach to co-operative development focusing on the need for creation and sustaining an enabling policy and legal environment and the need for establishment of new forms of co-operation between the governments and co-operatives.

The recommendations of the Conference centered around this approach to co-operative development. Through the Ministerial Conference ICA ROAP has facilitated an active dialogue between co-operatives and the governments.

In order to ensure effective implementation of recommendations and Joint Declaration, the Conference constituted a Steering Committee at the ICA ROAP level. The Steering Committee will monitor the progress of implementation and report to the next Ministers' Conference.

Besides, participating countries formulated Action Plans to implement the recommendations.

At the closing ceremony, Bruce Thordarson, Director General of ICA, congratulated the ICA Regional Office and Robby Tulus, its Regional Director for the efforts put in organis-

ing the Conference and thanked the host organisation and all the ministers and other delegates who actively participated in the conference.

Robby Tulus, Regional Director, also thanked the host organisation and its staff for the excellent arrangements they have made for the conference. Many of the delegates had the opportunity of a Special Audience with H.E. the Prime Minister of the People's Republic of China.

The Government of China treated the delegates to a big banquet dinner at the Great Hall of People, while the All China Federation of Supply and Marketing Co-operatives gave a banquet dinner accompanied by a spell-binding acrobatic show at the Friendship Palace, the venue of the Conference.

The Mayor of Beijing gave a farewell dinner to the delegates at the famous Beijing Roast Duck Restaurant.

The delegates were also taken out for a sight-seeing tour to the Great Wall of China and they had the opportunity to visit a co-operative supermarket, affiliated to the All China Federation of Supply and Marketing Co-operatives.

It was felt by all the delegates participated that the Conference was a great success.

The meetings will be hosted by Dewan Koperasi Indonesia (DEKOPIN) and will take place at

Hotel Natour Kuta Beach, Bali, Indonesia.

It is expected that various important issues will be discussed at these meetings and a tentative work plan for the year 2000 will be adopted.

Reports on the youth seminar held in Manila, Philippines and on the World Youth Seminar will also be presented.

ICA to collaborate with ADB on development

Bruce Thordarson, Director General and Robby Tulus, Asia-Pacific Regional Director of ICA met the President and officials of the Asian Development Bank in Manila early October, 1999 and discussed potential co-operative development activities in collaboration with ADB.

They explained to the Asian Development Bank on the activities of the ICA globally and in the Region and explored the possibilities of making co-operatives viable models for micro-finance and poverty alleviation strategies being pursued by the Bank.

"Added Value through Women's Participation: The enhancement of Co-op Opportunities and Performance"

Robby Tulus, ICA Regional Director for Asia and the Pacific participated at a Global Conference organised by the ICA Global Women's Committee in Quebec City on 29 August, 1999, and presented a paper titled 'Some experiences in Goal-oriented Training and Education'.

In his paper he explained the cultural and historical context, specially the Asia situation and despite constraints by the historical and cultural contexts, how businesses owned, managed or operated by women have '**added-value**' and contributed to the economies of the region. He also explained, how the ICA in Asia-Pacific, with the unfailing support of the Japanese Consumers Co-operative Union and the ANGKASA - Malaysia, were able to work towards gender-mainstreaming in co-operatives in the region. The Regional Office and the Gender Programme Coordinator were able to organise Regional Women's Committee and hold the first ever Regional Women's Forum last year.

The ICA Regional Office also collaborated with the ILO Coopnet Project on gender related activities and are working to develop a manual on Co-operative Leadership Training for Women. The gender-mainstreaming activities will be an ongoing effort. ICA ROAP will look for workable mechanisms to sustain the involvement of women as leaders and decision makers in co-ops.

The New ICA Flag

The ICA has approved, in principle, the use of this new co-operative flag during the board meeting at Québec, which is white in colour with 7 birds flying out of the rainbow. The flag is made in pure silk and can be ordered from the ICA Regional Office for Asia and the Pacific.

NCUI celebrates 46th All India Co-operative Week

The National Co-operative Union of India is scheduled to celebrate the 46th All India Co-operative Week, 14 to 20 November, 1999.

The theme of the Co-op Week is "Co-operatives for Empowerment of People". It is expected that over 300 delegates from all over India will participate at the celebrations.

Canadian Co-ops going strong

The top 50 co-operatives in Canada continued to thrive in 1998 and showed an increase of more than eight per cent compared to 1997.

According to the new figures, membership for the top 50 co-operatives rose by 13 per cent in 1998.

While the employment rate in Canada increased by 2.8 per cent between 1997 and 1998, the top 50 Canadian co-operatives hired five per cent more workers in 1998, employing nearly 39,000 people.

The *Coopérative fédérée de Québec* was the largest employer again last year with more than 7,400 employees.

The Saskatchewan Wheat Pool remains the largest amongst the top 50 co-operatives, with more than \$4.3 billion in sales.

ICA Consumer Committee and Consumer Forum held in Bali, Indonesia

The 32nd meeting of the ICA Committee on Consumer Co-operation for Asia and the Pacific was held in Bali, Indonesia, 30th November 1999.

The Committee agreed to conduct an overall study of a member co-ops in the Region during 2000, by visiting a number of consumer co-operatives by the members of the Committee. There was also a proposal to establish a training project for studying the market trends and products. The project will conduct a survey using questionnaires.

The proposal came from the Japanese member and cited the example of Co-op Sapporo, where the severity of the

management situation was felt by JCCU.

During the Consumer Committee meeting a Co-operative Consumer Forum was organised, where serious discussions about the consumer co-operative operations in the Region were discussed.

The theme of the Forum was "What is the value of consumer co-ops in Asia". The aim of the forum was to understand the activities and present conditions of consumer co-operatives in member countries.

Mr. Mats Ahnlund, Senior Advisor of Membership Services at the ICA Head Office in Geneva reported on 'Ethical

Value of Co-ops' when the market competition intensifies.

Mr. Romulo Villamin spoke about the value of co-operatives in relation to local communities. The participants also spoke about member participation, community impact, employee's education, joint buying, at the national level, etc.

The Consumer Forum was a success and participants felt that similar forum should be held in the future too.

ICA Consumer Sub-Committee on University/College Co-ops meets in Bali, Indonesia

The 5th Meeting of the ICA Consumer Sub-Committee on University/College Co-operatives for Asia and the Pacific was held at the Udayana university in Bali, Indonesia, 29th November 1999.

About 30 students participated with the observer from Indonesia every place. Students even travelled more than 26 hours by bus to participate at the meeting.

The major theme discussed at the Forum was the setting up of a Youth Project for setting up university co-operatives in every country of the region. It was reported at the meeting that 3 campus co-ops were established in Singapore and Vietnam. It was also reported that co-operative joint activities were introduced in Indonesia.

The 3rd Asia Pacific youth forum will be held during June, 2001 in Japan.

The 2nd Youth forum had decided on the Logo of the Youth Forum, wherein a male youth stands in front and a woman youth, partly hidden at the back. The meeting decided to bring out possible designs from member participants and bring out a brochure for the Co-op Youth Forum.

APHCO holds its Board meeting and Regional Seminar on Co-op Healthcare

The board meeting of Asia Pacific Health Co-operative Organisation (APHCO) was held at Armada Hotel, Kuala Lumpur, Malaysia on 8 October, 1999. The meeting was chaired by Dr. Shoji Kato, Chairperson of APHCO.

The board meeting decided that the present board members will continue for a further period, expect that Dr. Ogino of JCCU will be replaced by Dr. Yasuyuki Takahashi.

The meeting was followed by a Regional Seminar on 'Co-operative Healthcare in the new Millennium', on 9th October, 1999, held at the same venue, wherein a total of 80 delegates from 7 countries participated.

Dr. Kato, in his keynote address, emphasized the need to promote solidarity and co-operation among health co-operatives to enhance the quality of health and social care services in communities and to exchange experiences

and learn from each other. He also felt that APHCO should collaborate with NGOs and the WHO and promote co-operation with governments and private enterprises in a realistic way.

The need to expand the membership of APHCO was felt by all the members.

In the regional seminar 5 reports on Co-operative healthcare at primary level in Korea, Role of health co-operatives in Nepal, Care of the aged in Japan, Networking among co-operatives in India, and Health financing/insurance and co-operative healthcare in Malaysia were presented. The seminar was attended by a number of delegates from Malaysia.

Mr. Juku Ozawa, Director (Special Programmes) of ICA served as the Secretary to the APHCO.

The next meeting of the board of APHCO is scheduled to take place in Kerala, India, 27-28 March, 2000.

Third University Co-op established in Vietnam

During a seminar on 6-7 December, 1999, 3rd University Co-operative has been established at the university of Thai Nguyen city, located in the north of Vietnamese capital Hanoi.

The university co-operatives established earlier were at Hanoi and Hochi Minh City. Even children from the minority races of Vietnam north mountainous areas are studying at Thai Nguyen University.

Local governments in the country are active in co-operative promotion and the conference aimed at creating a common understanding between government and the co-operative sector.

The National Conference on Local Governance and Co-operative Development was held 8-10 November at the Subic International Hotel. It was organised by the Philippine Co-operative Center. The conference brought together around 300 participants from the government and co-operative sectors.

Mr. Romulo Villamin, Director for South East Asia of the ICA Regional Office presented a paper on 'Co-operatives and the Changing of the State'.

B. D. Sharma visits Iranian Co-operatives

B. D. Sharma, Director for South, West and Central Asia, at the ICA Regional office for Asia and the Pacific, visited the co-operatives in the Islamic Republic of Iran during December, 1999.

During his visit, Mr. Sharma has found that the Iranian co-operatives are highly diversified and has much to offer in co-operative trade. The Iranian co-operatives process food products and exports to various countries.

The Iranian co-operatives are keen to get their HRD personnel trained at other regional institutions for providing a better co-operative training to their personnel and members. They have requested the ICA to provide such opportunities for training in Malaysia, India, Japan, etc. on self-financing basis.

The Iranian constitution specifically mentions co-operatives as important component of national economy. The

government is willing to provide all out help to co-operatives and requested ICA if it could help them in conducting an analytical study on present position of Iranian co-operatives.

The Iranian co-operatives and the Ministry of Co-operatives are keen to support financially co-operative development efforts in central and west Asia. They have also requested ICA to set up a sub-regional project office in Tehran for this purpose.

Iran has also set up a Co-operative Bank and requests for technical support from co-operative banking institutions. Mr. Sharma promised to coordinate these efforts from the ICA Regional Office for Asia and the Pacific.

On the whole, it looks that the co-operatives in the region have a better future with the Iranian support.

Minister sees Enlarged Role for NCDC

Hon. Nitish Kumar, Union Minister for Agriculture, Government of India, hoped that the co-operatives will continue to play a vital role in the overall economic development of the country in future, especially in handling commodities like milk, fish, fruit and vegetables, agricultural inputs, etc.

Mr. Nitish Kumar was speaking at the 49th General Council Meeting of National Co-operative Development Corporation of India in New Delhi, on Dec. 9, 1999.

The Minister assured that the amendment to the NCDC Act pending for quite some time, will be passed soon, to enable NCDC to finance industrial co-operatives, cottage and village industries and other services.

The amendment to the Act will also facilitate the Corporation to provide funds to co-ops without insisting on government guarantees.

Singapore National Co-operative Federation holds Seventh Triennial General Assembly

The Seventh Triennial General Assembly of Singapore National Co-operative Federation was held on 27 November, 1999 at The Grand Hyatt Hotel. A new Board of Trustees and Executive Council were elected by delegates of the affiliates at the Assembly.

The six members of the Board of Trustees are: Mr. Goh Chee Wee (Chairperson), Mrs. Yu-Foo Yee Shoon (Deputy Chairperson), Mr. Anthony Pragasam (Member), Mr. Victor Pang (Member), Mr. Anthony Samy (Member), and Mr. Pal Tan (Member).

The ten members of the Executive Council are: Mr. Tan Kin Lian (Chairperson), Mr. S. Maganaruban (First Deputy Chairperson), Mr. Chan Tee Seng (Second Deputy Chairperson), Mr. K.T. Samuel (Member), Mr. Thomas Thomas (Member), Professor Poo Gee Swee (Member), Mr. Ismail Mohd. Yusof (Member), Mr. Nithiah Nandan (Member), Mr. Seah Kian Peng (Member), and Ms. Nichole Tan (Member). Mr. Goh Chee Wee and Mr. Tan Kin Lian were re-elected as Chairpersons of Board of

Trustees and Executive Council respectively.

Ms. Yu-Foo Yee Shoon, the Acting Chairperson of the Board of Trustees and also the Senior Parliamentary Secretary of the Ministry of Community Development addressed and chaired the Assembly.

Ms. Yu-Foo Yee Shoon, at her opening address of the Assembly emphasized: "It is my sincere hope that the new Board of Trustees and Executive Council will provide the leadership and the drive for the various tasks ahead and deliver tangible results for the co-operative movement, building on its reputation as a responsible and effective partner in Singapore and on the international stage."

Mr. Tan Kin Lian, Chairperson of SNCF, in his statement during the Assembly said: "We aim to make co-operatives play a more meaningful role, - a role which will meet the changing needs of our people in the twenty first century. New programmes with more activities involving members must be drawn up from time to time to reflect the thinking

of our leaders and the ever-growing membership of the movement. People are expected to be generally more informed and better educated and they can therefore be demanding. Co-ops must be more competent and competitive to survive and remain relevant.

He spoke about the regional events being held in Singapore during June 2000, the First Asia-Pacific Co-operative Forum, the 2nd Regional Women's Forum, the Co-operative Research Forum and the 4th ICA Regional Assembly for Asia and the Pacific.

He also mentioned about the forthcoming meeting of Chief Executive Officers of Co-operatives and the ICA/ICFTU/APRO Regional Workshop on Employment Generation, Poverty Alleviation and Human Resource Development.

The Singapore National Co-operative Federation has 67 co-operative affiliates and a total membership of 1.3 million, are associated with the ICA Regional Office for Asia and the Pacific on all these events.

Fostering Agricultural Co-operatives - JA-Zenchu Field study mission in Laos

With a view to encourage for mation of agricultural co-ops and to streamline agricultural production by providing a service institution at the grassroots level, the JA-Zenchu (Central Union of Agricultural Co-operatives of Japan) has fielded a survey mission to Laos PDR. The study mission is assigned the task to identify the pitfalls and highpoints as to the establishment of primary level multi-purpose agricultural co-operatives and to recommend fostering of such institutions.

The study mission consists of four technical consultants and two national counterparts. The survey will be carried out in collaboration with the Ministry of Agriculture and Forestry of Laos and is spread over a period of two years.

The first phase of the survey was carried out during November 15-26, 1999 under the leadership of Mr. Midori Matsuhiro, Senior Advisor at the JA-
