PREFACE

This bibliography on the co-operative movement was compiled following a suggestion made at the Conference on Technical Assistance at Holte, Denmark, in September, 1968. One of the recommendations adopted by the Conference recognised that there was a considerable need for basic co-operative literature to be made available on different types of co-operative activities. It was therefore suggested that the International Co-operative Alliance should prepare a select bibliography on each important sector of co-operative endeavour.

The aim has been to include about twelve entries on each sector or subject. Books have been chosen for the universality of their application; this consideration made it necessary to exclude a number of works of a more limited or national interest. The books listed are, as far as can be ascertained, in print. Where known, the full details of the publisher's name and address and the price have been given. At the end of the bibliography there is a short list of publishers and organisations from which books on the co-operative movement may be obtained.

Certain subjects where little printed material is available, such as co-operative legislation and taxation, are under constant review and study by the I.C.A.; inquiries on material relating to these, and other fields, may be directed to the I.C.A.

The Librarian of the International Co-operative Alliance, Miss A. Lamming, who has compiled this bibliography, welcomes suggestions for the improvement of this bibliography, either in its arrangement, or in regard to the inclusion of new titles.



