# Executive Summary

In order to step up implementation of the 5 priority themes identified in the ICA Blue Print for a Co-operative Decade, ICA-AP organised several events focused on increasing participation within membership, capacity building of members as well as co-operative institutions, preserving the co-operative identity, ensuring supportive frameworks for co-operative growth and securing reliable co-operative capital while ensuring member control.

## 1. Elevating participation within membership

In order to increase interaction among members and enhance their capacity to actively participate in the business of their co-operatives, ICA-AP conducted several activities with members from the region.

- i. Continued collaboration with the Ministry of Agriculture, Forestry and Fisheries (MAFF) Japan; National Agricultural Co-operative Federation (NACF), Korea; All China Federation of Supply and Marketing Co-operatives (ACFSMC) China to implement innovative projects.
- ii. Strengthened communication and information sharing with members through newsletters, reports and website.

## 2. Sustainability

Capacity building of members and co-operative institutions is necessary to make co-operatives sustainable business organisations. At the same time, it is essential to increase participation of women and youth. ICA-AP conducted trainings, workshops and seminars to increase the capacity of all stake holders, especially women and youth.

- Training of coop managers and leaders for development of consumer co-operatives.
- Training and workshop for enhancing the role of women in co-operative business.
- Conferences and meetings for enhancing participation of youth in co-operative development.
- Training, workshops, study visits for fostering core leadership in agriculture co-operative and safety and quality management for farm products for enhancing income of the farmers.
- Workshops and Seminars for human resource development in co-operatives.
- Seminar for promotion of international trade among co-operatives in the region.

## 3. Identity

The co-operative business is based on unique principles and values. It is a business with difference wherein members are owners and work for collective benefit and not for individual profit.

The Board of ICA-AP is fully aware of the need to keep and promote the unique identity. The regional board meetings deliberated upon governance issues which help members in organising/identifying authentic co-operatives based on the identity and discouraging co-operatives that do not follow ICA principles and values.

The new ICA COOP marque was launched in Cape Town, Africa during the ICA General Assembly in November 2013. There were four options of the co-operative marque for the Asia Pacific region to choose from and these were circulated to all members. Of the 20

responses (12 countries, 20 members) received, an overwhelming majority opted for the marque Option 1b (see section on New COOP Marque).

#### 4. Ensuring Supporting Legal Frame Works

The 1st Asia Pacific Co-operative Registrars' Conference was held in November in Kuala Lumpur, Malaysia from 10-11 December 2013. The ICA-AP study on, "Bye Laws of Primary Co-operative Societies" was commissioned and presented at the Conference.

#### 5. Securing Reliable Co-operative Capital

Reliable capital is the base of any business. However, in case of co-operative business, securing reliable capital is more of a concern as it is a collective business and risk taking capacity among members is not so strong. In line with the values of self-help and solidarity, members should generate their own funds and not invest in risky ventures. The co-operatives should be made aware of reliable investment streams and be vigilant in

safeguarding the interest of members in case they accepted investment from outside of co-operatives.

ICA-AP conducted several capacity building programs to enhance the capacity of stakeholders to create wealth through co-operative business. ICA-AP collaborated with several members in the region to generate capital for implementation of its various activities. It also extended support to members who required financial assistance in implementing their projects. Besides financial capital, skilled human capital is also very important. Therefore, serious efforts need to be made for inclusion of women and youth in the co-operatives to make it an inclusive organisation.

ICA-AP members contributed generously to support members from co-operatives in the Philippines who were devastated by typhoon Haiyan.

In order to promote trade among co-operatives, a seminar was held in China.

# 1st ASIA PACIFIC CO-OPERATIVE REGISTRARS' CONFERENCE

## Theme: Sound Tuning of Co-operative Law, Policy & Regulation and Primary Co-operative Bye-Laws

The 1st Asia-Pacific Co-operative Registrars' Conference on the theme, 'Sound Tuning of Co-operative Law, Policy & Regulation and Primary Co-operatives Bye-Laws' was held on 10-12 December 2013 in Kuala Lumpur co-hosted by the Malaysia Co-operative Societies Commission (MCSC) and Malaysian National Co-operative Movement (ANGKASA).

Co-operative Registrars are the central and very important Government Authorities who are responsible for formation, development, amalgamation and dissolution of cooperative societies especially in the South Asia region. Therefore, conferencing among

context, the objectives of the Conference were multi-functional:

- To review and follow up on the progress of action taken on the Declaration and Recommendations of the last Co-operative Ministers' Conference
- To address legal, policy and regulatory issues impacting overall governance and supportive measures for co-operatives in their respective countries
- To share experiences of countries and best practices in respect of the concerned areas of co-operative development.

Registrars of various countries is the best instrument to carry out the mandates given by the Co-operative Ministers' Conference and to build better co-operative system together with the co-operative apex organizations of their respective countries in the region.

The Conference was mandated by the 10th ICA Asia-Pacific Regional Assembly held in Kobe, Japan on 29 November 2012, in order to address legal, policy and regulatory issues impacting over all governance and functioning of Co-operatives in the region. Given this

With the above objectives, the Conference deliberated on co-operative governance, experience sharing including best practices so as to arrive at a common understanding of main issues – legal and practical for preparation of bye laws of primary Co-operatives in a manner consistent with the ICA Statement on Co-operative Identity and to consider common guidelines for adoption in the conference on framing of bye laws of primary co-operatives.

The owner of the Conference, Registrars of Co-

operatives from 7 countries, representatives of seventeen ICA-AP member apex co-operatives and three international organisations – International Labour Organisation (ILO), Asian Confederation of Credit Unions (ACCU) and International Organisation of Industrial, Artisanal and Service Producers' Co-operatives (CICOPA) participated fully and their contribution has been of immense value to the Conference.

The participation of the H.E Dato' Hasan bin Malek, Honourable Minister of Domestic Trade, Co-operatives and Consumerism, Government of Malaysia; Emmanuel S. Santiaguel, Chairperson, Co-operative Development Authority of Philippines; Dr. Chandrapal Singh Yadav, Vice Chairperson of the ICA Asia and Pacific Board and Datuk Hj. Nik Ali Bin Mat Yunus, Executive Chairperson, Malaysia Co-operative Societies Commission and around 200 co-operators

representing the co-operative movement made the Conference a broad based conclave on the subject of bye laws taken up for the first time by the ICA Asia and Pacific (ICA-AP) as a strategic issue for co-operative development. The Regional Director of ICA AP drew the attention of the Conference to the System Elements in 'Building Enabling Legal and Policy Environment for Co-operatives in Asia-Pacific' highlighting basic principles, institutions of governance and their inter relationships for building this environment conducive to growth of co-operatives. This constituted the framework of the proceedings of the Conference.

The findings of the study on bye laws of primary co-operative societies in the region formed the base paper for deliberations of the Conference. Delivering the inaugural address, the Honourable Minister of Domestic Trade, Co-operatives and Consumerism, Malaysia informed the Conference that the Government of

Malaysia has accorded high importance to the co-operatives as a sector balancing market based economic activities under capitalism and state sector taking into account the social impact of globalisation which necessitated a clear separation as well as simultaneous and harmonious growth of agencies and sectors influencing the economy. This is in line with the Vision-2020 document to make Malaysia a developed country by providing its citizens opportunities for growth in all spheres. Malaysia is keen to expand social co-operatives as distinct from co-operatives engaged purely in business activities as a means to maximise socio-economic benefits blending concern for community with economic progress.

Dr. Chandrapal Singh Yadav, Vice Chairperson - ICA Asia and Pacific and President, National Co-operative Union of India, gave an overview of the co-operative sector in India highlighting its huge coverage in the form of 600,000 co-operatives with 230 million members in

diverse sectors. He also mentioned that in Asia Pacific region, the enactment of Co-operative Code 2009 in Philippines containing the seven ICA Principles of Co-operative Identity and laying down elaborate rules and procedures for specialised co-operative activities in 20 sectors, e.g. agriculture and fisheries, the Co-operative Amendment Act 2009 of Bhutan and the co-operative policy reforms measures in Sri Lanka, inclusion of the Right to form co-operatives as a fundamental right in the list of Fundamental Rights in the Constitution of India, the Co-operative Development Plan 2011-2016 of Philippines, the Iranian Plan to raise the share of the Co-operatives in the national GDP from the present 9% to 25% by 2020, the Japanese Basic Plan for food and agriculture and rural areas for ensuring food security and the important role assigned to co-operatives in the national effort must be viewed as outcomes of the advocacy of ICA-AP.


## CONFERENCE RESOLUTION

Adopted on December 11, 2013


Whereas, the ICA-Asia and Pacific has been urging its members and national Governments through various forums such as the Co-operative Ministers' Conference especially, the Joint Declaration of the 9th Asia Pacific Co-operative Ministers' Conference, Bangkok - 2012, that called upon countries to initiate changes in co-operative laws and policies to achieve the objective in creating the legal and policy environment that is conducive to the development of co-operatives in accordance with the principles embodied in the ICA Statement on Co-operative Identity (Manchester - 1995) and that, in pursuance of the aforesaid Declaration, the Regional Assembly of the ICA-Asia and Pacific, Kobe - 2012 decided to convene a Conference of Registrars of co-operative societies of the region in Malaysia in 2013 to deliberate on the making of by-laws by primary co-operative societies - viewed as a 'strategic issue' with the objective of making the process transparent and participatory with active participation of women and youth, and attaining financial sustainability while exploring new areas of co-operative businesses and that, we, the participants from sixteen countries deliberated on the legal, policy and management issues, taking note of the positions obtained from the region, and while reaffirming the autonomous and voluntary character of co-operatives and the co-operative principle of 'concern for the community', hereby resolve,

1. that ICA-Asia and Pacific members and representatives of Governments will work earnestly in close co-ordination to review the existing provisions in co-operative laws of their respective countries relating to the formulation of by-laws and make the process truly participatory;
2. to increase the participation of women and youth in the overall functioning of Co-operatives to ensure inclusive participation and social cohesion;
3. to incorporate systems and procedures in by-laws to ensure financial sustainability of co-operatives by introducing prudential norms of management designed to help the members to avoid risky ventures and to improve and diversify their businesses while achieving their social, cultural and economic well being in a manner consistent with the co-operative principles;
4. to recommend a facilitative role for the concerned co-operative apex organisation in providing expert advice in the preparation of by-laws and institutionalise such roles of the co-operative apex organisation by proposing suitable legal measures and further recommend a mechanism of organising national conferences to deliberate on legal, policy and management issues concerning the co-operatives in their respective countries to enable co-operatives to evolve towards a higher and sustainable growth path;
5. to encourage the formation of a parliamentarian network to support the efforts of the Registrars/Regulators in establishing a responsive legal and policy framework;
6. to consider the indicative by-laws presented in the Conference, an adaptive approach of making of by-laws which allows a responsive mechanism to meet local needs and situations to be adopted rather than the prevalent practice of 'adopting' model bylaws, to appropriately provide a practical, legal and functional framework for primary co-operatives;
7. to invite the ICA-Asia and Pacific to follow up the matter of reforming the process of making by-laws with members and respective regulatory authorities and report the progress achieved to the Regional Assembly from time to time; and
8. to consider the establishment of the Asia-Pacific Co-operative Registrars'/Registrars' Association and its secretariat.

## ICA-AP Business Office in Malaysia

The 10th ICA-AP Regional Assembly held on 29th November, 2012 in Kobe, Japan approved the opening of a Malaysia Business Office (MBO) in collaboration with member organisation, ANGKASA. To this end, Dr. Chan Ho Choi, Regional Director of ICA-AP and Dr. Mohd Ali Baharum, President of ANGKASA signed a Memorandum of Understanding (MOU) on 27th February, 2013 for establishing the office at ANGKASA premises.

The soft opening ceremony of the ICA-AP MBO was held on the afternoon of 28th August 2013 in the premises of ANGKASA. The opening address was by Dato' Hj. Abdul Fattah Hj. Abdullah, the newly elected President of ANGKASA, followed by Dr. Chan Ho Choi. Those present at the opening included, ICA-AP staff, the Deputy President, Vice Presidents and other officers of ANGKASA, representatives of two other ICA-AP members, ACFSMC, China and NACF, Korea and the staff seconded by these organisations to the MBO. A press conference was held after the opening. The MBO will plan and implement relevant activities to achieve following strategic objectives:

- To increase business interaction and exchange between/among consumer co-operatives, co-operative insurance and banking.

# Projects

*During the year, 22 activities were conducted under the 10 projects, covering 750 women and men co-operators from 18 countries. The projects covered all sectors of business in which our members are involved and included cross cutting themes such as gender mainstreaming and youth co-operation.*

## 1. Agriculture

The ICA-AP in collaboration with MAFF Japan, JA-Zenchu and IDACA implemented three major capacity building programs in which about 40 co-operative leaders/officials from 15 countries were trained.

- i. Two courses under the ICA Japan Training on, “Fostering Core Leadership of Agricultural Co-

operatives,” were held in February-March and October-November. The duration of each program is about 2 months; one month is spent at the Institute of Rural Management (IRMA), India where the participants attend training on co-operative management and the other month they move to Japan and attend training by Japanese agriculture co-operatives. The intake in each batch is 12 participants from 10 countries.

ii. Organising farmers and strengthening marketing activities of farmer's organisations is essential for ensuring sound development of agriculture and activation of rural economy. The ICA-Japan Training Course on, "Quality and Safety Management of Farm Products" was designed as a new training course from 2011 for a period of 3 years. The course is held once in a year and participants are invited from Cambodia, Lao, Myanmar and Vietnam (CLMV countries) and South Asian countries. The objective of the training course is to assist experts in the distribution field to play an important role in the

quality and safety management of farm products.

This program is held for 23 days in IDACA, Japan every year. This year, 12 participants from 6 countries attended the program held from 9th July to 1st August 2013.

iii. Training on "Agricultural Products Marketing and Logistics for Co-operatives" was held in Beijing

## 2. Consumer

The following activities were implemented for development of Consumer Co-operatives in the region.

- i. Workshop on Development of Consumer Co-operatives was held on 3rd April 2013 in Goa, India.

- ii. A 17 days training program on 'Management of Consumer Co-operatives' for managers of consumer co-operatives was held by ICA-AP in collaboration with JCCU from July 19 to August 4 2013 at Miyagi Co-operative in Japan.

- iii. The 13th Asia Pacific Regional Workshop on 'Management of Consumer Co-operatives' was held in Singapore from 3-5 July 2013.

The objectives of the workshop were to promote understanding of socio-economic role of consumer co-operatives, to study the successful cases of international and to establish an international network of consumer co-operative leaders and managers. □

### 3. Gender Mainstreaming

Women empowerment and gender mainstreaming for co-operative development are the core strategic areas for ICA-AP. A number of programs were implemented to achieve the goal of increasing women's participation at all levels of co-operative business management. The ICA-AP Committee on Women is quite active in planning and implementing its activities. The following activities were implemented during the year:

- i. Meeting of the Office Bearers of ICA-AP Committee on Women was held on 13th Feb 2013 in Saitama City in Japan.

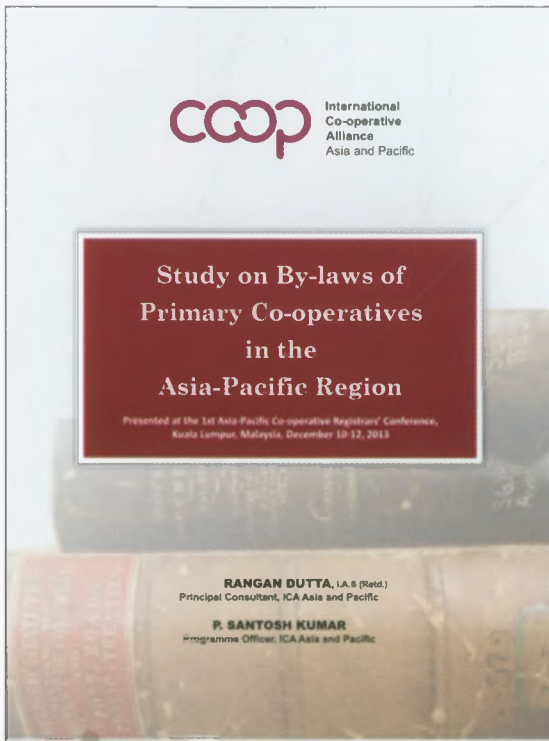

Leelavathi, Chairman, Department of Studies in Economics and Co-operation; Prof. Yashavantha Dongre, Professor of Commerce, University of Mysore and Prof. M. Indira, Coordinator, Third Sector Research Resource Centre, University of Mysore were the chief organisers and speakers who stressed upon the urgent

need to establish good study and research on co-operatives as the Asia-Pacific region lacks good research documents on co-operatives. The Conference was attended by officials from the State Co-operative Department, faculty from various departments of the University of Mysore, research scholars, students and paper presenters from various parts of India, South Asian countries, Japan and Malaysia.

During the two days Conference, three technical sessions with three parallel streams were held and attended by over 250 participants. The Conference ended with a Closing Plenary. Out of 52 abstracts received, 37 were selected based on blind reviews. 32 scholars attended and presented their papers in the parallel sessions. The papers were well-received and there was lively discussion.

# Highlights from the Region

## ICA President in India



*ICA President with President of NCUI and other co-operators in New Delhi*

In April, Dame Pauline Green, President of ICA visited India. This was her first visit to India since she took charge as President of ICA in November 2009. Dame Green visited the ICA-AP office in New Delhi to meet staff, paid a visit to Indian Farmers Fertiliser Co-operative Limited (IFFCO) and attended a meeting organised by National Co-operative Union of India (NCUI).

She put down succinctly her views on the role India could play as an emerging economy and the present and future potential of the co-operative movement in the country. According to her, "India is now getting used to being something other than just a 'developing' country, as its economy continues to grow at rates significantly

greater than those of mature Western economies — an average of 7.6% between 2002 and 2007 and of 8.2% for the four years 2007 to 2011. So what of its huge co-operative sector? The largest co-operative country by numbers of primary co-ops at just over 610,000, with 98% of Indian villages covered by co-operatives that are active in a vast range of economic activities, the Indian movement represents one quarter of the worlds one billion individual co-operative members! A three-day visit can only touch the surface of understanding just what that means for the future of co-operation in this vast, teeming, energetic and young country as it starts to lift itself into a better future. The ICA has had an Asia Pacific office in New Delhi now for over 50 years and this was the starting place for my visit. ...."

## New Zealand: New Trends Emerging

*Co-operative Business NZ* reported that while new co-ops are emerging, consolidation is taking place.

Two seemingly opposite trends are going on right now among New Zealand's co-operatives. While almost 30 groups are taking advantage of provisional membership of Co-operative Business New Zealand to help them get a new co-op off the ground, the members of large, well-established co-ops are voting to combine. In February 2013, members of the country's two largest farm supply coops voted in favour of merging. A merger of South Island co-op CRT and the North Island co-op Farmlands, with 54,000 members, more than 1,000 staff and 78 stores, the new Farmlands Co-operative Society will

have an annual revenue of more than NZ\$ 2 billion.

So as consolidation takes place among existing co-operatives, the number of coops in New Zealand is growing as more entrepreneurs become aware of what can be gained through joining together with others in a co-operative business that transacts with its members. The small number of co-operatives and mutual businesses in New Zealand are not insignificant: put together, their annual revenue is almost NZ\$ 40 billion. These two seemingly opposite moves are likely to result in a long-term increase in the contribution co-operatives make to the economy.

# ICA Co-operative Identity Statement

## DEFINITION

A Co-operative is an autonomous association of persons united voluntarily to meet their common economic, social and cultural needs and aspirations through a jointly-owned and democratically-controlled enterprise.

## VALUES

Co-operatives are based on the values of self-help, self-responsibility, democracy, equality, equity and solidarity. In the tradition of their founders, Co-operative members believe in the ethical values of honesty, openness, social responsibility and caring for others.

## PRINCIPLES

The Principles of Co-operation are guidelines by which Co-operatives put their values into practice.

**First Principle: Voluntary and Open Membership:** Co-operatives are voluntary organisations, open to all persons able to use their services and willing to accept the responsibilities of membership, without gender, social, racial, political or religious discrimination.

**Second Principle: Democratic Member Control:** Co-operatives are democratic organisations controlled by their members, who actively participate in setting their policies and making decisions. Men and women, serving as elected representatives, are accountable to the membership. In primary Co-operatives, members have equal voting rights [one member one vote], and Co-operatives at other levels are also organised in a democratic manner.

**Third Principle: Member Economic Participation:** Members contribute equitably to, and democratically control, the capital of their Co-operative. At least part of that capital is usually the common property of the Co-operative. Members usually receive limited compensation, if any, on capital subscribed as a condition of membership. Members allocate surpluses for any or all of the following purposes: developing their Co-operative, possibly by setting up reserves, part of which at least would be indivisible; benefiting members in proportion to their transactions with the Co-operative; and supporting other activities approved by the membership.

**Fourth Principle: Autonomy and Independence:** Co-operatives are autonomous, self-help organisations controlled by their members. If they enter into agreements with other organisations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control by their members and maintain their Co-operative autonomy.

**Fifth Principle: Education, Training and Information:** Co-operative provide education and training for their members, elected representatives, managers, and employees, so that they can contribute effectively to the development of their Co-operatives. They inform the general public – particularly young people and opinion leaders – about the nature and benefits of Co-operation.

**Sixth Principle: Co-operation among Co-operatives:** Co-operatives serve their members most effectively and strengthen the Co-operative Movement by working together through local, national, regional and international structures.

**Seventh Principle: Concern for the Community:** Co-operatives work for the sustainable development of their communities through policies approved by their members.







## Co-operative History The Rochdale Pioneers

Co-operatives started out as small grassroots organisations in Western Europe, North America and Japan in the middle of the last century, however, it is the Rochdale Pioneers that is regarded as the prototype of the modern co-operative society and the founders of the Co-operative Movement.

In 1844 a group of 28 artisans working in the cotton mills in the town of Rochdale, in the north of England established the first modern co-operative business, the Rochdale Equitable Pioneers Society (photo). The weavers faced miserable working conditions and low wages, and they could not afford the high prices of food and household goods. They decided that by pooling their scarce resources and working together they could access basic goods at a lower price. Initially, there were only four items for sale: flour, oatmeal, sugar and butter.

The Pioneers decided it was time shoppers were treated with honesty, openness and respect, that they should be able to share in the profits that their customer contributed to and that they should have a democratic right to have a say in the business. Every customer of the shop became a member and so had a true stake in the business. At first the co-op was open for only two nights a week, but within three months, business had grown so much that it was open five days a week.

The principles that underpinned their way of doing business are still accepted today as the foundations upon which all co-operatives operate. These principles have been revised and updated, but remain essentially the same as those practiced in 1844.

As stated in the MOU, the Business Office in Malaysia shall act as a regional hub for overall ICA establishment and will specifically implement the activities of ICA-Asia Pacific Region in promoting the business interactions among members through sectoral and thematic committees focusing on strategic areas such as Consumer Coops, Fair-trade, Insurance & Banking, IT Technology and Recycling of Renewable Resources.

For the operation of this ICA-AP Business Office, ANGKASA will provide 133 m2 of office space in the premises of it's Subsidiaries & Business Division opposite the main building. Mr. Shahrudin Bin Mohamed, Chief Development Officer expressed his interests in the development of cold-chain system in Malaysia and to promotion of the the 'ANGKASA Food' abroad. This business would get a boost with opening of the ICA-AP Business Office in Malaysia.

Dr. Choi extended his visit to the Malaysia Co-operative Commission and met Executive Chairman Datuk Nik Ali Bin Mat Yunus to discuss about organising of the 1st ICA-AP Co-operative Registrars' Conference in Kuala Lumpur in August this year.

## Study of By-Laws of Primary Co-operatives Commissioned

In order to promote the use of co-operative By-laws that reflect the participatory governance and financial sustainability, the ICA Asia Pacific has commissioned a study of By-Laws of Primary Co-operatives in the Asia Pacific region for the year 2013. This is viewed to uphold the interest of the primary co-operatives in their right to co-operate and operate autonomously to undertake functions of an ethical enterprise.

This study was commissioned as part of the ICA AP Strategic Objectives (S.O. 2013-2016) drawn at the 10th Regional Assembly that laid down the need for what is a ‘sound-tuning’ between co-operative laws and commercial laws and between co-operative laws and government policy provisions under S.O. 15 along with the study on countries’ By-Laws of primary co-operatives under S.O.09. The activity aims to draw a model By-Law with a view to ensure the financial sustainability of co-operatives and participatory governance and decision-making of members, and enhanced participation of women and youth by ensuring certain seats in their

Board structure.

The ultimate objective of this doctrinal activity would be to promote the adoption of co-operative By-laws through a ‘conscious participatory process’, the corner stone of participatory governance and Democracy. The activity is positioned to bring out a study covering the vast Asia Pacific region and will reach out to the primary level societies and unions with the help of its ICA members. The activity is an effort to scrutinize by-law making powers of primary societies from the angle of co-operative jurisprudence and the Rule making power of the Government and the powers exercisable upon these rules by Registrars/Regulators of co-operative societies that affect the functional autonomy and the financial sustainability of primary co-operatives.

The study shall include a draft-outline for a model By Law and promote the Guidelines that will be arrived at during the Registrars’/Regulators Conference.

## Enhancing the Role of Women in Co-operative Business

The ICA-Asia and Pacific Workshop on 'Enhancing the Role of Women in Agriculture Co-operative Business' was held from 17-19th December, 2012, Vientiane City, Lao PDR in collaboration with Ministry of Agriculture and Forestry, Government of Lao PDR. Six participants from four countries namely China, India, Indonesia and Malaysia attended the workshop along with participants from MAF, Lao.

The opening ceremony was held on 17th December, 2012 with Mr. Chantha Thippavongphanh, DG of DAF-VC of MAF delivering the welcome address.

Dr. Chan Ho Choi, Regional Director of ICA-AP delivered special address and inaugurated the workshop.

The business session started with introductory presentation on the topic of the workshop by host organisations, ICA-AP and MAF, Lao. Mrs. Savitri Singh initiated business proceedings by making a presentation on "Gender Integration and Situation of Women in Co-operatives in Asia –Pacific." Ms. Sisomphet Souvanthisith made presentation on the theme of the workshop "Enhancing Role of Women in Agriculture Co-operative Business in LAO PDR".

The participants from 4 countries made presentation of country reports and shared information with each other followed by discussions and question-answer sessions.

As part of the exposure visit to best practices, the participants visited to Lao Women Union, Organic Vegetable Production Group and Nikone Handicraft Centre.

The Lao Women's Union Gender Resource Information and Development Centre (GRID) made a detailed presentation of plans

and projects of the Union for empowerment of women in the country. Lao Women Union was established in 1955 and has status equivalent to the Ministry at the central level. The organisation structure is from centre to provinces and village level. Activities of GRID Centre are to provide Gender Training, conducting Research and maintaining a Library as study and information centre.

Organic Agricultural group in Vientiane Capital were established from year 2005 by PROFIL Project (Promotion of Organic Farming and Marketing in Laos PDR) of Department of Agriculture, Ministry of Agriculture and Forestry in cooperation with Department of Agriculture and Forestry of Vientiane Capital.

The Nikone Handicraft Centre is a business with difference where they employ women artisans for weaving and colouring etc. The centre provides flexible working hours and also women are free to work at home. We saw that women weavers could bring their small children at the centre and look after them while at work. It was felt that the centre should consider providing separate nursery for children.

## From The Region

### Japan: JCCU launches its first Fair Trade product

With new release of "CO-OP Charcoal Coffee Fair Trade Coffee Bag" using only fragrant and high quality coffee beans sourced from Brazil, JCCU launched its first certified Fair Trade Product on March 1, 2013. The basic aim of JCCU Fair trade coffee production is to contribute towards poverty alleviation and sustainable development. JCCU purposes to create opportunities for producers in developing countries who have been economically disadvantaged or marginalized by the conventional trading system. The product source is limited to Brazil because of its stable production volume, quality of the coffee beans, varieties as well as its low acidity. Overall, the flavour is sweet and soft. Development of this Fair-trade product is an effort to demonstrate co-ops social role and responsibility through its business as one of the aspiration of the "Co-ops Vision 2020" is to make co-operatives leader in economic, social and environmental sustainability.

JCCU continues to develop easy to use products for senior citizens.

Taking into consideration the feedback received from senior citizens that "although can food is convenient, the lid of the can is hard and it is difficult to open", JCCU has developed new tuna

flakes products packed in pouch bags which was released on March 1, 2013.

The product is of highest quality standard and flavour, pouch bags are easy to open and can be stored at room temperature for two years. It could be eaten after warming in hot water for about 3mins. By adopting plastic bag, opening is easy and can be stored in a refrigerator and having convenience of re-cycling.

## New Ordinance to Support Korean Co-operative Law

On February 6, Preparatory Committee for Seoul Co-operative Council held a press conference with PARK Yang-sook, a member of Seoul council, to propose ordinance for supporting co-operatives in Seoul. The committee consists of 14 co-operatives in various sectors such as consumer, finance, health care, worker and child care. Since Framework Law of Korean Co-operative took effect on December 1 last year for support of various co-operatives in new sectors besides traditional sectors such as agricultural and livestock. 93 out of 279 registrations of new co-operatives under the new law were accepted nation-wide while 28 cases in total 95 were approved

in Seoul.

To vitalize various co-operatives, the support of local government is crucial. It can be said that the ordinance embodies its efforts and the cooperation among co-operatives, Council and Government in Seoul has borne fruit. Through the ordinance and active support by local government and the public, cooperators hope that this is an opportunity for co-operatives as an alternative to tackle social polarization, enhance the economy of self-help and reciprocity, and achieve 'Seoul, Co-operative City', one of the aims of Seoul Metropolitan Government.

## KOREA: The Co-operative Counselling Center launched

On December 1, iCOOP Seoul Co-op, one of the primary co-ops of iCOOP KOREA launched "The Co-operative Counselling Center" to provide useful information for establishing and managing co-operatives.

2011 Framework Act on Co-operatives was enacted on December 29, 2011 and took effect on December 1 this year. Under the act, over 5 persons can organize a co-operative in various fields. To provide professional counselling service for those who want to establish their co-operatives, a total of 4 Co-operative Counselling

Centres started operating on November 1.

All centres are located in currently operative co-operatives which already have management education experiences, skills and know-how. Anyone can easily visit them to get information and counselling service from 9 am to 6 pm with no charge. The main counselling focuses are the Framework Act on Co-operatives, possible sectors for co-operatives, the differences between social enterprises and co-operatives, and proper operating, membership and governance system for co-operatives.

## NEW ZEALAND: Co-operative Business NZ'S Annual General Meeting

Around 40 people from 18 member businesses attended the Association's Annual General Meeting which took place in Christchurch on 30 November.

The meeting gave members an opportunity to reflect on achievements during the UN International Year of Co-operatives (IYC) and to look forward and discuss how they might change focus from leveraging the IYC to capitalising on the enhanced profile of co-operatives in general, the Association in particular, and education and advocacy work.

A new subscription table was approved which reduces the number of steps from 15 to 9, allows a brand new business to pay a reduced fee for their first year of membership and introduces a new category of membership- Corporate Associate Membership.

## INDIA: Making the Right to Form Co-operatives a Fundamental Right

National Conference on the Constitution (Ninety Seventh Amendment) Act, 2011 which has made the right to form co-operatives a fundamental right of the people was convened on 12th October, 2012 at NCUI. Dr. Charan Das Mahant, Hon'ble Minister of State for Agriculture & Food Processing Industries, Govt. of India inaugurated the Conference. In the inaugural speech the Hon'ble Minister emphasized the importance of Amendment of the

Constitution and contained measures to strengthen the co-operative sector in India which has emerged as a unique institution to serve economically weaker sections of people with wide reach. The objectives of the Constitutional Amendment are to ensure that the co-operative societies in the country function in a democratic, professional, autonomous and economically sound manner.

The Hon'ble Minister informed that he had already written to the



Chief Ministers/Lt. Governors of the States/Union Territories (UTs) to amend State laws in tune with Constitutional Amendment within the stipulated time.

## ICA President in India

This was the first visit of the ICA President Dame Pauline Green to India after she was elected the President of ICA in November 2009.

She visited the ICA-AP office in New Delhi and met with staff and also paid a visit to Indian Farmers Fertiliser Co-operative Limited (IFFCO) and National Co-operative Union of India (NCUI). She had put down succinctly her views on the role India could play as an emerging economy and the present and future potential of the co-operative movement in the country. This is reproduced below:

"India is now getting used to being something other than just a 'developing' country, as its economy continues to grow at rates significantly greater than those of the mature Western economies — an average of 7.6% between 2002 and 2007 and of 8.2% for the four years 2007 to 2011.

So what of its huge co-operative sector?

The largest co-operative country by numbers of primary co-ops at just over 610,000 with 98% of Indian villages covered by co-operatives that are active in a vast range of economic activities, the Indian movement represents one quarter of the worlds one billion individual co-operative members!

A three-day visit can only touch the surface of understanding just what that means for the future of co-operation in this vast, teeming, energetic and young country as it starts to lift itself into a better future.

The ICA has had an Asia Pacific office in New Delhi now for over 50 years and this was the starting place for my visit. Its key aim was to recognise the growing influence of the Indian political and

economic leadership in the global economy, and the role of the leadership of the Indian co-operative movement in helping to develop its representative role, not just its traditional work on behalf of Indian co-operatives, but more particularly now on global issues as well.

The office visit was also a rare and valuable opportunity to meet with the staff of the New Delhi office, and I was able to see the way in which a significant tranche of the historical archive of the ICA (recently transferred from Geneva) is now housed and being catalogued in the library facility. Ultimately, the catalogue will be made available for worldwide researchers, whilst we continue to find ways to digitize as much as possible.

The Indian Farmers Fertiliser Co-operative (IFFCO) has been a strong supporter of the

work of the ICA and the international movement particularly during the last decade. Started in 1967 with 59 co-operative members, IFFCO now has nearly 40,000 primary co-ops grouping 55 million farmer members, and a turnover in 2011-12 of over USD 4.5 billion. The largest fertiliser production business in India by far, it now has five major manufacturing units in India, and significant investment in fertiliser production in Dubai, Oman, Jordan, Senegal and recently Peru and Canada.

Is this just big business? Not a bit of it.

What really encouraged me was the detailed, planned and utter focus of management and staff on trying to take a business with a traditional heavy energy and waste water discharge, and take down those levels year on year, and at the same

time encourage the use of non chemical fertiliser amongst its farmer membership through its 'Save Our Soil' campaign. Whilst that campaign started relatively recently, at a meeting I attended of a primary co-op in the village of Isanpur Mota in Gujarat, it is clear that the farmers had a very good understanding of the issues, and their need to protect their soil. Whatsmore, they were using their collective initiative to go further and develop a bio-digester and other organic fertiliser alternatives themselves, and by the way, the Chairman of the co-op showed me round the soon to be finished building that will become a shopping unit to bring consumer goods to the village. This is grass roots co-operation at its best and I was inspired.

One of the most powerful moments was to visit the IFFCO township. I was struck by the strong resonance with the work of social reformer Robert Owen's New Lanark, as I saw the homes built to house the workers at the original manufacturing plant in Kalol, Gujarat, some four kilometres away. Incidentally, those workers of the enlarged workforce not now able to be housed by IFFCO are given a 25% (of salary) housing allowance to find suitable local housing. The township had a shopping mall, a four bed hospital unit with doctors and nurses in attendance each day, a school, multiple play and recreation areas, a post office and bank, a small Hindu temple for worshippers, and a small facility where retired family members of workers could meet to avoid loneliness and alienation. The three gentlemen present when I visited told me that the Managing Director of the site visited them about once a fortnight to chat and see how they were.

So was this a one off, built when the co-operative was new in the 1970s and started as some idealistic dream?

No, the same provisions have been provided at all five

manufacturing units — just as every floor of the head office in New Delhi has exercise bicycles somewhere along the corridor! When you travel the streets of India and see the levels of housing deprivation, poverty and need that still waits to be tackled, it is very easy to see how unusual IFFCO is and why people are so loyal and keen to do a very good job.

The last day in New Delhi was a public holiday, but despite that, the long-standing national member of the ICA in India, the National Co-operative Union of India (NCUI) brought together about 70 people including many of its governing council and the leaders of many of its state co-operative federations and business sectors to talk to me and the Additional Secretary for Agriculture and Co-operatives from the Indian Government Mr Dilip Singh.

The NCUI has a major education and training arm and provides key traditional trade association services to this huge movement, and produced the excellent 'Indian Co-operative Movement A Statistical Profile' from which some of the statistics in this short article were taken. It was a unique opportunity to spend a couple of hours listening to just what they do and what their concerns are. What was very clear is that they know that they have some great challenges and some huge opportunities in the coming decades. They worry about the relationship with government, about some poor governance, a growing lack of knowledge about the value of co-operatives, the need for more co-op to co-op business, whether they can fund development — all this sounds very familiar? They can take heart that these are the worldwide issues that dominate the co-operative movement and that led us to come together in 2012, the International Year of Co-operatives, and develop the Blueprint for a Co-operative Decade.

Am I confident that the Indian co-operative movement will continue



to flourish in the new economic order? Yes, but there are some fundamental concepts that will make it much less painful as the need to embrace change becomes more evident — the most crucial is that they work together. This was also one of the challenges that they raised with me. The NCUI has just negotiated a ground-breaking amendment in the Indian Constitution to enshrine the right to form a co-operative as a fundamental right of Indian citizens. If they are to

make the most of this great opportunity, then confronting the competing interests of the sovereignty of an individual co-operative enterprise, with the need to lift their collective eyes to the big picture in a maturing domestic economy in a global market, will become paramount. I have every confidence that they will do so".

Her observations were well received.

## ICA-AP Regional Board Meeting

First meeting of the reconstructed ICA-AP Regional Board was held in Haikou (China) on 15th March 2013 hosted by All China Federation of Supply and Marketing Co-operatives (ACFSMC). The meeting was chaired by Mr. Li Chunsheng, ICA-AP President and Chairman of the Regional Board. 24 persons including members, observers and interpreters were present.

Dr. Chan Ho Choi, Regional Director informed the meeting about his visit to Malaysia and signing of the Memorandum of Understanding (MOU) with ANGKASA on 21st February 2013 regarding opening of the Business Office, secondment of the staff and other logistics for smooth functioning of the office.

Dr. Choi also presented the draft subscription details of ICA-AP members for the 2nd phase (2013-2016). He said that the Invoices have been sent by ICA Geneva based on number of individual members and World Bank Country Income Index (WBCII). Prior to 2009, the subscription was based on business turnover which was more reasonable. For six countries in our region (China, India, Iran,

Pakistan, Thailand and Vietnam) the WBCII has gone up. Accordingly, the total subscription from our region has increased by 30 per cent which was very high.

The agenda for appointment of one trustee to ICA Domus Trust came up for discussion and Dr. Choi suggested that since it was an honorary post and involves additional time and funds, it could be better if a global board member from our region was nominated as trustee in his place.

Mr. Li Chunsheng asked the members to be a trustee of the Domus Trust voluntarily. Since nobody came forward, the meeting authorized the Chairman and two Vice Chairmen to discuss this issue further and nominate a person as trustee to the ICA Domus Trust.

The next board meeting will be held in Cape Town (South Africa) in the afternoon of 1st November 2013 in conjunction with the ICA General Assembly.



## Capacity Building

### Fostering Core Leaders of Agricultural Co-operatives

2nd Training course on “Fostering Core Leaders of Agricultural Co-operatives-2012” was organized by ICA-AP in India and Japan between 17th February and 12th April 2013. The overall objective of the training program was to assist fostering of the core leaders, who are expected to play the leading roles in agricultural co-operatives and farmers’ groups that will contribute to the improvement of agricultural production and income of the farmers in the LDCs of Mekong River countries and South Asian Countries. The training program was implemented by ICA-AP in collaboration with Institute of Rural Management, Anand India, Institute for the Development of Agriculture Cooperation in Asia (IDACA), Japan and ICA’s member-organizations in India and Japan.

The program was inaugurated by Mr. Hitesh Bhatt, MDP Coordinator of IRMA on 20th February 2013. 13 participants from

10 countries – Bangladesh, Bhutan, Cambodia, Lao PDR, India, Maldives, Myanmar, Nepal, Sri Lanka and Vietnam attended the training. After completing the IRMA Module in India, the participants moved to IDACA and attended the Japan segment of the training.

At the concluding session, Mr. Masahito IWAHANA, Deputy Director of International Cooperation Division, MAFF, Dr. Chan Ho Choi, Regional Director, ICA-AP, Mr. Hiraoka Keiji, E.D. IDACA & Mr. A.K. Taneja, Project Coordinator, ICA-AP, addressed the participants. Ms. Dhiyana Fathimath, a participant from Maldives, presented a vote of thanks on behalf of all the participants.

The Certificates of Participation were awarded to the participants at the concluding session.

### Workshop on Development of Consumer Co-operatives

ICA/NCCF Workshop on Development of Consumer Co-operatives was held on 3rd April 2013 in Goa, India hosted by National Co-operative Consumers’ Federation of India Ltd.

ICA Committee on Consumer Co-operation for Asia and the Pacific decided to start a Sub-Regional Workshop on Development of Consumer Co-operatives in 2009.

The Workshop is held every year by turns in India and Sri Lanka. It was the second time to hold the Sub-Regional Workshop in India. 50 delegates from consumer co-operative movement in India, Japan and Vietnam attended the Workshop.

The objectives of the Workshop were to promote understanding of

co-operative principles, strengthen management of consumer co-operative societies, understand the present status and problem areas of consumer co-operatives and strengthen relationship with local government.

Mr. P. M. Dhavlikar, the Honorable Minister for Cooperation Government of Goa, Mr. Virendra Singh, Chairman of the National Co-operative Consumers’ Federation of India Ltd, Mr. Haruyoshi Amano, Chairman of the ICA Committee on Consumer Cooperation for Asia and the Pacific, Dr. Chan Ho Choi, Regional Director of ICA Asia and the Pacific addressed the delegates during opening ceremony. On the second day the participants visited Bardez Bazaar Consumers Co-op Society, Baigaitdar Consumer Co-op Goa and Goa Co-op Marketing and Supply Federation.

## Resource Guide for Advanced Training of Co-operatives

The Pilot testing of the ICA-AP “Resource Guide for Advanced Training of Co-operatives on Entrepreneurship Development of Women and Gender Equality” was held from 27 April to 1st May 2013 at Vakunth Mehta National Institute for Co-operative Management in Pune, India hosted by the National Co-operative Union of India.

Women empowerment and gender mainstreaming in co-operatives is one of the priority areas of ICA and we are very much concerned about low and negligible participation of women at all levels of co-operatives in the region. Therefore, Training of Trainers program was being organized based on “Leadership Training Manual for Women Leaders of Co-operatives” jointly produced by ICA-AP and ILO-COOPNET.

In the present manual there is only one module which talks about co-operative enterprise management which is not adequate for meeting the requirement of the present day participants in coops who face more technical challenges in day to day operations of a coop. The focus is gradually shifting towards competence than the gender, the glass ceilings exists though.

Therefore, ICA-AP has commissioned developing of a resource

guide which is aimed at taking care of the requirement of the co-operators. First draft of the Resource Guide is ready and needs to be tested in a training class of co-operative trainers.

The pilot testing of the draft resource guide was held with the trainers and resource persons of the co-operative movement of India and hoped to generate valuable response which will enrich the document further and will be use full for the co-operators in the region. The consultant documented the responses on and gaps in the recourse guide and will revise the document with the inputs received during the testing.

The objectives of the program are :

1. To test the content and format of the resource guide
2. To get feedback from Trainers on the resource guide for improvement

The following topics were addressed during the programme:

**Chapter 1 :** Statement on the Co-operative Identity (SCI) vis-à-vis market economy perspective

**Chapter 2 :** Cooperative Governance Chapter

**Chapter 3 :** Cooperative Enterprise and Management

*Message from Dame Pauline Green, President of the International Co-operative Alliance*

Over the last four decades, the position of women has made some progress, however, it is still too little and too long in coming. Let us encourage our daughters, and granddaughters. Let us insist that today’s world demands equality for each individual whether man or woman.

Today the world faces unparalleled challenges. What we know today is that the traditional approaches to governing society, managing businesses, financing public services, handling conflict and war are simply no longer relevant.

Having more women in key decision-making places in political, economic and social decision-making at all levels in society is the way to move away from the sort of decision-making that has served us so poorly in recent years.

Today we want a different approach – one that values each individual and the contribution they can make to building a better world.

We can no longer put up with a world where it is acceptable to shoot a girl child for wanting to go to school, or to disregard the crime of rape against a woman who just happens to be in the wrong place at the wrong time. We thought the campaign for equality was about low pay, discrimination, humiliation or glass ceilings in the work place, or by hunger and poverty. But its more, all too often it is a classic case of oppression and repression. Building a better world is about allowing each person to flourish and fulfil their potential – nothing else will do.

We want to prioritise policies for people; one that values businesses that have people at the heart of economic decision making and not profit; one that believes that money is better spent on creating a fairer, more just legal and social environment rather than funding political despots or trading in conflict.

Co-operative businesses have done so much to help women onto the ladder of economic activity. With that comes community respect, political legitimacy and influence. So far it has come too slowly. It is time for us to show that our co-operative movement can be a movement for the economic, social and political emancipation of all women. This is the real co-operative message of International Women’s Day.

## Fisheries Sector: TMC Meeting

The 10th National Technical Monitoring Committee (TMC) review meeting on strengthening of database and geographical information system (Central Sector Scheme) for fisheries sector development was held under the chairpersonship of Shri V. K. Bhatia, Director, IASRI, New Delhi on 29th January, 2013 at Bhubaneswar, Orissa.

The review was chaired by key Government of India functionaries, Shri O.P. Mishra, Deputy Director General (Fy.), Ministry of Agriculture, Govt. of India, Sri B.K. Mishra, Managing Director of FISHCOPFED and Sri K. Vijay Kumaran, Director General, Fishery Survey of India.

## NEW ZEALAND

While new co-ops are emerging, consolidation is taking place at the same time.

Two seemingly opposite trends are going on right now among New Zealand's co-operatives. While almost 30 groups are taking advantage of provisional membership of Co-operative Business New Zealand to help them get a new co-op off the ground, the members of large, well-established co-ops are voting to combine.

In February, members of the country's two largest farm supply co-ops voted in favour of merging. A merger of South Island co-op CRT and the North Island co-op Farmlands, with 54,000 members, more than 1,000 staff and 78 stores, the new Farmlands Co-operative Society will have an annual revenue of more than NZ\$2 billion.

The grocers who own Pak'nSave, New World and Four Square stores are members of one of the three co-operatives that cover the length of New Zealand: Foodstuffs Auckland, Foodstuffs Wellington and Foodstuffs South Island.

If the much discussed merger of Foodstuffs Auckland and

The Technical Session comprised of presentation by CIFRI, Barrackpur on Inland catch assessment and other related components while fishery survey of India presented on marine catch assessment. Directorate of Fisheries, Govt. of West Bengal submitted presentation on pilot project of Geographical Information System and presentation on marine fishery resource was made by CMFRI, Cochin.

The programme was attended by more than 80 delegates from across the country and was first of its kind, to be conducted in the state of Orissa.

Foodstuffs Wellington Co-operative Society goes ahead, the new co-op – likely to be known as Foodstuffs North Island – will have an annual revenue of more than NZ\$6 billion, making it New Zealand's third largest business.

Back in the rural sector, two grower-owned kiwifruit and avocado packhouse co-operatives, Te Puke-based Satara and Edgcombe-based Eastpack, announced that they will be merging after a member vote supported merger by a large margin.

So as consolidation takes place among existing co-operatives, the number of co-ops in New Zealand is growing as more entrepreneurs become aware of what can be gained through joining together with others in a cooperative business that transacts with its members.

The small number of co-operative and mutual businesses in New Zealand are not insignificant: put together, their annual revenue is almost NZ\$40 billion. These two seemingly opposite moves are likely to result in a long-term increase in the contribution co-operatives make to the economy.

The annual Co-operative Business Education Seminar will be taking place in Wellington, New Zealand, on 17 and 18 September, 2013. The focus will be:

Adapting to the Demands of Modern Business – Leading Change in a Cooperative

The seminar is expected to attract senior managers and board members of co-operatives and mutuals from New Zealand and Australia, as well as those wanting to start a co-operative.

## President of India inaugurates 16th Indian Co-operative Congress

The National Co-operative Union of India organized its 16th Indian Co-operative Congress on 25-26 June 2013 in New Delhi. The Congress was inaugurated by Honorable President of India, Shri Pranab Mukherjee. Shri Sharad Pawar, Hon'ble Union Agriculture Minister of India, several very important political leaders such as Chief Minister and Governors of States, Ms. Dame Pauline Green, President, International Co-operative Alliance (ICA), Mr. Li Chunsheng, President, ICA-Asia Pacific were present at the ceremony.

About two thousand national co-operators, leaders, government officials along with about forty foreign delegates attended the two days long deliberations.

In solidarity with the slogan of IYC-2012, the theme of the congress was set as "Co-operative Enterprise Build a Better World".

The Co-operative Congress is a very significant event of the Co-operative movement of India which is held in every three years. This

event is an important platform for lobbying, advocacy and capacity building wherein the leaders and co-operators come together to discuss relevant issues concerning various aspects of co-operatives in the country and making recommendations to impress upon the government and other stakeholders for creating enabling environment for sustainability and development.

Shri Pranab Mukherjee, Hon'ble President of India expressed his pleasure in inaugurating the great event of national importance and mentioned the importance of co-operation as a philosophy being followed in all walks of life. To him, co-operatives have a great potential which needs to be harnessed for the development of the society. He recalled the thoughts of Mahatma Gandhi on cooperation and referred the Directives Principles of the Indian Constitution and considered co-operatives as a tool for economic growth. community life. He expressed his belief in the strength of co-operatives in facing global crisis. Though co-operatives have limitation, he reiterated his conviction over the strength of co-operatives in finding solutions and hoped that co-operatives can enter into new areas such as education, health, precision farming etc. He viewed that co-operatives need a bottom up approach wherein it can work as an organization of the people, by the people, among the people and achieve qualitative development along with the quantitative achievements and concluded by hoping that this congress will deliberate on strategies for developing an equitable world through co-operatives.

Dr. Chandrapal Singh Yadav, President NCUI delivered welcome address and congratulated Agriculture Minister for passing of historical Constitutional Amendment Bill 2011 in the Parliament making "formation of co-operatives" a fundamental right of the citizens. He also mentioned about the merits of co-operatives and touched upon core issues which needs attention of the government such as Director Tax Code and its implication on the economic viability of co-operatives, inclusion of a separate chapter on co-operatives in 12th Five Year Plan draft and inclusion of subject on co-operatives in the school syllabus.

Dame Paulin Green, President, ICA said that "India as cooperatively developed country could widen its coverage to all the villages, towns and cities. Their are good stories to tell in the co-operative sector and India should develop global brands too". She also shared her experiences of visiting IFFCO which is serving the rural people.

In her speech, she congratulated President of India for making formation of co-operatives a Fundamental Right through 97th Constitution Amendment and stressed upon the need for helping the co-operatives by recognizing their significance as well as channelizing the funds to this movement.

She concluded the speech by positively hoping for building a better world through co-operatives.

Shri Sharad Pawar, Hon'ble Minister of Agriculture & Food Processing industries said that he came from the field of co-operatives and understands the role played by the co-operatives in various spheres like rural credit, supply of inputs storage, marketing, consumer, sugar and other areas and financial inclusion is the mantra to achieve inclusive growth. He said that the Government of India, in its endeavor to provide enabling policy & legal framework for co-operatives, brought out important milestone in amending the constitution of India, Multi-State Co-operative Societies Act and the implementation of Short Term Co-operative Credit Structure Reforms & Revival Package. He also mentioned the contribution of co-operatives in ensuring achievements of target in food production and the greater role played in implementing the food security bill.

The Minister concluded by saying that co-operative is the potential tool for the sustainable development of its members, stakeholders and women.

### Opening of ICA-AP Business Office in Malaysia

Dr. Chan Ho Choi along with Mr. K Sethu Madhavan, Manager (P&M) visited ANGKASA in Malaysia to review progress of establishment of the ICA-AP Business Office in Malaysia with Prof Dato Dr. Mohd Ali Baharum, President of ANGKASA, Dr. Baharum organized a formal meeting on 15th May, 2013 wherein 4 Vice Presidents of ANGKASA along with several Sr. Officers were present for discussion.

He extended a warm welcome to all and informed that the office space identified earlier for ICA-AP Malaysian Business Office has been taken over by MyANGKASA Holdings for its expansion and ANGKASA has identified two sites for ICA-AP which they have already visited in the morning.

Dr. Choi said that ICA-AP would like to locate its Business Office closer to the MyANGKASA Holdings and preferred the 1st floor of A-307, Glomac Business Centre. Dr. Baharum informed that the paper work of this office would take 2-3 months to complete and it will be ready by August and renovation work could also be done

simultaneously.

Dr. Choi said that the office will be registered as ICA-AP Representative Office in Malaysia. In short it would be called as Malaysian Business Office (MBO). The registration of the office is very important and it should be attended to immediately. In order to avoid any laps, ANGKASA being the local organisation may help in completion of Registration formality. Dr. Baharum informed that Dr. Mohamed Shafari Yaakub of MyANGKASA Holdings will be responsible for registration of ICA-AP Malaysian Business Office and facilitation of long-term visa for expatriate staff.

Dr. Choi also talked about opening of a office bank account in Malaysia as soon as possible and this year's contribution of USD 20,000 from ANGKASA would be used for setting up the Malaysian Business Office and further discussed about work allocation of the staff to be seconded from ANGKASA and joining of other staffs from 3 other countries. Since 2 staff would join office in June and July respectively and the office would not be ready by that time, ANGKASA may provide two working desks for them.

After the meeting in ANGKASA, Dr. Choi met Datin Hajah Zuraidah Binti Hasni, Director, Extension and Promotion Division, Co-operative Societies Commission of Malaysia in her office on 16th May and discussed the proposal of organising the 1st ICA-AP Regional Conference of Registrars of Co-operatives in Malaysia in August. The Director informed that she will convey the decision of the commission in due course.

## Capacity Building

### Enhancing the Role of Women in Co-operative Business

In our endeavour to reach out to all the members and provide services, the first ICA program was held in the country ever since the Mongolian Co-operatives became member from the region.

ICA-AP Regional Workshop on "Enhancing the Role of Women in Co-operative Business" for women and men co-operative leaders of our region was held from 4-6 June, 2013 in Mangolia in collaboration with Mongolian Co-operative Alliance (MNCA).

The three days programme consisted of one day workshop followed by two days study visits to few successful co-operative businesses/women groups in the country. The consultations during the workshop focused upon co-operative endeavour to promote women's interests for gender mainstreaming in co-operatives. The program objectives were to:

- Provide a platform to co-operators of different countries for networking and experience sharing which may lead to mutual business opportunity.

- To have an exposure of gender focused best co-operative practices in Mongolia.
- The co-operative members of Mongolia will be having an opportunity to interact with foreign co-operators and learn from their experience.

Twelve co-operative leaders / managers from ICA member co-operatives from six countries namely China, India, Indonesia, Philippines, Nepal and twenty one from the host country Mongolia attended the program.

Mr. Enkhbold N, Chairman of the MNCA and Member of Parliament, Ms. Gantsetseg B, State Secretary Ministry of Labour, Ms. Bat-Amgalan B, Head of SME Development Department, Ministry of Labour and a group of Members of Parliament attended the opening and delivered opening and special address respectively.

Dr. Chan Ho CHOI, Regional Director addressed the participants and Ms. Savitri Singh, Advisor-Gender Programme & Communication of ICA-AP delivered introductory address at the opening ceremony. The MNCA presented status paper and discussed certain co-operative stories. Ms. Savitri Singh made presentation on ICA initiatives for women empowerment and gender mainstreaming in co-operatives and also introduced the "ICA-AP Committee on Women". The foreign participants also made presentation to share information about status of women and gender integration in their country and coop stories followed by question –answers and discussion. Next day the foreign and local participants made a study tour to Bornuur bor tolgoi co-operative, an agriculture co-operative located 100 km north of the Ulaanbaatar city.

The program was widely covered by the Mongolian national print and television media.

Since 1990, started development of 'market driven' co-operatives and there are about 1900 co-operatives by the end of 2008 with 2125 thousand members. In terms of co-operative operation fields, about 26% of total co-operatives are in agriculture sector, 25% in consumer service and wholesale trade, 25% in manufacturing, 10% in financial sector and rest of co-operative operations belong to social service, education and health service etc. The annual total income of all co-operatives is approximately USD18 million and there are 59 thousand employees in co-operatives. By the end of 2012, there are over 3000 co-operatives. (source: MNCA, Mongolia).

One of the successful agriculture co-operatives we visited is the Bornuur bor tolgoi co-operative. It was established in 2012 with ten

members and now it has total 396 members out of which 190 are women and 150 men. Source of the livelihood of most of the members are herding (80%) and live stock. The co-operative is helping members in developing their business by providing soft credit, skill development training and also making available fodder and other utility items during winter. The business of members from herding community is unpredictable. The members own hundreds of cattle, sheep, goats, yak and cows. To provide covered shelter to such large herd is unaffordable and they remain in open during harsh winters and snow fall. Many of them die due to harsh weather conditions and the member loses the source of livelihood. Sometimes the whole herd perishes overnight. The role of co-operatives becomes crucial under such trying circumstances. Since terrain is unapproachable and members travel far off places with herd in search of fodder, the co-operative dispatches food,

medicines, fodder and other consumables through horse riders to members in need.

Most of the members are active and participate in co-operative activities but attendance in meetings are normally short as members

are generally travelling with herd to far off places. However, co-oparive has introduced motivational schemes for attracting members to attend meetings and participate in activities. There are many households in the area who need to be convinced to join the co-

- (c) To promote technical exchange and assistance in IT technology through workshops and trainings.
- (d) To transfer the technical and managerial know-how, especially in the field of 'resource recycling' and 'renewable energy' business.

Dr. Mohamed Shafari Yaakub, Mr. Ge Shuyuan and Mr. Seung-Min Lee seconded by ANGKASA, Malaysia, ACFSMC, China and NACF-Korea respectively have already joined the MBO.

### Training on Quality and Safety of Farm Produce

Organizing farmers and strengthening marketing activities of farmer's organisations is essential for ensuring sound development of agriculture and activation of rural economy in the Asia-Pacific region.

Therefore, ICA-Japan Training Course on "Quality and Safety Management of Farm Products" has been designed as a new training course commencing from year 2011-2013, and is being implemented by ICA, based on an

agreement among ICA, Central Union of Agricultural Co-operatives of Japan (JA ZENCHU), Institute for the Development of Agricultural Co-operation in Asia (IDACA) and Ministry of Agriculture, Forestry and Fisheries (MAFF) of Japan.

The training is being held once in a year with the objective to assist fostering of experts in distribution field who play vital role in the quality and safety management of farm products of agricultural cooperatives or farmers'

groups in order to increase their income through enhanced production of good quality and safe agricultural produces in the LDCs of Mekong River countries and the South Asian countries.

The 3rd course, coordinated by Ms. Savitri Singh of ICA-AP and Mr. Yukio Abe of IDACA was held on 9th July to 2nd August, 2013 in Japan and nine participants from six countries attended the program. Besides the classrooms lectures, the participants also went on a week long study visit to Hyogo Prefecture where they have been received by the cooperative and government officials.

An introductory meeting was held wherein Mr. Tsuneo-Miura, Director General of the Agriculture, Forestry and Fisheries Bureau of Hyogo Prefecture interacted with participants along with other senior officials. Mr. Miura in his speech introduced the features of the prefecture along with agriculture system. He said that "Japan consists of 47 prefectures, and Hyogo Prefecture is located in the middle of Japan, consisting of

Since 1992, we proposed a concept "Environment friendly agriculture" and promote using environment friendly technologies without chemical fertilizers and pesticides as far as possible. In 2009, we renewed "The promotion plan of environment friendly agriculture" and this concept is the base for our agricultural production. At present, in the case of rice production, for example, this technology is introduced in 21,495ha, some 60% of rice cultivation. We have founded a system "Hyogo certified foods" verifying and confirming safe and secure, individual and characteristic features. By using this system, we make an effort to secure great trust in safety and security of Hyogo products. The share of Hyogo certified foods, vegetables and fruits in the market in our prefecture tend to increase, reaching some 30%. In addition, we require to cope with challenges of globalization of world economy and trade liberalization. We need to implement our agricultural policies actively taking advantage of our strong points such as location near cosmopolitan city and our branded products.

various geographical areas from cosmopolitan cities and rural agricultural towns to isolated islands. That's why it is also known as "Japan in a miniature" and by visiting few places you can almost understand all about Japan. Agriculture is prosperous taking advantage of various natural resources, climate and culture and also location close to a cosmopolitan city. There are many products ranking in upper phase in Japan based on shipment amount such as brewer's rice named "YAMADA-NISHIKI" and world's biggest soybean "TAMBA-GURO" as number 1 in Japan. Furthermore, we have onion, fig and carnation. You must know "KOBE BEEF," most delicious beef in the world. But the degree of Japanese food self-sufficiency is only 39% on the calorie base and depends on specific foreign countries for most of our food. We must increase our agricultural productivity but now faced with the problem of aging farmers and an increase of fallow land. So it is important to increase number of farmers and fostering farm managers, especially young farmers, is a significant and urgent issue for us along with ensuring quality of products.

Other officers talked about various subjects such as outline of agricultural policies, system of safety and security of food production and agricultural cooperatives. In addition, participants visited KOBE Consumer's Cooperative which promotes supply of safe and secure food to consumers working jointly with agriculture cooperatives and TAJIMA agricultural cooperative which has implemented production of secure and safe foods.

A formal closing ceremony was held in IDACA to conclude the program and to award certificate of participation. Mr. Iwahana Masahiro, Deputy Director of International Cooperation Division, MAFF, Government of Japan, Mr. Hiraoka Keiji, Executive Director of IDACA and Ms. Savitri Singh, Advisor and Coordinator of the program from ICA-AP addressed the participants at the closing. The officials appreciated efforts of the participants and hoped that they will be able to use their learning back home in introducing a system for improvement of quality and safety of farm products in turn enhancing capacity of farmers to increase their income.



## University/ Campus Cooperative Committee Workshop and Meeting

The ICA-AP Committee on University/ Campus Cooperative held its meeting followed by a Workshop held on the theme – 'Better Campus Life, Better Society by Cooperation' in Seoul, Korea on 4th-7th July 2013 hosted by the Korean University Cooperative Federation (KUCF). Dr. Choi, Regional Director made a presentation on the topic – 'University Campus Cooperatives in the Contemporary Society'.

The three days workshop was attended by fairly large number of 102 participants from 9 countries namely Korea (45), Japan (27), Indonesia (8), Thailand (6), Philippines (5), India (3), Malaysia (1), Singapore (1) and Sri Lanka (4), among them were 70 students from their respective universities as member of campus cooperatives.

The participants of the workshop were enthusiastic and dynamic discussions

took place as the program was organized and conducted by the student themselves and the workshop moved venues to three universities in Seoul – Kyung Hee University, Kook Min University, and Dong Guk University. Field trips were arranged to see the Kook Min University Coop and last day of the Exhibition of Seoul City Social Cooperatives on 7th July which was held in commemoration of the International Cooperative Day-2013 in Seoul.

The Committee meeting, chaired by Prof. Kokichi Shoji (NFUCI), was productive and remarkable as the discussions concluded with an important recommendation to adopt student members as the ICA-AP Committee member. This innovative idea was proposed by Prof. Sang-Jin Park, President of KUCF in his opening

remarks. He suggested that every country/ organization would nominate one student, besides their professor or president, as Committee member in constituting the University/ Campus Cooperative Committee of the ICA Asia-Pacific. Accordingly, meeting revised the new Constitution which was adopted in November last year in Kyoto to change the clauses on 'Membership' and 'Officers'. The meeting also adopted, so-called 'Seoul Resolution' of the Asia-Pacific Committee on University/Campus Co-operatives.

Dr. Dinesh and Prof. Dongre from India, Prof. Zenaïda Diola from Philippines, Ms. Emily Cheyenne from Singapore, Mr. J. Apichainunt from Thailand participated as Member, and Mr. Pathirana from COOPFED, Sri Lanka attended as an observer.

## Youth meeting: Co-operatives achieve greater happiness than other forms of enterprise

The ICA AP Committee on Youth Co-operation (ICYC) has successfully completed its Sixth Meeting that was convened in Buldana, India on 19th July 2013 and has formally adopted its Constitution. It was attended by fourteen members hailing from twelve countries from the Asia Pacific region representing

ICA membership across various sectors such as banking, fisheries, consumer, housing, education & training along with national apex co-operative organisations. The meeting also elected the new ICYC Office Bearers that shall serve until the ICA AP Regional Assembly-2016 with Dr.

Sukesh Zamwar, India as the Chairperson, Mr. Ahsan Ali Thakur, Pakistan and Mr. Udaya Prabhat, Sri Lanka as Vice Chairpersons and Mr. P. Santosh Kumar of ICA AP continues as Secretary.

The meeting was held along with the Asia Pacific Co-operative Youth Forum

on the them “Challenges for Youth as a Strategic Group in Development of Co-operatives” which was attended by 600 persons, mostly youth, from the Sahakar Vidya Mandir in Buldana along with international delegation. The students presented various performances showcasing youthful talent during the cultural night organised in the school auditorium and reminded the audience of how meeting cultural needs of people will ensure a better world. The infectious energy of the cultural performers rubbed on to the members who joined the celebrations after spending over nine hours deliberating on thematic issues at the Forum.

The ICA Blueprint was placed by the committee as the governing document and the following issues were addressed in detail – a. Meaning and definition of Youth in the Co-operative sector, b. Knowledge Platforms for awareness on climate change among coops, c. Status of coops in central Asia & middle east; and case studies on co-operatives from Pune, India (Women's Waste collectors

co-operative) and from Thimpu, Bhutan (Organic farming and multipurpose co-operative) were presented by young co-operative entrepreneurs and managers. Committee members got opportunity to speak about their nations' co-operative movements as well as share information on the business-sector they represent professionally.

The committee plans to reach out to a larger number of youth and provide them with an easy access to co-operative awareness and cultural exchange. It is also noted that an estimated 30 million jobs in co-operatives are held by youth, and it is our objective to strengthen their labour market value with the International Co-operative Identity Statement (ICIS) as guiding principles. The Forum was presided over by Dr. Chan Ho Choi. Case studies on 1. Women's Waste Collectors Co-operative – Solid Waste Collection and Handling Co-operative and 2. Organic farming and multipurpose co-operative

– Happy Green Co-operative were presented by young co-operative entrepreneurs and managers Ms. Pratibha Sharma and Mr. Sangay Rinchen respectively. Two technical papers were presented by Dr. R.K. Jalan, Moderator and Resource Person – UN Community on Climate Change and Dr. Bhagwati Prasad, Former Chief – NCUI and Vice Chairperson – Sahakari Awas Nirman Evam Vitt Nigam Ltd., Lucknow. Mr. Babak Koshnevisan, a Member from Iran shared vital information on co-operatives in Iran through his presentation.

It was proclaimed that co-operatives achieve greater happiness than other forms of business associations. The Committee decided to provide a platform for the Asia Pacific youth during the ICA Global Conference in Cape Town later this year and create one for the co-operatives at the UN Youth Conference in Sri Lanka in 2014. The committee also decided to work along the lines of the UN communities to create a reliable knowledge base.

## From the Region

### Indonesia: International Workshop on Cooperatives

The International Workshop on Cooperatives was held in Jakarta, Indonesia on 13-14 May 2013 attended by 13 delegates from European Research Institute on Co-operative and Social Enterprises (EURICSE), WCM

Scientific Committee members (WCM SC), ACO members, DEKOPIN representatives, Indonesian cooperative scholars and observer from Timor-Leste. Main topics presented and discussed were:

Improvement of World Cooperative Monitor (WCM) Methodology and Tools and Proposal for Regional ASEAN and the National Cooperative Monitor. The workshop came up with the following remarks and conclusions that need to be



further followed-up by stakeholders:

HE. Syarifuddin Hasan, Minister of Cooperatives and SMEs of the Republic of Indonesia in his opening speech extended warm welcome to participants and thanked all partners involved to make the workshop successful. He stated that cooperatives play vital role in Indonesian economic and social development. Therefore, enabling policy initiatives are of importance to foster cooperative development in the country and to face the globalization. He further stated that international strategic alliances among cooperatives could lead to even more significant contribution of cooperatives to the world economy. He declared the establishment of National Cooperative Monitor under the leadership of Indonesian Cooperative Movement.

The president of DEKOPIN represented by Mr. Teguh Budiyan in his welcome remark indicated strong intention of Indonesian cooperatives to get involved in the global engagement by actively participating in the ICA agenda and programs. Under close collaboration with the Ministry of Cooperatives and SMEs, DEKOPIN encourages their members to participate in the WCM.

During the workshop, there was common view that the methodology and tools

used in the WCM process need to be continuously improved to fulfil the ultimate goals of the WCM. The improvement is necessary to ensure fairness, universally comparable, guided by ICA cooperative identity and featuring global competitiveness.

WCM SC welcomed the initiative of Indonesia in making suggestion to improve WCM instruments, to create more inclusive networking and strategic alliances between cooperatives and mutuals with that of the developing countries for greater sharing of information, business intelligence and opportunities. This objective should be promoted worldwide for the benefit of cooperatives.

WCM SC also welcomed the proposal to provide a greater opportunity to all ICA members to expose their cooperatives under the WCM. There was suggestion to expose top 10 ranking cooperatives of ICA members by having new categories according to country and areas or sector. The methodology and criteria for producing these categories might be discussed separately. The Indonesian cooperatives also proposed that cooperatives from the developing countries to be listed in WCM General

Report 2013. After discussion, it was agreed to provide to all ICA members the opportunity to list some of their good practices in WCM report. This could be undertaken by adding some chapters to the General Report. WCM SC needs to consult with ICA to materialize this proposal.

EURICSE and Indonesia cooperation in the area of WCM development will be covering the following activities:

- a. EURICSE will transfer knowledge in the field of methodology and tools of the WCM and a reference to be used by Indonesia in establishing national and possibly regional cooperative monitors.
- b. EURICSE and Indonesia may establish joint project, in order to implement and evaluate the methodology and tools established by Indonesia.

During the workshop, ACO members from ASEAN member states expressed their willingness to establish a regional cooperative monitor using the WCM approach and methodology as guidance. The establishment of the ASEAN Cooperative Monitor will be led by Indonesia and will be reported during 2014 ACO general assembly.

## Iran: ICC International Building and Construction Industries Exhibition

The Iranian Chamber of Cooperatives (ICC) organised 13th International Building and Construction Industries Exhibition on 3-6 July, 2013 at the Tehran Exhibition Ground Auditorium. The opening ceremony was held on 3rd July where the Cooperative Minister of Iran was the Chief Guest and delivered opening address.

Mr. Dariush Pakbin, General Secretary of ICC and the chief host extended warm welcome to delegates and gave an introduction of the event highlighting the success of the exhibitions held under the leadership of ICC for last several years. He also spoke about the ambition of constructing low cost housing so that all the people of Iran can have homes to live in. 21 countries, mainly from Middle East, Central Asia and Africa participated

in the Exhibition. The exhibition was organised very well with many professionally displayed stalls covering all the possible range of quality products ranging from wall stones, steel and interior designing to office furniture, kitchen and computers. A large number of visitors from all over Iran as well as from neighbouring countries were present crowding the stalls. Though participation is from private builders and business houses, this is an important project of ICC which generates revenue and gives publicity. The secretary general also held a meeting with all the participants of the exhibition and asked them to share their views and if there is any problem. He offered to facilitate smooth business for them. The participants

from Afghanistan and other countries appreciated the efforts of ICC. The representatives from Govt. of Afghanistan Urban Development Ministry hoped that ICC /Iran may help them in rebuilding the country.

ICA-AP office was invited by ICC to attend the event. Ms. Savitri Singh represented ICA-AP and also had a meeting with Mr. Pakbin. He talked about activities of ICC and its influence on the cooperative sector in the country. He said that ICC, under his leadership is doing significant work to strengthen the cooperative movement in Iran as well as influencing the neighbouring countries in Central Asia and Africa. Savitri Singh informed him about the forthcoming ICA Regional Assembly in Cape Town. She also discussed with him about the



potential of ICC/ Iranian Co-operative movement in developing and promoting cooperative movement in Central Asia as several of these countries have potential. Also, there are ICA members in Middle

East and Central Asia who need to be more participative in ICA activities. She presented him a copy of the 4th Critical Study-2012 on Co-operative Legislation & Policy Reforms in ICA-AP

Region and Recommendations of the 9th Asia Pacific Co-operative Ministers' Conference-2012.

## Japan: JJC 91st International Day of Co-operatives Commemoration

The Japan Joint Committee of Co-operatives (JJC) and Cooperatives Japan (National Co-operatives Alliance replacing the Japan National Planning Committee for IYC 2012) organised the 91st International Day of Co-operatives Commemorative Forum on July 26 in Tokyo. The theme of the Forum was "Reconstruction Efforts by Japanese Co-operatives after the Great East Japan Earthquake". Approximately 250 participants from co-operative and other organizations, academicians and the press attended the event.

At the 91st Forum, Mr. Banzai Akira, President of the Central Union of Agricultural Co-operatives (JA ZENCHU), Chairman of the JJC and Representative of the Co-operatives Japan, made his opening remarks

followed by message from Dame Pauline Green, President of ICA.

Prof. Koyama Ryota, the associate professor of Fukushima University delivered keynote speech entitled "Report on Support Activities for the Reconstruction of Fukushima after the Earthquake and How Co-operatives Can Contribute". It was followed by a panel discussion. Panellists from consumer, agricultural, workers and fisheries co-operatives presented their activities concerning the reconstruction and revival of the communities in Tohoku area after the Great East Japan Earthquake. Ms. Nakamura Yuko, Vice Chairperson of Miyagi Consumer Co-op, represented consumer co-op sector as a panellist, and made a brief speech on Miyagi Co-

op's contribution to the recovery from the earthquake and what they learned from the support activities. In the course of discussion, members of JJC and Co-operatives Japan formally agreed to strengthen their collaboration and partnerships in implementing concrete measures for the reconstruction, taking this event as the starting point.

The forum was concluded by closing remarks from Mr. Asada Katsumi (President of Japanese Consumers' Co-operative Union), Vice Chairman of the JJC and Vice Representative of the Co-operatives Japan. This forum provided an opportunity to recognize the importance of social responsibility of co-operatives and a need to further strengthen their collaboration for the development of the community.

### Workshop on Agricultural Co-operative System

The National Agricultural Federation of South Korea is the apex organisation of Agricultural Cooperatives in the country with the mandate to provide extension and support services marketing and supply and financial services to its members.

In March 2012 the NACF restructured its operations, establishing financial and marketing holding companies through the revised agricultural cooperative law and resolution of board of Directors in February 2012. The restructured NACF performs as the centre of member coops governing the extension and support unit, the agricultural and supply business unit, the livestock marketing and supply unit and the cooperative banking unit. It has created a unique model of cooperative service provider. The ICA/NACF joint "workshop on agricultural cooperative systems in Korea" was conducted for the cooperative members of ICA AP to give them an exposure to the working of NACF as well as providing an opportunity for networking and experience sharing.

The workshop was conducted on 23rd-28th September, 2013 in Seoul wherein 14 cooperative members from 9 Asian countries participated. Mr. Kim Hyun Gun, Executive Vice President of NACF delivered opening address followed by welcome speech by Dr. Chan Ho Choi, Regional Director, ICA AP. Participants from 9 countries made presentation during the technical session and reported about agricultural cooperative system in their respective countries.

The participants got opportunity to visit the Yang Jae Hanaro-Mart, Ansung Farm Land and an Agricultural Processing Complex (APC) producing and marketing Ginseng and packaging Korean Apples and Gosam Primary Agriculture Cooperative, a unique small primary cooperative with 1159 members and has been in the business of organic cultivation since 1996. The participants also visited NACF agricultural museum showcasing old and contemporary farming equipments and culture.

### 1. Training in Japan

(Mr. Patil Anant Surgonda) and Malaysian National Co-operative Movement (Mr. Mohd. Othman Bin Adam).

Miyagi Co-op and the Co-op Net Business Association provided the training grounds, the facilities and resource persons.

The program consisted of different training modules that together covered all the training proposals requested by the trainees such as, consumer co-operative store operation, marketing, merchandising & supply chain, environmental management as practiced by co-op, personnel management and customer service.

The participants arrived in Japan on July 19 and having gone through a

two-day orientation at JCCU headquarters spent two and a half days at Co-op Net to receive lectures on structure of business solidarity, social and environmental initiatives to mention a few.

The training module at Miyagi Co-op contained practical exercises allowing them to work at the store, attending conventional meeting between the store manager and the chiefs of various divisions leaving them with memorable experience.

The trainees were also impressed about Miyagi Co-op's human resource development program that instills co-operative spirit in employees.

At the end of the training, an action plan was drawn by trainees to address what they intend achieving upon returning to their home countries on August 4.

The second batch of the 2013 ICA-AP training program for Managers of Consumer Co-operatives will be held from November 22 to December 8.

3. "Supply Chain Management" by Mr. Mark Teo, Senior Manager of Logistics, Fairprice.
4. Mr. Alberto Marrassini, General Manager of Co-op Global Sourcing (China), gave a lecture on "Overview of Co-op Global Sourcing and Business Collaboration with European Consumer Co-operatives".
5. Mr. HORI Hiroyuki, Senior Manager of New Business Development, Co-op Net Federation (Japan) also gave lecture on the Case study on Japanese Consumers' Co-operative "Dinner Delivery Service".

A group discussion was held on the topics; "value of being a co-operative" and "co-operation among co-operatives".

Mr. Beng Lee Kao gave a closing speech at the concluding session and participants gave encouraging feedback.

## GENDER MAINSTREAMING

# Management Capacity Building of Women for Co-operative Development

*I would like to recall the UN Resolution adopted by the General Assembly in February 2010. It noted that "recognizing that cooperatives, in their various forms, promote the fullest possible participation in the economic and social development of all people, including women, youth, older persons, persons with disabilities and indigenous people, are becoming a major factor of economic and social development and contribute to the eradication of poverty..."*

said Dr. CHOI, Regional Director in his opening speech of the ICA-AP/ICC Training Program on "Management Capacity Building of Women for Co-operative Development" held on 14-18 October 2013 in Tehran, Iran, hosted by the Iranian Central Chamber of Co-operatives (ICC). In this 5 days training program for women trainers, conducted by Ms. Savitri Singh, 2 participants from ANGKASA-Malaysia and 32 women cooperative leaders from various provinces of Iran participated intensely.

Dr. G. Hossein Hosseininia, Deputy Minister of the Ministry of Cooperatives, Labor and Social Welfare, Mr. Dariush Pakbin, Secretary General of ICC and Mr. Zakaria Motevalli, Deputy Secretary General of ICC also addressed the opening and

expressed their views. The Deputy Minister thanked ICA for conducting the program for cooperative members of Iran and talked about schemes and programs run by the ministry for cooperative development and inclusion of women.

Mr. Pakbin welcomed ICA delegation and participants and talked about the importance of women empowerment through cooperatives in Iran and gave an account of and ICC initiatives. Ms. Savitri Singh also welcomed the participants and delegates and gave briefing of the program in her introductory address.

Unfortunately, Ms. Simel Esim, Chief of the ILO Cooperative Branch couldn't join the program due to some last minute urgent business in ILO, but provided her speech for the inauguration. Her speech was read by Mr. Babak wherein she mentioned that "We welcome ICA efforts in promoting gender equality in cooperatives going back to a resolution and strategy on gender equality adopted in 1995. The ILO and the ICA worked together in developing training materials then, which have recently been updated by the ICA's Asia Pacific region through its Regional Women's Committee."



The session on the topic 'Situation of Women and UNDP Programme for Gender Mainstreaming in Iran' was conducted by Mr. Ali Farzin, Programme Specialist, Inclusive Growth and Development Cluster, UNDP, Iran.

As resource speaker, Mr. Ali Farzin talked to the women participants about UNDP programs and initiatives. He also invited one of the women entrepreneurs' promoted by UNDP Program to talk about setting up of Bee keeping business which was appreciated by the participants. The participants found information by Mr. Ali very useful and were keen on keeping in touch with him in future for guidance.

iv. Introduction of the "Resource Guide for Advanced Training of Co-operatives on Entrepreneurship Development of Women and Gender Equality".

The participant from ANGKASA, Malaysia introduced the organization and made presentation on various cooperatives in the country which generated lot of interest among the participants resulting into many questions to the presenter.

An 'Experience Sharing Session' was exclusively conducted for the Iranian Co-op Entrepreneur participants who came from about 30 provinces of Iran and got opportunity to meet each other. The session came out to be very useful as it

- i. ICA Gender initiative and Leadership Development of Women in Co-operatives – The Global Perspective;
- ii. Various Aspects of Management of a Co-operative business;
- iii. Understanding Gender;

provided a lot of information, sharing and networking opportunities. There were some interesting sectors of coops represented by the participants such as horse breeding coop, coop in building and monument preservation business etc.

The training completed with study visit to an Agriculture cooperative in the neighbouring city where participants got opportunity to interact with the office bearers along with visiting farm equipment museum and testing of delicious farm products.



## Revitalization of Local Community by Rural Women

The 3rd ICA-Japan Training Course on “Revitalization of Local Community by Rural Women” was held in Thailand and Japan from 16th September to 18th October 2013. The Training Course is being organised in collaboration with the Ministry of Agriculture, Forestry and Fisheries (MAFF), Government of Japan and implemented by the ICA.

Eleven women participants from eight countries, namely, Cambodia, India, Indonesia, Laos, Myanmar, Nepal, Thailand and Vietnam attended the Training Course.

The main objective of the Training Course is to assist fostering women coordinators who play important role in mobilising women in agricultural sector and rural community which will contribute in income-generation and poverty reduction in the Least Developed Countries of Mekong River countries and the South-Asian countries.

The part-I of the program – field study visits with a focus on observation of the activities of cooperatives/women groups and social institutions – was held in Thailand from 16th to 22nd September in collaboration with the Cooperative League of Thailand (CLT), a member organization of ICA.

The part-II of the program held at IDACA from 23rd September to 18th October included extensive classroom work and study visits to agricultural cooperatives in Kyoto

Prefecture of Japan. Lecture-cum-practical field study visits assignments were combined to impart necessary knowledge to the participants on the working of women's associations and the general activities of agricultural cooperatives in Japan.

In view of the experiences gained by the participants through class room lectures, field visits in Thailand and Japan, they were able to finalize/improve their Action Plans which they would be recommending to their respective organizations.

An end-of-the Course Evaluation was conducted at the conclusion of the Training Course. The participants felt that the training course was very relevant for the women leaders of agricultural cooperatives in Asia and hence it should be continued.

They also expressed their deep appreciation to the Ministry of Agriculture, Forestry and Fisheries (MAFF), Government of Japan for providing financial support for this Training Course. They hoped that the MAFF would continue to support this training program in the future also for the development of rural women in the developing countries.

A Certificate of Participation was awarded to each participant at the closing ceremony held in IDACA, Tokyo on 17th October.

### Cooperative Week Celebration in Iran

Iran celebrated its Co-operative Week from September 3-9, 2013. Each day of the Iran Co-operative Week was given a name with certain meaning and connotation. A translation of the Persian script reads as:

- Day 1: Cooperative, political and economic epic
- Day 2: Cooperative and morality
- Day 3: Cooperative and economic and social justice
- Day 4: Cooperative, and Islamic and national unity
- Day 5: Cooperative and job creation, entrepreneurship, Day supporting national production
- Day 6: Cooperative, altering distribution system, and improving people's livelihood

- Day 7: Cooperative, media, education, cultural awareness, Islamic-Iranian pattern to advance

The Minister of co-operative along with the Secretary General of the Iranian Chamber of Cooperatives, Mr. Dariush Pakbin, and co-operators from various parts of Iran joined in celebration of the Iranian co-operative week. Expositions, seminars, and conferences were organized in different provinces to showcase coop-products. Appreciated authors, editors, and people who have been engaged in promoting the cooperative economic model were played an important role during the celebratory week. 21 co-operatives were appreciated for their activities. There has been a political development in Iran and a new President has been elected. The newly sworn in cooperative minister traveled to different provinces in order to get acquainted with the stake holders in Iran's co-operative sector. The 8th festival to select the top co-operatives in Iran was also held during the week. The Minister for co-operatives, labor and social welfare mentioned that Iran's economy is suffering from inflation and recession. He added that the best way to resolve that was the inclusion of people based enterprises like co-operatives in national growth. He mentioned that the capital has to return to production cycle. He further said that Iran needs 8% economic growth, job creation mechanisms and does not need the burden of economic sanctions.

The ICC Secretary General Dariush Pakbin stated a co-op university was in the pipeline and negotiations with MPs to amend the co-operative laws were on. He also expressed that co-operative bank and coop insurance were two important achievements of the Iranian co-operative system.

## Regional Board Meeting

The meeting of the ICA-AP Regional Board was held in Cape Town International Convention Centre, South Africa on 1st November 2013 under the chairmanship of Mr. Li Chunsheng. Both Vice Chairpersons Dr. Chandra Pal Singh Yadav and Mr. H.A.M. Nurdin Halid, were present along with other members and one youth representative.

Mr. Seah Kian Peng, ICA Global Board Member from Singapore was also present.

Mr. Charles Gould, Director General of ICA was the special invitee at the meeting.

Mr. Li Chunsheng extended a warm welcome to the members and invited their views and comments on the Agenda. The Agenda of the meeting was unanimously approved and Minutes of the last Meeting held in Haikou on 15th March 2013 were confirmed.

The National Cooperative Council of Sri Lanka (NCC) had nominated its current Chairman Mr. W. Lalith A. Peiris in place of Mr. Bandu Ranawake on his retirement from the board and the meeting unanimously ratified the substitute member from Sri Lanka

Dr. Sukesh Zamwar, Chairman of the ICA-AP Youth Committee was unanimously co-opted to the Regional Board as per rules of ICA-AP.

Dr. Chan Ho Choi, Regional Director presented the ICA-AP Activities Report for January to October 2013. Dr. Chandra Pal Singh Yadav from India, Mr. Hajime Yaguchi from Japan and Mr. Phanuwat on behalf of CLT, Thailand gave their inputs to be included in the report.

The Financial Report for 1st January to 30th June and the estimated cost for July to September 2013 were presented by the Regional Director. He reported a surplus of CHF 65,813 as per the estimates and informed about the administrative problems faced by the office in getting the funds from outside India which was solved only in July. Even salary to the staff was not paid for six months and he expressed regrets for this hardship caused to them. This was the main reason for the surplus funds. ICA-AP accounts are audited by the auditor appointed by the ICA and the audited report is being sent to ICA for inclusion in the global financial report.

In addition to this, MAFF project fund is also audited separately and sent to MAFF as per the agreement. The MAFF supported training project is going on for the last 30 years for which ICA is grateful to MAFF. He also suggested that the duration of the training courses should be reduced, if possible, so that more participants could attend the training courses.

Mr. Li Chunsheng expressed happiness and satisfaction on the financial situation of Asia-Pacific region as it is very good in comparison with other ICA regions and hoped it would be getting better in the coming years.

Agenda on Membership situation came up for discussion and Dr. Choi informed that the following four organizations have been admitted as members of ICA from the region: (a) Department of Agricultural Cooperative Marketing (DACM), Ministry of Agriculture and Forests, Bhutan; (b) Coop Global Sourcing Limited (CGS), China; (c) Cooperative Union of Kyrgyzstan (CUK), Kyrgyzstan; and (d) National Fisheries Federation, Sri Lanka and following 3 more organizations have applied for membership (1) The Delhi State Consumers Cooperative Federation Limited, India; (2) Sarsabz Foundation (SF), Pakistan; and (3) Economic and Social Development Center of Palestine.

However, following four organizations have ceased to be members (1) Fiji Cooperative Union Limited (FCUL), Fiji; (2) Mollah-Ah Movahedin Credit Cooperative (MAMCC), Iran; (3) Supervision & Coordination Central Union of Rural and Agricultural Coops of Iran; (4) Sharjah Cooperative Society (SCS), United Arab Emirates.

Dr. Choi presented the progress report of the ICA-AP Representative Office in Malaysia (MBO). The soft opening of the office was held on 28th August 2013 in the premises of Malaysian National Cooperative Movement (ANGKASA). Three staff on secondment from NACF-Korea; ACFSMC-China and ANGKASA-Malaysia have started working in the MBO. The staff from JCCU-Japan will join from in January 2014.

While presenting the ICA-AP Work Plan for 2014, Dr. CHOI said that 27 activities included in the work plan are based on the ICA-AP Strategic Plan for 2013-2016 as approved by the Regional Assembly in Kobe (Japan) on 29th November 2012. Work Plan was approved with appreciation to Dr. Choi for inclusion of a variety of activities.

The ICA-AP Budget for 2014 was presented based on the multi-annual budget for the years 2013-2016 approved by the Regional Assembly in Kobe (Japan) on 29th November 2012 and was unanimously approved.

Members were informed that the 1st Asia-Pacific Cooperative Registrars' Conference on "Sound Tuning of Cooperative Law, Policy and Regulation and Primary Cooperatives By-Laws" would be held in Malaysia from 10th to 12th December 2013 in collaboration with Malaysian Co-operative Societies Commission and the Malaysian National Cooperative Movement (ANGKASA).

On the issue of appointment of the new Regional Director for Asia-Pacific, Mr. Charles Gould informed that Dr. Choi has agreed to work up to 31st March 2014 and the recruitment process for the new Regional Director would continue until December 2013. He sought the help of Regional Board members to get good candidates. He wanted to know whether the ICA-AP Board will accept the candidate from outside the region. The board members were of the view that the Regional Director should be from the Asia-Pacific region.

Mr. Li Chunsheng said "I really believe the DG would consider our concern while appointing the new Regional Director". He concluded that the new Regional Director should come from our region. Mr. Gould said that he would continue the process of recruitment of new Regional Director and report it at the next Regional Board meeting in Beijing in February 2014.

Moving towards next the agenda, DEKOPIN had offered in Kobe, 2012 to hold the 11th Regional Assembly and related events in Indonesia in 2014. Mr. Halid informed that they are in the process of selecting a city/venue for the events and he would inform the Chairman and the Regional Director as soon as possible. The DEKOPIN also suggested the theme of the event as "Cooperative Enterprises Become the Most Roving Business Model in the Region".

Keeping in view the International Summit of Co-operatives to be held in Quebec in early October 2014, the last week of November 2014 would be more suitable for the ICA-AP events.

As the matter of nominating one board member to ICA Domus Trust was discussed at its meeting held in Haikou on 13th March 2013, Mr. Li Chunsheng informed that Mr. Won Byung Choi (NACF-Korea) has kindly agreed to be the trustee of ICA Domus Trust in place of the Regional Director.

The next board meeting will be held in Beijing, China on 17-18 February 2014 in conjunction with the ICA Global Board meeting.

The meeting ended with a vote of thanks to the Chair.

### Fostering Core Leaders of Agricultural Co-operatives-2013

1st Training course on “Fostering Core Leaders of Agricultural Co-operatives-2013” was organized by ICA-AP, in India and Japan between 18th October and 14th December 2013. The overall objective of the training program was to assist fostering of the core leaders, who are expected to play the leading roles in agricultural cooperatives and farmers' groups that will contribute to the improvement of agricultural production and income of the

farmers in the LDCs of Mekong River countries and South Asian Countries. The training program was implemented by the ICA-AP in collaboration with MAFF, Government of Japan, Institute of Rural Management Anand (IRMA) in India, Institute for the Development of Agriculture Cooperation in Asia (IDACA), Japan and ICA's member-organizations in India and Japan. The Training course was inaugurated by Ms. Jeemol Unni, Director of IRMA. Mr. A.K. Taneja, Project Coordinator, ICA-AP, also addressed the participants on behalf of the Regional Director, ICA-AP. Prof. Madhavi Mehta of IRMA coordinated the events.

11 participants from 10 countries – Bhutan, Cambodia, Lao PDR, India, Indonesia, Myanmar, Nepal, Philippines, Sri Lanka and Vietnam attended the program and after completing the IRMA Module in India, they moved to IDACA in Japan and attended 24 days training there.

The Certificates of Participation from the ICA as well as from the IDACA were awarded to the participants.

## HRD Seminar

The ICA-AP Committee on HRD held a Regional Seminar on “Success Stories as a Tool for Cooperative Education and Training” in Colombo (Sri Lanka) on 26-28 November 2013 in collaboration with the Sri Lanka Consumer Cooperative Societies Federation Limited (COOPFED).

Cooperatives, as an organization, are using Human Resource Development (HRD) efforts to ensure capacity building of all stakeholders' i.e. members, officials and employees engaged in achieving its objectives.

## 1st ASIA PACIFIC CO-OPERATIVE REGISTRARS' CONFERENCE

December 10-11, 2013 – Kuala Lumpur, Malaysia

**Theme: 'Sound Tuning of Co-operative Law, Policy & Regulation  
and Primary Co-operative By-Laws'**

### CONFERENCE RESOLUTION

Adopted on December 11, 2013

Whereas, the ICA-Asia and Pacific has been urging its members and national Governments through various forums such as the Co-operative Ministers' Conference especially, the Joint Declaration of the 9th Asia Pacific Co-operative Ministers' Conference, Bangkok - 2012, that called upon countries to initiate changes in co-operative laws and policies to achieve the objective in creating the legal and policy environment that is conducive to the development of co-operatives in accordance with the principles embodied in the ICA Statement on Co-operative Identity (Manchester - 1995) and that,

in pursuance of the aforesaid Declaration, the Regional Assembly of the ICA-Asia and Pacific, Kobe - 2012 decided to convene a Conference of Registrars of co-operative societies of the region in Malaysia in 2013 to deliberate on the making of by-laws by primary co-operative societies - viewed as a 'strategic issue' with the objective of making the process transparent and participatory with active participation of women and youth, and attaining financial sustainability while exploring new areas of co-operative businesses and that,

we, the participants from sixteen countries deliberated on the legal, policy and management issues, taking note of the positions obtained from the region, and while reaffirming the autonomous and voluntary character of co-operatives and the co-operative principle of 'concern for the community', hereby resolve,

1. that ICA-Asia and Pacific members and representatives of Governments will work earnestly in close co-ordination to review the existing provisions in co-operative laws of their respective countries relating to the formulation of by-laws and make the process truly participatory;
2. to increase the participation of women and youth in the overall functioning of co-operatives to ensure inclusive participation and social cohesion;
3. to incorporate systems and procedures in by-laws to ensure financial sustainability of co-operatives by introducing prudential norms of management designed to help the members to avoid risky ventures and to improve and diversify their businesses while achieving their social, cultural and economic well being in a manner consistent with the co-operative principles;
4. to recommend a facilitative role for the concerned co-operative apex organisation in providing expert advice in the preparation of by-laws and institutionalise such roles of the co-operative apex organisation by proposing suitable legal measures and further recommend a mechanism of organising national conferences to deliberate on legal, policy and management issues concerning the co-operatives in their respective countries to enable co-operatives to evolve towards a higher and sustainable growth path;
5. to encourage the formation of a parliamentary network to support the efforts of the Registrars/Regulators in establishing a responsive legal and policy framework;
6. to consider the indicative by-laws presented in the conference, an adaptive approach of making of by-laws which allows a responsive mechanism to meet local needs and situations to be adopted rather than the prevalent practice of 'adopting' model by-laws, to appropriately provide a practical, legal and functional framework for primary co-operatives;
7. to invite the ICA-Asia and Pacific to follow up the matter of reforming the process of making by-laws with members and respective regulatory authorities and report the progress achieved to the Regional Assembly from time to time; and
8. to consider the establishment of the Asia-Pacific Co-operative Registrars'/Registrars' Association and its secretariat.
