POST TAGAYTAY REVIEW PROJECT MEETING 25&26 FEB-2005, BANGKOK

In 1997, The ICA ROAP and AWCF had jointly organized a regional conference on 'Women in Decision-making in co-operatives: which was held on May 7-9, 1997 in Tagaytay City, Philippines. In order to enhance the number and participation of women in leadership and decision making conference proposed six important strategies and actions to be implemented within a period of 8 years, from 1997 up to year 2005.

Therefore, the ICA Regional Women's Committee for Asia & the PACIFIC (ICA RWC) and representative of AWCF and ACCU had held two days meeting to review the post "Tagaytay Declaration 1997 achievements or lack thereof". Meeting was chaired by Ms. Rahaiah baheran, the Chairperson of the ICA RWC. The group has reviewed all report from their organizations about the progress achieved or lack there of. Based on the reports from members, it was found that all the six strategies have been dealt with but performance could not be maximized due to various reasons.

Therefore, it has been decided that it is necessary to collect sex disaggregated data in order to review the achievements and lack thereof. The data will cover number of women and men at all levels of co-operatives such as general membership, managers and board of directors, breakdown by age group and also number and kind of educational/training activities have been implemented and policies put in place for capacity building of co-ops on women leadership development and building capability of women for leadership and decision making in co-ops. The data will be collected from all the ICA, AWCF and ACCU

member organizations in the region. Based on the data so collected the achievements will be evaluated and will be presented before the "Post Tagaytay Review Conference: to be held in May 2006.

The ICA Regional Women's Committe will collaborate with Unifem to get the benefit of the expertise of the agency in the field of sex-disaggregated data collection and the services of an expert consultant recommended by the UNIFEM to expedite and complete the task.

INTERNATIONAL WOMEN'S DAY - 2005 CELEBRATIONS

A NTUC/SNCF International Women's Day 2005

Held at the Intercontinental Singapore on Saturday, 5 March 2005. Together with the ATUC Women's Committee, the SNCF Women's Programme Committee organized a seminar to celebrate International Women's day which falls on 8 March. The Guest-of-Honour was Dr. Vivian Balakrishnan, Acting Minister for Community Development, Youth & Sports and Senior Minister of State for Trade & Industry. Mdm Halimah Yacob, Assistant Secretary-General of NTUC also attended the event in her capacity as the Secretary of the NTUC Women's Committee.

With the theme "The Power In You", the event aimed to showcase successful women figures in Singapore as well as to discuss issues relevant to women in this globalised economy. More that 500 participants, from both the union and the co-operative sectors, attended the half-day event which witnessed three prominent women speakers elaborating on sub-themes pertianing to the social, political and entreprepreneurial aspects.

In his keynote address, Dr Vivian Balakrishnan mentioned that the Women's Charter was one of the earliest legislative changes that the People's Action Party Government pushed through and he further added that the journey is not over yet although women have indeed come a long way in terms of bridging the inequality gap between the genders. He emphasized that women should be given the power to choose the path that gives them most fulfillment and the power to contribute to society.

The first speaker, Dr Paulin Tay Straughan, Associate Professor & Deputy Head of Department of Sociology /

Vice-Dean, Faculty of Arts and Social Sciences, National University of Singapore (NUS) Highlighted the many social progress that Singapore women have made and also gave her views on work and family life balance. Her many personal anecdotes further shed light on the need for women to embrace their commitments especially where family matters are concerned. Her humourous and entertaining delivery brought smiles and laughter to the strong turnout.

Briefing the participants on "Women's Political Participation & Empowerment in Singapore" was Dr Suzaina Kadir, Assistant Professor, Department of Political Science, Faculty of Arts and Social Sciences, NUS. Dr Suzaina touched on the need for more women to come forth and take on leadership roles especially in the political arena. Though tremedous improvements have been made through the decades, more can be done because it is crucial that women's voices are heard particularly in areas and which will affect the lives of the common Singaporeans.

The last speaker was Ms Loh Wai Kiew, President & CEO of Semb Corp. Environmental Management, who gave a more personal account of her climb up the corporate ladder. As the head of a successful and rapidly-growing environmental business, Ms Loh who often calls herself a garbologist, emphasized the fact that women leaders do not have to change or try to fit themselves in their respective male-dominated working environment. The key point is that female bosses can bring in their own unique style of consultative leadership which is evidenced from her success story.

The panel discussion, comprising of Mdm Halimah Yacob, Ms Goh Ming Huay and the three speakers, saw a

lively discussion between the panelist and the participants. In her closing address, Ms Goh emphasized and urged the many ladies present to unleash the power within them and to go all out to achieve aims and goals in life especially those who are able to excel in male-dominated field to take that crucial step forward and contribute in whatever ways possible.

Feedback received from the majority of the participants was very positive and they enjoyed the afternoon session.

On the whole, many participants commented that the event well-organised and the more of such events should be organised in the future. Majority of the participants were most impressed with Dr Paulin Tay Straughan and has requested that she be invited to speak again in future events.

JOINT MESSAGE OF THE ICA PRESIDENT AND CHAIRPERSON OF THE ICA GENDER EQUALITY COMMITTEE

WOMEN CO-OPERATIVES IN INDONESIA

Indonesia is the fourth world's most populous country, with a population of over 215 million in 2003, approx 50 % of whom are women and 55.60 % of them live in the rural areas. 65.60 % of the population are under the productive age category (15 -64 years old). The official data reveals that 18.40 % of the Indonesian people live below the poverty line and the average income per capita per annum is US\$ 621.

In education, the constitution mandates that every citizen has the right to receive education and the obligation to follow basic education for 7 to 15 years-olds and the government has obligation to provide the funding. The central and regional governments has the obligation to provide services and facilities and ensure the provision of quality education without discrimination. There is a significant gap in drop out rates between females and males and this gap widens as the level of education increases.



As table 3 shows, at the senior high school level, there are 7 female students who drop out for "every 3 male tudents who drop out. An indication of the-low level of education in Indonesia is in the high, number of students who drop out reaching around 6 million. In addition, chool-age children (7-12) from poor families that are mable to go to school number around 1.4 million.

n health, the current Maternal Mortality Rate (MMR) in ndonesia still high: 396/100.000 life births. It was estimated that every year 20.000 women died during pregnancies and deliveries. Bleeding contributed 42% to ne MMR, following eclampsia (13%), infection (10%), omplication during abortion (11%), prolonged labor 9%) and others (15%).

n co-operative, the total number of co-operatives in 2003 vas 123.181 units scattered over 341 districts and nunicipalities within 30 provinces in Indonesia. The total nember of—coperatives in 2003 was 27.282.658.

The total number of women co-operatives in 1999 was 1284 units, and the total members was 275.417 and the total number of women co-operatives in 2000 was 1.405 units, and the total members was 366.194 members.

STRATEGIC OBJECTIVES

We have commitment to improve women participation in co-operative by various strategic acts:

- 1. Ensure equal access to co-operative
- 2. Improve women's access to co-operative facilities
- 3. Develop non-discriminatory education and training in co-operative
- 4. Promote lifelong career for women in co-operative

ACTION TAKEN

- Education is "key" to empowering women in cooperative An equitable access in co-operative will raise awareness among women of the meaning of their rights and obligations for themselves.

- To provide education, training and information to all members, especially to women in co-operative and get the opportunity for education and training in cooperative.
- 4. Training and Capacity Building is the key to empowering women that will make women self sufficient, responsible, knowledgeable, aware of the importance of future, aware of opportunity to participate in co-operative.

- 1. The participation of women in co-operative has been raised. Total women co-operative in 1999, were 1264 units and total women co-operative members 275.417 and total women co-operative in 2000 are, 1405 units and total women co-operative members 366.194.

Total membership of Japanese Consumer Co-ops is almost 22 million. According to survey conducted in 2003, we would estimate that more than 90% out of total membership are female.

The Japanese Consumers' Co-operative Law, as well as the rules, regulations and by laws contain no discriminatory provision against women. Therefore, there are no constraints against women.

On the other hand, even though there are also no constraints to men, the number of male members are much smaller than female. This is because the notion that women bear the primary role of consumers' affairs in the families is popular in Japan.

Actions

(1) Policy Making

Several Co-ops as well as JCCU adopted the policies to ensure female-male equal participation. These included some positive actions such as (a) an increase in women employees, support for women to continue to work, and improvement in the ratio of women in management positions, (b) Transfer of more power to part-timers and promotion of more part-time employees to full-time positions, (c) prevention of sexual harassment.

(2) Employees/Human Resources

Several Co-ops have created a position, whose job is to focus-on and deal with gender issues. This staff is responsible for contacting local governments and other organizations for the purpose of collaboration on gender related issues. Furthermore, they organize gender sensitivity training and activities for Co-op employees. ICCU also has appointed staff who is in charge for gender issues.

(3) Awards

The Basic Law for a Gender-Equal Society enacted in 1999. Since the establishment of the Law, central and local government of Japan have jointly presented Corporation Awards for the Promotion of Gender Equality. 12 Co-ops nad the Awards during 1999-2003.

LEADERSHIP DEVELOPMENT PROGRAMME FOR THE CHAIRPERSON/WOMEN DIRECTORS OF COOPERATIVE SOCIETIES IN INDIA

The National Centre for Cooperative Education the Education wing of NCUI, New Delhi organises Leadership Development Programme for the leaders of cooperative societies all over the country. These programmes are organised either in New Delhi or in collaboration with nstitutes of Cooperative Management located across the country. These Programmes are being organised sectorwise.

One such leadership Development programme for Chairpersons/Women Directors of Cooperatives in Andhra Pradesh was organised in collaboration with Institute of Cooperative Management, Hydrabad from 10-12 May, 2005. 31 women cooperators from all over the tate participated in this programme. The inauguration was attended by senior officers of the cooperative department, Govt. of Andhra Pradesh who emphasised on the role of women in development of cooperatives and the lation. The role of NCCE was also appreciated in organising such programmes and giving women cooperators a platform to hone their skills in managing there Cooperative Societies.

the participants were exposed to such diverse topics such as cooperative ideology role and responsibilities of the board of directors, conducting meetings, understanding inancial statements, legal aspects of cooperatives,



member participation etc. In addition they were also asked to share their own personnel experiences in respect of their Cooperatives so as to facilitate learning from each other. The deliberations were addressed by the faculty members of ICM Hydrabad and also experts from different fields.

The women participated very enthusiastically in all the deliberations and frequently asked questions about many issues which they are unable to clarify at their own level.

NATIONAL WORKSHOP FOR TRAINING OF TRAINERS FOR LEADERSHIP DEVELOPMENT OF WOMEN IN COOPERATIVES SRI LANKA 1-6 AUGUST, 2005

The ILO-Coop Net and ICA ROAP has developed a training manual fo leadership development of women in cooperatives in the Asia pacific region. The manual is being used for training of trainers of cooperatives who in turn will train the women cooperative leaders.. The ICA ROAP has decided to conduct the training for women and men trainers of primary, secondary and tertiary cooperatives whose role and task is to conduct training activities on gender sensitivity and accountability and on leadership capacity building of women in cooperatives.

During past 3 years, we have conducted 4 Regional TOT in 4 differer countries in the region and trained 100 trainers. Six participants from Sr Lanka have also attended the programme.

As the objective of the TOT is to multiply trainers so that a team of trainer could be generated who in turn train the women co-operative leaders a grass-root/primary level.

Therefore, it is decided that National TOT should be conducted in the ICA member countries who have already participated in Regional TOT and in the

National TOT, 25 local trainers, both men and women will be trained.

We are happy to report that NICD, Sri Lanka had accepted our proposal to host a national TOT. The ICA-AP had provide regional resource persons and technical help required for organizing the programme. The NICD invited 29 women and men trainers of primary, secondary, and tertiary cooperatives with basic knowledge of cooperatives and substantial grasp of gender issues and concern in the society, committed to the advocacy for gender equity and equality in society in general and in cooperatives in particular. The trainers had willingness and capability of training and mentoring current potential women leaders in the effective management of cooperatives, to attend TOT and extended all the support for successful completion of the training.

The program was arranged for 6 days (Mon to Sat) 5 days for classroom training and one day for study visit.

This training workshop aims to assist trainers of Asia Pacific to:

- Raise the awareness of women and men leaders and members of cooperatives on gender issues, on the manifestations of gender bias (against women) in cooperatives, and on the effects of gender discrimination on the personal and interpersonal growth of its leaders and members as well as on the organizational development of cooperatives.
- Build up the capacity of current and potential women leaders of cooperatives by equipping them with knowledge and skills on the following:
 - Nature of Cooperatives
 - Effective and gender-responsive leadership
 - Cooperative Enterprise Management
 - Coping with challenges; and
 - Personal Development

ICA RWC EXPOSURE AND NETWORKING PROGRAMME FOR EMPOWERMENT OF WOMEN IN CO-OPERATIVES

The ICA AP has organized an exposure and networking programme for women co-operative leaders of our region in Seoul, Korea from 5th to 10th September, 2005. The challenges of globalization and free trade are affecting lives of people unevenly across the world. The cooperatives worldwide are feeling the heat of unequal opportunities and threats created by the free market. As usual, this has intensified the existing inequalities and insecurities for many poor women. The high tech means of trade and business are tend to benefit rich than the poor. Women are most likely to suffer more from the rapid changes societies are undergoing due to globalization and free trade.

In the context of these challenges, ICA Regional Women Committee has been making this attempt to share information with women cooperative leaders in the region and expecting to find ways and means to promote women's economic security and empowerment through the cooperatives. The information sharing during the exposure visits to successful co-operatives, focused upon co-operative endeavour to promote women's interests.

Last year the same programme was conducted in India.

This year the programme was held jointly with Agriculture Cooperative Study visit_ sponsored by ICA-AP and hosted by National Agricultural Co-operative Federation (NACF) of Korea. The main purpose to combine these two programms is gender integration and giving more exposure to women in the field of agriculture and credit as about 55% of farming work is done by women in Asia. Two women cooperative leaders/directors on the board of cooperatives or person dealing with women development activities in co-operative organization in the region have been invitation to participate in the seminar. 18 persons, 10 men and 8 women from India, .Vietnam, Thailand and Malaysia attended the programme.

Mr. Jae Bok Kim, Executive Vice-President of NACF opened the joint programme with his inaugural speech. He spoke about the agriculture and agricultural cooperatives in Korea and informed that NACF is working to encourage every citizen to support rural communities and to raise awareness of the importance of having a thriving agricultural industry. Ms. Savitri Singh spoke on behalf of ICA-ROAP. She extended warm welcome to all the participants and talked about objective and benefits of such programmes. She expressed her gratitude to all the participants and their Coops for sponsoring them to attend the programme and special thanks to NACF for their collaboration and contribution. Mr. Ryu Kun-Won, General Manager of NACF, Mr. Hyung Jo, Asstt. General Manager of NACF and Mr. Lee Kwan Hee, Officer of the International Division were also present.

The participants have been requested to prepare a success story about how cooperatives are helping women's economic empowerments in their country/cooperative and good practices for advancement of women. During the interaction session the participants discussed with their Korean counterparts role of the farm credit business and spoke about activities of their own country and coop. They visited to Hanoramart Chain Store Division, Agriculture Coops including meeting with Women Association in the coop and Kyoyang Agricultural Marketing Complex and Agricultural Co-operative Collage.

ICA-AP-CLT WORKSHOP FOR SENSITISATION OF CO-OPERATIVE LEADERS TO GENERATE AWARENESS FOR PREVENTION OF SPREAD OF HIV/AIDS

The ICA-AP has taken initiative to address the HIV/AIDS crisis in the region and a strategic project focusing on prevention and intervention activities has been put in place to cover all the member co-operatives in the region. According to plan to cover the countries with high HIV prevlance first, a workshop for sensitisation of co-operative leaders to generate awareness for Prevention of Spread of HIV/AIDS has been held on 1-2 July

2005 in Bangkok, Thailand in collaborating with Cooperative League of Thailand. Last year the same workshop was held in India with the support of UNAIDS and NCUI.

The 30 participants who attended the workshop were cooperative leaders, directors and managers from various sectors of Thai co-op movement.

The workshop has been inaugurated by Dr.Suthiporn Chirapada, Deputy Permanent Secretary, Ministry of Agriculture and Co-operatives, Govt. of Thailand.Mr.Shil Kwan Lee, Regional Director of ICA-AP, Mr.Wisoot Sutthinoon, Chairman of the CLT, and Dr. Wiwut Daengsubha, Executive Director of CLT addressed the participants and expressed solidarity in fight against the pandemic. Mr.Bhagwati Prasad, Chief executive of NCUI, India was also present as special invitee and he shared his experience about ongoing HIV/AIDS awareness activities in co-operatives in India with the participants. Ms.Savitri Singh, Advisor Gender Programme presented her report as co-coordinator of the workshop and introduced the programme.

This workshop was designed with an aim to sensitise cooperative ministers, leaders and managers of the co-operative about the sensitivity of the issue and pronounced commitment from them to bring out required facilities for spread of preventive education to reduce risk of HIV/AIDS among the co-operators.

At the end of the workshop, as intended following objectives have been achieved:

- 1. Orientation of the leaders and managers about the issue.
- Strategy for conducting HIV/AIDS awareness programmes.
- Framework for national action plan to implement the strategy in all the co-operative societies throughout the country.

During the Technical sessions, experts from UNAIDS, ILO and AOHCO deliberated upon the following issues:

- Basics of HIV/AIDS, it's impact on the society and ongoing programmes for prevention and cure of the disease
- Prevalence of HIV/AIDS in Thailand as workplace issue and need for action on part of co-operative institutions
- > APHCO and health issues in cooperatives, and
- "Need for creation of political Will" had been discussed by Savitri Singh

The sessions followed by Interaction and discussions by the participants.

At the last session, group discussion have been held and group leaders presented their Out-put/ action plan as how they think they will implement HIV/AIDS prevention and care programmes in their co-operatives.

We at ICA are making efforts to mobilize funds for implementation of total project in selected countries and organizing more such workshops Also, hope to cover more countries in the region in coming years.

Our partners here, in this endeavour are Co-operative League of Thailand(CLT) which is the Apex organization of Thai Co-operative Movement and very active member of ICA-AP. We are thankful to CLT for their enthusiastic support as host and hope that this programme will be beneficial for the participants and to the co-operative community in Thailand as a whole. We also expect the co-operative department to take necessary action to make it a regular processes.

There are more than 3,016 co-operatives in Thailand with about 4 million individuals as co-operative members, both men and women in different age groups. As Co-operatives are community based organizations and follow the principal of "concern for community", they can reach out to 4 million individual members, their families and community in which they live and operate from. If co-operatives take up this issue in organized manner, it will be a major breakthrough in fight against this dreaded pandemic.

HIV/AIDS epidemic, as we know is not merely a health issue but a development challenge that disturb the social, economic and cultural parameters of the society.

Co-operatives as a large employers, producers and economic institutions are suffering the loss of their members, skilled workers and business due to HIV/AIDS.

Therefore, there is great need to organize facilitating services for the members within the co-operative set-up for strengthening the capacities and capabilities of members so that co-operative members as well as their communities can withstand and sustain the burden of HIV/AIDS.

Addressing the need of co-operatives not only benefits its members but also their families and in turn the community. Thus one empowered co-operator multiplies into many empowered citizens

The ICA-AP has taken initiative to target and sensitize cooperative leaders, directors and government officials of the department to utilize the potential of co-operative in fight against the pandemic as Role of leaders for creating political will is very important for initiating community based programmes.

Leaders, policy makers, educators and others can help in:

- Recognizing the epidemic publicly and openly and act to reduce the stigma surrounding HIV/AIDS
- Display political courage in applying sound measures to reduce the spread of the virus as community follows the leader
- Support the commitment of national resources which in turn may encourage increased external funding.
- Endorse a multisectoral approach, including the involvement of people living with HIV/AIDS as a priority.
- Give leadership to the fight against this global epidemic.

- Creation of a special fund by the government and the co- operative movement to mainstream gender in co- operatives. (ICA DOMUS Trust ANGKASA, JCCU, IDACA, NCUI and ILO)
- Ways to come out with gender-responsive and gendersensitive policies in order to attain equality and equity in co-ops in accordance with our Co-operative Identity Statement.

In conclusion she appealed on behalf of all the women cooperators that;

We need the assistance of government and the co-operative movement in formulating policies to attain equality and equity in line with our Co-operative Identity Statement.

NEWS FROM MEMBERS: MALAYSIA: ANGKASA COMMEMORATES WORLD RURAL WOMEN'S DAY

Co-operators from all regions of Malaysia convened at ANGKASA to celebrate the World Rural Women's Day this year. Over 140 women and men members from 51 co-operatives took part in the event.

The World Rural Women's Day was held for the fifth year at the Wisma Ungku A. Aziz, ANGKASA, Kelana Jaya from the 25th to 26th November, 2005 and the theme was, "The Right to Knowledge- Production and Marketing of Tapioca Chips."

Madam Hajah Rahaiah Baheran, Vice President of ANGKASA and ICA Board Member, officiated the ceremony. Madam Baheran explained that the focus this year was to introduce and to encourage ANGKASA's women co-operators to get involved in the tapioca chip production industry. She explained that ANGKASA was committed in helping its members to attain an in-depth knowledge of the industry. She also reaffirmed that ANGKASA would provide suitable training and education programs to its members and, would subsequently match them up with the appropriate government assistance.

After the opening ceremony, participants were introduced to the chip-making business by guest speaker, Mrs Hajah Che Rahani Zakaria, Manager of the Malaysian Agricultural Research and Development Institute (MARDI). Mrs Zakaria explained the various production, packaging and technological options currently existing in the industry.

This programme aimed at providing participants with an overview of the cooperatives in India and specially women participation therein and also latest developments in the cooperative sector.



The manual will be sent to all the ICAAP members and partners for use with a request to get it translated in their own language for better and effective use by co-operatives.

WOMEN'S ROLE IN THE ECONOMY: FACTS AND FIGURES

- Women account for about 40% of all workers worldwide, and their participation rate has risen steadily. The largest increase over the past 20 years was in South America (up from 26% to 45%), while the lowest rates were in North Africa and West Asia, where only a third of all women are economically active. But women still earn about two thirds of what men earn. The manufacturing wage gap ranges from 52% in Botswana and 75% in Egypt to 81% in Costa Rica and 86% in Sri Lanka.
- Women spend twice as much or more time as men on unpaid work and grow about 65% of the world's food. They represent the majority of the world's part-time and informal sector workers and have a higher unemployment rate than men, although this varies significantly by region.
- > 60% of the world's 550 million working poor are women.
- Women account for just under half of all people with HIV/AIDS.
- The number of women dying in childbirth is on the rise, reaching 1,300 deaths per 100,000 live births in some poor countries.

NORWAY SMASHES THE GLASS CEILING

This story was printed from TODAY online 500 listed firms told to install women on their boards within two years

Tuesday · January 10, 2006

LONDON • The 500 companies listed on Norway's stock exchange face being shut down unless they install women on their boards over the next two years in a radical initiative imposed by a government determined to help women break through the glass ceiling. After a week in which the Equal Opportunities Commission in Britain warned that it would take 40 years for women to break into the ranks of the FTSE 100 in the same way as men, Norwegian companies face a two-year deadline to ensure that women hold 40 per cent of the seats of each company listed on the Oslo bourse. The requirement came into effect at the start of this year after companies were given two years to embrace the demands voluntarily, following the passing of the law in 2003. Stateowned companies are already obliged to comply and now have 45-per-cent female representation on their boards.

The failure of companies to act • about half of the listed companies are estimated to have no women on their boards • has prompted the Norwegian equality minister, Ms Karita Bekkemellem, to take the draconian step of threatening firms with closure.

"I want to put in place a system of sanctions that will allow the closure of firms," she said. "I do not want to wait another 20 or 30 years for men with enough intelligence to finally appoint women. "More than half of the people who have a business education today are women. It is wrong for companies not to use them. They should be represented."

ICA Message on the occasion of International Women's Day, 8 March 2006

The theme "women in decision-making" chosen at international level to celebrate the 2006 International Women's Day is a good occasion to assess the progress made, and set out the path ahead, in line with the commitments taken, to accomplish true and sound gender equality at all levels, including in decision-making.

According to global data, despite much recorded progress and numerous policy commitments, women's representation needs to be strengthened at all levels of decision-making. The empowerment of women is at the centre of the Millennium Development Goals which are so important to the ICA and the Global Campaign against Poverty; women and men sharing equally in decision making is vital for democracy, peace and development.

Women all over the world create and join co-operatives. Through them millions of women have been able to raise their living standards and "co-operate out of poverty". They contribute to the development and cohesion of their communities and local and national economies, both developed and developing.

The International Co-operative Alliance (ICA) promotes gender equality: it is specifically noted as one of its fundamental organisational aims. Training of Trainers on Women Leadership

ANGKASA provides various program and courses to increase the participation of women members in the Malaysian cooperative movement. Besides the Women in Leadership Skills course and the TCM Childcare Training Institute, ANGKASA also offers Training of Trainers workshops throughout Malaysia.

A two day Training of Trainers workshop focusing on women leadership in the co-operative movement was recently held in Selangor on the 22^{nd} to 23^{rd} March, 2006 and in Trengganu on the 6^{th} to 7^{th} of April, 2006.

Some 29 women co-operators from 18 co-operatives attended the Selangor workshop whilst the Trengganu program had 32 participants from 17 co-operatives.

The ToT workshop was organised by ANGKASA and facilitated by Dr. Paul Sinnappan, an international resource consultant on the development of women in co-operatives.

The program was activity based to encourage participants to express and assert themselves, to make effective decisions and to learn about their rights as co-operators. The course focused on the methods and tools available to the participants to improve their skills and knowledge as quality leaders within their co-operatives.

Dr. Sinnappan also addressed the issue of gender equality in cooperatives. He advised the participants to create a plan to address the issue which could be implemented at the grassroots level of their respective co-operatives.

The next ToT on Women Leadership is scheduled to be held in Kedah and Melaka in June 2006.

National Co-operative Organisation of Malaysia Open for discussion

Women of Malaysia, the United Nations is listening to you. As two Malaysian delegations prepare to meet a panel of experts on women's issues at the UN headquarters, LEE TSE LING explains the significance of our government's choice to go with a rather special Convention 11 years ago.

EVERY woman has probably felt this niggling bit of paranoia: somewhere, someone is talking about me. And in this case, it's not only true, but downright comforting to know.

Later this month, on May 24 to be exact, representatives from the Ministry of Women, Family and Community Development will head for the UN headquarters in New York to speak on behalf of women in Malaysia at the 35th session of the Convention on the Elimination of All Forms of Discrimination against Women (Cedaw).

The Cedaw (pronounced: "see-daw") is an international treaty that defines what constitutes discrimination against women and provides guidelines for national action to end it.

This will be the very first Malaysian presence at a Cedaw session, 11 years after our government ratified the Cedaw in 1995, and two years after they submitted their first report in 2004.

There, the government delegation will discuss the status of women in all aspects of Malaysian life (as documented in their 2004 report) with the UN Committee on the Elimination of Discrimination against Women as part of the country's review process.

This in itself is a considerable achievement for the country, and a clear demonstration of the government's continued support for the rights of women in Malaysia.

Even more laudable is the fact that they won't be in New York alone. Two days before their review session, six representatives from local women's rights groups are scheduled to present their Shadow Report which "shadows" the government report to the same UN Committee.

Forming the Shadow delegation are Dr Hamidah Karim from the National Council of Women's Organisations (NCWO); Ivy Josiah, Vizla Kumaresan and Meera Samanther from the Women's Aid Organisation (WAO); Zaitun Kasim from Sisters in Islam (SIS); and Zarizana Abdul Aziz from the Women's Centre for Change (WCC).

The Shadow Report is a Cedaw reporting mechanism that allows non-governmental organisations in member countries to

comment on their government's reports, identifying discrepancies and/or filling in gaps where necessary.

Needless to say, our first Shadow Report could not have been produced in the absence of a healthy population of women's rights activists in the country, and assistance from groups like the International Women's Rights Action Watch, Asia Pacific, through whose *Global to Local* programme the Shadow delegation were trained in Cedaw procedures.

And yet it is vital that such reports are researched and published because it provides an alternative snapshot of the faces of women in Malaysia, highlighting issues that may be underexposed in the government report, having been deemed "sensitive" or "controversial" by the government.

The significance of this, according to Josiah, executive director of WAO, is that there is added pressure on the government to be accountable in manner of a checks and balances system where an entity is prevented from having too much power within a group.

"And we all know the importance of this mechanism in civil society," she said at the public briefing to highlight how Cedaw works, its significance, and the four critical issues that will be presented by the Shadow delegation to the UN Committee at the 35th Cedaw session.

Once both delegations return from New York, their work will be far from over. Following each country review, the UN Committee issues its concluding comments which can be used both by governments to take action domestically, and by women's rights groups to lobby governments to do so.

As Zaitun puts it, "It will be up to the groups to pick up on the concluding comments from the session and run with them."

Zaitun and her fellow activists are keenly aware that ratifying a treaty is one thing, but implementing and all that it entails from ensuring legislation is in concordance with its articles to ensuring your citizens are gender-sensitised is another.

"Treaties ratified by the government do not automatically become the law of the land. They still need to be enacted into domestic law," says Dr Hamidah.

And therein lies the significance of the Malaysian presence at the Cedaw session. It means there is another level of international authority women in Malaysia can refer to, another platform where injustices can be heard, and another forum in which such injustices can begin to be resolved.

SINGAPORE'S CO-OPERATIVE REPORT

1. SINGAPORE NATIONAL CO-OPERTIVE FEDERATION

The Singapore National Co-operative Federation Lt. or the SNCF is the apex body representing the co-operative movement in Singapore.

2. MEMBERSHIP

The Singapore movement has more than 1.4million individual members from 83 co-operative societies, of which 73 are affiliated to SNCF. Total population is 4 million.

3. WOMEN'S PARTICIPATION IN CO-OPERATIVE

Women make up more than half of the 1.4million co-operative members in Singapore. However at the leadership and decision-making level in the co-operative, only 25% hold position of managerial or professional and above.

In Singapore, regardless of gender, everyone share the responsibility and the work of building our nation and the benefits. It is in keeping with this formula that the co-operative movement has maintained it relevance in Singapore.

4. SINGAPAORE'S REPORT ON WOMEN'S STATUS

The development of women in the co-operatives is very much in line with the general development of women in Singapore.

According to the Report on Labour Force in Singapore, women participation in labour force increased from 51 percent to 54 percent. Dual income households rose from 37 percent to 45 percent over the same period. Among full-time workers, the median monthly income of men was \$2,217 compared with \$1,625 for women. Hence women earned about 73 percent of what males earn.

Occupational upgrading of women has been significant after 2000, as compared to 1990, 53 percent of women in the 25 to 34 age group took up managerial, professional and technical posts. This is a significant increase from 27 percent in 1980. Similarly, for women in the 35 to 44 age group, there was also a percentage increase of female managers, professional and technicians over the 10-year period.

5. GOVERNMENT'S POLICIES RELATING TO WOMEN

- a. Singapore has adopted an equal opportunity policy based on the principles of meritocracy. This principle encourages both women and men to do their best in all sectors. Singapore women have equal access to basic social services, including educational and health.
- The government recognizes the challenges men and women face in fulfilling their responsibilities at home and at work. For this reason the Ministry of Community

Development, Youth and Sports, together with other Ministries and National Trade Union congress, provides a comprehensive range of family services such as child care centres, student care centres and family service centre etc.

In this respect, the co-operative have also been very forthcoming in the promotion of practices to promote work life harmony at workplaces.

6. RECENT DEVELOPMENT OVER LAST 2 YEARS

- a. No of women in parliament has increased markedly from 5 to 11 (100%)
- Singapore introduced "Married Women's cost Relief".
 The objective of this tax relief is to encourage women to continue working after marriage.
- c. The government has removed the quota on the number of women entering medical faculty.
- d. The government has changed its policy to grant citizenship to children born outside of Singapore to a Singaporean mother and non-citizen father.
- e. Introduced a cost of benefit for working and non-working mother to encourage families to have more children e.g. baby bonus, 3months maternity leave etc.
- f. Singapore women today have enjoyed better social status. However, more can be done to encourage women to participate actively and lead in their respective workplace, co-operative and community.
- g. 3 years ago only 9% of the women co-operators have participated in co-operative movement programmes. Since we started to organise yearly workshop/seminar with the total of 3 events per year for women, the number of women participation from co-operative have increased to 24%/

Dr Low Guat Tin, Associate Professor in Policy and Leadership Studies, National Institute of Education was the guest speaker at this half-day workshop.

The workshop offered women co-operators an opportunity to network as well as to develop a unique leadership style that is adaptable to their co-operative and will enable them to

exercise influence over their members. The workshop also aimed to equip participants' with self- confidence to face leadership challenges.

In her welcome speech, Ms Goh Ming Huay quoted former US President Richard Nixon who said "People are persuaded by reason, but they're moved by emotion" She added that "the leader must both persuade them and move them. The manager thinks of today and tomorrow. The leader must think of the day after tomorrow". Ms Goh also stressed the importance of training and highlighted that leadership training can provide a wide array of valuable resources to current and future leaders in the co-operative movement.

Mr. Zulkifli Mohammed, Chief Executive of Singapore National Co-operative Federation in his opening speech urged the Women's Programme Committee to assist in educating young co-operators about gender issues and promote awareness of the need and importance for women to be in leadership and decision-making roles as well as to establish a network of women leaders in the primary level. He stated that this would help to highlight the women's agenda (empowerment of women, support for carrying out multiple roles, equitable sharing of power in co-operatives) to the co-operative movement, build solidarity at all levels, build consensus on common issues and exercise influence on decision making processes in co-operatives at all levels.



ICA AP workshop on HIV/AIDS awareness for cooperative Leaders

CO-OPERATIVE FIGHTING AGAINST HIV/AIDS

The ICAAP initiative to protect the co-operative community against the major challenge of HIV/AIDS resulted into implementation of a comprehensive and sustainable project on prevention of HIV/AIDS and other sexually transmitted infections through education and training for cooperatives in India. The project is started in India first because of all the countries in the region, India is said to have the largest burden of about 5 million infections. It's being implemented in 4 states of India.

The objective of the project is:

- Sensitization of cooperative leaders/managers and increasing the knowledge and awareness of cooperative trainers and project staff of the cooperative set upAbout prevention of HIV/AIDS and other STDs through education and training. Pronounced commitment from co-operative leadership and managers of all co-operatives to bring out required facilities for spread of preventive education to reduce risk of HIV/AIDS among the co-operators
- 2. Increasing the training capacity and capability of cooperative training staff in imparting knowledge and skills of training on prevention of HIV/AIDS and other STDs. The expected outcome is Capacity building and skill development of 60 co-operative trainers in each state and 240 in all who will act as master trainers and will facilitate Creating network of trainers and will disseminate information among co-operative members.

So far 4 sensitisation workshops for cooperative leaders have been organized. 50 cooperative leaders of primary coops in each state participated. Contents of the workshop are;

Ice breaking and Expectations from the work shop
Basics of HIV/AIDS, it's impact on the society and ongoing
programmes for prevention and cure of the disease

Prevalence of HIV/AIDS in Thailand as workplace issue and need for action on part of co-operative institutions, HIV risk behaviour and assessment, Need for creation of political Will, Interface with Person Living with HIV/AIDS, Developing Strategy for prevention of HIV/AIDS. With Specific Objectives To enhance the knowledge level of the participants on HIV/AIDS

To discuss the prevention modes

To clarify attitudes towards HIV

To clarify myths and misconceptions, To discuss the extent of HIV/AIDS Problem in the country

To familiarize participants to the facts that make HIV/AIDS a work place issue

To discuss how co-operatives can be effective tools for prevention of HIV/AIDS in the co-op community as well as in the society, To discuss various risk behaviour that pose a risk of HIV Transmission.

To sensitise participants about role of counseling in risk assessment and reduction

130 women and men cooperators and gender advocates representing cooperative organizations from Asia and the Pacific countries India, Indonesia, Israel, Japan, Korea, Lao PDR, Malaysia, Myanmar, Philippines, Singapore, Thailand and Vietnam and one from Italy gathered from 6-8 November 2006 for the "Regional Conference on Gender Integration in Cooperatives: 10 years Before and After (Empowerment and development of Women in Cooperatives)"in Tataytay City, Philippines. The theme of the conference is Empowerment and development of women in co-operatives. Speakers from ILO, FAO, ICA GEC and Cooperative Development Board of Philippines deliberated upon the themes and sub themes. The speakers shared how the efforts of co-operatives in poverty reduction are strengthened and made even more possible by involving the women, by helping them in their empowerment and development. The conscious inclusion of women and their concerns in the various processes of the co-operatives, including decision-making and leadership, is tapping half the

potential, talent, strength, and experience pool of the cooperatives that are needed for their growth and progress, and effective and timely implementation of programs and services for the members and the community, as a whole.

In addition to 6 strategies of Tagaytay-97 the conference adopted the following additional four strategies:

- Enterprise development for women as a strategy for poverty reduction.
- Development of monitoring and evaluation tools and indicators

And also to improve and expand our initiatives in the following areas:

 Promotion of transformative leadership that is development oriented, issue focused and gender sensitive.

- 2. Personal, professional and leadership capacity building of women
- 3. Documentation of successful cases for replication
- 4. Collection and analysis of sex-disaggregated data
- Availability of funds for empowerment and development of women
- 6. Development of successor generation program
- 7. Gender responsive legislation
- 8. Use of ICT in reducing the gender divide.

The meeting was held to discuss planning and arrangements of next day's conference. Besides, work plan for 2007 was also discussed.

Training of Trainers (TOT) for leadership Development of Women in Cooperatives 4-7 December, 2006 Hanoi, Vietnam

The ILO-Coop Net and ICA ROAP have developed a training manual for leadership development of women in cooperatives in the Asia Pacific region. The manual is being used for training of trainers of cooperatives who in turn will train the women cooperative leaders. The ICA AP is conducting trainings for women and men trainers of primary, secondary and tertiary cooperatives whose role and task is to conduct training activities on gender sensitivity and accountability and on leadership

capacity building of women in cooperatives.

During past 4 years, we have conducted 4 Regional TOT in 4 different countries in the region and trained over 100 trainers. The objective of the TOT is to multiply trainers so that a team of trainers could be generated who in turn train the women cooperative leaders at grass-root/primary level.

Therefore, it is decided that after regional TOT, national TOT should be conducted in the ICAAP member countries who have

already participated in Regional TOT. Therefore, first National TOT in Sri Lanka has been held last year and 30 trainers were trained.

This year the national TOT was held in Vietnam from 4-7 December, 2006 hosted by VCA at the Vietnam Institute for Small Enterprise and Cooperatives (VISEC). 20 local trainers, both men and women from different part of Vietnam cooperatives attended the training. The ICAAP provided technical support and resource person to coordinate and conduct the training. Different training tools and methods were adopted to conduct the training such as role play, games, question answers and group discussions. A wide range of topics

i.e. gender analysis, gender socialization process, nature values and concept of cooperatives, ICA statement of identity, Coop law, By-laws and policies, gender issues in coops, removing barriers in empowering women, functional training for women leaders such as planning, budget, evaluation and monitoring, financial management, enterprise management, qualities of effective coop leaders, leadership styles, communication, decision making net working and lobbying etc. have been covered during the training. At the end of the training, the participants were asked to prepare a plan that how they plan to make their own coop gender responsive and how they will utilize these training skills in their own trainings.

This is story of a successful women cooperative in Vietnam. I personally visited this cooperative at the end of the TOT for leadership development of women in cooperative in Vietnam. There are 38 members in the cooperative, 94% of them are women. Share of per member is 3millon Vietnamese Dong.

There is an 8 member Board out of which 7 members are women and only one male member.

The Ha Lacquer and Incrustation Cooperative is located in Chuyen My Commune Phu Xuyen, District HA TAY. It was established in 1960. There are 105 employees working and 38 labourers. The cooperative is running 3 training classes for 139 children out of which 39 boys and 32 women. The training started in 1996.

The Chairperson of the cooperative is Ms. Nguyen Thi Vui. She informed that volume of the business of the cooperative is about 1.5 million DONG yearly and profit is 8%. Besides board members there is one chief accountant employed by the coop to take care of the business activities of the cooperative. The economic activity of the coop is handicraft making, marketing and export and training. Under their social programme, they have been arranging vocational training programme for women, boys and handicapped children. This training programme is supported by national and international donors. They provide residential facilities for handicapped children.

This cooperative is member of HATAY Province Cooperative which in turn is a member of Vietnam Co-operative Alliance (VCA).

WOMEN & HIV/AIDS

Geeta Rao Gupta(ICRW) said in Washington on June 2, 2005 that it is a cruel paradox that in many developing countries, women who have complied with their expected gender rolesthey have married early, become mothers and remained faithful to their spouses- are becoming infected with HIV. It is this paradox of low risk yet high HIV vulnerability that underlies the large number of new infections among women in countries as diverse as Thailand, India, Kenya and Zambia. The experience of these women reveals that marriage does not provide protection from HIV risk, especially when the age of the husband in five years or more than that of the wife. Data from Kenya and Zambia show that HIV infection levels among married girls aged 15 to 19 were 10 percent higher than for unmarried sexually active girls of the same age. This because men are typically older than their brides, and are therefore more likely to have had other sexual partners before marriage, increasing the probability that they have been exposed to HIV. Also, in marriage, condoms do not serve as a viable protection option because they do not permit new married couples to meet the most desired goal of marriage to bear a child. And many married women lack the ability to negotiate condom use with their husbands out of fear of violence or other repercussions because the talk of condoms typically raises questions about trust and fidelity. These realities about the HIV risk within marriage are all the more important to understand given that 51 million adolescent girls worldwide are currently married, and in the next 10 years 100 million more young girls will marry before they are adults.

Therefore, women in cooperatives need to build their capacity to fight against HIV/AIDS.

Thus, ICA AP incollaboration with NCUI launched an HIV/AIDS awareness and prevention programme for cooperatives in India. 120 Women cooperative trainers of state of Bihar, Gujarat, Uttar Pradesh and Andhra Pradesh of India have been chosen to be trained through TOT on the subject so that they are able to disseminate information and spread awareness among women coop members and the community during their regular cooperative training and education classes.

The TOT for Women Cooperative Trainers conducted from September to December in these 4 states and a group of 30 women trainees in each state inclusive of women cooperative trainers, cooperative officers and lady mobilisers attended the programme and have been taught the skills for imparting correct and complete information about various aspects of HIV/AIDS. Training was designed for 5 days class room and one day study/exposure visit to a HIV/AIDS care and treatment centre. The 5 days curriculum covers issues: Why HIV/AIDS is an issue for cooperatives? Women and HIV/AIDS, Environment building, HIV and AIDS: General scenario, HIV/AIDS: basic knowledge, addressing concerns of HIV/AIDS and training skills. 3 women trainers who are specialized in training on the subject conducted the training



The Tagaytay + 10 DECLARATIONS, 2006

We:

Women and men co-operators and gender advocates representing co-operative organizations from Asia and the Pacific (India, Indonesia, Israel, Japan, Korea, Lao P.D.R., Malaysia, Myanmar, Philippines, Singapore, Thailand, and Vietnam) and the Chairperson - ICA Global Gender Equality Committee who gathered on 6-8 November 2006 for the "Regional Conference on Gender Integration in

Co-operatives: 10 Years Before and After (Empowerment and Development of Women in Co-operatives)" in Tagaytay City, Philippines

Note the diverse context in which our co-operatives operate as well as acknowledge the diversity of women and men served by our co-operatives

Recognize that significant gains have been achieved in the past decade, notwithstanding the uneven results in implementing the strategies identified in the 1997 Platform of Action, to increase women's quality participation in leadership and decision-making as well as mainstream gender in cooperatives

Are aware that barriers and challenges persist to women's full and active participation in co-operatives and that globalization has brought forth new and more serious forms of poverty and inequalities among women and men

Strongly challenge co-operatives to live up to their values and principles of democracy, equity and equality, and to their nature as instruments for poverty alleviation

We sustain our commitment:

Taking note of our achievement and gaps of previous actions from Tagaytay 1997, and in order to increase the women's participation at all level of co-operatives, we propose the following strategies and actions to be implemented within a period of ten years from year 2006 to year 2016.

Strategy 1: Instituting gender responsive co-operative laws, by-laws and policies that promote increased women membership in co-operatives and participation in leadership and decision-making therein

The challenges of globalization and free trade are affecting lives of people unevenly across the world. The cooperatives worldwide are feeling the heat of unequal opportunities and threats created by the free market. As usual, this has intensified the existing inequalities and insecurities for many poors women. The high tech means of trade and business are tend to benefit rich than the poor. Women are a most likely to suffer more from the rapid changes societies are undergoing due to globalization and free trade.

In the context of the above challenges and the resolution of the ICA Co-operative Minister's Conference for exposure of women cooperators to success stories and networking for business development, the ICA Regional Women's Committee has been making attempts to share information with women cooperative leaders in the region and expected to find ways and means to

promote wamen's economic security and empowerment through the cooperatives. This programme is being organised by ICAAP every year in one of the member countries.

Objective of the programme

The objective of this program is to provide a common meeting ground to Asian cooperative women leaders/persons responsible for gender and women development in co-operatives for sharing information and experience about success stories and best practices of their co-operatives and most importantly help women to establish a network for mutual cooperation and business interest across the Asia & Pacific Region.

Expected outcome

- Establish contacts among women leaders/cooperative members and create network
- Collection of information and dissemination of best practices
- Identify mechanism to overcome factors that limit women's participation as organizer and decision maker
- Business information about products and services as well as know- how for women entrepreneurs
- Identify areas of mutual interest and collaboration.
- Based on the success of the programme, more such programme will be organized in future.

The Programme

This year the programme held in Pune India, from 12-14 Dec. 2007 in collaboration with national cooperative Union of India (NCUI). There were 10 participants, 7 women and 3 men from 4 countries, namely Bangladesh, Malaysia, Nepal and Srilanka. The 3 days programme was divided into 2 parts- Inaugural session and class room

interaction combined with information sharing of best practices from the participants' countries and visit to cooperatives. The resource persons, Assistant General Manager of National Agriculture and Rural Development Bank of India talked about cooperative and SHG Bank Linkage. Programme for entrepreneurship development and Ms. Bonani Dhar of UNIFEM made a presentation on "Sustainable entrepreneurship development for women in cooperatives". The ten participants represented eight different cooperatives in their respective countries and shared information about their work through power point presentation and discussions.

Second day - The group visited to a very successfull business organization Lizzat Papad factory which is operated by women. It is not registered under Co-

operative Act but functioning is on cooperative pattern i.e. collective effort and collective benefit.

In the afternoon the participants visited to Jija Mata Women Cooperative bank where majority of membership is of women and chairperson and several directors are also women. The bank has got 9 branches. There are total 19 board members out of which 11 are women. Women bank concept is popular and successful in India which is providing opportunity to women as service users, managers and leaders which they are being deprived of in mixed membership banks.

Third day, we visited 'AKLUJ' a cooperative village, promoted by cooperatives. The Co-operative village is housing a cooperative sugar factory, a spinning mill, co-operative milk dairy and cooperative consumer store. The whole village, more or less, is the member and service users of these cooperatives. The cooperatives are doing success full business and fulfilling the daily needs of the members along with providing employment and other social services such as schools for children, health care and farming inputs in way of training and education to farmers.

News from Members

NCF, Nepal

National Cooperative Federation of Nepal has successfully organized the Seminar on Gender Equality through Cooperatives on September 20, 2007 and 12th World Rural Women's Day on October 15, 2007 at Kathmandu, Nepal.

The seminar was inaugurated by the Hon'ble Parliament Member Mrs. Sujata Koirala. Total 45 participants, 27 women and 18 men were present. They represented cooperatives/unions from the primary levels to national levels, concerned stakeholders, Nari Chetana Kendra, Cooperatives Consulting Service and Japan International Cooperation Agency (JICA).

The Objective of the seminar is:

- a) To sensitize participants on gender equality in cooperatives,
- b) To educate participants about need of enhancing women participation in their cooperatives,
- c) To find out ways and means of increasing active participation of women at all levels of cooperatives.

Presentation on Gender Situation in Vietnam by VCA at RWC-2007

- About 18,000 cooperatives and 300,000 cooperative groups (pre-cooperatives) in Viet Nam.
- 30,000 female workers accounting for 50, 9% of the total workers in the cooperatives.
- The high rate of female workers in small industry and handicraft cooperatives (68, 5%), 47% in consumer and trading services and low rate in transportation, fishery, construction etc.
- Around 10% women involved in management or indirectly working in the cooperatives and the Unions and over 90% female labourers participate in certain parts of the whole business and production process.

- Only 4, 9% are chairman, vice chairman and chief inspectors.
- Education and technical levels of women are lower than that of men
- Number of female workers graduated at the high schools above accounting for 15, 4%; around 4, 5% of female labourers have the college and university graduation in the cooperative sector.
- Propaganda and raise awareness on the laws and policies on gender equality, roles and rights of women in the cooperative sector.
- Eliminate the feudalism thoughts and low evaluation on the potentials of female workers, not facilitate them to join in the activities and decision making process.
- Emulate the good examples as chairwomen, directors and managers in directing the production and business activities.
- Implement the training, vocational training for female labourers in the cooperatives in short and long term courses.
- Encourage women to take the high positions in the cooperatives and in the unions so that they are self believable and independent.

The ICA AP-CLT National Trainers Training Programme for "Management Capacity Building of Women for Gender Integration and Co-operative Development" was held from 7-. 11 January 2008 at CLT Training Centre in Bangkok. 28 women co-operative leaders and managers from all over the country attended 4 days programme. Mrs. Savitri Singh, Adviser Gender Programme of ICAAP was the main resource person and conducted training on gender mainstreaming issue in cooperatives and entrepreneurship and leadership development of women.

This training workshop aims to assist cooperative leaders/ trainers of Asia Pacific to:

- 1. Raise the awareness of women and men leaders and members of cooperatives on gender issues, on the manifestations of gender bias (against women) in cooperatives, and on the effects of gender discrimination on the personal and interpersonal growth of its leaders and members as well as on the organizational development of cooperatives.
- 2. Build up the capacity of current and potential women leaders of cooperatives by equipping them with knowledge

and skills on the following:

- Nature of Cooperatives
- Effective and gender-responsive leadership
- Cooperative Enterprise Management
- · Coping with challenges; and
- Personal Development

ICA Message on International Women's Day, 8 March 2008

"Investing in Women for Co-operative Success"

Increasing evidence shows that gender inequality is simply bad economics. Investment in gender equality and women's empowerment is therefore vital for improving economic, social and political conditions. Further, it has a multiplier effect on productivity, efficiency and sustained economic growth according to the United Nations.

It is for this reason that the 2008 theme of International Women's Day focuses on the need to invest in women and girls and calls on actions to increase resources for gender equality and women's empowerment.

Investing in women and girls means not only making financial commitments to build capacity and implement gender sensitive programme and policies, but also to take a leadership role in ensuring gender equality progress. It means taking practical actions to remove barriers and create opportunities for women's empowerment and professional growth. It also means addressing the issue of young women and ensuring that they find co-operative services relevant; that they find value in joining or forming their own co-operatives and that they consider participation in co-operative democracy rewarding and worthwhile. We are reminded too that the larger youth issue is of significant importance to the success of the co-operative movement. One person in eight is a girl or young woman age 10-24 and so co-operative education for girls and young women, and gender awareness for all are essential for the continued success of the movement.

- ❖ Educated girls contribute to increased economic productivity and improved family nutrition: for every year a girl goes to school beyond the fourth grade, her wages rise 20% and her family size drops by 20%
- A job given to a woman means support for the entire family
- Empowered women are agents for the common good and uplift the well-being of the human family overall
- Women who are empowered to make decisions strengthen family healthcare, reduce the spread of HIV/AIDS and promote long-lasting peace.

So in celebrating International Women's Day, co-operatives are called to assess their budgets to see what proportion of financial resources are allocated to activities to promote gender equality, to seek additional resources for new and existing gender programmes, to keep gender balance in mind when recruiting staff and electing leadership, and to address the issue of young women and girls and their participation in the co-operative movement.

The ICA and its Gender Equality Committee are convinced that

the co-operative movement has a significant role in making investments of all types to promote gender equality and that we can make a difference.

Let us not forget that progress for women is progress for all.

Several states in India have already introduced certain percentage of reservation for women at leadership level but Gujarat State has not introduced any such provision as yet. The participants impressed upon the Agriculture and Co-operation Minister for reservations. He promised to look into the matter and help.

The conference provided opportunity to many village and small town women to travel to the capital city and meet up with many co-operative women from other parts of the state. It was a great platform for sharing and networking.

Initiating participation and sharing views through a platform like this is of immense value in building up better understanding about the issues and forming strategy for improvement and change.

Hope that participant have found ideas/information useful and will make use of experiences gained during this conference for networking and exploring possibility of partnership and collaborations in future.

WOMEN'S EMPOWERMENT KEY TO ACHIEVING MILLENNIUM SUMMIT ANTI-POVERTY GOALS,

If the Millennium Goals of socio, economic and political empowerment of all the human beings are to be achieved in the envisaged time frame, then it is imperative to enable the full participation of women in this endeavour. Women constitute more than half of humankind. They are, without exception, in all cultures, the predominant communicators and caregivers. Hence the importance of their role in fostering a culture of peace and harmony amongst peoples, a culture of gender equality, a culture of sustaining the environment, a culture of mutual support across families, communities, and nations. Women and children represent 70 per cent of the world's poor and two thirds of the world's illiterate population not to mention that 80 per cent of the world's refugees and displaced persons are also women and children.

If the number of victims of extreme poverty and hunger is to be halved by the year 2015, then women have to be empowered to achieve this goal for themselves and their families. It is recognized that when we educate a woman we educate a multitude, when we educate a man we educate one individual. Because of the traditional gender division of labour in all societies, where the male head of the family is expected to provide the economic means for the family, and the women are left at home to give birth to children and care for the daily needs of the family, women then become the main channel of communication with the baby from the moment of its birth. Therefore, their impact and influence can be decisive in fostering new attitudes in their sons and daughters, attitudes of living in peace and harmony with diverse racial and religious cultures, fostering mutual respect in gender equality, for the environment, for prevention of diseases through safe water and sanitation habits, and so on. Women's role as communicators is also enhanced by virtue of the fact that most of the teachers around the world are women. If women are educated and empowered, together with their male partners, they will constitute a mighty force to combat hunger, poverty, disease and environmental degradation. The inclusion of women in development is, therefore, indispensable.

For prosperity to flourish, we need peace and security. Women of all cultures know the deep pain of losing their beloved fathers, husbands and sons in armed conflict and wars. They would be harbingers of peace if allowed and empowered to participate in peace negotiating, peace building, peace-keeping and conflict prevention activities, in other words building and promoting a culture of peace.

The economic empowerment of women is a fundamental step towards the eradication of poverty. Micro-credit schemes that benefit women are yielding dividends around the world. The concept of micro-credit was an initiative of Professor Muhammad Yunnus of Bangladesh. Through lending women small amounts of cash without collateral, and the ensuing success of the loan repayments, he revolutionized the concept of rural economic and social development, coupling capitalism

with social responsibility. The concept of micro-credit is being copied in 52 countries and the multilateral agencies are supporting micro-credit projects around the world at the grassroots level.

Political empowerment of women has also yielded positive results wherever they have the opportunity to participate in decision making. To cite one example, the Panchayat system in India, (local bodies at the village level that are meant to ensure people's participation), which has always existed though dominated by male members, now has a minimum of 30 per cent women constituents due to an amendment to the Constitution of India, providing for one third of the seats to be reserved for women. This has allowed women to use their empowerment in, for instance, improving local water and sanitation systems and educational facilities for the children in their villages, thus fostering sustainable development at the grassroots level.

The potential of information and communications technologies for advancement and empowerment of women is unlimited and should be tapped through training and capacity building.

There are many players and stakeholders in the aim to reach the Millennium Goals. Apart from the efforts of the United Nations family of organizations, multilateral organizations and civil society, the positive role of women also depends on the supportive attitudes of the local family unit, the local community in each village, in each town. In financing for development, the governments should promote participation of women in the allocation of aid. I would like to take this opportunity to pay tribute to all of the organizations and individuals for their tireless and sustained efforts to promote gender equality and thus enhance the chances of attaining the Millennium Goals for a better world for all.


Dr. Suvedi, a member of Parliament from Nepal, Mr Deepak Baskota, Chairman of National Cooperative Federation of Nepal (NCF),

Following topics were covered by the resource persons during 5 days class room programme:

- 1. Concept, rational, constraints and opportunities
- 2. Basic principles of capacity building
- 3. Understanding Gender
- 4. Gender mainstreaming in co-operatives
- 5. Situation of women and UNIFEM Programmes for gender mainstreaming in Nepal
- 6. Various aspects of management of co-operatives with special reference to the various kinds of co-operatives
- 7. Enterprise development- Role of Manager and Managing Committee
- 8. Decision-making capacity

As mainstreaming of HIV/AIDS in co-operative education and training is one of the focused area of the ICA-AP, a separate session on the topic was conducted by the expert from ILO. As a moderator, Savitri Singh explained why HIV/AIDS is an issue for co-operatives. Following issues have been covered during the session:

- 1. Basics of HIV/AIDS, it's impact on the society and ongoing programmes for prevention and cure of the disease

- 3. HIV/AIDS risk behaviour and assessment

WTO, Trade and Gender

The United Nations Conference on Trade and Development (UNCTAD) India Programme, New Delhi has organising an International Seminar on "Moving Towards Gender Sensitisation of Trade Policy" in New Delhi on 25-27 February 2008. Dr. Supachai Panitchpakdi, Secretary- General of UNCTAD inaugurated the seminar. UNCTAD India Programme on "Strategies and Preparedness for Trade and Globalization in India" is a joint trade related capacity building project of DFID (Government of UK), Department of Commerce (Government of India) and UNCTAD.

The seminar provided a forum to international trade and gender experts, policy makers, academia and civil society to discuss gender concerns in the context of trade liberalization. Recent research undertaken by UNCTAD India Programme and evidences from other countries reveal that women are important stakeholders in the process of trade liberalisation. This must be recognized and harnessed by the Government as part of the broad trade-policy formulation for integrating women into the international trading system. The results of globalization need to be made more gender equitable. Gender sensitization of trade policy needs to be taken seriously at the international level so that appropriate support measures can be provided to increase opportunities for integrating the gender dimensions into trade more effectively.

The primary objective of the seminar is to sensitize stakeholders, policy makers and trade experts about trade and gender linkages. It is hoped that insights emerging from the seminar will have an impact on trade policy formulation and it becomes sensitive to gender concerns.

Savitri Singh from ICA was invited to participate. The issues of women in traditional sectors such as agriculture, weaving, dairy and fisheries were discussed at length. Savitri Singh raised the concern for women in co-operative business in India and in other Asian countries. The huge population involved in co-operatives, in general, and women in particular are ignored by such forums. The seminar took note of the concerns of rural and urban women in co-operatives business and included in the preliminary report/ observation of the seminar.

Gender statistics from India

I just came across The World Economic Forum's Gender Gap Report 2007 and a UNIFEM India supported SAARC database which prompted me to share this with you.

The Indian economy is booming, women's education, employment and income opportunities are increasing yet as per The World Economic Forum's Gender Gap Report 2007, among Asia and Oceania countries, it continues holding one of the lowest ranking -114. It performed very poorly on the economic, education and health sub indexes but relatively good performance on political empowerment ranking-21st. The report further says that over all labour participation of women in the country is 36% in comparison to men which is 84%. Only 3% women are senior officials and managers but 97% are men.

Women literacy rate is only 48% and over all sex ratio (male/female) is 1.06.

Women in India provide up to 90% of labour for rice cultivation, dairy and other farm related work but less than 10% women farmer own land, - by Savitri Singh

Absence of women from leadership positions undermines democracy, Commission on status of women told

Commission on the Status of Women Fiftieth Session 4th & 5th Meetings (AM & PM) Panel Discussions Focus on Ways To Enhance Women's Participation in Development, Decision-Making

The absence of women from political life and leadership positions undermined democracy and women's empowerment, the Commission on the Status of Women heard during discussions on the enhanced participation of women in development and on the equal participation of women in decision-making processes - the two substantive themes of the 45-member body's fiftieth session.

Chaired by Commission Vice-Chairperson Dicky Komar (Indonesia), a morning panel discussion focused on the need to create a more conducive environment that fully enabled women to participate in development. He noted that the 2005 World Summit reaffirmed that gender equality was essential to advancing development and peace. Measures for enhanced education, health and work for women were among the strategic priorities identified.

Stressing that education of women still lagged behind that of men, Bernadette Lahai, Member of Sierra Leone's Parliamentary Committee on Agriculture and Food Security, noted that women were more likely to be illiterate than men, and girls were less likely to access schooling than boys. No country could develop if it failed to tap women's talent for full participation in society. It had been generally found that the returns to educating women were higher than those of men; hence the adage, "If you educate a man, you educate an individual, but if you educate a woman, you educate the nation."

Evy Messell, Director, Bureau for Gender Equality, International Labour Organization (ILO), noted that combating gender inequalities in the world of work called for equal access to social protection. An enabling environment would be created by extending national social security systems more widely. The ILO firmly believed that action to strengthen the capacities of its tripartite constituents - Governments and employers' and workers' organizations -- to promote positive change for gender equality hinged on men's and women's equal participation in meaningful social dialogue. Social dialogue also meant creating partnerships and networks with local and national women's associations. Organization was an essential tool for women to gain confidence, increase their representation and acquire a voice in local, national and international employment policymaking.

Opening the afternoon panel on the equal participation of women and men in decision-making, Commission Vice-Chairperson Szilvia Szabo (Hungary) said equal access to decision-making and leadership at all levels was a necessary precondition for the proper functioning of democracy. Equal participation in political affairs made Governments more representative, accountable and transparent. It also ensured that the interests of women were taken into account in

policymaking. Women, however, had traditionally been excluded from decision-making processes.

Since the Fourth World Conference on Women in 1995, women's visibility in public life had grown, she continued. In 1995, women represented 11.3 per cent of all legislators. In 2006, they represented 16.3 per cent -- the highest percentage in history. More women judges had been appointed and more women had reached the highest executive positions in public and private companies. At the same time, persistent barriers to women's entry into positions of decision-making persisted, and equitable participation remained a challenge.

Nesreen Barwari, Minister of Municipalities and Public Works of Iraq, noted that the real reason women should be engaged in politics at all levels was not to emulate men, but to bring a unique feminine perspective to bear on the decision-making process. The human right to full and equal participation in power and decision-making included, among other things, the right to participate on equal terms with men in shaping and implementing decisions and policies affecting them, their families, communities and societies. Also, the presence of women in the halls of power was not sufficient. That was mere tokenism. What mattered was the effect of that presence.

The Secretary-General of the Inter-Parliamentary Union (IPU), Anders B. Johnsson, said the achievement of democracy required a balanced participation of men and women in politics. One could not talk about democracy when half of a country's population did not participate in its work. The IPU had been tracking the numbers of women in national parliaments since 1970. Ten years ago, Sweden had led the pack, but today, Rwanda, a developing country, had the highest proportion of women in its national assembly, some 48.8 per cent. He added that the critical mass the Beijing Platform had asked for -- 30 per cent - would not be reached until 2025, and parity would not be reached until 2040.

We should take this time of crises as advantage for preparation of safeguard mechanism to avoid future crises. We, the women of Asia Pacific, in solidarity with women in Americas and Africa and Europe appeal to the cooperative institutions to take lessons from this crises and strengthen their capacity to help more and more people in need.

Women development and gender mainstreaming in cooperatives is one of the priority areas of ICA. We are very much concerned about low and negligible participation of women at all levels of cooperatives in the region i.e. 30% at membership and 8% at leadership and decision making. This is not a comfortable situation given the fact that 60-70 % of farming and food production work is done by women. Therefore, ICA AP is implementing a number of capacity building programme for the member cooperatives for gender mainstreaming and enhancing number and quality of women participation. Towards this endeavour, a skill development programme - "Management Capacity Building of Women for Co-operative Development" is being conducted regularly.

This year the programme was organized for the cooperative movement of Malaysia and held in Kuala

.umpur from 28 June to 3 July, 2009.




The resource persons were invited from the State AIDS Control Societies of the respective states.

ICA has organised a training on "Capacity Building of Women Co-operative Leaders for Entrepreneurship development" for the women cooperative leaders and extension staff of Ministry of Agriculture of Laos. The training was held from 21-25 December, 2009 in Vientiane City.

Mr.Latsanivong Amarathithada, Director General, Department of Agriculture and Forestry of Vientiane Capital and National Assembly Member of Laos delivered opening address and Savitri Singh, Adviser-Gender Programme of ICAAP addressed the participants and gave brief introduction of the programme. "Equal rights, equal opportunities: Progress for all"

This year the United Nations focuses attention on the fact that the respect of women's rights and the guarantee of opportunities leads to significant advances in social and economic development. Under the theme, "Equal rights, equal opportunities: Progress for all", International Women's Day underlines the need for governments, civil society, women'sorganisations, the private sector, the media, the entire UN system, and individual women and men to join forces in making important changes to policies, programmes, attitudes and behaviours to ensure that women fully participate in economic and social life.

Nearly every study that addresses the impact of women's participation in the economy concludes that gender equality is not only the right thing to do, it also makes good business sense. There are business studies showing that the higher percentage of women in decisionmaking positions, the more successful and efficient enterprises are. In times of economic stress, there is no business argument that can counter the value-added of investing in women.

Similarly development studies over and over show that investing in women

has a high return improving livelihoods, improving access to education for children and health for all, and reducing poverty in general terms, thus making an impact on overall national economic and social development.

In the co-operative movement, there are similar indications that women's participation leads to successful enterprises that fully serve the needs of all members and their families. Women are participating in co-operatives sometimes making up a very significant proportion of the membership and workforce as a recent ICA Gender Equality Committee survey is showing.

The evidence abounds for why it is in the interest of all to make women's rights and opportunities a priority and yet progress at all levels continues to be slow. Despite this, ICA and its Gender Equality Committee wish to underline the important contribution made by the worldwide co-operative movement in creating a culture of mutual respect and its commitment to democracy and participation. All over the world, co-operatives contribute to the challenge of gender equality by implementing at various levels gender equality policies and programmes, providing co-operators with awareness-rising, training and education, and decent work. Furthermore, co-operatives are promoting this model of business to women entrepreneurs who often find that this form of enterprise allows them the flexibility and alternative management structures that they seek – an efficient business model that takes into account their specific needs and that promote their socio-economic empowerment.

More action is nonetheless required. Co-operatives must intensify their efforts in improving gender equality in

Dame Pauline Green President International Co-operative Alliance (ICA) particular at this time of economic instability. Co-operative resilience can only be reinforced when programmes to ensure equal rights and equal opportunities for women and men are implemented, particularly at senior levels in our movement. On the one side, there is continued need to review national and co-operative policies and cooperative statutes and bye-laws to ensure that these do not constrain women's access to equal opportunities including the right to own land and other property. Innovative strategies are needed to promote changes in organisational culture, rules of procedure and working methods as well as address constraints related to lack of time (work-family balance), and lack of personal security.

There is also the need for attitude changes. Too often obstacles in the form of negative stereotypes about women's leadership potential continue to limit change and progress. Specific measures to encourage and support women's participation and enable them to seek and gain senior leadership positions should be enhanced, including management and leadership training, formalised mentorship programmes and sustainable financial support. On the 8th March 2010, International Women's Day, we call on ICA member organizations and co-operators, to review and reinforce their commitments, policies and programmes to make gender equality a reality.

Let us be leaders in assuring progress for all by taking important steps to booster women's rights and access to participation and leadership in co-operative enterprise. Let us begin by asking all our members to ensure that from this year onwards that their representative delegations are truly gender-balanced.

Dr. Chan Ho Choi, Regional Director of ICA-AP and Mr. Amano, Manager –JCCU has attended the meeting as special invitee and Mr. Yoshimitsu Nakamura, ICA-AP and Ms. Makiko Sakurai from JCCU have been present as observers.

The meeting was held to discuss important issues such as arrangements for forth coming Regional Women Committee

Meeting and Women Forum to be held in China in September this year. One of the important issues was review of Training programme. The usual business of the committee such as election of one vice chair, work plan 2011 etc. have also been discussed in the meeting.

Dr. Choi observed that RWC is one of the oldest active and educational committee of ICA-AP. that co-operatives can be inspired. ICA-AP is increasing sectoral and thematic committees. The women committee can intervene not only in consumer but also in other sectors, especially in agriculture, credit union and housing etc. We should develop new grass root strategy for women movement into co-operatives.

News from FAO on gender issues

Supporting Asia-Pacific agriculture with better data Access to agricultural land emerged as the numberone source of gender inequality in national gender profiles compiled for the first time ever in Cambodia, Lao People's Democratic Republic and Vietnam.

In Cambodia, female-headed households have access to about 21 percent less land than male-headed households, while in Lao PDR and Vietnam; they have 16 and 27 percent less land, respectively.

These details were among those included in profiles published after nearly one year of re-tabulation and analysis of existing government census data and other statistics. Technical and financial support for the initiative came from a strategic partnership between FAO and Sida, the Swedish International Development Cooperation Agency.

The initiative, Strengthening National Capacities for Sociallyand Sex-Disaggregated Data in Agriculture and Rural Development (SDD project), addressed the need for high quality, reliable statistical data gathered according to sex and age for the food and agriculture sector – data that could help the Asia-Pacific region to more effectively target agricultural and rural development policies and programmes.

The profiles showed that in Vietnam, less than a tenth of all commercial farms were owned by female-headed households. And in the mountain-plateau zone of

Cambodia, the average land size of female-headed households was up to 54 percent smaller than in male-headed households, leading female-headed households to produce up to 8 times less rice.

While the profiles looked closely at access to land, crops produced, access to equipment and other resources for use in farming, fisheries and forestry, some of the data also looked at a broader range of economic and social details that could provide information on gender in agricultural households. These areas included access to financial services; literacy and educational level; available technology and training; communication sources, and access to food, drinking water and sanitation.

The tables revealed gender inequalities in access to productive resources, as well as basic amenities and social services. In Laos, women had fewer alternative income and loan opportunities, spent a greater portion of their total expenditures on food purchases, and had less access to safe drinking water than men.

In Vietnam, statistics also showed a disparity in access to financial services. Proportionally fewer female-headed households accessed loans – 24 percent compared to 33 percent in male-headed households.

In Laos, 9 percent fewer women than men had completed primary school, while in Cambodia, the proportion of

educated males in agricultural households was 10 percent higher than that of female members.

The country profiles were created during the process of developing, testing and finalizing a Gender and Agricultural Statistics Framework (GASF), which is designed to guide both producers and users of statistics through a series of standard stages for producing sex-disaggregated data.

The stages include identification of gender and agriculture issues to investigate, the listing of relevant statistics or indicators, the identification of appropriate data sources, and the re-tabulation and analysis of existing data according to sex

GASF was designed to be used by countries worldwide and is compatible with the World Programme for the Census of

Agriculture (WCA) and FAO statistical frameworks like FAOSTAT and Country STAT. It draws on several existing frameworks and toolkits designed for gender and poverty analysis and the collection of agricultural statistics.

The GASF was developed in recognition of the multi-faceted approach needed in order to document women's roles in agriculture and gender disparities in access to productive resources.

Government ministries in Cambodia, Laos and Vietnam have indicated that they plan to incorporate the GASF in planning and analyzing the next round of agricultural censuses.

Global Open Day

Starting on 7 June 2010, the Global Open Day for Women and Peace will break new ground. Throughout June, in more than 20 post-conflict countries, senior UN officials are opening their doors to women peace activists and leaders. Special Representatives of the UN Secretary-General and other high-level officials will engage with women advocates to hear their concerns, and discuss how to increase women's participation in sustainable conflict resolution, peacemaking and peace building.

In a statement, UN Secretary-General Ban Ki-moon has

called the Global Open Day for Women and Peace an opportunity to "reinvigorate our efforts to realize the vision set out in resolution 1325." Recommendations from the meetings will be forwarded to the UN Security Council for it to consider in accelerating the resolution's implementation.

The Open Day is organized by the UN Department of Peacekeeping Operations (DPKO), the UN Department of Political Affairs (DPA), the United Nations Development Fund for Women (UNIFEM) and the UN Development Programme (UNDP).

ECOSOC 2010

Gender equality and the empowerment of women will be the main focus of attention when government ministers from across the world gather in New York on 28 June – 2 July for the annual high-level meeting of the UN Economic and Social Council (ECOSOC).

The programme has been organized by ICA-AP Gender Programme Division and was hosted by Central Organisation of Rural Co-operative (CORC) of Iran and Central Union of Rural and Agricultural Co-operatives of Iran (CURACI).

Men and Women Co-operative Leaders from 6 countries, namely- China, Malaysia, Nepal, Srilanka and India attended the programme. The cooperative members from Iran were also present. rural cooperative made a presentation on "Rural women cooperatives in Fars Province of Iran".

She informed that Fars province with 1.7 hectare of agricultural lands and 10 million tons of various kinds of agricultural products has got the best rank among provinces in Iran. Due to high agricultural production in this province during last 50 years, 500 rural and agricultural women cooperative companies have been established which caused enhancement of development in agricultural sector.

The women cooperatives are running successful business of tissue paper manufacturing which is supplied to the consumer outlet run by the co-op itself. Hence, there is no much problem of marketing.

Similarly, we visited to a fresh bread making unit run by the women co-operative.

There is popular demand for the bread in the local area itself and we saw a long queue of buyers at the bakery.

Both these units manage to generate some profit and are self sustaining. The CORC supports these units (co-operatives) with funds and loans.

The women cooperative also runs a nursery school for children of the members and local residents.

We had a briefing session at the office of Passargad Rural Co-operative Union. The Managing Director of the Union informed that 5 primary cooperatives are the members of the union. The co-operative members are basically farmers and the main crops are vegetables and wheat.

We visited to cucumber and tomato farms of the members.

A brief closing ceremony was held on 27 May evening in Shiraj. Mr. Khairad, Head of the Minister of Agriculture of Fars Province and other officials of the co-operative department were present. Mr. Khairad thankd the participants and the ICA for coming to Fars province. He said that it was an important event for the cooperatives of Fars Province to meet with foreign delegates and exchange information with cooperators of several countries. He spoke about women cooperatives in Iran and important role of cooperatives in socio-economic empowerment of women.

Cooperatives also contribute to the improvement of the economic, social and cultural situation of women in other ways including promoting equality and changing institutional biases.

The 6th International Co-operative Alliance Regional Women Forum was held on 2nd September, 2010 in Beijing, China in conjunction with ICA Regional Assembly and related events.

This was a Joint event. 5th Youth Conference was also jointly held with the 6th Women Forum.

The Theme of the Forum was decided keeping in view participation of youth as well. The theme was "Co-operatives: The Sector for Empowerment of Women and Youth". The Theme was further divided in to 2 sub themes in order to put more emphasis on and address to the concerns of women and youth exclusively as mentioned below:

Sub theme no. 1: Women's Livelihood and Leadership through Cooperatives.

Sub theme no. 2: "Socio-Economic Empowerment of Youth through Co-operatives".

40 participants from following 10 countries attended the event:

India, China, Indonesia, Iran, Pakistan, Japan, Thailand, Philippines, Singapore, Korea

The programme of the forum was divided into 4 sessions:

Registration and opening, Business session comprising of presentation by speakers, Group discussions, Closing which includes Presentation of the reports of the group discussions and Forum's Resolution.

The opening ceremony was facilitated by Ms Savitri Singh, Advisor, Gender Programs of ICAAP and Secretary of the ICA Regional Women's Committee for Asia-Pacific (RWC). She initiated the program by welcoming the participants. She gave a brief background of the ICAAP initiatives on Gender main streaming in co-operatives and Role of Regional Women's Committee. She also introduced the outline of the day's program to the participants. Thereafter, she invited Ms. Hitomin Tanaka, Chairperson of the ICA RWC to address the participants.

Ms Tanaka is the Vice Chairperson of Japanese Consumer Co-operative Union and Vice Chairperson of ICA Regional Board. She has vast experience of promoting women in consumer co-operatives in Japan. She extended a warm welcome to the participants and thanked them for attending the Forum. She spoke about the endeavor of the Regional Women's Committee for empowerment of women and gender mainstreaming in co-ops in the region.

Dr. Chandra Pal Singh Yadav, Chairman of National Cooperative Union of India (NCUI) was invited to deliver the opening address. Dr Yadav said that platforms like the women forum are very important for organizing stake holders and providing opportunity to discuss issue of equal participation of women and youth in social and economic activities.

Dr. Yadav delivered his opening address and declared the forum open.

He said that I appreciate the Women's committee for choosing the very appropriate theme: "CO-OPERATIVES: THE SECTOR FOR EMPOWERMENT OF WOMEN and YOUTH". Women and youth are very important components of the society-women are the backbone, and youth is the future. This is very true for co-operative sector as well. Almost 55% of food production is done by women in Asia as well as many other countries in the world. Majority of the co-operative members are related to agriculture.

Secondly, the co-operatives business needs young generation to gradually take over from the old so that new vision and methodology of young people can take co-operatives to new heights.

Mr. Shil Kwan Lee, former Regional Director of ICAAP presided over and chaired the session. He introduced the speakers and facilitated Question and Answer session.

Keynote speech on the theme" "Co-operatives: The Sector for Empowerment of Women and Youth" was delivered by Ms. Miyea OH, Chairperson of iCOOP Goyang / President of Mutual Aid Society For Enhancing Korean Agriculture.

It is a mutual aid society established by the members of iCOOP KOREA to support local co-ops and agricultural producers. Ms. OH started her address by reminding the participants, the message of this year's International Co-operative Day. It was "Co-

operative Enterprise Empowers Women." At iCOOP KOREA, most of the leaders in 76 local co-ops are women. And, of course, women are playing a crucial role also in representative and executive posts. She said that she believes this year's message bears a great significance for iCOOP KOREA, because its progress for the past decade is attributable to devotions and hard efforts made by the women leaders across the nation.

She proposed following tasks to participants:

- To study and create a variety of co-operative business models where both women and the youth can participate.
- However, we cannot draw interest and support from the public only by promoting values and social significance we pursue. Co-operative enterprises should at least secure the productivity level as high as the average business productivity level in the market.
- In addition, we should strive to promote the values and alternatives of co-operatives toward women and the youth.
- Lastly, I would like to highlight two things. First, it is imperative for us to take a closer look at the realities that each country's women and the youth are facing, and it is also important to come up with alternatives to promote co-operation and solidarity with marginalized women and the youth.

Ms, Hiroka Yanagishi, Vice Chairperson of Japanese Consumer Co-operative presented paper on the sub theme I: "Women's Livelihood and Leadership through co-operatives".

She presented her paper based on the activities of her cooperative in Cobe, Japan.

Mr. Ilham Nasai, Vice Chairperson of the ICA Regional Youth Committee delivered speech on the sub theme II: "Socio-Economic empowerment of youth through co-operatives".

Mr. Lee, Chair of the session initiated discussion on the equal participation of women in co-ops, especially in agricultural co-operatives as the requirement of membership is ownership of land and most of the women do not own land. He cited the example of Korea where law is

enacted to allow two members per family in order to provide opportunity to women. He invited Savitri Singh of ICAAP to give more information on the issue. Ms. Dolly Goh, CEO of Singapore National Co-operative Federation (SNCF), Ms. Emma Neiva of NATCCO NETWORK and other participants also shared their views.

Ms. Pauline Green, President of ICA joined the forum for a short while and interacted with the participants. She emphasized the need of women empowerment and gender main streaming in co-ops. She shared ICA vision on co-operatives as equal opportunity organizations. She informed the participants about UN proclamation of co-operative year 2012 and it's significance for co-operatives to emerge as a strong socio-economic sector.

Business session concluded with summing up of discussion by Mr. Lee.

In the post lunch session, participants were divided into 2 groups, one for women and one for youth. The topic for the discussion was: "Co-operative for Professional Development of Women and Youth".

The members discussed the topic in detail and a report was presented by each group.

Report of the Women Group:

The women co-operators recommended the following:

The co-operative system can help professional development of women:-

- By conducting sex disaggregated data for appropriate design of products and services for both women and men
- By conducting a need-based capacity building programs, i.e., Gender Sensitivity Training and creating awareness to change the stereo-type mindset, Leadership Training, Responsible Parenthood, Livelihood and the like.
- Working in tandem with the government, to reach out for information on various gender issues.
- By conducting regular forums participated by women delegates from ICA member countries for exchange of best practices.
- For ICA to recognize successful women, youth and other co-operative leaders by giving AWARDS during ICA Assembly.

Report of the Youth Group:

The members of youth group agreed that there is a need of to promote youth co-operatives professionally by cooperative organizations.

The group focused their discussion around certain KEY ISSUES:

- Unemployment
- Education (social illness)
- Environmental (climate change)
- As co-operatives cater to the people with limited needs and aspirations, students and youth in general, automatically qualify under this group.
- The idea of a coop press in the colleges and universities could help the young citizens of the

- world to be self sufficient and live independently.
- The Idea: As soon as the young students qualify into university, he or she is sou-moto inducted into the co-operatives wherein he or she becomes a member and contributes to the project.

The co-operatives own newsletters and periodicals. One way of employment for youth could be writing/contributing articles, reports etc. for the periodical.

For example, sports, debates, academics and research on relevant issues.

- ECONOMIC ASPECT
- The Newspaper could carry advertisement material of various co-operative enterprises in the world. This will give the co-ops much needed publicity especially with the International Year of Co-operatives only a year away. The Newspaper too would be able to earn its costs with such advertisements and promotional material.

Recommendations of the Youth group:

 The co-operatives are suitable organization for young students who have limited resources as co-op can provide part-time employment along with education.

- A system of employment to entice the youth to get involved in the agriculture activities.
- More information / publicity about co-ops for awareness in general public.
- Home-based work for women (with child and home care) and entrepreneurship / self employment for youth.
- All the student in university should join co-operative and contribute to co-op activities.
- The students should be encouraged to write on various topics in co-op newsletters and periodical. This may be a part-time employment for them.

The Chair Person of the ICARWC presented these resolutions of the women forum at the ICA Regional Assembly to be adopted by the ICA.

Recommendation to RA:

The co-operatives can provide professional development for women by:

- Conducting survey to assess needs of women and design need-based products and services.
- Conducting need-based capacity building programs such as training of cooperative members on gender

sensitivity to change the stereo-type mindset, leadership skills, responsible parenthood and livelihood etc.

- The co-operatives should be aware of various government's programs on gender issues and work in tandem with the government to derive the benefit of such programs for their own members.
- ICA / co-operatives should organize regular forums / interactive sessions for exchange of best practices.
- ICA-AP should recognize successful women, youth and other cooperators by giving AWARDS during ICA Assembly.

Current situation of Women in Co-ops and Our Burning CONCERNS

 Socio-cultural barriers supported by generations of patriarchic system are too strong to be changed through awareness and persuasion.

- Women face difficulty to get elected in decision making positions because of socio-cultural and religious barriers.
- Absence of supportive legal provisions in many countries.

Therefore, there is urgent need of adopting fast actions/measures.

Our all time recommendations to be acted upon by co-operative fraternity in the region:

Minimum 30% reservation of seats for women in membership, management and leadership position of the co-operatives in the region.

ICAAP to organize national and regional conferences and workshop to discuss legal issues/co-op laws towards gender mainstreaming, and revise the law to make women's membership easy and thereby increasing participation of women at leadership and decision making positions.

Meeting of the Office Bearer's of ICA Regional Women's Committee was held on 21 June, 2011, in Kuala Lumpur, Malaysia. Ms. Hitomi Tanaka, Chairperson of the Committee chaired the meeting. The meeting was attended by the Chairperson, 2 Vice Chairs, Ms. Emma Neiva from NATTCO and Ms. Kruewan from AWCF and Ms. Savitri Singh, Advisor-Gender Programme and Secretary to the committee. She convened the meeting and presented the progress report.

The members reviewed the progress of activities and discussed usual business of the committee, work plan for 2011 and preparation for major activities coming up next year-2012 such as Regional Women Committee Meeting and Women Forum to be organized in conjunction with the ICA Regional Assembly-2012. Datuk Nraini, RWC member from ANGKASA, Paul Sinnappan from Credit Co-operative Network of Malaysia, Ms. Armi

Zainudin, ICA Global Board member and other senior staff of ANGKSA participated as observers. In the light of International Year of Co-operatives-2012, the members discussed to plan special events and Madam Armi suggested that ICA-AP should consider organizing a women conference in 2012 as part of IYC-2012 celebrations.

Review of "Leadership Training Manual for Women Leaders of Co-operatives"

Low and negligible participation of women in co-operatives, especially at leadership level is a matter of serious concern for ICA. In order to build the capacity of women and men to facilitate and help women taking leadership role, a leadership training programme for co-operative trainers and leaders has been designed in 1998. Since then, the ICA-AP is organizing a Training of Trainers Programme (TOT) once in a year using the "Leadership Training Manual for Women Leaders of Co-operatives". The manual was produced in collaboration with ILO-COOPNET.

Initially the response was good and the curriculum was appreciated by the participants. Gradually, a demand for more technical and need based curriculum was raised by the participants in some countries. The first Regional TOT was held in 2003 and some participants especial from Singapore, found the training very basic and content not so relevant to the co-operative environment in their country. Based on the feedback and suggestions received from the participants during trainings, the curriculum was modified a bit to meet up the requirement. More time devoted to cooperative enterprise management and financial management which included fund raising, loans, book keeping and accounts and reading and understanding

balance sheet of the co-operative.

However, in order to evaluate the usefulness of the programme and relevance of the curriculum, it was decided to approach the participants from countries where the programe was held in recent years. We designed a feedback form and sent to the participants of 4 countries in Feb 2010. However, Thailand (2008) did not respond and only following 3 countries sent the feedback:

- 1. Vietnam (2006)
- 2. Nepal (2008)
- 3. Malaysia (2009)

The participants (about 20-30 each country) appreciated the training and found it very useful for their work as a co-operative, trainer, manager and leader. Most of them conducted several training in their country using the reference from the manual. Gender socialization process is very informative for women and men. They recommended that the ICA should continue with such capacity building programmes for co-operative members in the region.

The current manual has got seven modules and several units in each module.

Hence, in the last meeting of the RWC, it was decided to

view the manual and a committee was formed imprising of following members:

5. Ms. Savitri Singh, Advisor Gender Programme, ICA-AP The review meeting was held in Malaysia in June, 2011 and further action will be taken on the report of the committee in due course.

Co-op Stories from Malaysia

The meeting of the Office Bearers of the RWC was coincided with visit to a couple of women co-operatives and Day Care Centre operated by ANGKASA. As the host from ANGKASA, Ms. Armi extended warm welcome to the Manual Review Committee and gave a brief account of gender mainstreaming programmes in ANGKASA.

Commencing from current year, the women committee of ANGKASA will be discontinued. A small technical committee on women comprising 3 members only will be functioning under the main training department of the organisation. This is a huge drawback/constrain towards achieving of gender mainstreaming in co-operatives.

The participants visited to Koperasi Usahawan BIGDee Selangor Berhad which is run by a group of technical professionals. This co-operative manufactures and markets high end health care, beauty care products and electronic devices. They are the distributors of Wireless Security and Automation System via SMS .

The participants also visited to a women co-operative Koperasi Wanita Bersuadara Berhad (KWBB). The women members produce many variety of noodles, breads and buiscuits etc which has very good market. During the interaction, the members expressed satisfaction about their association with the co-operative which helps them getting employment and income to support house expenses. Most of the workers at the cooperative were the members and they get

paid for the work. The co-operative provides all the raw material for preparation of the eatables.



Some of the products

The ANGKASA is operating a Child Care Centre for the staff. There are 108 child care centers in the country out of which 27 are run by co-operatives and 71 are run by private people. ANGKASA has also organised course on "Women and Health". A book on the subject is under preparation and will be published soon.

UNDP Speech by Ela Bhatt

The founder of Self Employed Women's Association (SEWA) India, Ms.Ela Bhatt gave a speech on June 27, 2011 Tarrytown, NY which has raised some serious concerns regarding approach to development. The exurpts of speech is produced below:

Respected Helen Clark, Secretary General Ban Ki Moon, distinguished colleagues and friends. Thank you for inviting me to speak at the UNDP Global Meet to share some of my ideas on inclusive, equitable growth, and, on people, poverty and development. Coming from a labour organization, my world view begins with people. In this context, I am to stress today on fulfillment of the Millennium Development Goals.

MDG is a pathetic story. The deadline for meeting the Millennium Development Goals is fast approaching, and still we find ourselves wondering why despite our best intentions and efforts, we have not made significant headway. Surely, it is time to reconsider our approach. After all, one cannot solve problems with the same thinking that brought us these problems in the first place. We need a fresh vision. We need to think seriously of a new approach.

At the Tallberg Forum, two women from Ghana said, We are farmers, but what we produce, we do not eat, and what we eat, we do not produce. The women grew cash crops for export, but at mealtimes, they ate frozen and canned food imported from another continent. Such ironies confront us at every corner today: farmers who till the land and feed the world go hungry themselves. World food consumption is increasing, but farming is no longer a viable occupation. Countries that have the most abundant natural resources are among the poorest. Their indigenous populations, neglected and pushed away to remote forest areas are now once again being driven from their lands because it is rich in timber and minerals. They join the growing numbers of economic refugees. Women work from dawn to dusk fetching water, collecting fuel, tending cattle, growing crops, processing grain, sewing, making baskets, but their labor is not considered work. They form the backbone of any developing country's economy but they remain invisible, their work considered marginal, and their contribution considered negligible to the national

My appeal is that before we rush ahead to modernize and urbanize our world, armed with technology and capital, we must pause and look more closely at the economic and social structures that are collapsing, or are being dismantled in the name of development. Urbanization is not development. Technology, if it creates imbalances is not a solution. If profit is our only measure of success, we will turn a blind eye to the exploitation of people and nature. So long as the goal is maximizing production and consumption, and progress and wealth are measured by a

country's capital-intensive industries, exports, and Green we are embracing both imbalance and inequality. But if o goal is to build a society where everyone's basic needs food, clothing and housing are fully met, and where the function of every human being is realized, we will need radically different approach. We will need to get in partnership with our conscience; we will need to get in partnership with our fellow human beings and we will need a long-term partnership with Mother Nature.

It is time we paused and took a fresh look at old? subsistence farming methods and horticultural practice to learn some lessons in sustainability, in risk reductio and in maintaining biodiversity. Their finely tune production and consumption cycles which are holistic, as designed to meet human needs in the face of adversity, at systematically being broken. Even today, such selsustaining communities and sustainable forms of agriculture and production still survive in our countrie but they are considered backward, inefficient, ar unrealistic! Their plots of land are considered too small their methods of farming too inefficient, their output to small, and their knowledge of local crops and local soils to specific and worthless! Indeed, where development is see i as membership in a cash-based market economy, when crops are a commodity, and market forces are large an increasingly distant and invisible, what hope does a simple farmer have of survival? This is our mistake. People who ar still intimately tied to their land have many lessons t teach us. If we do not learn them, we are allowing our hop for the future to die; they are our lifeline.
