Message from the President, ICA-Asia & Pacific



he year 2004 was a very good year for the ICA in Asia-Pacific. A host of activities were carried out during the year. Several major initiatives like developing agricultural co-operatives in Vietnam, Laos and Cambodia, organizing the 3rd Asia-Pacific Cooperative Forum, the 3rd Regional Research Conference, the 4th Regional Women's Forum, etc. were held in Chiangmai, Thailand. So also the 6th Regional Assembly for the Region. With these major meetings, meetings of many of the specialized organizations of the ICA also met in Chiangmai, Thailand. I would take this opportunity to complement and appreciate the support provided by the Co-operative League of Thailand, our member organisation, in organizing these numerous activities.

With all these initiatives the ICA Regional Office were able to involve more and more co-operative members in their efforts to make our part of the world worthwhile to live.

The ICA in this Region has all along been associating itself with the UN and other multi-lateral agencies in developmental efforts.

The ICA Asia-Pacific collaborated with the All China Federation of Supply and Marketing Co-operatives (ACFSMC) to organize an International Trade Fair and Forum during April 2004, which saw a large number of delegates and representatives of major consumer co-operative organizations in the world joining together in the hope of making China a source country for their co-operatives.

A very important event was the organizing of the Regional Youth Seminar in Kuala Lumpur, Malaysia, during September 2004, wherein more 180 youth delegates from the Region, the UK and the United States participated. The youth seminar was so

successful that the delegates were able to plan their strategies for setting up a Statutory Youth Committee for the Region. A number of delegates were nominated to a Steering group. It is expected that by the time the next Regional Assembly takes place, probably in Sri Lanka, the Regional Youth Committee will be officially formed, to give impetus to the youth cooperative activities in our Region.

You would agree with me that the ICA in Asia-Pacific has emerged as a major initiator of co-operative development in the world.

Taking into consideration the emerging needs of the society, the ICA Asia-Pacific also organized a programme on awareness creation for HIV/AIDS prevention in the region and is associating with UN AIDS.

One of the saddest moments for humanity and co-operators in our Region was the devastating Tsunami which afflicted Indonesia, India, Sri Lanka, Thailand and Malaysia, which saw more than 270,000 people dead, most of them co-operators. Homes have been lost, and so is the livelihood of a large number of people in our region. While relief and support is being provided by several governments and other agencies, we found that support to co-operative organizations and co-operators are not pouring in sufficiently.

In view of this, the ICA Asia-Pacific has conducted field studies in India, Sri Lanka and Indonesia and is in the process of formulating some projects for the long-term rehabilitation of the victims in these countries. As in the past, I am confident, that the cooperative fraternity will keep on supporting their hapless brethren and show their solidarity to the poor people in their times of need.

ICA members in the Region have all along been very supportive of activities of the ICA Regional Office, which I very sincerely appreciate. I hope you will continue to support the ICA for a better Asia-Pacific.

The ICA Asia-Pacific had a successful and eventful year 2004. During the year, we have been able to conduct a large number of activities, compared to previous years. We have also been able to cover all sectors of cooperatives and have also formulated programmes and sectoral importance, be it agriculture, gender, consumers, human resource development and research, youth mainstreaming, cooperative policy and legislation, etc.

We have collaborated with AGRITERRA, Netherlands, to set up pilot projects in agricultural sector in Laos, Combodia and Vietnam. Collaborated with the Trade Union movement to set up possible development projects in Nepal, organized a workshop in collaboration with UN Aids and National Aids Control Organisation of India (NACO) in India, and are looking forward for possible project support to have a full-fledged aids control project in the Region.

This year we also organized a Regional Youth Seminar in Kuala Lumpur, Malaysia, as follow-up to the previous Regional Youth Seminar in Tokyo, Japan during 2001. In this year's seminar, more than 180 youth leaders from countries of the Region and from the UK and the US participated. The youth delegates were well focused that

they have formed a Youth Steering Committee for Asia-Pacific, with serious plans to set up a Youth Committee for the Region under the ICA Regional Assembly. This might materialize during the next Regional Assembly in 2006 in Sri Lanka.

Towards the fourth quarter of the year, we have organized the 3rd ICA Regional Co-operative Forum, the 3rd Regional Research Conference, the 4th Regional Women's Forum and the 6th Regional Assembly, all at Chiangmai, Thailand, which was well attended. Especially the Forum was so focused that it discussed crucial issues related to 'Re-engineering Co-operatives in a Globalised Economy'. More than 350 delegates participated in these meetings. Many of the Regional Committees like the HRD and Research Committee. University/Campus Sub-Committee, the Consumer Committee, the Regional Women's Committee, Regional Co-operative Banking Association, etc. have also met at Chiangmai, during this period.

Earlier, during April, 2004, the ICA collaborated with the All China Federation of Supply and Marketing Co-operatives in organizing an International Trade Fair and Forum in Beijing, wherein co-operative products and services were exhibited. In the Forum, there were interesting discussions on co-operative-to-cooperative trade. As a result of this fair and Forum, the number of cooperatives (Co-op Atlantic, Canada, NTUC Fairprice, Singapore, Co-op Trade, Japan, Co-op UK, etc) have started sourcing their procurement from China. Also the ACFSMC are also doing business with co-operatives in Indonesia.

The two major training courses for Managers' of Agricultural Co-

operatives and for Rural Women Cooperative Leaders, with the support and assistance from the Ministry of Agriculture, Forestry and Fisheries, Government of Japan, in close collaboration with the Institute for the Development of Agricultural Cooperation in Asia (IDACA), continued during 2004 also. We hope that these courses will continue in some form or the other in the coming years too.

The ICA Asia-Pacific also held a few trainers' training activities for Leadership Development for Women in Indonesia and Iran, apart from holding a Networking and Exposure Programme for women.

The difficult part of the year was the year-end Tsunami devastation, which has affected millions of cooperators and thousands of cooperatives. This tragedy has seen a death toll of more than 270,000 in Indonesia, India, Sri Lanka, Thailand, Malaysia, Maldives, etc. The ICA was quick to issue an appeal to the world co-operative movement to come to the aid of the suffering co-operative brethren in these countries. We are also formulating some projects for long-term rehabilitation of the victims.

Our member organizations are our only assets and we wish to recruit more and more members in the Region. We would request co-operative organizations in the Region to join under the ICA umbrella for mutual benefits.

We are very grateful to our member organizations in this region and our development partners in supporting us in organizing these very useful activities and are hopeful the support and collaboration will continue.

Seventh Asia-Pacific Co-op Ministers' Conference held in New Delhi, India

The Seventh Asia-Pacific Co-operative Ministers Conference held on 2-5 February, 2004, had a grand opening session at the Vigyan Bhawan convention centre in New Delhi by the Hon'ble Deputy Prime Minister of India, Mr. L.K. Advani.

The other senior leaders present were Mr. Rajnath Singh, Minister for Agriculture and Co-operation, Government of India, Mr. Hukumdeo Narayan Yadav, Minister of State for Agriculture and Co-operation, Mr. Ivano Barberini, President ICA, Mr. Iain Macdonald, Director General, ICA, Dr. S.S. Sisodia, President, National Co-operative Union of India and Mr. R.C.A. Jain, Secretary in the Ministry of Agriculture.

Over 180 delegates, including 11 Co-operative Ministers, and co-operative leaders from Afghanistan, Bangladesh, China, Fiji, India, Indonesia, Iran, Israel, Japan, Republic of Korea, Kuwait, Malaysia, Nepal, Pakistan, Palestine, Singapore, Sri Lanka, Thailand and Vietnam participated at the Conference.

Besides, fraternal delegates from Middle East countries and Europe and international organisations were also well represented as well as leading cooperative leaders from Asia and the Pacific participated at this meeting. Apart from Ministers, senior government representatives, and co-operative leaders, representatives from

major international organizations like the ILO, CCA, AARDO, APRACA, ICFTU, ACCU and others made presentations.

The meeting discussed various legal and other aspects affecting the development of co-operatives. After detailed discussions and presentations and group work, the Conference adopted the following declaration, which will be known as the 'New Delhi Declaration'. This declaration was signed by ministers and other representatives on behalf of their respective governments and co-operative movements.

The International Co-operative Alliance, especially the Asia-Pacific Regional office, recognising the importance of

continuance of the process of legislation and policy reforms for sustainable co-operative development, particularly in the context of globalized competitive world, identified 'Co-operative Policy Development and Legislative Reforms', as one of the key result areas.

To achieve this, the ICA convenes a conference of cooperative ministers' of Asia and the Pacific. Six such Conferences were convened since 1990 in Australia-Sydney; 1992 Indonesia-Jakarta; 1994 Sri Lanka-Colombo; 1997 Thailand-Chiagmai; 1999 China-Beijing; 2002 Nepal-Kathmandu. All these conferences were hosted by the concerned national governments. The Department of Agriculture and Co-operation in the Ministry of Agriculture, Government of India hosted the 7th Conference.

The theme of this conference was "Establishing Supporting Co-operative Legislation and Policy for sustainable co-operative development".

The Conference deliberated on the Third Critical Study on Co-operative Legislation and Policy sponsored by ICA Regional Office for Asia and the Pacific, New Delhi. A number of international resource persons presented papers on: Important Concern of co-operatives, Best Practices in co-operatives, Globalization and Poverty Reduction, Co-operative Legislation and Policy, and ILO Recommendation 193 on Promotion of Co-operatives.

During the Conference, the delegates undertook study visits to a few co-operatives and also an excursion to the Taj Mahal.

THE 'NEW DELHI DECLARATION'

adopted by the 7th Asia-Pacific Co-operative Ministers' Conference

- 1. RECOGNIZING that co-operatives, despite all of the challenges and problems posed by reforms in the economy and liberalization of policies, have continued to serve the economic interests of people, hence contributed significantly to the socio-economic growth of the countries in the Asia-Pacific Region;
- 2. RECOGNIZING the significance of supportive co-operative legislation and public policies that will harness the full potential of co-operative enterprises for the promotion of the socioeconomic well being of the people in general, for the creation of employment, for the alleviation of poverty, and for the development of human resources in particular;
- TAKING NOTE that enabling legislation and favorable public
 policies of the government alone will not result in the
 development of viable co-operatives, unless facilitated by
 follow-up measures in terms of policy implementation that is
 matched by supportive measures of the government;
- 4. APPRECIATING ILO Recommendation 193 on the Promotion of Co-operatives, which enunciates the views of the global co-operative movement on co-operative legislation, as well as government role and policies that facilitate the growth of member-centered, community-oriented, autonomous and competitive co-operative enterprises, as well as ensure equitable distribution of new opportunities and benefits emerging from globalization that is for the good of the community;
- TAKING NOTE other resolutions adopted by the UN General Assembly that supports the development of cooperatives, in particular the role of co-operatives in social development;
- 6. REALIZING that despite the existence of a more favorable environment for co-operative autonomy, independence and democratic management, there still exist potentially viable co-operative enterprises in developing countries in the region which are over-dependent on government support and patronage, and are found to be weak and dormant in several sectors, with no concrete action plan for revival and revitalization in a time-bound manner;
- 7. The participants of the 7th Co-operative Ministers' Conference held at New Delhi, India from 2nd to 4th February 2004, CALL UPON the Governments and Co-operatives in the Asia-Pacific Region, as well as the ICA-ROAP, to hasten the process of legislative and policy reforms that will guarantee more autonomy and independence of co-operatives, ensure the creation of a conducive environment that will lead towards a more balanced and sustained growth of the co-operatives in all sectors of the economy, and hence ensuring the socioeconomic development of the people and the country, particularly in regard to:
 - a. The formulation of specific public policy in consultation with the co-operative movement that will facilitate the growth of member-centered, community-oriented, autonomous and competitive co-operative enterprises;
 - b. The harmonization of co-operative policy and legislation;
 - c. The definition of an appropriate role and engagement of co-operatives in public policies relating to different sectors of economy, e.g. agriculture, credit, banking and insurance, trade and commerce, labor, etc.;

- d. The repositioning and strengthening of the co-operatives by way of: i) Augmentation of capital and resources,
 - ii) Professionalization of management, iii) Adoption of appropriate manpower development strategies,
- iv) Diversification and broad-basing business operations, v) upgrading technologies for enhanced efficiency and effectiveness of services, and vi) Learning from experiences, good practices and successful growth models of co-operatives in different sectors in the countries of the Asia-Pacific Region;
- The empowerment of co-operatives in order that they can play an enhanced role in social sector development;
- f. The creation of appropriate provisions in Co-operative Legislation that will enhance the role and participation of women in co-operative management and leadership.
- RECOGNIZING FURTHER the depth and significance of presentations made in this Conference pertaining to "Important Concerns of Co-operatives", "Co-operative Best Practices", and "Globalization and Poverty", CALL UPON the Governments and Co-operatives in the Asia-Pacific Region, as well as the ICA-ROAP, to:
 - a. Give special consideration to increasing women's participation in the Cooperative movement at all levels; the Government together with the co-operative movement in each country must provide the necessary FUNDS for gender disaggregated data base, training and education of women, networking and exposure to success stories, and particularly to those co-operatives where young co-operators can play an active role in co-operative activities based on their understanding of the Co-operative Identity.
 - b. Recognize the important role of co-operatives in a rapidly changing global environment, and for governments to create a favourable environment for the development of co-operatives including, if necessary, to offer those preferences for co-operatives which work for the betterment of the community and for the creation of an information technology in order to help co-operatives to operate more efficiently.
 - c. Confirm and advocate to the UN and other relevant Development Agencies the contribution co-operatives can make in the area of Good Governance and Business Development as value-added features in Poverty Reduction Strategies (PRS) being undertaken by governments and Civil Society Organizations (CSOs) in ICA member-countries in Asia and the Pacific.
 - d. Seek a new strategy through which co-operatives can become an integral part in the PRS processes being undertaken by the corresponding governments and CSOs in ICA member countries.
 - e. Create and bring about effective and enhanced partnerships that have been developed with Trade Unions, Employers' Groups, women's groups and other Civil Society Organizations, and supported by multilateral and bilateral agencies as well as other partners.

18th ICA-Japan Agricultural Training Course held

The Eighteenth [18th] ICA-Japan Training Course on "Strengthening Management of Agricultural Cooperatives in Asia" was inaugurated in India on 16 January, 2004, after a month-long home country assignment segement. The India segment lasted until March 1, 2004.

The 12 participants of the training course (from Bangladesh, China, India, Indonesia, Malaysia, Nepal, the Philippines, Sri Lanka, Thailand and Vietnam) visited agricultural cooperative in Vietnam from 2-6 March, 2004 and then proceeded to Japan, for the last leg of the course which concluded on April 17, 2004.

The Inaugural Session of the Course was attended by Mr. D.K. Bhatt, Marketing Director of IFFCO, Mr. Shil-Kwan Lee, ICA Regional Director [Asia-Pacific], Mr Tomofumi Inoue, First Secretary in the Japanese Embassy in India, Mr S. Fukamachi, Managing Director, IDACA, was represented by Mr. Toru Nakashima, Deputy Manager (Trg.), Mr. D. Bhatacharya, Joint General Manager (HRD), IFFCO, Dr. R.N. Kundu, Sr. Manager (Trg.), FMDI, and Mr. Prem

Kumar, Adviser, ICA-Japan Training Course. As a part of their studies, the participants had produced 12 development project proposals during their Home Country Assignments [HCAs] in accordance with the guidelines provided by the ICA.

The second part of the programme held at IDACA included

extensive classroom work and study visits to agricultural co-operatives in and around Tokyo, Yamanashi and Kochi Prefectures in Japan.

The programme was implemented by the [ICA-AP] in collaboration with JA-Zenchu [Central Union of Agricultural Co-operatives of Japan] and the Institute for the Development of Agricultural Co-operation in Asia-Japan [IDACA].

During these 18 Training Courses, a total of 267 managers of agricultural co-operatives from 14 countries of Asia attended the training programmes and prepared a total of 264 project proposals on topical subjects.

The Fair and Forum was sponsored by All China Federation of Supply and Marketing Co-operatives (ACFSMC), with support and assistance from Co-op Atlantic, Canada, The Co-operative Group, UK, the NTUC Fairprice, Singapore and the ICA Regional Office for Asia and the Pacific. The Fair and Forum were jointly inaugurated by Mr. Bai Lichen, President of the Board of All China Federation of Supply and Marketing Co-operatives, in the presence of senior level delegates from various countries, including Mr. Ivano Barberini, President, ICA, Mr. Iain Macdonald, Director General, ICA and others.

Co-operative Exhibitors displayed a large variety of foodstuff, handicrafts, machinery, clothes, fabrics, etc. from all over China and India, Indonesia, Iran, Sri Lanka, Nepal, Singapore, Japan, Korea, the UK also set up stalls at the exhibition.

A 2-day International Co-operative Trade Forum (26-27 April, 2004) was organized attended by about 100 delegates from various countries and from provinces all over China. The Forum was divided into 4 segments. Mr. Robby Tulus, Senior Consultant, ICA chaired the Forum.

Forum I was on 'Marketing and Merchandizing'; Forum II dealt on 'China's Trade/Exposure'; Forum III was on 'Competition'; and Forum IV was on 'Global Trade', wherein Mr. Iain Macdonald, Director General, and Mr. Shil Kwan Lee, Regional Director, ICA spoke.

Strengthening Co-operatives in Laos PDR and Cambodia

In pursuance of its Key Result Area of Co-operative Development, the ICA ROAP identified three countries of Asia-Pacific viz. Afghanistan, Cambodia and Laos PDR, where cooperatives have been victims of either political ideology or instability.

Mr. Shil Kwan Lee, Regional Director, and Mr. B.D. Sharma, Senior Consultant, visited Laos PDR on 8-11 April and held extensive discussions with policy makers and senior officials in the Ministry of Agriculture and Forestry and also with leaders of water user associations, farmers' production groups, and self-help groups to examine the possibilities of promoting cooperatives.

On this occasion a National Workshop of officials in-charge of implementation of various development programmes relating to agriculture and rural development was convened.

Last year, the ICA ROAP with the support of AGRITERRA of The Netherlands had conducted a detailed study on the prospects of promoting agricultural co-operatives in Laos PDR. The study was also circulated in the workshop.

Rural co-operatives were destroyed by a 30-year long civil war and the Government has taken a conscious policy decision to promote agricultural co-operatives on a pilot basis. The success of these pilot co-operatives will pave the way for their country-wide replication and also for promotion of co-operatives in non-agricultural sector.

The ICA interventions will add value to the efforts of the Government to promote co-operatives. Areas in which the ICA support has been sought are (a) capacity building; (b) formulation of suitable legal framework for co-operatives; (c) management of business of co-operatives; (d) development of suitable co-operative credit system; and (e) development of co-operative marketing system.

Fourth Trainers' Training Programme for Leadership Development of Women in Co-ops held in Iran

he fourth Trainers' Training Programme for Leadership Development of Women in Cooperatives was held on 7-12 June, 2004, at Esfehan, Iran. Concerned about the under- representation of women in leadership and decision making position in co-operatives in the region, the ICA Regional Office and the Regional Women's Committee identified training needs for women to enable them take up leadership role. With the efforts of the Committee, ICA ROAP and ILO CO-OPNET a Trainers' Training Manual was developed for this purpose. Mr. M Karim Beiki, the Managing Director of CURACI extended all support to make the programme a great success.


- sharing experiences on "healthy community building" to clearly define the role of health co-ops;

STATEMENT ON THE NEW CO-OPERATIVE IDENTITY

Definition

A co-operative is an autonomous association of persons united voluntarily to meet their common economic, social and cultural needs and aspirations through a jointly owned and democratically controlled enterprise.

Values

Co-operatives are based on the values of self-help, self-responsibility, democracy, equality, equity and solidarity. In the tradition of their founders, co-operative members believe in the ethical values of honesty, openness, social responsibility and carring for others.

Principles

The co-operative principles are guidelines by which co-operatives put their values into practice. They are:

First Principle: Voluntary and Open Membership

Co-operatives are voluntary organizations, open to all persons able to use their services and willing to accept the responsibilities of the membership, without gender, social, racial, political or religious discrimination.

Second Principle: Democratic Member Control

Co-operatives are democratic organizations controlled by their members, who actively participate in setting their policies and making decisions. Men and women serving as elected representatives are accountable to the membership. In primary co-operatives, members have equal voting rights (one member, one vote) and co-operatives at other levels are also organized in a democratic manner.

Third Principle: Member Economic Participation

Members contribute equitably to, and democratically control, the capital of their co-operative. At least part of that capital is usually the common property of the co-operative. Members usually receive limited compensation, if any, on capital subscribed as a condition of membership. Members allocate surpluses for any or all of the following purposes: developing their co-operative, possibly by setting up reserves, part of which at least would be indivisible; benefiting members in proportion to their transactions with the co-operative; and supporting other activities approved by the membership.

Fourth Principle: Autonomy and Independence

Co-operatives are autonomous, self-help organizations controlled by their members. If they enter into agreements with other organizations, including governments, or raise capital from external sources, they do so on terms that ensure democratic control by their members and maintain their co-operative autonomy.

Fifth Principle: Education, Training and Information

Co-operatives provide education and training for their members, elected representatives, managers, and employees, so they can contribute effectively to the development of their co-operatives. They inform the general public – particularly young people and opinion leaders – about the nature and benefits of co-operation.

Sixth Principle: Co-operation among Co-operatives

Co-operatives serve their members most effectively and strengthen the co-operative movement by working together through local, national, regional and international structures.

Seventh Principle: Concern for Community

Co-operatives work for the sustainable development of their communities through policies approved by their members.

The Seventh Asia-Pacific Cooperative Ministers Conference held on 2-5 February, 2004, had a grand opening session at the Vigyan Bhawan convention centre in New Delhi by the Hon'ble Deputy Prime Minister of India, Mr. L.K. Advani.

The other senior leaders present were Mr. Rajnath Singh, Minister for Agricutlure and Co-operation, Government of India, Mr. Hukumdeo Narayan Yadav, Minister of State for Agriculture and Co-operation, Mr. Ivano Barberini, President ICA, Mr. Iain Macdonald, Director General, ICA, Dr. S.S. Sisodia, President, National Co-operative Union of India and Mr. R.C.A. Jain, Secretary in the Ministry of Agriculture.

A total of over 180 delegates, including 11 Co-operative Ministers, and co-operative leaders from Afghanistan, Bangladesh, China, Fiji, India, Indonesia, Iran, Israel, Japan, Republic of Korea, Kuwait, Malaysia, Nepal, Pakistan, Palestine, Singapore, Sri Lanka, Thailand and Vietnam

The International Co-operative Alliance, especially the Asia-Pacific Regional office, recognising the importance of continuance of the process of legislation and policy reforms for sustainable co-operative development, particularly in the context of globalized competitive world, identified 'Co-operative Policy Development and Legislative Reforms', as one of the key result greas.

To achieve this, the ICA convenes a conference of co-operative ministers' of Asia and the Pacific. Six such Conferences were convened since 1990, as follows:

The Department of Agriculture and Co-operation in the Ministry of Agriculture, Government of India hosted the 7th Conference.

The theme of this conference is "Establishing Supporting Co-operative Legislation and Policy for sustainable co-operative development".

The Conference deliberated on the Third Critical Study on Co-operative Legislation and Policy sponsored by ICA

Regional Office for Asia and the Pacific, New Delhi. A number of international resource persons presented papers on (a) Important concern of co-operatives, (b) Best practices in co-operatives, (c) Globalization and Poverty Reduction (d) Co-operative Legislation and Policy, (e) ILO Recommendation 193 on Promotion of Co-operatives.

During the Conference, the delegates were taken on study visits to a few co-operatives and the Taj Mahal.

The 'New Delhi Declaration'

adopted by the 7th Asia-Pacific Co-operative Ministers' Conference

New Delhi, 2-4 February 2004

- RECOGNIZING that co-operatives, despite all of the challenges and problems posed by reforms in the economy and liberalization of policies, have continued to serve the economic interests of people, hence contributed significantly to the socio-economic growth of the countries in the Asia-Pacific Region;
- 2. **RECOGNIZING** the significance of supportive cooperative legislation and public policies that will harness the full potential of co-operative enterprises for the promotion of the socio-economic well being of the people in general, for the creation of employment, for the alleviation of poverty, and for the development of human resources in particular;
- 3. TAKING NOTE that enabling legislation and favorable public policies of the government alone will not result in the development of viable co-operatives, unless facilitated by follow-up measures in terms of policy implementation that is matched by supportive measures of the government;
- 4. APPRECIATING ILO Recommendation 193 on the Promotion of Co-operatives, which enunciates the views of the global co-operative movement on co-operative legislation, as well as government role and policies that facilitate the growth of member-centered, community-oriented, autonomous and competitive co-operative enterprises, as well as ensure equitable distribution of new opportunities and benefits emerging from globalization that is for the good of the community;
- 5. TAKING NOTE other resolutions adopted by the UN General Assembly that supports the development of co-operatives, in particular the role of co-operatives in social development;
- **6. REALIZING** that despite the existence of a more favorable environment for co-operative autonomy, independence and democratic management, there still

- exist potentially viable co-operative enterprises in developing countries in the region which are over-dependent on government support and patronage, and are found to be weak and dormant in several sectors, with no concrete action plan for revival and revitalization in a time-bound manner:
- 7. The participants of the 7th Co-operative Ministers' Conference held at New Delhi, India from 2nd to 4th February 2004, **CALL UPON** the Governments and Co-operatives in the Asia-Pacific Region, as well as the ICA-ROAP, to hasten the process of legislative and policy reforms that will guarantee more autonomy and independence of co-operatives, ensure the creation of a conducive environment that will lead towards a more balanced and sustained growth of the co-operatives in all sectors of the economy, and hence ensuring the socio-economic development of the people and the country, particularly in regard to:
- The formulation of specific public policy in consultation with the co-operative movement – that will facilitate the growth of member-centered, community-oriented, autonomous and competitive co-operative enterprises;
- b. The harmonization of co-operative policy and legislation;
- c. The definition of an appropriate role and engagement of co-operatives in public policies relating to different sectors of economy, e.g. agriculture, credit, banking and insurance, trade and commerce, labor, etc.;
- d. The repositioning and strengthening of the cooperatives by way of:
 - i. augmentation of capital and resources, ii. Professionalization of management, iii. Adoption of appropriate manpower development strategies, iv. Diversification and broad-basing business operations, v. upgrading technologies for enhanced efficiency and

- effectiveness of services, and vi. Learning from experiences, good practices and successful growth models of co-operatives in different sectors in the countries of the Asia-Pacific Region;
- The empowerment of co-operatives in order that they can play an enhanced role in social sector development; and
- f. The creation of appropriate provisions in Cooperative Legislation that will enhance the role and participation of women in co-operative management and leadership.
- 8. RECOGNIZING FURTHER the depth and significance of presentations made in this Conference pertaining to "Important Concerns of Co-operatives", "Cooperative Best Practices", and "Globalization and Poverty", CALL UPON the Governments and Cooperatives in the Asia-Pacific Region, as well as the ICA-ROAP, to:
- a. Give special consideration to increasing women's participation in the Cooperative movement at all levels; the Government together with the co-operative movement in each country must provide the necessary FUNDS for gender disaggregated data base, training and education of women, networking and exposure to success stories, and particularly to those co-operatives where young co-operators can play an active role in co-operative activities based on their understanding of the Co-operative Identity.

- b. Recognize the important role of co-operatives in a rapidly changing global environment, and for governments to create a favourable environment for the development of co-operatives including, if necessary, to offer those preferences for co-operatives which work for the betterment of the community and for the creation of an information technology in order to help co-operatives to operate more efficiently.
- c. Confirm and advocate to the UN and other relevant Development Agencies the contribution co-operatives can make in the area of Good Governance and Business Development as value-added features in Poverty Reduction Strategies (PRS) being undertaken by governments and Civil Society Organizations (CSOs) in ICA member-countries in Asia and the Pacific.
- d. Seek a new strategy through which co-operatives can become an integral part in the PRS processes being undertaken by the corresponding governments and CSOs in ICA member countries.
- e. Create and bring about effective and enhanced partnerships that have been developed with Trade Unions, Employers' Groups, women's groups and other Civil Society Organizations, and supported by multilateral and bilateral agencies as well as other partners.

Young Co-operators plan strategies at National Seminar on Student/Youth Co-ops in India

A national seminar was organized by the Regional Institute of Cooperative Management, Bangalore, India, in collaboration with the International Co-operative Alliance, Regional Office for Asia and the Pacific, the National Co-operative Union of India, New Delhi, Forum for Co-operatives in Educational Institutions, Chennai (FCEI), the Karnataka State Co-operative Federation Bangalore, at the Institute premises in Bangalore, 26-28 February, 2004.

The seminar was inaugurated by Mr. K.K. Misra, IAS, Chief Secretary, Government of Karnataka and chaired by Mr. B.S. Vishwanathan, Chairman, Co-operative Bank of India and Regional Institute of Cooperative Management, Bangalore. Mr. Ramesh Ram Mishra, Registrar of Co-operative Societies, Tamil Nadu and Chairman, FCEI, Mr. K.R. Shashidhara, Registrar of Cooperative Societies, Government of Karnataka, and Mr. Kiyotaka Ohno, Chairperson, ICA Consumer Sub-Committee on University/College Cooperatives for Asia and the Pacific. addressed the seminar. The delegates came from Japan, Indonesia, Sri Lanka and Karnataka, Tamil Nadu, Andhra Pradesh, Kerala, Pondichery, Orissa, Haryana and Assam.

At the end of the 3 days' seminar, the participants were grouped together in 4 groups and they discussed on the following 4 issues:

- Co-operatives and Corporates to confront or to collaborate.
- ii. How to Enhance Students' Participation in Campus Cooperatives.
- iii. Steps to be taken to Stabilize and Expand Students Co-operatives in India
- iv. Redesigning the National Youth Policy and Developing a National Youth Co-operative Policy.

Group 1 came up with a suggestion that it should be collaborative competition and not confrontation.

They have also pointed out examples of collaboration between cooperatives and corporates. They suggested amendments to cooperative acts and rules and increasing members' stake in the cooperatives.

Group 2 came up with various suggestions to enhance participation of students in campus co-operatives, like requesting the college authorities to include information about the co-operatives in the prospectus, organizing admission orientation seminars where discussions on campus co-operatives are given, campus co-operatives are given, campus co-op stores to sell one item every month at cost price, promoting a fund to help poor students, displaying price comparison with the market on products sold by the co-operative store. They also wanted

school/college authorities to remove the restriction on age limit, etc., providing concession to students who are active in co-operative activities, providing some remuneration to such students, etc.

Group 3 came out with ideas for stabilizing and expanding students'

co-operatives in India, by creating awareness among students, managements, teachers and parents, organizing joint purchases amongst the various co-operatives, introducing a credit/debit card system for purchase, incentives to loyal customers in the form of purchase discounts, etc.

They also suggested that micro-credit facilities be established by student cooperatives, and activities should be expanded from the current books and stationery stores, like running of cafeterias, recreation activities, health clubs, career guidance, transport services, language clubs, etc. Also publish newsletters and look and insist on a good location for the cooperative store.

Group 4 came up with various suggestions for developing a National Youth Co-operative Policy. They wanted a model bye-law for students' co-operatives all over India, minimum age for full-time membership to be reduced to 15 years, introducing co-operation in the curriculum of schools and colleges should include co-operation for eligibility tests, government to introduce a separate Indian Co-operative Services (ICS), etc.

During the seminar, the participants were taken on a field study trip to Citizens' Consumer Co-operative and the Dr. Vishveshariah Engineering College Co-operative, which they enjoyed very much.

Co-operatives for improving Asian slums

An International Seminar was organized by the International Co-operative Housing Foundation for Asia and the Pacific (ICHFAP) in collaboration with National Co-operative Housing Federation of India (NCHF), 19-21st January, 2004 at New Delhi. 30 participants, including representatives of co-operative housing institutions from various Asian Countries attended the Seminar.

The Seminar was inaugurated by Mr. Deep Chand Sharma, Chairman, NCHF and by Mr. Paramasvaran Kandiah, President of ICHFAP. The focus of the seminar was to evolve as a think-tank for resolving the problems faced by the poorer sections of the society who are unable to afford reasonable housing facilities and, therefore, are compelled to live in unhygienic and ill-equipped slums of various cities of Asian countries.

In the theme paper presented on 'Slums of Asian Cities: Role of Cooperatives for Improving their Living Conditions', Dr. M.L. Khurana, Director of the Foundation, explained the magnitude of the slum problems faced by various Asian Cities and the concern expressed by United Nations in tackling them. As an effective alternative, he suggested that the system of development of slums should be through the mechanism of co-operatives – a co-operative for housing, a co-operative for health and hygiene, a co-operative for water and sanitation, a co-operative for infrastructure, etc. or alternatively a multi-purpose co-operative for the combination of all the above.

The Seminar also deliberated issues relating to various technology options including adoption of new construction materials, designs and training programmes for artisans with a view to reducing housing cost, improving durability and increasing the skill levels of construction labourers.

NACF re-elects Chung as Chairman

Mr. Dae-kun Chung was re-elected as Chairman of the National Agricultural Cooperative



Federation (NACF) with strong support from the co-operative leaders in Korea.

Mr. Chung was first elected in 1999 and oversaw the establishment of the new NACF when the livestock and ginseng co-operatives merged with the former NACF in 2000. He served as the Chairperson of the organizing committee for the ICA 2000 General Assembly in Seoul and has been on the ICA Board since 2001.

The NACF is a multi-purpose agricultural co-operative and bank. It is the largest co-operative in Korea and has over 2 million farmer members.

Eighteenth ICA-Japan Management Training Course concludes

The Eighteenth [18th] ICA-Japan Training Course on "Strengthening Management of Agricultural Cooperatives in Asia" was held in India, Vietnam and Japan, from December 15, 2003 to April 17, 2004.

The programme was implemented by the International Co-operative Alliance [ICA] in collaboration with JA-Zenchu [Central Union of Agricultural Co-operatives of Japan] and the Institute for the Development of Agricultural Co-operation in Asia-Japan [IDACA]. A generous financial assistance was provided to the ICA by the Ministry of Agriculture, Forestry and Fisheries [MAFF] of the Government of Japan to conduct the programme.

The Course was held in the following two phases. Phase-I covered Home Country Assignments [December 15, 2003 to January 14, 2004]; Programme held in India [January 15-March 1, '04] and Programme held in Vietnam, Mar 2-6, '04], while Phase-II of the Programme was held in Japan at IDACA [March 7-April 17, 2004]

Twelve [12] participants from ten countries i.e., Bangladesh-01, China-01, India-02, Indonesia-01, Malaysia-01, Nepal-01, the

Philippines-01, Sri Lanka-01, Thailand-01 and Vietnam-02 were selected for this course, of whom, two were women.

The main objective of the Training Course was to help improve the capabilities of managers in agricultural co-operatives. It was expected that the trained managers, by using project-oriented approaches, help the basic members at the grassroots level to enhance and sustain their farm income. It was also expected that agricultural co-operatives introduce and accelerate

the agro-processing activities to add value to the primary products of their members.

Part I of the training course held in India was preceded by the Home Country Assignments [HCAs]. The participants followed downerehensive field study visits from March 2-6, 2004 in Vietnam, which was

organised in close collaboration with the ICA member-organisation in Vietnam, the Vietnam Cooperative Alliance [VCA].

The Course was inaugurated by Mr D.K. Bhatt, Marketing Director of the Indian Farmers' Fertiliser Cooperative Limited [IFFCO] at the Fertiliser Marketing Development Institute (FMDI) of IFFCO at Gurgaon. Mr Shil-Kwan Lee, ICA Regional Director for Asia and the Pacific, Mr Tomofumi Inoue, First Secretary in the Japanese Embassy in India, Mr. S. Fukamachi, Managing Director, IDACA, represented by Mr. Toru Nakashima, Deputy Manager (Trg), Mr. D.K. Bhattacharya, Joint General Manager (HRD), IFFCO, Dr. R.N. Kundu, Sr. Manager (Trg), FMDI and Mr. Prem Kumar, Adviser, ICA/Japan Training Course, attended the Inaugural Session. A message received from Mr. Fukamachi, Managing Director, IDACA, Tokyo, was read by Mr. Nakashima of IDACA at the inaugural session.

Mr Prem Kumar, Programme Adviser, ICA ROAP, was responsible for the conduct of the Training Course.

The programme in Japan was held under the direction of Mr S.

Fukamachi, Managing Director of the IDACA. Mr. Toru. Nakashima, Deputy Manager (Trg), and Ms. Eiko Oshita, Coordinator, were designated by IDACA as Programme Co-ordinators for the Part-II of the course.

As a part of their studies, the participants had produced 12 development project proposals during their Home Country Assignments [HCAs] in accordance with the guidelines provided by the ICA. They developed the concepts of these

proposals in consultation with their parent organisations. While at IRMA, the participants were imparted training in skills of developing project proposals.

The second part of the programme held at IDACA included extensive classroom work and study visits to agricultural co-operatives in and around Tokyo, Yamanashi and Kochi Prefectures in Japan. The focus of studies was on the historical development of the Japanese

Agricultural Co-operative Movement, innovations, management practices, and diversification and business promotion.

A continuous process of evaluation and appraisal has been followed throughout the term of the Training Course, e.g., at the end of each component, through evaluation forms and group discussions. An End-of-the-Course Evaluation was conducted at the conclusion of the Training Course. Certificates of Participation were awarded to the participants at a concluding session held at the IDACA in Tokyo before their departure for their home countries.

During these 18 Training Courses, a total of 267 managers of agricultural co-operatives from 14 countries of Asia had attended the training programmes. They prepared a total of 264 project proposals on topical subjects.

A Century of Indian Co-operative Movement

This year, in March 2004, the Indian Co-operative Movement has completed a century of its services to the nation. Starting with a limited spectrum of rural credit dispensation in 1904, the co-operative sector of India has expanded tremendously and emerged as a significant component of national economy.

With a wide network of more than half million co-operatives and membership of 230 million spreading from village to tertiary levels, the cooperative movement has acquired commanding heights in the spheres of agriculture, handlooms and handicrafts, finance and banking, distribution of consumer goods, etc. Besides economic development, the co-operative movement in India contributed to the creation of good public leadership. A sizeable number of members of the Indian Parliament and Provincial Assemblies have been associated with the co-operative movement.

To commemorate the achievement of co-operatives, the National Co-operative Union of India has constituted a high level committee for the Centennial Celebrations from village to national levels. All the sectoral federations at secondary, provincial and national level will be organizing seminars, conferences, discussions, debates, etc., important

publications will also be brought out on "Success Stories of Co-operative Movement during 100 Years"; "A Directory of Research on Co-operation"; and "A Directory of First Co-operative in all the States". The celebrations will culminate into a National Co-operative Congress during December, 2004.

As a part of the centenary celebrations, the National Federations of State Co-operative Banks of India, one of the members of the ICA in India, convened a national conference of co-operative banks to introspect on the achievements of rural co-operative credit system during the last 100 years and to formulate strategies to strengthen rural credit system in the context of the changing environment.

The Indian Co-operative Movement has been part of the ICA family since 1900.

Strengthening Co-operatives in Laos PDR and Cambodia

In pursuance of its Key Result Area of Co-operative Development, the ICA ROAP is focusing on those countries of Asia-Pacific, whose co-operatives have been victims of either political ideology or instability. In this context three countries, viz. Afghanistan, Cambodia and Laos PDR have been identified.

Mr. Shil Kwan Lee, Regional Director, along with Mr. B.D. Sharma, Senior Consultant, visited Laos PDR on 8-11 April and held extensive discussions with policy makers and senior officials in the Ministry of Agriculture and Forestry and also with leaders of water user associations, farmers' production groups, and self-help groups to examine the possibilities of promoting co-operatives.

On this occasion a National Workshop of officials incharge of implementation of various development programmes relating to agriculture and rural development was convened.

Important conclusions of the workshop are: (a)earlier coops collapsed due to interference of government and members' apathy; (b) there is a need to promote cooperatives. However, they should not be imposed from above. The prospective members should be educated appropriately in co-operative principles and management; (c) a few water users' associations/farmers' groups/self-help groups may be transformed into co-operatives on a pilot basis. After evaluating their success, country-wide replication process for co-operative development be initiated; (d) there is a need to develop a specific co-operative legal framework. The ICA was urged to extend required support in this regard; (e) the Ministry of Agriculture and Forestry (MAF) will create a core group of

officials who could be intensively sensitized in co-operative principles and management and approach/strategy on co-operative development in Laos PDR; and (f) ICA ROAP should organize capacity building programmes, both for core group members and also for leaders of pilot water user's associations/farmers'groups/self-help groups.

Last year, the ICA ROAP with the support of AGRITERRA of Netherlands had conducted a detailed study on the prospects of promoting agricultural co-operatives in Laos PDR. The study was also circulated in the workshop.

Mr. Shil Kwan Lee, Regional Director, along with Mr. B.D. Sharma, Senior Consultant, also visited Combodia recently and interacted with senior officials of the Ministry of Agriculture and Forestry to formulate an Action Plan to Strengthen Co-operative Institutional Framework for the benefit of farmers and the rural community.

Rural co-operatives were destroyed by a 30-year long civil war and the Government has taken a conscious policy decision to promote agricultural co-operatives on a pilot basis. The success of these pilot co-operatives will pave the way for their country-wide replication and also for promotion of co-operatives in non-agricultural sector.

The ICA interventions will add value to the efforts of the Government to promote co-operatives. Areas in which the ICA support has been sought are (a) capacity building; (b) formulation of suitable legal framework for co-operatives; (c) management of business of co-operatives; (d) development of suitable co-operative credit system; and (e) development of co-operative marketing system.

Now, the fourth training programme in Iran trained 25 participants from Iran, Malaysia, Nepal and Sri Lanka. Chairman, Central Organisation of Rural Co-operatives of Iran (CORC) inaugurated the one-week Trainers' Training Programme.

Ms. Rahaiah Baheran, Chairperson of the ICA Regional Women's Committee, Mr. M Karim Beiki, Managing Director, CURACI, Mr. Reza Geramipour, Dy. Managing Director of CURACI, representative of Governor of Esfehan city, Mr. Jiro Ito, Director-Special Programs, ICA ROAP, and several other prominent cooperators and faculty members of training center attended the from ceremony, apart participants. Message from the International Co-operative Alliance

Co-operatives for Fair Globalisation: Creating Opportunities for All

FAIR GLOBALISATION means putting people first; respecting their rights, cultural identity and autonomy, and the empowerment of the local communities in which they live. On this International Day of Cooperatives, co-operative enterprises worldwide, whether large or small should be recognised as making this kind of globalisation a reality.

Globalisation affects everyone. It undoubtedly has benefited many, but overall its advantages are not yet being felt by the majority of the world's Persistent population. imbalances in the current workings of the global economy are ethically unacceptable and politically unsustainable. The World Commission on the Social Dimension of Globalisation made up of world leaders has been working on finding ways to make globalisation work for all. They argue that economic benefits should and could be more fairly shared through fair alobalisation based universally shared values, and respect for human rights and individual dignity which is democratically inclusive. and provides governed opportunities and tangible benefits for all countries and people.

The Commission highlights the critically important role that cooperatives can play in shaping the evolution of globalisation alongside other actors of civil society. It specifically mentions the key role co-operatives can play in the following areas: strengthening dialogues and governance - co-operatives have long been known as "schools of democracy": strengthening economic capacity - co-operatives are market leaders in many industry sectors around the world, they also often address situations of market failure thus ensuring the economy functions more efficiently; building a local economic base - co-operatives start by addressing a local need. but they remain committed to their local communities, unlike some businesses: increasing corporate social responsibilities - co-operatives have long been innovators in combining economic and social values and practices.

People at the heart of enterprises that is what cooperatives are all about. Cooperatives create opportunities for people to help themselves; to response to the economic and social challenges faced in their lives. Over 800 million people around the world are already members of co-operatives. Cooperatives employ more women and men than multinational corporations, one of the main symbols and beneficiaries of globalisation. Although co-

operatives focus on serving and meeting local member's needs they also connect and cooperate globally. They share a set of internationally agreed principles and values. Because of their democratic base and unique combination of economic and social objectives they are ideally placed to play a role in making globalisation fairer – something they have been doing for generations.

In many ways co-operatives represent a fairer and more human face of globalisation. For example, co-operatives themselves are globalising their activities with transnational co-operatives that respect local communities but are economically competitive with multinational enterprises.

Fair trade initiatives for the most part include a co-operative component either at the producers or retailer side, and enable smaller producers to access global markets. And no matter what activity that a co-operative may have at an international scale, the economic and social return goes to its members usually in local communities.

Globalisation is not of itself necessarily bad. The challenge is to make it fairer and distribute its benefits more widely. The cooperative movement stands ready to play its part.

The Steering Committee discussed in details about the youth seminar and the sessions and came out with recommendations the respective national co-operative organizations and the ICA in the Region, suggesting ways and means to development youth co-operative activities in the region.

The closing session was addressed by Mr. Iain Macdonald, Director General of the ICA.

National Workshop on "Strengthening Agricultural Coeperatives in Cambodia"

ontinuing its interventions for the co-operative development Jin Cambodia one of the least developed countries of Asia - Pacific Region, ICA Regional Office sponsored a national workshop on strengthening agricultural cooperatives in Cambodia on 16-17th September, 2004. Nearly 60 participants including Chairmen of pilot co-ops, senior government officials at national and provincial levels in-charge of farmers organizations and pilot co-operatives, representatives of Rural Development Bank, a few community based organizations and international NGOs interested in co-operative development, represen-tative of FAO, JICA etc. participated in the workshop. Hon'ble Minister of inaugurated the Agriculture workshop and Secretary General of the same Ministry delivered valedictory address. Inputs to the workshop included presentations from experts from Thailand, Republic of Korea, Ministry of Agriculture of Cambodia and ICA ROAP Mr Shil Kwan Lee, Regional Director and Mr. B.D. Sharma, Sr. Consultant.

After two day intensive discussions the workshop prepared an action plan

specifying action points regarding agricultural co-operatives. The action plan includes following components:

- Formulation of specific policy on agricultural co-operatives;
- 2. Establishing an appropriate cooperative legal system;
- Identification of areas of government support;
- 4. Clear enunciation of goals of agricultural co-operatives;
- 5. Formulation of clear business and functional structure of agrico-operatives;
- 6. Creation of a suitable

- mechanism for development of agri-coops within the Ministry of Agriculture;
- 7. Specific actions regarding capacity building and creation of financial system for agricultural co-operatives.

Participants have formulated practical recommendations on these components that will form the basis of strategy for the development of agricultural co-operatives in Cambodia. Both government and farmers organizations are very much supportive of co-peratives.

APHCO holds is tenth board meeting in Bangkok

he Asia-Pacific Health Cooperative Organisation, a specialized organization of the ICA in Asia-Pacific Region, held its 10th board meeting at Bangkok, Thailand, 19-20 July, 2004.

27 delegates and 15 observers from Japan, India, Malaysia, Sri Lanka, Nepal, Vietnam and Thailand participated at the meeting.

Opening the board meeting, Dr. Yasuyuki Takahashi, Chairperson, APHCO thanked the CLT for hosting this Board Meeting of APHCO in Thailand and welcomed the participants. There were two main objectives for the meeting, (1) sharing experiences on "healthy community building" to clearly define the role of health co-ops; and (2) promoting international human exchange programmes to train future bearers of the co-operatives.

Mr. Wirat Iam-Ua-Yut, Chairman of the Co-operative League of Thailand thanked APHCO board for holding its meeting in Thailand and also welcomed the participants.

Mr. Jiro Ito, Secretary of APHCO, highlighted the main points in the minutes of last meeting and also reported the activities carried out by the Secretariat since last meeting.

One CT Scanner was offered by HCA-JCCU and Sri Lanka has shown keen

interest to have the CT Scanner. So far Sri Lanka and Nepal have given their requirement of used equipments. A Study Mission was sent to Vietnam to survey the healthcare situation in Vietnam, which submitted its report.

Dr. Yasuyuki Takahashi, Chairperson of APHCO, reported about the IHCO Board meeting held on 10-11 June 2004 at Ottawa, Canada. He informed that the IHCO includes members from Belgium, Brazil, Canada, Japan, Malaysia, Russia, Spain and Sweden. From Asia, HCA-JCCU, Japan and KDM Malaysia are members of IHCO. He requested other members of APHCO to become

its members in order to share their experiences with other countries of the world.

Country reports were presented by the representatives of Japan, Malaysia, Nepal, Sri Lanka and India. Copies of the presentations were distributed amongst members.

It was reported in writing that 8 Japanese medical students joined the training session held in Nepal, August 19 to 31, 2003. The students studied a lot about primary healthcare in the community through many activities; i.e. assistance for blood collection from donors at Kathmandu Model Hospital, teaching the villagers how to measure blood pressures and body-fat and how to brush teeth, home-stay at the houses of Phect Nepal leaders, etc. A similar training will be organized in 2004 as a next step and some medical students have already signed up.

Dr. Somkiat Tatritorn of Thailand gave an account of Health situation in Thailand. From his presentation, it was clear that there was no health care co-operative in Thailand. Only public hospitals, private hospitals and health centers are there. They are keen to introduce health care cooperatives. They wanted APHCO to help in the introduction of health care

co-operatives in Thailand.

Fujiwara, Chairman, Committee on Health Activities, HCA-JCCU, toured Vietnam from 1-7 March, 2004, as the head of the committee's delegation to study the situation of health care in that country. Lack of health care infrastructures could be felt in many places. For instance, at the Tu Du Hospital, a central hospital for genecology in Ho Chi Minh City, there were only 1,000 beds for about 1,300 in-patients. A bed is often allocated to two patients with one of them sleeping on a foldable bed besides the bed at night. There were also patients lying on the floor on straw mats in the ward corridors.

Public employees generally have health insurance, but non-insured patients must bear all the healthcare costs. The way hospitals deal with poor patients varies from one hospital to another: In rural areas, even general hospitals are more like what they used to be in Japan some 40 years ago. Village clinics also look like countryside health-centers that

existed in Japan in the past. Their major activities seemed to be directed at protecting health rather than providing medical care.

He said that the APHCO should see how we can build on the relations we have established. We believe that, in the fist stage, we should organize seminars and study meetings to make known the movement of Japanese health co-operative, its aims and practices. In particular, we should conceive different initiatives through which we can get our message well understood while respecting the "Vietnamese way" of doing things.

National Conference sets up pace of cooperative reforms

The National Co-operative Development Corporation organized a conference of Secretaries in-charge of Co-operation, Registrars of Co-operatives and Senior Executives of Co-operative Federation in New Delhi, 28 July, 2004.

The conference focused on the problem faced by co-operatives and the strategies the co-operatives can adopt to meet the present challenges and step up the pace of co-operative reforms. Ms. Radha Singh said that the enactment of Multi-state Co-operative Societies' Act 2002 was a major step for the development of viable co-operative organizations. She further said that the Ministry of Agriculture is emphasizing on transparency, accountability, professionalism, quality services, and enlightened and democratic leadership in co-operatives.

Ms. Singh was very appreciative of the Integrated Co-operative Development Project of the NCDC and cited the NCDC initiative in which support would be provided for women's activities through co-operatives, by providing 100 per cent subsidy for training and consultancy and 40 per cent for infrastructure.

Mr. Dinesh Rai, Managing Director, NCDC, welcomed the delegates. Mr. Rai noted the work of co-operatives in rural credit sector and said that the possible areas and sectors which could gain excellence as marketing, fisheries, horticulture, handloom, consumers, labour, etc. During the conference perspective plans for NCDC assistance to all states, amounting to Rs.5928 crores have been prepared.

The meeting had a large gathering of about 100 delegates from various states in India.

Community Gardens provide health benefits to urban dwellers

live in Vancouver, in a small apartment that has no access to the outdoors other than a small fire escape that hovers over a busy, urban street. Yet I am about to prepare a salad of organic tomatoes and herbs that I have grown myself. No, I do not have an expensive indoor lighting system. What I do have is a plot in a community garden, 2 metres by 2 metres, which keeps me stocked throughout the summer months in tasty, organically grown salads, beans, herbs, tomatoes, radishes, and beets. I also grow bright, colourful flowers with which to grace the kitchen table and uplift the spirit.

Community gardens exist in various neighbourhoods throughout Vancouver. They offer urban apartment dwellers access to land and community-shared tools with which to garden, thereby reaping the benefits of interacting with the land:

gardeners to the surrounding neighbours who appreciate the beauty and wildlife they add to big city environments. There are those who vandalize (one year someone maliciously beheaded all of the sunflowers in the garden) and steal the odd vegetable, plant, or trellis, but by and large people respect and



dozens of gardens in Vancouver and the Lower Mainland.

There are usually 15-20 individuals or families per garden, who work both individually on their own plots and collectively to maintain the garden as a whole. Work Parties are usually organized at the beginning and the end of the season in order to prepare beds, weed the paths, and clean the gardens of dead plants for overwintering. Such occasions are usually quite festive, with the participants each bringing a dish of freshly made food to be shared with other gardeners.

Municipal authorities recognize the valuable role of community gardens in terms of environmental awareness and education, community development and social awareness. The Vancouver Parks & Recreation Board has an active policy in place to encourage and support those who are interested in creating and maintaining community gardens.

Specifically, such support is given by assisting interested parties in finding available land, negotiating with the landowner, and assisting with a program for community education about the garden. Land considered available is not only private but possibly also city-owned land or land owned by other government agencies.

Community gardens are part of an overall approach to the City of

a quiet oasis from the din of city sounds, a sense of pride and ownership over the garden and the neighbourhood, the opportunity to be creative, physical activity, and something to put on your dinnerplate, as well!

The pride of the community garden extends beyond the individual

appreciate the existence of urban gardens.

Community gardens in Vancouver and throughout Canada are run as non-profit societies or co-operatives. Plots are open to anyone in the community for a small yearly fee (C\$10-20), though there are often long waiting lists despite there being

Vancouver's Food Action Plan, designed in response to our food system as it presently exists – bringing in foods from far away locales incurs huge expense, both in monetary terms and in terms of environmental repercussions resulting from the use of fossil fuels in long distance transport, the chemicals used to preserve and ripen fruits. Ultimately, our disassociation and industrial treatment of our foods wreaks havoc on our collective health.

Community gardens are mandated to be organic, prohibiting the use of chemicals which kill wildlife, and eventually, humans as well. Skills such as composting, crop rotation, and companion planting are taught in well-organized gardens. Our grandparents knew the wisdom of these techniques; since then we have been systematically destroying our fertile soils and hardy strains with modern techniques such as monocropping and genetic modification. Fortunately there are many people working hard to educate supermarket shoppers on the dangers of mass food production gone awry, and promoting healthy choices and ensuring that stores carry organic alternatives.

Vancouver has become a leader in the development of sustainable food policy and practice, which includes: community gardens, rooftop gardens on top of apartment buildings, farmer's markets, community (shared) kitchens, the distribution of excess fruits from backyard fruit trees to agencies serving the homeless, emergency food distribution and the local food economy.

Giving people the opportunity to

participate in the growing of wholesome, healthy foods and to share the process with their own communities is a fundamental building block of sustainable agriculture and food policy. Though cities are known throughout the world as 'concrete jungles', community gardens give us the opportunity to reclaim public space and make it green again, to build relationships with our neighbours, to feed ourselves and our children, and to beautify our surroundings.

There is something very rewarding about being intimately involved with your food: collecting and planting seeds, nurturing your garden, plucking the perfectly ripe tomato fresh from the vine and then eating it before you even get home. It is a symbiotic relationship - the more nurturing we give to the foods and the more loving we put into the creation of meals to be enjoyed with the people we share our lives with, the healthier and more nurtured we will be.



The workshop was organized by ICA Committee on Consumer Cooperation for Asia and the Pacific and hosted by Singapore National Cooperative Federation (SNCF) and NTUC FairPrice Co-operative. 22 managers from 6 countries (India, Indonesia, Philippines, Sri Lanka, Thailand and Vietnam) participated

tedly one of the most successful consumer co-operatives not only in Asia but also in the world. The co-op has nearly 60% of market share of supermarket business in Singapore with 463,000 individual members and 75 supermarkets and 34 convenience stores. The participants learned the store management theories from the lectures by the experienced managers of FairPrice and practiced the comparison of the stores between FairPrice and their competitors. The participants collected information from their store for comparison and sharing them with each other, which will benefit their cooperatives for their management.

The program included the presentation by Mr. Yabuta of Co-op Kobe, the biggest consumer co-op in Japan, which introduced their experience of recovery from their hard times after the big earthquake in 1995.



Fourth Training course for strengthening women's agricultural co-ops in rurai areas held

The International Co-operative Alliance Regional Office for Asia and the Pacific (ICA ROAP), in association with its member organisation in Japan, the Central Union of Agricultural Co-operatives of Japan (JA-Zenchu) and IDACA, organised the 4th ICA-Japan Training Course for "Strengthening Women's Agricultural Co-operatives in Rural Areas and Improvement of Farm Management and Rural Life" in Malaysia and Japan. Eight participants - two each from Bangladesh, India, Malaysia and Nepal, attended the training course, which was and funded by the Ministry of Agriculture, Forestry and Fisheries (MAFF), Government of Japan.

The Course was organised and held



by the ICA at the IDACA premises from 05-30 September 2004. The 10-day component of Comparative Field Study Visits was held in Malaysia from 26th August to 4th September 2004 in collaboration with ANGKASA. The field study visits in Japan were arranged to agricultural co-operatives and women's associations in Mie and Nagano prefectures of Japan. Lecture-cum-

practical field study visits assignments were combined to impart necessary knowledge to the participants on the working of women's associations and the general activities of agricultural co-operatives in Japan.

The main objective of the training course was to train women leaders in rural areas in developing countries by means of strengthening women's agricultural cooperatives, farm management, and improvement of rural life. The training course also provided opportunities for capacitybuilding of the participants with a view to organise women's associations and study co-operative activities. An endof-the-course evaluation session was also held.


The activitity report for the year 2004

he ICA-Asia & Pacific, in collaboration with the ICA Regional Research Forum convened the 3rd Regional Co-operative Research Conference at the Lotus PSK Hotel, Chiangmai, Thailand. The Conference was inaugurated by Ivano Barberini, ICA President, who stressed on the need for values, culture and professionalization to sustain cooperative growth in a competitive world economy. Amnat Rojanapaibul of the CLT welcomed the delegates. Akira Kurimoto, Chairman of the ICA Global Research Committee, welcomed the delegates and explained the research activities of the ICA in different regions of the world. M.V. Madane, Chair of the Regional Research Forum, presided, and explained the background and the objectives of the conference.

The Conference was attended by 81 Researchers and Experts working in academic institutions and field-related co-operatives in the Region. Shil Kwan Lee, the ICA Regional Director,

explained the activities of the regional office during the current year.

Twenty-one papers were presented on

the three themes kept for discussion at the Conference. Theme One: Widening the areas and scope of Cooperative Action; Theme Two: Cooperative Governance and Globalization; Theme Three: Role and Dynamics of Women's Co-operatives.

Out of the 21 papers, ten were presented by awardees of the fellowship given by the Consumer Cooperative Research Institute of Japan.

The emphasis during the Current Conference was on Empirical Research to identify problems and development indicators. This emphasis was aptly justified by several presentations. It was possible to put the co-operatives on the path of progress, if need-oriented policies are formulated after identifying the drawbacks. Several papers proved the effectiveness of this approach.

Country Reports on HRD activities were presented by members from India, Indonesia, Malaysia, Sri Lanka and Thailand. The meeting decided that in future country reports should be replaced with "Presentation of Initiatives on HRD".

The meeting unanimously re-elected Mr. Leow Peng Kui from Singapore and Mr. Bhagwati Prasad from India as Chairperson and Vice Chairperson respectively for another term.


