e 9th Asia Pacific Co-operative Ministers' Conference held 27-29 February 2012 at UNCC in Bangkok, convened by A-AP and hosted by the Government of the Kingdom of ailand was attended by 14 Co-operative Ministers and out 300 delegates including government representatives, ernational delegates and ICA members from the Asia cific Region.

The Deputy Prime Minister highlighted the significance of co-operatives in the national economy and social stability and therefore, the government is committed to support and promote growth of co-operatives.

Mr. Li Chunsheng, President ICA-Asia Pacific expressed deep appreciation for the support of the Royal Government of Thailand for hosting the conference and the warm hospitality extended to delegates.

Overview of the conference

Dame Pauline Green, in her special address, highlighted facts to establish the unstated yet significant role of co-operatives in global economy as co-operatives have one billion members as compared to just 327 million share holders of companies listed in the stock markets and the net worth of 300 globally successful co-operatives published every year is about US \$ 1.6 trillion. She however regretted that the present role of cooperatives in environment and conservation and its future potential in this field were not noted in the Rio Conference and ICA has been trying to include Co-operatives as an item in the forthcoming Rio+20 conclave.

The Conference Honoured Mr. Shill Kwan Lee for successfully organising three Co-operative Ministers' Conferences during his tenure as the Regional Director of ICA-AP from the year 2002-2009.

There were 36 speakers from 21 countries including 14 Cooperative Ministers, 3 international organisations; FAO, ILO and ACCU besides 4 Government representatives and cooperative success stories presentation by the ICA-AP members. The important highlights of the statements made by the Honourable Ministers are as follows:

- 1. Concerns about the unsustainable exploitation of natural resources for profits only and that commodification of public goods, rising prices, privatization of public services have been causing massive hardships for the common people and the cooperatives must step in to institutionally counter these adversities.
- 2. To expand the base of the co-operatives it is imperative that the activities of the SHGs, Micro Credit and Micro Finance Institutions, NGOs and Civil Society groups with shared values and methods of organisation are brought within the ambit of co-operatives.
- 3. Empowerment of women could be achieved by innovative programmes such as tree plantation in Mongolia and forming women led Diary co-operatives as achieved in India, Bangladesh and elsewhere.
- 4. The Governments of Malaysia, Thailand, Indonesia, Bangladesh, Brunei, Bhutan Iran Mongolia, Nepal and Sri Lanka reported policy, law and institutional changes

- made to create an environment conducive to co-operative development, while Philippines and Laos emphasised measures to make farms increasingly 'use organic methods through the co-operative mechanism with support from the Government to bring about balanced agriculture development.
- 5. The Islamic Republic of Iran projected the present share of cooperatives in the GDP at 9% and a target of 25% to be achieved in five years due to the concerted efforts of the Government to strengthen and expand the co-operatives and suggested formation of a consortium of Governments to support co-
- operatives and a common chamber of co-operatives and regional and international unions for all co-operatives.
- Japan, Korea and Vietnam informed the conference about new mechanism to promote ethical consumerism and co-operatives becoming an integral part of economic transformation programmes with emphasis on upgrading the capacities of co-operatives to take up larger business activities. Mr. Shuji Yamada informed the exemplary work of Agricultural Co-operatives in providing relief to the victims of last year's devastating earthquake and highlighted their role in food security, sustainable development and diversified activities leading to diffusion of democracy. Considering the positive role of co-operatives, the National Planning Committee is engaged in the preparation of a comprehensive plan for co-operatives in Japan.
- 7. The Minister from India informed that the co-operatives are taking up a wide range of diverse activities and also informed about the legal and policy reforms undertaken by the government to reform the sector and in particular the credit sector.

The Conference in progress

- The Minister of Bhutan stated that Bhutan has taken up a plan to promote co-operatives to achieve holistic human development in line with its development philosophy of Gross National Happiness which goes beyond GDP based on only material factors. The co-operative law 2009 has been enacted to provide the framework under which 170 co-operatives have been functioning. Bhutan supports the ICA Principles at this stage and is keen to actively participate in the UN and ICA work relating to co-operatives.
- The President of the Co-operative League of Thailand urged upon creation of a strong capital base needed by co-operatives of the region. Hence special funding arrangements are to be created by the Governments to facilitate the growth of co-operatives.
- 10. The representative from Nepal stated that the cooperatives are to be the foundation of Nepal's economy based on multipurpose co-operatives, micro enterprises, and diary co-operatives with emphasis on participation of women and disadvantaged sections. A new Co-operative Law in conformity with ICA Principles is under preparation. Reforms in co-operative Policy are being considered under a mission mode approach to

- achieve professionalization and efficiency to raise share of co-operatives in the GDP from the current I level of about 3.2%.
- 11. The representative from Kuwait stated that the concept of co-operation is rooted in Kuwaiti tradition of community help which the Government has harnessed to develop co-operatives in different spheres.

At the end of each session, the conference provided an open forum for the delegates to participate in the proceedings.

Several governments argued for special funding mechanisms

for the development of co-operatives by initiating a Special Co-operative Fund and submitted their presentation materials. In order to make the conference more effective, the ICA-AP is commissioning critical study of cooperative law and policy of countries in the region before every conference which is being presented and discussed in the conference. This study gives an insight of prevalent practices and 'what is working what is not" which is meant to help the ministers and stake holder in creating a road map for future progress. This time also the 4th Critical Study was completed by Mr.Rangan Dutta, Sr. Consultant of ICA-AP and was presented by him at the conference.

The proceedings of the conference were concluded with the

adoption of the Joint Declaration, consideration of the conference report and the concluding address by the Honourable Deputy Minister of Agriculture and Co-operation of The Kingdom of Thailand, Mr. Nattawoot Saikuar. Dr. Chan Ho CHOI, Regional Director of ICA-AP expressed his deep appreciation and gratitude for the warm hospitality and

all round support provided by the Government of Thailand and also acknowledged with gratitude the support of the Honourable Ministers and delegates by attending and actively participating in the conference.

Governance

Regional Board Meeting



Board members and observers

The meeting of the ICA-AP Regional Board was held in Bangkok on Sunday, 26th February 2012. 30 persons including Board members, officials and observers were present.

Mr. Li Chunsheng, President, ICA-AP welcomed the board members and extended warm welcome to all and especially to Dame Pauline Green, President of ICA who was also present. Dame Pauline Green came to Thailand to attend the meeting of the ICA Domus Trust and the 9th Asia-Pacific Co-operative Ministers Conference which was to be opened next day. He also welcomed the youth representative - Ms. Tahmineh Kashani of CURACI, Iran – for attending the board meeting for the first time.

Dame Pauline Green thanked Mr. Li Chunsheng for making excellent arrangements for the meeting. She said that 2012 is an important year for international cooperative movement and we have a key job to do. International economy is still in a

chaotic situation. In this context, she thinks the message we have given to the UN that we need more diversified economy is a critical one.

She underlined the importance of cooperatives that has over 10 billion members across the globe compared to shareholders of companies listed in the stock market that is just 327 million. The list of Global 300 successful cooperatives published each year alone is worth 1.6 trillion US dollars from 25 countries including Asia. She extended an invitation to all members to the closing of the international year of cooperatives on 31st October 2012 in Manchester. She also informed that there would be a special General Assembly of ICA where key issues would be discussed and the invitation will be sent soon. Ms.Green also appreciated the region for the good work being done.

She informed the meeting about the ICA Domus Trust meeting held in the morning of 26th February at the same venue

wherein trustees/members have finally reached to an agreement on the appointment of trustees which has been pending for a long time. She specially thanked Dr. Chandra Pal Singh for taking the right way forward. She informed the meeting that there were two different kinds of advices from the lawyers and hence a practical way had to be found.

The meeting conducted usual business of approval of the current agenda and minutes of the last meeting, report of the activities, financial report and ratification of the substitute Board member from Vietnam etc.

Dr. Choi also informed about 3,000 books received from ICA, Geneva to Delhi office library and plan is to digitalize the library so that the member organizations would be able to retrieve these documents through ICA-AP home page.

Talking about membership situation of the region, Dr. Choi informed that Pishgaman Kavir Yazd Cooperative Company (PKYCC) of Iran has applied for membership of ICA and National Federation of Urban Cooperative Banks and Credit Societies Limited (NAFCUB) of India ceased to be a member of ICA due to non-payment of membership. The current total membership of ICA-AP is 77 organizations from 25 countries. Constitutions of ICA-AP Sectoral/ Thematic Committees were also discussed .There is need to review the constitutions of the committees and there should be a model Constitution to increase the participation of members in a democratic way and achieve the objectives.

Mr. Phanuwat Wanraway, Chief of International Department, Cooperative League of Thailand made a presentation on Thailand's Flood Disaster in 2011 and Rehabilitation Plan of CLT for the benefit of the members. The CLT thanked the members for their generous financial support.

Dr. Choi informed the meeting that the 10th Meeting of ICA-AP Regional Assembly and Related Events would be held in Kobe (Japan) from 26th to 30th November 2012. The venue of the meeting would be Kobe International Conference Centre.

Agenda on Celebrations of IYC-2012 also came up for discussion. Dr. Choi requested the board members to send information about their activities to be posted on the ICA-AP website to be shared with others.

The members informed that the following activities would be hosted by their respective countries:

Singapore:

- (a) The International Year of Cooperatives 2012 celebration comprises 3 events; a 1-day conference on 3rd October that focuses on "How social capital drives profits, growth and sustainability".
- (b) Auto venture with 150 vehicles from Singapore to Kuala Lumpur.
- (c) Coop Hot Shots a photography competition with the 5 competition themes: cooperation, self-help, equality, mutual help, care for others during1st March to 30th April.

India:

National Co-operative Congress will be held in April. The President of India would be inaugurating. It is going to be a big event.

Indonesia:

- (a) International cooperative day celebrations in July.
- (b) International seminar on role of cooperatives.
- (c) IYC will also be celebrated at provincial level.

Malaysia:

- (a) Auto venture.
- (b) Setting up of a factory for clean drinking water.

China:

- (a) Organize series of events at national, provincial and primary level including exhibition, fair, workshops etc.
- (b) Trade networking.
- (c) Cultural activities.



he Urmia Economy Consumption Cooperation was established in Shahrivar 1363 (September 1985). The primary capital was 26 dollars divided to 260 shares. The main task is meeting members need and providing them with public goods. All the activities of the co-operative led to loss of money. Even dissolution of the co-operative was planned.

The main activity of the co-operative was on home appliances. The place of the co-operative from inside the organization was changed to outside where you can have close contact with the clients. The afore-mentioned measures as well as building trust amongst the members of the board of directors, devising other's opinions, and the like brought boom to the co-operative.

Under the current management the number of staff has risen from 2 to 20 people. The capital grew from 6000 dollars to 4000000 dollars. Its sale grew from 100000 dollars to 650000 dollars. The co-operative has signed contracts with over 40 company and stores to use their services. This is a leading Co-operative in selling home appliances in instalment plan during a period of 12-36 months. Over 15000 members buy products from the co-operative stores. Establishing more sales centres for members and governmental employees and planning to have direct import from other countries are the future plans of the Cooperative.

Around the Region

Isreal: NISPED

eW Co-op Japan and Israel Coop movement and Isra Aid are operating joint workshops for nurses in the Northern Japan Tohoku region.

MullyDor, from Israel, Chairperson of NISPED and Board member of the Central Union for Co-operative Initiative and IsraAid in Israel, met last week in Tokyo Japan with Keiso Fujitani managing director, Hiroki Tokubo Executive director and Miwako Takato chief of nurses in Japanese Health and Welfare Co-operative Federation (HeW Co-op Japan). Since the March 2011earthquake and tsunami IsraAID and HeW co-op Japan are operating together PTSD (Post traumatic stress disorder) Workshops for nurses in Korivama, Fukushima Prefecture in the Northern Japan Tohoku region. In the meeting they discussed the ways to continue the successful PTSD workshops in 2012 and 2013 and ways to launch new programs to support the efforts of the people of Tohoku to recover, rebuild, and mobilize for a better future.

Since it began its activities in the town of Watari, IsraAID's (Israeli NPO that was founded by NISPED, Israel coop movement and Israeli NGO humanitarian organizations) work has expanded from one

small group to 30 different groups spread across 8 towns of the Miyagi and Fukushima prefectures of Northern Japan's Tohoku region. IsraAID works with temporary housing residents, local government officials, teachers, children, nurses, community representatives, counselors, social workers and parents from these communities, and helps to alleviate the stress and tension these individuals are experiencing in the aftermath of the disaster. In the coming


year, IsraAID will aim to provide tools and training that can be implemented by professionals (nurses, teachers, counselors) in their work in the future, therefore creating a sustainable model that will last for years to come.

Mully Dor Keiso Fujitani and Hiroki Tokubo who agreed to continue the cooperation in disaster relief projects in the future, said that this

joint project is a good way to express the solidarity among the Japanese and Israeli coop movement in The International Year of Co-operatives. This joint program provides an opportunity to captivate the attention of national governments, the business community and the general public on the advantages provided by the co-operative model and cooperation among coop movements.

India:

FISHCOPFED insures 3.48 million fishers in India



FISHCOPFED, India offers a Group Accident Insurance Scheme for the fishers focusing to have a system that compensate members in times of misfortune and thereby guaranteeing their personal and financial security. In the year 2011-2012, FISHCOPFED has covered 3.48 million fishers of the country under the Centrally

Sponsored Group Accident Insurance Scheme, with a cover of Rs.1,00,000/- (around 1886 USD) against death and permanent (total) disability and Rs.50,000/- (around 943USD) against permanent (partial) disability, as a result of accident against an annual premium of Rs.28/-, out of which 50% is paid by the State Government and 50% is paid by the Central Government. For the north-eastern states, the premium ratio is 25:75 whereas for the UTs entire premium is borne by the central govt. It is a 24 hours insurance scheme covering 19 states and 4 union territories of the country.

Besides the above insurance, FISHCOPFED is also planning some more insurance schemes in India like Hut Insurance, Health Insurance, Fish-Pond Insurance and Pond-Fish Insurance for the welfare of the poor fishers. FISHCOPFED also stresses the need to save the lives of these fishers from various accidents as someone has well said precaution is always better than cure. FISHCOPFED conducted a survey on the causes of fatalities with the fishers in the five states of India to find out the precautionary measures to protect their lives specifically in sea accidents.

Korea:

50th Anniversary of Korea National Federation of Fisheries Co-operatives



The Celebration

Korea National Federation of Fisheries Co-operatives (KNFC) held its 50th anniversary on 2nd April, 2012 with South Korean President Lee Myung-bak, Minister of Ministry of Food, Agriculture, Forestry and Fisheries and many cooperators from home and abroad.

President Lee Myung-bak said that KNFC has played a major role in fisheries in Korea and requested its continuous efforts to make the fisheries into a new growth engine in the future. He also pledged that he would support the fisheries co-operatives to become the protectors of fishermen and to be the best co-operatives in the world.

President of KNFC Lee Jong-koo promised that he will do his best to make a new leap toward the best co-operatives based on the experiences of the last 50 years. He also received the Golden Tower Order of Industrial Service Merit which is the best honor.

KNFC introduced a new vision - "One value, one united force, and the best co-operatives at the event. After the event, ICFO delegates had a chance to look around the Korean fisheries facilities in Pusan. They visited Pusan Fisheries Cooperative, Pusan Cooperative Fish Market and Pukyong National University which has turned out best fisheries related manpower with the best college of fisheries sciences facilities, fisheries and marine Sciences laboratory center, etc.

Iran: ICC: IYC -2012

Islamic Republic of Iran Central Chamber of Co-operatives (ICC) as the apex organization of the Co-operative Sector in Iran has a plan to hold a series of International Conferences on different areas in the International year of Co-operatives (IYC). two nations but also among Iran and all African countries, East Africa in particular".


Korea:

"UR JIMS" co-operative

The story of the "Ur jims" co-operative was presented by Ms. D.Tsendsuren, Director of the co-operative at the 9th Asia Pacific Co-operative Ministers Conference held in February 2012 in Bangkok, Thailand. The "Ur jims" co-operative is a women led co-operative and is member of the National Association of Mongolian Agricultural Co-operatives.

The co-operative was established in 1999 with 10 members, who are single mums. It started with 2,5 million tugrugs (MNT) and in 2010 this fund increased to 85 million MNT. Now as on 2011 it has 35 members out of which 32 are women.

The main activities of the co-operative are:

- Forestation
- Fruit tree plantation
- Fruit processing
- Seedling nursery

The "Ur jims" co-operative produces:

- 7.5 tones sea buckthorn
- 1.5 tones gooseberry
- 15000 sea buckthorn seedlings
- other green house plants every year

Advantages of the co-operative

- Permanent activities
- Regular increase of members' income

- Members' active participation
- Market recognized high quality product
- Good leadership member's mutual solidarity and
- Trust in their leaders and their ability and willingness to make the cooperative business successful
- Empowers women economically and socially

Eco-friendly activities

- One of the co-operative's main goals is to afforest the region. It started with 56000 tree saplings in 1 hectare. In past 12 years, the co-op has regenerated 360 hectares of wasteland and have planted over 2.1 million trees
- New varieties of trees were introduced in the region in 92 hectares and called their place "Green wall"
- Co-operative by this activities fights against desertification, helps to balance the eco-system and protects the environment
- 90% of Mongolian territory can be regarded as vulnerable to desertification
- These areas are almost exclusively used rangelands, supporting about 40 million heads of livestock and numerous populations of wild animals

Report of the Committee on Youth Employment - 101st International Labour Conference

The 101ST International Labour Conference
held in May-June-2012 discussed and passed
resolutions on youth employment which was

The resolution in particular includes a number of references to co-operatives including:

- guiding principles on youth employment
 Promoting youth entrepreneurship with the aim of encouraging the growth of sustainable enterprises, including co-operatives and social enterprises, in rural and urban areas.
- youth entrepreneurship and selfemployment through co-operatives (para 35)

- enabling environment for businesses owned and run by youth - including for co-operatives (para 37 and recommendation for governments para 40b)
- inclusion of co-operatives in entrepreneurship programmes (para 38)
- improving access to finance for co-operatives (para 40 d)
- co-operatives in curricula (para 40 g)
- technical assistance for co-operatives (para 53).


Development of Consumer Sector

More than 50 persons participated in the Workshop. After the Workshop, the participants enjoyed visiting Co-op Wennappuwa.. Co-op Wennappuwa is a multi purpose co-operative society that is located about 2

can become a co-op member by paying Rs. 100 as share capital and can receive services from the co-op.

Message of the International Co-operative Alliance (ICA)

90th ICA International Co-operative Day 18th UN International Day of Co-operatives 7th July 2012

The 2012 International Day of Co-operatives is a day of unusual significance, as 2012 marks the United Nations International Year of Co-operatives. In keeping with that special occasion, the theme for the International Year is also the theme for this International Day: 'Co-operative enterprises build a better world'.

The International Year of Co-operatives is the time to tell the co-operative story to a wider audience. It is not only a story of past success, of individuals coming together during difficult economic times to leverage their resources, access markets, and restore balance to price negotiations. The resiliency and stability of the co-operative enterprise model is also a message for today.

Co-operatives are a key part of the way forward for the 21st Century economy. In recent years, the world has demonstrated an urgent need for a more diversified global economy.

Co-operatives have the scale to contribute in a much greater way to that diversification. Even today, the Global300 Report produced by the ICA shows that the 300 largest co-operatives in the world have a combined annual turnover of USD 1.6 trillion, equivalent to the GDP of many large countries. They provide over 100 million jobs worldwide. In Brazil, Russia, India and Africa, some 15% of the population is a member-owner of a co-operative, compared to less than 4% who are shareholders. In Kenya, co-operatives contribute 45% of GDP, while in New Zealand, they contribute 22%. In the United States, 30,000 co-operatives employ two million people, with the largest regularly appearing on Fortune's '100 best places to work' list.

Co-operatives are values-based enterprises. The co-operative has the greatest degree of participatory governance of any of the major enterprise models. Because of this member engagement, cooperatives reflect the values of the community. Since their earliest days, they have been concerned with how their goods have been produced and their services delivered. A commitment to sustainability is one of the seven Principles that ICA's members in 100 countries have agreed define a co-operative.

These Principles—equity, participation, sustainability—come together to make co-operatives vibrant and successful places for decent work. In every sector, from agriculture, fisheries, and forestry to co-operative banking and credit unions, from housing and healthcare to mutual and co-operative insurance, and especially in worker formed co-operatives, co-operatives create decent jobs, enjoy greater trust among consumers and last longer than other forms of enterprise. They are building a better world.

The ICA was established in 1895 to advance the co-operative model. It works with inter-governmental and nongovernmental organisations to promote co-operative development; with countries to advocate for a legal and regulatory framework that recognises the

unique and specific needs for co-operatives to flourish; and with its members to encourage inter-co-operation.

The ICA calls on all co-operators throughout the world to take the occasion of this special year's International Day of Co-operatives to tell their co-operative story. These stories can be found at www.stories.coop.

More than 500 co-operatives, social enterprises and self-

help groups participated in the festival which featured a great variety of displays, concerts, performances, lectures, and forums. In the Inauguration of 7th morning, a video message of ICA President Dame Pauline Green was presented. Congratulating new enactment of the 'General Co-operative Law' in December and knowing that many successful co-operatives are already existing in Korea, she encouraged Korean society to take this new wave opportunity, particularly for new

generation and youth. Video message from the UN Secretary General, Ban Ki-Moon also congratulated and encouraged all stakeholders to continue building awareness and pursuing policies to strengthen co-operatives in Korea. At the presence of the Strategy and Finance Minister Bahk Jae-Wan, NCAF President Choi Won-Byung, iCoop President Oh Mi-Yae, NFFC President Lee Jong-Koo and IYC Committee-Chair Jeong Jae-Don, Seoul Major, Park Won Soon declared his vision named 'Building a Cooperative City' aiming that "co-operative form of public services enterprises create new jobs, new services, new communities and better life for Seoul citizens."

In the streets of Cheonggye Plaza and along Mugyo road, citizens could enjoy to visit co-operative exhibits and buy their products at more than 110 booths. In the night time, with many youth groups, festival continued to play cultural performances at the Seoul Plaza. Alongside the Plaza event, a series of academic forums were held for the days of 4th~7th July at the auditoriums of Seoul YMCA and of the Korea Chamber of Commerce & Industry for researchers and cooperators. Especially for the youth on 6th July, the Sungkonghoe University held 'Co-operative Youth Forum' that actively attended with more than 300 youths. The formation of Rach Gam co-operative in Vietnam was encouraged by the open door policies of the government as there were many weaknesses in the centrally-planned economic system. When this co-operative was set up in 1979 at My Tho city, Tien

Giang province, few would have imagined that it would turn out to be a huge success story in the transportation sector of Vietnam. The main activities of this co-operative are; goods transportation, passengers transportation in land and rivers, building new ships and repairing ships, constructing the roads and undertaking civil works, etc. The members are the focal point of this co-operative. They take initiatives to innovate and find out ways to increase income and have a better life. The motto of the co-operative is 'Rich members, powerful and sustainable co-operative.' The co-operative creates jobs for labourers to work on shops, patrol stations and construction sites.

The co-operative follows sustainable development and its business and production activities are in line with environment protection. This co-operative now has 280 household members; 350 billion VND of share capital (17,5 million USD); total working capital of 690,5 billion VND (34,6 million USD); total asset value of 685 billion VND (34,25 million USD), while the total number of labourers is 1,254 The total asset value of this cooperative comprises of 288 ships and ferries; 12 trucks and 2 tourist buses; 12 specific industrial heavy machines; 1 ship building site of 10,200m2 with fully modern technical equipment and with capacity of building the container ship with the capacity of 1,750 tonnes; one

petrol store with capacity of 600,000 litres and 9 retail petrol stations. The members contribute 90% of the total asset values and the remaining amount is accumulated from the operational profits of the cooperative.

In transportation and infrastructure development, this example of best practice from Vietnam merits attention. The co-operative has been able to succeed due to the strength of the members. This best practice shows that co-operatives can succeed as compared to big construction, or infrastructure development companies if they utilize the full potentialities of their members.

"Revitalization of Local Community by Rural Women"

The 2nd Training Course on "Revitalization of Local Community by Rural Women" was held in Thailand and Japan from 3rd July to 4th August 2012. The Training Course is funded by the Ministry of Agriculture, Forestry and Fisheries (MAFF), Government of Japan and implemented by ICA.

Fourteen women participants from 10 countries, namely, Cambodia, India, Laos, Maldives, Myanmar, Nepal, Philippines, Sri Lanka, Thailand and Vietnam attended the Training Course.

The main objective of the Training Course was to assist fostering women coordinators who play important roles to activate women in agricultural sector and rural community which will contribute in income-generation and poverty reduction in the Least Developed Countries of Mekong River countries and the South-Asian countries.

The part-I of the program – field study visits with a focus on observation of the activities of cooperatives and social institutions—was held in Thailand from 3-9 July in collaboration with the Cooperative League of Thailand [CLT], a member organization of ICA. The participants also joined the IYC-2012 and 90th International Cooperative Day Celebration at the premises of CLT on 6th July which was inaugurated by the Honourable Minister for Agriculture and Co-operatives, Government of Thailand and the regional conference on "Cooperative Transformation into the Era of ASEAN Economic Community (AEC).

The part-II of the program held at IDACA from 10th July to 4th August 2012 included extensive classroom work and study visits to agricultural co-operatives in Fukushima Prefecture of Japan. Lecture-cum-practical field study visits assignments were combined to impart necessary knowledge to the participants on the working of women's associations and the general activities of agricultural cooperatives in Japan.

In view of the experience gained by the participants through class room lectures, field study visits in Thailand and Japan, the participants were able to finalize/improve their Action Plans which they would be recommending to their respective organizations on return to their home countries.

An end-of-the Course Evaluation was conducted at the conclusion of the Training Course. The participants felt that the training course was very relevant for the women leaders of agricultural cooperatives in Asia and hence it should be continued. They also

expressed their greatest appreciation to the Ministry of Agriculture, Forestry and Fisheries (MAFF), Government of Japan for providing financial support for this Training Course. They hoped that the MAFF would continue to support this training program in the future also for the development of rural women in the developing countries.

A Certificate of Participation was awarded to each participant at the concluding session held at IDACA in Tokyo on 3rd August. The concluding session was attended by Mr. Masahito Iwahana, Deputy Director of International Cooperation Division, International Affairs Department of MAFF; Mr. Keiji Hiraoka, Executive Director of IDACA; Mr. K. Sethu Madhavan, Manager-Planning & Membership, ICA-Asia and Pacific; and other senior officers of IDACA.

Management of Consumer Co-operatives

The 12th Regional Workshop for Managers on "Management of Consumer Co-operatives in Asia-Pacific" was held from the 11 – 13 July 2012 at the NTUC Fairprice Training Institute (FPTI) in Singapore. The 3-days workshop was organized by the ICA Committee on Consumer Cooperation for Asia and the Pacific in collaboration with the NTUC Fairprice Cooperative Ltd. 18 participants, 2 observers and 5 speakers from 12 organizations coming from 8 countries, i.e. India, Indonesia, Japan, Korea, Malaysia, Singapore, Sri Lanka and Vietnam attended the workshop Previously, the target audience were managers who engaged in the business operation of the Committee member organizations. Since Year 2012 is the International Year of Cooperatives (IYC), this year, higher or senior executives were also invited.

The objectives of the Workshop were to:

- Raise the awareness of participants on socio-economic role of consumer co-operatives in the community through learning from the contributions of Singapore, Korean and Japanese consumer co-operatives.
- Understand the successful cases of international business collaboration between consumer cooperatives, so that the participants' coops can become cooperatively competitive and promote their growth.
- Study successful business models and policies from Singapore and Korean speakers so that the participants will be able to design appropriate coop business strategies.
- Establish an international network of senior managers of the consumer co-operatives.

The workshop opened with a Welcome Address by MrPoh Leong Sim, Director of Fairprice. The Fairprice corporate video was shown to give the participants an overview of NTUC Fairprice. It was supplemented by more detailed explanations on the "Socio and Economic activities" of the co-operative.

From the region

Nepal: Formation of Separate Ministry of Co-operatives

On May 5, 2012 the government of Nepal has formed a separate Ministry of Co-operatives and Poverty Alleviation (MoCPA) by breaking up the Ministry of Agriculture and Co-operatives. The National Co-operative Federation of Nepal welcomed the government's decision by issuing a press release on May 6, 2012.

Mr. Keshav Prasad Badal, Chairman, the National Co-operative Federation of Nepal said that the government has finally addressed the long standing issue of demand of the Nepalese Cooperative Movement for a separate ministry to look after the cooperative affairs exclusively. During the International Year, 2012, the establishment of separate ministry is break through and one of the great achievement in Nepal.

Japan: Road to Recovery- post Earthquake Recovery Update by JWCU

This is reported by the Japan Workers' Co-operative Union (JWCU) as on August-2012.

17 months have passed since the disaster, and media rarely covers it any more. But we still have a long way to go.

We are still struggling with the old problems, such as cleaning up of debris, radioactive contamination and delayed reconstruction. The picture on the top (a former public gym in a disaster area) was taken in July 2012, NOT 2011. Over 340,000 people, including some of our members, are still living as evacuees.

Now we are also facing new challenges. A number of people in the

disaster areas are losing concentration and energy without clear future prospect. Many of them have lost unemployment benefits without hope of finding a job.

Yes, we do have a lot of challenges, BUT we are moving forward, slowly but surely.

JWCU launched Tohoku Reconstruction Head Office on July 15th 2011. The first anniversary event was held on July 14th 2012 in Sendai City (Miyagi Prefecture), where about 100 people shared the experiences in the last 12 months and encouraged each other for the further reconstruction efforts.

In Otsuchi Town, almost 10% of the residents were killed or are still missing due to the disaster last year. The mayor requested JWCU members to propose whatever the ideas we had to develop industries and human resources for the future. In response, our members proposed 2 vocational training programs, one in forestry and the other in care and farming. Both of these projects were approved and started in early June.

Students in both programs were unemployed and became members of the co-operative when the program started. They receive about 160,000 yen per month plus various social insurances while taking the training. After 1 year of training (lecture and field work), graduates are expected to create jobs to reconstruct the community while leveraging the local resources.

India: Empowerment of Fisherwomen

FISHCOPFED organized a two days national workshop on 'Empowerment of Fisherwomen' on 29-30 June, 2012 in Bhubaneswar wherein about 30 fisherwomen and officers from the relevant ministries and departments across the state participated. The venue was the conference Hall of Institute on Management of Agricultural Extension (IMAGE). The workshop was inaugurated by Sj. Prafulla Samal, Hon'ble Minister of Co-operation, Tourism & Culture, Government of Odisha. The Honourable Minister said that co-operative is the only important means to uplift the socio economic condition of the poor fishermen and fisherwomen of the country. The Govt. is ready to provide any kind of support for the empowerment of fisherwomen. He appreciated the Group Accident Insurance Scheme of FISHCOPFED and said it is a very important

instrument for the welfare of the poor fishermen and women of the country. Shri B.K. Mishra, M.D. of FISHCOPFED, in his welcome address said that this year is being celebrated as International Year of Cooperatives as declared by the United Nations. FISHCOPFED has planned to organize a series of events during this year. The workshop is one such initiative. Shri Mishra also talked about various activities of FISHCOPFED including the Group Accident Insurance Scheme for fishermen and women. He informed that out of 12 lakh fishermen, 10 lakh fishermen have been insured under the scheme which is highest in India. Shri T. Prasad Rao Dora, Vice Chairman of FISHCOPFED also addressed the workshop and proposed vote of thanks.

There were speakers invited from the concerned organization to share information and exchange of technology with the participants namely Shri Mohan Mishra, Director, National Co-operative Union of India (NCUI), Shri Nirmal Kumar, Joint General Manager, IFFCO, Smt. Savitri Singh, Advisor-Gender Programme and Communicationr, nternational Co-operative Alliance- Asia and Pacific office (ICA-AP), Shri P. Krishna Mohan, Director of Fisheries, Government of Odisha, Shri T. Prasad Rao Dora, Vice Chairman, FISHCOPFED, Shri Dhananjay Hembram, Joint Secretary, Fisheries & ARD, Government of Odisha and Shri Subrat Kumar Nanda, Asst. General Manager, NABARD, Bhubaneswar.

At this occasion, five of insurance claim cheques were also distributed to the nominees of the insured person.

On the second day, women participant were invited to voice their concern, share problems and experience. Almost all women talked about problem of credit and lack of employment during off season. Certificate of participation were distributed to the participants.

New Zealand: Education seminar

Each year New Zealand Cooperatives Association runs a two-day education seminar for co-operative and mutual directors and senior executives. Last year, fifty people from New Zealand, Australia, Canada and Thailand were involved.

Dr. Chan Ho Choi and experts from NACF (Korea), JA-ZENNOH (Japan), Canadian Wheat Pool as international speakers. Participated with 90 participants from different provincial ACFSMC in China, the objective of this workshop was to build needed organizational capacity in promoting international trade of ACFSMC. The International Seminar on "Co-operatives: Empowering Communities Towards Gross National Happiness" was held on 8th -10th, October 2012 in Thimphu, Bhutan. This is the first ever International seminar organised on co-operatives.

It was organized by the Royal Government of Bhutan with sponsorship of UNDP in Bhutan. In the opening, the Hon'ble Lyonpo (Dr) Pema Gyamtsho, Ministry of Agriculture and Forests

stated that "Bhutan has taken up a plan to promote co-operatives to achieve holistic human development in line with its development philosophy of Gross National Happiness which goes beyond GDP based on only material factors."

Dr. Chan Ho Choi, Regional Director for ICA-AP was invited as speaker and presented his topic on "Co-operatives and Social Economic Empowerment: Links between Individuals, Private Sector and State Actors". Dr. Choi hoped to hold a consultation workshop next year in Bhutan on co-operative development at village level in collaboration with the Association of Asian Confederations of Credit Unions (ACCU). The co-operative law 2009 has been enacted in the country to provide the framework under which 170 co-operatives have been functioning.

This international seminar in the capital city of Bhutan gathered a good number of participants and international speakers. Ms. Claire Vander Vaeren, Resident Representative and Resident Co-ordinator, UNDP, Bhutan; Mr. Somchai Channarongkul, DG of the CPD in the Ministry of Agriculture and Co-operatives, Thailand; Ms. Elenita V. San Roque from ACCU; Dr. Bhagwati Prasad from India; Dr. Dinesh, Chief Executive of NCUI, India; Mr. Xu Defan, Director of Supervisory Board Office, All China Federation of Supply and Marketing Co-operatives (ACFSMC), China; Mr. Hideva Suzuki from the Institute for the Development of Agricultural Cooperation in Asia (IDACA), Japan; Mr. Jalan Kumar Sharma, CEO, Small Farmer Development Bank, Nepal were among the distinguished co-operators present.

It is particularly fitting that this year's theme for World Food Day focuses on agricultural co-operatives both because we are about to conclude the UN's International Year of Co-operatives (IYC) and because it is those agricultural co-operatives that can mean the difference between success and failure of the world's farmers to earn a decent living and meet global food needs.

We believe that food production is not some distant operation but one that challenges us in our own countries, in our own fields. Farmers in our own communities are working every day on our behalf. And it is through agricultural co-operatives that small farmers - so critical to meeting our food needs - are able to develop the safeguards and receive the education and support that helps individuals, their families and their local agricultural communities. The smallholder farmers are the bedrock of good quality food production underscoring that communities can in many areas of the world provide adequate food for their own populations.

Co-operatives from around the world—including those in Argentina, Australia, Canada, Korea, Japan, Norway, Sweden, the UK, and the US—are working to combat food insecurity and fight poverty.

Co-operatives strengthen the bargaining power and livelihoods of small farmers who are less vulnerable to price fluctuations, through working together.

Agricultural co-operatives are valuesbased businesses that are the essence of both "can do" and "must do."

"Can do" in the sense that farmers who alone could not compete with their limited crop yields or limited capital together can help build a better and more secure world.

"Must do" because it is agricultural cooperatives which reflect co-operative values including giving back to the community-helping not just the individual to earn a living but supporting the communities in which those co-operatives reside. Time and again the "can do" and the "must do" signal the best of what World Food Day wants from all of us: respecting the individuals and the groups that toil around the globe to provide our food. They also underscore that working in harmony with a sense of greater purpose enriches all of us.

Capacity Building

Training of Consumer Co-op Managers

2012 ICA/JCCU (Japanese Consumers' Co-operative Union) Training Program for Managers of Consumer Co-operatives (Miyagi Coop/Coop Net course) was held from 20th July to 5th August 2012. 3 trainees from India, Indonesia and Sri Lanka attended this year.

Co-op Net is the biggest business federation of consumer co-operatives in Japan.

The course began with introductory lecture about business operations, member activities and social contributions of JCCU and its member societies. After that the trainees moved to Miyagi prefecture and had an on-the-spot training of the store operation at the Miyagi Co-op. In the last part of the training, the trainees visited Coop Net and studied about their environmental and social activities.

Quality and Safety of Farm Products

Telling the Co-operative Story





The MMIMS has been established by a group of academicians, researchers, industrialists and prominent professionals with extensive exposure to a wide range of innovative knowledge, experience and teaching/learning practices. Apart from this, MMIMS aims at providing high-end health services facilitating with modern medical technologies within the reach of all Nepalese citizens. Dr. Chan Choi visited the NEHCO and MMIMS on 4th September, and hoped that the Asia-Pacific Health Coop Organization (APHCO) could be an ICA-AP Committee together with NEHCO. Dr. Choi suggested an international seminar with NEHCO in this regard.

Dr Kurien, Father of India's White Revolution, showed how a small co-operative can grow to dominate a business sector. The Gujarat Co-operative Milk Marketing Federation, or Amul as it is well known and which he led for 30 years, helped make India the world's largest producer of milk.

More importantly, Dr Kurien found a way to bring a decent and fair livelihood to thousands of India's dairy farmers, who would otherwise have been unable to compete against the big, commercial dairy machine. The co-operative model has done the same for workers and customers in sectors from banking to retail around the world.

I am pleased that the co-operative movement had the opportunity to recognise Dr Kurien's contribution in 2001 when it bestowed upon him the first ICA Rochdale Pioneers Award.

Re-constitution of ICA-AP Regional Board

The term of office of the current Regional Board is upto November 2012 and according to Rules of ICA-AP, elections to reconstitute the Board for the next four years should be held by the Regional Assembly. 14 nominations from member organizations were

The Regional Board appointed an Election Committee comprising of Mr. Simon Alfred Pereira, President of Association of Asian Confederation of Credit Unions (ACCU); Mr. Charles Gould, Director General of International Co-operative Alliance (ICA); and Dr. Sisno Tanguyan Romulo, Board of Director, VICTO National Co-operative Federation and Development Center, Philippines to conduct the elections.

Mr. Pereira explained about the election procedure and after voting process, the new Board was announced.

Report on UN IYC-2012 and Blueprint for a Co-operative Decade

Mr. Charles Gould, Director General of International Co-operative Alliance (ICA), made a presentation on "UN International Year of Co-operatives and Blueprint for a Co-operative Decade" which was approved at the ICA Extraordinary General Assembly in Manchester on 31st October 2012.

Approval of Revised ICA-AP Rules

In view of shifting the ICA-AP Business Office from Singapore to

Malaysia, the following change was proposed in the Rules of ICA-AP.

Article 3: Structure

The ICA-AP is structured at the regional, sectoral and thematic levels and comprises the following:

- A regional office in New Delhi, India
- A sub-regional office in Malaysia.

The Regional Assembly approved the above change in the Rules of ICA-AP.

Formation of ICA-AP Committee on Forestry

Dr. CHOI placed before the assembly that looking at the importance of the forestry sector, it has been decided at the Secretariat that an ICA-AP Committee on Forestry should be constituted. ICA-AP has already received eleven nominations from seven countries to become members of the Committee. Formation of ICA-AP Committee on Forestry was approved.

Approval of Revised Constitutions of ICA-AP Committees

The Chairpersons of the respective Committees presented their Constitutions based on the model Constitution approved by the Regional Board and the discussions they had in their respective Committee meetings while presenting their report to the RA (Agenda Item 13) for approval. The RA approved the revised Constitutions of all the ICA-AP Sectoral/Thematic Committees.

Board Meeting in Progress

The meeting of the ICA-AP Regional Board was held at KICC in Kobe on 26th November 2012. All the eleven board members attended the meeting.

Dr. Chan Ho CHOI, Regional Director presented the ICA-AP Activities Report for January to October and Financial Report for January to September 2012 and membership position for the information of the Board. Four new organizations joined during the year and the National Labour Co-operative Federation (NLCF) of India has ceased to be a member of ICA.

While presenting the Strategic Plan for the new Business Office in Malaysia he talked in detail about the background; Strategic Objectives; Office Structure; Mode of Activity; Mode of Financing; Four-Year Plan; Financing of Activities for One Year; and Expected Outcomes. Prof. Dr. Ali Baharum, President of ANGKASA agreed to the Strategic Plan of the ICA-AP Business Office in Malaysia. He said that ANGKASA Board has already discussed about the MBO and approved it. One coordinator and

one support staff would be provided by ANGKASA in addition to free office space. Computers and other equipments are to be bought by ICA-AP. Further discussions would be held with the Regional Director. Referring to the forthcoming election of the Board, Dr. CHOI informed that ICA-AP has received 14 nominations from member organizations. Out of this, the Regional Assembly shall elect eleven board members including the President and two Vice Chairpersons at its meeting in Kobe on 29th November. He also informed in detail about the three nominations received from Iran for the benefit of the members. Mr. Li Chunsheng said that it was a complicated case. Finally, he suggested that we put this issue for voting. Seven members objected to accepting its nomination while four members supported the ICC. The Regional Board approved the formation of ICA-AP Committee on Forestry. It was decided that the date and place of next board meeting should be decided by the new Board after its election on 29th November, 2012.

Reports From ICA-AP Sectoral/ Thematic Committees

Agriculture Committee:

The 39th meeting of the ICA-AP Committee on Agriculture was held on 26th November at KICC, Kobe, in conjunction with the 10th ICA-AP Regional Assembly. 10 members from five countries namely India, Japan, Korea, Malaysia and Vietnam attended the meeting. In addition to the members, there were observers from the participating countries and Pakistan. Mr. Akira Banzai, President of JA-ZENCHU, welcomed the participants on behalf of the Japan Joint Committee of Co-operatives (JJC).

Agriculture Seminar:

A seminar on Agricultural Co-operative Development in Asia and the Pacific region was held at the same venue. 24 participants from India, Japan, Malaysia, Pakistan, Vietnam and ACCU attended the seminar. Mr. Srinivasa Gowda, Chairman of ICA-AP Committee on Agriculture, inaugurated the seminar. The objectives of the seminar were to provide opportunities to the participants to express their opinions about agricultural co-operative development in Asia and the Pacific, exchange information among them and establish mutual cooperation system in future.

The theme of the seminar was "Democratic Management System" and "Leading-edge Business Activities of Primary Agricultural Co-

Consumer Committee:

The 45th meeting of the ICA-AP Committee on Consumer Cooperation was held at Kobe KICC on 27th November, 2012. 18 members and 20 observers attended the meeting. The meeting was presided over by Mr. Haruyoshi Amano, Chairperson of the Committee. Mr. Katsumi Asada, President of JCCU conveyed his welcome greetings to the participants. Dr. Chan Ho Choi, Regional Director of ICA-AP also attended the opening session and gave his greetings. The members from eight countries (India, Iran, Japan, Korea, Malaysia, Philippines, Singapore and Sri Lanka) made brief presentations on the recent activities and business results and the report of the "Study on Consumer Co-operatives in Asia-Pacific" was presented. In addition to cover the routine agenda, the meeting discussed and adopted the revised Constitution of the Committee and a revised list of members of the Committee. Next meeting will be held in Singapore in collaboration with NTUC Fairprice.

Credit and Banking Committee:

The meeting of ICA-AP Committee on Credit and Banking (RCBA) was held on 26th November,2012 at KICC, Kobe. Four members (India, Japan, Philippines and Vietnam) and five observers from Indonesia, Malaysia and Sri Lanka attended the meeting. In the absence of the Chair and Vice Chair, Mr. Sivadasan Nair from India was appointed as interim Chairman to conduct the meeting. The meeting discussed about the revised Constitution based on the Model Constitution and approved it with some minor changes to Article-6, Article-12 and Article-13, as suggested by the members.

Mr. Kazuhiko Otake, Managing Director of NORINCHUKIN Bank, Japan made an impressive presentation on "Reconstruction Efforts - the Role Played by Co-operative Financial Institutions". In his presentation, he explained how NORINCHUKIN Bank provided emergency assistance followed by comprehensive reconstruction work and financial assistance to the community after disaster-2011 in Japan.

HRD Committee:

The 24th meeting of the ICA-AP Committee on Human Resource Development (HRD) was held on 27th November,2012 at Kobe KICC. 16 members and 12 observers from 10 countries, namely, China, India, Japan,Malaysia, Nepal, Pakistan, Philippines, Sri Lanka, Thailand and Vietnam attended the meeting.

The opening session was addressed by Dr. Chandra Pal Singh Yadav, President of NCUI and Vice Chairman of ICA Regional Board and Dr. Bhagwati Prasad, Chairman of the HRD Committee. Dr. Chan Ho Choi, Regional Director of ICA-Asia and Pacific also addressed the meeting at a later stage. The meeting was presided over by Dr. Bhagwati Prasad. He welcomed the members and stressed the importance of Global HRD Networking (www.hrd.coop) which is developed and maintained by National Cooperative Union of India (NCUI).

The meeting decided that the Co-operative Learning Center {CLC} project which was conceived, designed and launched by the Global HRD Committee should own and be responsible for the fate of this project. The ICA-AP Secretariat received 33 nominations for the HRD Committee from ICA member organizations in 13 countries. The meeting approved the membership of these nominees.

The Constitution of HRD Committee was revised according to the model constitution for ICA-AP and approved with some minor corrections to article-8 and article-14.

The following three presentations were made at the meeting:

- (a) HRD as a Tool for Good Governance in Cooperatives by Dr. Bhagwati Prasad.
- (b) How Human Resource Development Efforts Help Cooperatives Build Secured Society by Prof. Dr. Rosmimah Bt Mohd Roslin
- (c) Status Report of GHRD by Dr. Dinesh.

The committee discussed about the portal on training which was initially launched in February 2007 at VMNICM in Pune. Recently, the portal has been shifted to NCUI premises in Delhi. Dr. Dinesh informed that the portal will be operative again from early 2013 and the preparations are in advanced stage. The meeting also endorsed the following three points raised by Dr. Chan Ho Choi, ICA-AP Regional Director, in his remarks –

- (a) Networking of HRD training institutions to share experiences, best practices and matters on training;
- (b) Upholding of success stories in ICA-AP website;
- (c) Higher level training for cooperative leaders in the region. It was also decided that these issues will form the part of the strategic planning of HRD for the next four years.

It was decided that the theme of the next seminat to be held in 2013 will be "Success Stories as a Tool for Co-operative Education and Training".

Subsquently, Ms. Norwatim Abd Latif, Deputy Director General of Co-operative College of Malaysia elected as Vice Chair of the HRD Committee for the remaining two years.

Research Conference:

The ICA-AP Regional Research Conference/Meeting was held in KICC, Kobe on 26th November 2012. The conference was attended by 43 delegates from 10 countries namely; India Korea Japan , Malaysia , Philippines, Vietnam , Nepal, Turkey , Canada and UK. At the outset, Mr. Akira Kurimoto, Vice Chair of the Research Committee welcomed the participants to the Conference and Dr. G.N. Saxena, Chairperson of the Committee gave the Opening Address.

There were two keynote speakers at the Opening Session - Prof. Johnston Birchall from the University of Sterling, UK and Prof. Lou Hammond Kettilson of Saskatoon University, Canada - who is currently the chairperson of the Global Research Committee of the ICA. Their keynote addresses looked at the Cooperative Potential for Socioeconomic Development and Measuring the Cooperative Difference so that the visibility of co-operatives can be increased.

The theme of the Conference was Bringing Cooperatives back to Centre Stage and the Research Committee had accordingly invited research papers on six sub themes:

- (a) How to Gauge Co-operative Socioeconomic Impact;
- (b) How to Enhance Coop's Visibility by Branding, Publicity and Education;
- (c) Emergence of new Coops for General Interests (health, social care, utilities);
- (d) Public Policies, Laws and Regulations Conducive for the Formation, Growth and Stability of Cooperatives;
- (e) Co-operative Resilience to Economic / Financial Crises;
- (f) Co-operative Response to Natural Disasters.

Research presentations were made by Dr. Dongre, Dr. Shanta Raj Sharma Neupane, Ms. Ahlung Kim, Ms. Sumi Cho, Dr. Minoru Sugino, Mr., Sanjay Verma, Dr. T. Paranjothi, Dr. B. Ganesh, Dr. Basavaraja, Mr. Shinri Murakami, Ms. Yukiko Yamazaki and Mr. Humpei Hayashi on different sub-themes. The conference threw light on various research results, which are proposed to be documented for circulation shortly.

Research Committee Meeting:

After the Conference, the ICA-AP Committee on Research met to decide on the new Constitution of the Committee and also to elect new office bearers of the Committee. Dr. Chan-Ho Choi joined the Meeting and participated in the discussions on the new Constitution. It was impressed upon him to find more ways and means of attracting and engaging youth and researchers in the program of ICA. The new Constitution, as approved by the Committee and the researchers present was sent to ICA-AP for revision. Dr. G.N. Saxena and Mr. Akira Kurimoto have been re-elected as the Chair and Vice Chair of the Committee respectively for a second consecutive term of 4 years.

Women's Committee:

The meeting of the ICA-AP Committee on Women was held on 26th November,2012 at the Kobe KICC. Eight members out of eleven and 22 observers from 11 countries attended the meeting.

The meeting discussed about the revised Constitution of the Women's Committee based on the Model Constitution of ICA-AP and the revised Constitution was approved with some modifications to Artile-6 and Artile-12.

Ms. Hitomi Tanaka from JCCU (Japan) and Ms. Divina Cabunoc Quemi from NATCCO (Philippines) were re-elected as Chairperson and Vice Chairperson of the Committee respectively. The Committee commissioned writing of "Resource Guide for Advanced Training of Co-operatives on Entrepreneurship Development of Women and Gender Equality". The Consultant, Ms. Salome Ganibe, presented the outline of the first draft. The members from Korea, Nepal, Pakistan and the Philippines made presentation on current situation/updates about gender mainstreaming activities in their cooperatives. The meeting discussed and approved the work plan of the Women's Committee for 2013. The next meeting of the Committee will be held in Indonesia in conjunction with the ICA-AP Regional Assembly, 2014.

Regional Women Forum

The 7th ICA-AP Regional Women Forum was held on 26th November. The theme of the forum was: "Women in Co-operatives Build a Secured Society".

38 Women and men co-operators from 11 countries from the region were present.

5 papers were presented by expert resource persons and member of the committee. The forum discussed about positive action policy, work life balance, childcare, program for women on income generation, capacity building, policy and initiatives for women empowerment etc.

Recommendation of the Women Forum

We women and men from 11 countries from ICA Asia Pacific Region who participated in the regional women forum on this day 26th November, 2012 deliberated upon the theme "Women in Cooperatives Build a Secured Society" recommend the following points to be implemented by ICA-AP as well as it's member cooperatives for the empowerment of women and gender equality in co-operatives:

- 1. Assessment of the women empowerment and gender equality policy and strategy
- 2. Impact assessment of work done in last decade on gender issues and progress of status on participation of women at all levels in co-operatives.
- 3. Should re-affirm their commitment towards environment safety and food security to reduce burden on women as they carry the responsibility of food production and home care.
- 4. To implement our all time recommendations for reservation of 30% seats for women at all levels of the co-operatives.
- Must allocate budget for carrying out the above recommendations.

Youth Committee:

The 5th meeting of the ICA-AP Committee on Youth was held on 26th November,2012 at KICC, Kobe. The meeting was attended by members from India, Indonesia, Japan, Malaysia, Pakistan and Sri Lanka. Members from Iran and ACCU sent their messages through the internet.

In the absence of the Chairperson and Vice Chairperson, Mr. Ahsan Ali Thakur was appointed as the Interim Chair until the next meeting. The meeting was also attended by observers from Malaysia, Japan, India and Sri Lanka.

The members adopted the agenda and also confirmed the inclusion of Dr. Chan Ho Choi, Regional Director as the honorary member of the Committee. Opening remarks followed by Country Presentations by the members who gave a brief idea of the cooperative movement in their countries and the participation of youth in cooperatives and future plans.

A presentation was made by the secretary on 'Co-operative Business Solutions' and the need for effective results for the cooperative sector from efficient technology. A report on the Committee's Face Book page with over 700 members was also shown. This was followed by a presentation on Youth Workshop on

'Introduction to Co-operatives' and related activities in Pakistan along with an account of the Floods in Pakistan in 2010 and its grave consequences. The Regional Director shared his views and opinions on the future of co-operatives.

The model Constitution was discussed and received several suggestions.

However, the agenda remained inconclusive and will be taken up again in the next meeting to be held in Buldana (India) in April 2013.

Forestry Committee:

The preliminary meeting of the ICA-AP Committee on Forestry was held at KICC, Kobe on 27th November, 2012. Out of 11 nominated members from seven countries, only four members from three countries – India, Indonesia and Japan - attended the meeting. In addition, some observers also attended the meeting from these countries.

Mr. Shieyoshi Satoh, President of National Federation of Forest Owners' Coop Associations, Japan, was selected for the post of Interim Chair of the Committee and Dr. K.G. Wankhede, Chief Executive of Indian Farm Forestry Development Co-operative (IFFDC), India, was selected for the post of Interim Vice-Chair till the first formal meeting of the Committee.

The draft constitution of the Committee was approved with a slight change, and accepted the List of nominated members and wanted the Secretariat to place this constitution and List of nominated members to the 1st formal meeting of the ICA-AP Committee on Forestry for ratification.

University/Campus Coops Committee:

The meeting of the Office Bearers of the ICA-AP Committee on University/Campus Cooperatives was held on 25th November at the Coop Inn, Kyoto in Japan. The day-long meeting reviewed the activities of the Committee during the year 2012 and also planned the forthcoming activities. The meeting was presided over by Prof. Kokichi Shoji, Chairperson of the Committee. The Vice Chairpersons, Prof. Ali Hasan from Malaysia and Prof. Zenaida Diola from the Philippines and the Co-Secretaries Mr. Ohmoto from Japan and Dr. Dongre from India were present along with the observers. A team of representatives from the Korean University Co-operative Federation also participated in order to discuss about the preparations for the forthcoming regional workshop.

The meeting adopted new Constitution of the Committee and also the Budget proposals for the year 2013. The next ICA-AP Regional Workshop on University/Campus Co-operatives will be held at Seoul (Korea) in 2013.

Seminar on Promotion of Co-operative Tourism

A seminar on Co-operative Tourism was organised on 27 November 2012 in conjunction with Regional Assembly events in Kobe. The seminar was attended by 23 persons including participants from ACCU, India, Iran, Japan, Pakistan, Philippines, and Sri Lanka.

Mr. Yonemoto, Managing Director-Nokyo Tour delivered the key note address and highlighted the initiatives of N-Tour in Green tourism, data on inbound and outbound tourism and relief operations undertaken by them during the devastating earthquake of

March 2011. The other presentation was by COOPFED, Sri Lanka which gave an account of COOPFED tourism business. It is the tourism business arm of the Consumer Coop Federation.

Other papers were from representatives of Philippines who mentioned the nascent cooperative tourism business in Philippines, Mr. Sanjay Verma of the National Co-operative Union of India who cited the case of Durina Tourism as suggested by Dr. CHOI. Durina is a strategy developed by a Scottish Tourism consultancy company in parts of India There were frank and open discussions on the need and feasibility of a committee or committee like structure for the cooperative tourism sector.

Dr. Chan Ho CHOI, Regional Director led the discussions and identified the various facets of cooperative tourism.

Following recommendations were made at the Seminar:

The participants to the seminar Confirm that

- Co-operative Tourism has potential at the primary as well as at apex organisation to realise their business capacities.
- Co-operative Tourism is distinct from commercial tourism and is participatory in nature.

The Participants further confirmed that

- Co-operative Tourism should be defined as strategic area of co-operative business
- Co-operative tourism should be included as business for local development and should be supported by government in terms of enabling legal and policy environment.

Suggestion from Board Members at the Regional Assembly

Ms. Amneris G. Gabriel, ICA-AP Board Member from Philippines suggested that Regional Board election guidelines should be brought out and published in advance.

Dr. Choi replied that the new rules of election which have been followed in this election (2012) will be included in the minutes of the Regional Assembly which will serve as guidelines for the future Regional Board elections.

Venue and date of next Regional Assembly

Mr. H.A.M. Nurdin Halid, President of Dewan Koperasi Indonesia (DEKOPIN) offered to host the next Regional Assembly and related events in Indonesia in 2014. Dr. Chandra Pal Singh Yadav, President of National Cooperative Union of India (NCUI) offered to host the 2016 Regional Assembly in India.

The assembly accepted the offers of DEKOPIN and NCUI. The dates and venue would be decided in consultation with the DEKOPIN.

7th ICA-Asia and Pacific Co-operative Forum

7th ICA-Asia and Pacific Co-operative Forum on the theme "Role of Co-operative in Times of Natural Disaster" was held on 28th November, 2012 in Kobe International Conference Centre, Japan. More than 200 persons including international and local Japanese cooperative delegates, leaders, resource persons and government officials from 20 countries attended the forum.

The theme of the forum was "Role of Co-operative in Times of

Natural Disaster".

The general objective of the forum is to bring together co-operatives and other stake holders such as United Nations agencies on a platform to deliberate upon role of cooperatives as partners of disaster management and strengthening their capacity for disaster preparedness, mitigation and management.

Expected results:

- To raise awareness about role of co-operatives during the disaster and to resolve and recommend that cooperatives be recognized as "Partner in disaster management" by respective governments and UN.
- UN-ICA partnership for capacity building of cooperatives for disaster management.

Executive summary and result:

Following points emerged through presentations and discussions:

- In all the countries Co-operatives play an important role in supporting the community at the time of disaster and at any crises.
- The govt. Intervention in Japan during the 2011 disaster was slow whereas co-operatives provided more organised and faster services.
- 3. The ICA always mobilised the resources and helped members all over the world during disaster.
- 4. Emergency relief is important but post disaster rehabilitation is crucial
- 5. Disasters can not be prevented but preparedness lowers the risk
- 6. UN and Governments realise the importance of co-operatives in community mobilisation and coordination
- Net working and coordination with government and other civil societies for in put and support is very important for co-operatives.
- 8. The man made disasters like Fukushima Nuclear Power Plant leakage is more dangerous and having longer impacts. The man made disasters should also be included in the draft resolution.
- 9. The ICA mobilises resources but a system should be put in place for quick response.
- 10. Establish procedure for disaster management and prepare the community through communication and education
- 11. The ICA and UN will take forward the discussion for partnership.

Keynote Speech on the theme "Role of Civil Society in Times of Natural Disaster" was delivered by Mr. Masaki Watabe, Head of United Nations Office for the Coordination of Humanitarian Affairs (UNOCHA) Kobe Office, Japan.

After that country report presentation started. In the first part,

After the segment of country experience sharing, a panel discussion and open forum was held on the topic: Co-operatives Build A Secured Society.

A draft resolusion was prepared and circulated to the participants prior to the panel discussion. All the panellists made short statement and then the chairperson opened the floor inviting questions, observations and suggestions from the participants.

The statements by the panelists are as following:

JAPAN:

Mr.Akira Benzai stated that Co-operatives provide better and faster relief owing to the coop principles that are engrained in the Co-operative DNA. A stable, secure society will be reached when people to people and mutual help will become the norm. However, for a greater role to be played by co-operatives, local citizens and local governments are important. The government should recognize the values that coops bring to sustained activity. The IYC was a landmark opportunity. Co-operatives are now venturing in renewable energy and we hope to diversify into new areas of co-operative development.

THAILAND:

The political insecurity and the flooding were disastrous last year. Fortunately we have the king who has encouraged sufficient economy. I myself believe in principles of co-operatives. The 7th principle of cooperatives has assumed greater importance.

INDONESIA:

It is very important to translate the principle and spirit of cooperation into practice. Solidarity- mutual help is how cooperatives can move forward, principally concern and care of cooperative. Natural disaster is a common problem. Cooperatives need to maintain a close relationship with the government to give the government an input and seek support and give support at times of disaster.

UN OCHA:

Mr. Watabe said that every organisation has it's own comparative advantage. There is need to adopt standard procedure, mitigate the risks. One cannot prevent from natural disaster to happen but how come we are not prepared? Continuous education is needed. Cooperative play a key role and risk reduction-mitigation-preparedness—allows to respond effectively.

The cooperatives can handle disaster management very well and especially in Kobe it was proved. Community based activities are needed, communication ensures quality and transparent work.

Mrs. Errum Bhaiji from Karachi Co-operative Housing Societies Union, Pakistan wanted to know who was the faster actor in disaster management: PUBLIC Sector /GOVERNMENT/NGO? Mr. Akira Banzai (JJC) replied that in case of recent disaster relief and management, the Government have been a slow actor. Funding is made possible there but money is not always well spent. At all times, the principles of co-operation have helped the Japanese case. Community based activities, confidence of the people blessed with the tremendous help from members has helped cooperative development in Japan after disaster.

Mr. Watabe (UNOCHA) added that every organization has its own comparative advantage.

The national level response should be to establish coordination across different actors.

Prof. Dr. Mohd. Ali Baharum President, ANGKASA, Malay enquired where should the fund donations be collected for disas er help and he suggested that ICA-AP should create an International Fund. Dame Pauline Green, President-ICA responding to that, informed that there is a disaster management fund at ICA Cental Office but mobilization is rather slow.

Japanese delegates suggested that only natural disaster is r damaging but manmade disasters like leakage of nuclear pow plants in Fukushima have even longer lasting impact. Therefo manmade disaster like this should be included in the resolution.

After the panel discussion and open forum, a Special Speech w delivered by Mr. Uchihashi Katsuto, Japan IYC National Planni Committee Representative of Japan. On the topic "Creation o Safe Society". Mr. Uchihashi gave a thorough view of Japane society, culture and practices and also focused upon problem fac by the society in these rapidly changing times. He focused upon t disasters faced by the society due to various reasons. Mr. Uchihas propagates the philosophy of FEC: Food, Energy and Care. I emphasized on self sufficiency in food production, renewal energy sources and care for the community, elderly, environme etc. The forum concluded after the special speech by Mr. Uchihash

At the concluding session, Dr. Chan Ho Choi presented the resolution of the forum. He requested participants to send the observations and suggestions on the draft resolution for inclusion. Mr. Katsumi Asada, Chairman of JCCU and Vice Chair of JJC made concluding remarks. He said that I am happy to see many cooperators participating in the forum and expressed his gratitude all. He briefly mentioned about the speeches made during the dand further said that a bridge is built between co-operatives to fa disasters and the co-operatives should not only come together support each other during disaster but should also cooperate will each other always.
