

A National Seminar on the subject was jointly held by the ICA Regional Office & Education Centre for South-East Asia and the Bangladesh Jatiya Samabaya Union, in June 1972 at Dacca. The Seminar has helped to focus the minds of the leaders, both official and elected, on the entire range of the needs of the more important sections of the Cooperative Movement of the country. The Seminar has been an exercise of the cooperators themselves in planning in a general way the development of their movement. The findings of the Seminar should help the Movement as well as the government to steer clear of uncooperative ventures which masquerade as cooperative using the "Co-operative" name and the cooperative structure but not the cooperative method, thereby doing grave harm to the cause of Cooperation.

The Seminar discussed subjects like the structure and management policy of the Cooperative Movement, cooperative legislation, cooperative education and training, cooperative banking and credit, agricultural cooperation, consumer cooperation, fishermen's cooperatives, housing cooperative, transport cooperatives, weavers' cooperatives, etc.

The Public Accounts Committee, in their 106th Report presented in April, 1970, observed that they "have reasons to doubt whether the existence of an official organisation like the National Cooperative Development Corporation in the Cooperative Sphere, besides the Department of Cooperation is at all necessary", and suggested to the Government to remit the foregoing consideration for detailed expert study and come to a decision on the necessity for the continuance of the National Cooperative Development Corporation.

In pursuance of the above recommendation of the Public Accounts Committee, the Government of India, in the Ministry of Agriculture (Department of Cooperation) constituted an Expert Committee under the Chairmanship of Mr. B. Venkatappiah, Member Planning Commission, Government of India.

A working group on cooperation of Fifth Five Year Plan was constituted by the Government of India in 1972. The terms of reference of this group were:

- i. To make a critical review of the quantitative and qualitative progress made by the Cooperative in various fields and the position likely to be reached by 1973-74,
- ii. To make a critical review of the various 4th Plan schemes and programmes and to consider their continuance, modification or discontinuance,
- iii. To identify the difficulties and problems faced and to consider the legislative, administrative, institutional and other measures necessary for the removal of bottlenecks and acceleration of the tempo of progress in the coming years,
- iv. To formulate strategy and targets of the Cooperative Movement in various fields and to formulate schemes and programmes considered necessary for the achievement of these targets with due regard to the national objects of self-reliance, removal of regional imbalances generation of more employment and improvement in the economic and social condition of the weaker sections of the society. The long term perspectives for the period 1980-81 as given in the Fourth Plan document may be kept in view.

As per its terms of reference the working group suggested the policy and programme for cooperative should be followed during 5th Five Year Plan of India.

Until recently the Land Development Banks were the principal agencies for provision of long term finance for agriculture. The study further shows that happily, the extent of diversion of loans from the purposes for which they were taken is small. All the same, the study underscores the need to check the diversion that results from the peculiar arrangements made for supply of farm equipments to farmers.

Further, the members replicate within the societies the social and economic hierarchy of the wider socio-economic groups to which they belong. The role of farm cooperatives as "levellers" is also not much in evidence. The study emphasises the role played by the societies in capital formation with the help of surplus labour. The study underlines the need for bifurcating the technical and administrative functions on these farms, which, by implication, would necessitate insistence on large and viable organisations.

In recent years increasingly rapid vertical integration in agriculture has aroused doubts in some sectors regarding the loss of producer's control over production activities. In view of this the role of bargaining co-operatives assumes prime importance in increasing the farmers collective strength. Therefore, the study is primarily concerned with the question whether the bargaining co-operatives are sufficiently linked together to achieve bargaining power with the processors.


