
Dear Cooperator,

The North Eastern Regional Conference on "Cooperative Development" was organised at Gauhati at the suggestion of the Government of India, Ministry of Agriculture, Department of Cooperation, by the Committee for Cooperative Training. About 200 delegates representing cooperative departments and cooperative institutions of Assam, Manipur, Tripura, Meghalaya, Arunachal Pradesh, Mizoram and Nagaland participated in the Conference. Representatives of the Cooperative League of U.S.A, and the International Cooperative Alliance also

participated in the deliberations. National level cooperative organisations and the Government of India, were also represented by the concerned senior officers. The Assam State Cooperative Union was closely associated for making local arrangements for the conference. The important suggestions of the conference related to the approach and the concept of regional planning and implementation of economic programmes through cooperatives. For this the conference suggested the creation of a planning and promotional agency headed by a Commissioner of Cooperative Development may be established by the Government of India with headquarters in this region. The conference called upon the National level Organizations like the National Cooperative Development Corporation, National Cooperative Consumers' Federation, and National Agricultural Cooperative Marketing Federation to initiate intensive programmes keeping in view the requirements of the region. These agencies may co-ordinate their efforts for maximising the benefits of the meagre resources available for this purpose. These Federations may also work out the schemes for formulation and development of the regional cooperative organisations in their respective fields in collaboration with State Governments and the State Cooperatives.

The Conference suggested that for development of allied activities to agriculture, such as 'dairy development, agro-industries, etc. the additional credit needs of the people may be met on priority basis. The credit policy therefore, may have to be reoriented keeping in view some of these essential factors. In view of heavy overdues in the region, the conference suggested that a care-ful study of such cases need to be conducted after which had debts may have to be written off and the cases of wilful defaulters located and recovery process expedited. The programme of amalgamation and merger of smaller units may also have to be undertaken on scientific basis. Long-term finance may also have to procured for the land development bank for financing minor irrigation schemes.

A programme of linking marketing with production should be vigorously pursued. The marketing cooperatives should also have working relationship with the whole-sale consumer stores, the marketing cooperatives may also be given the right of monopoly procurement and the responsibility of distribution of goods presently taking place on government to government account.

Processing of agricultural produce, hill and forest produce as well as fruits may be taken up through cooperatives as a measure of overall economic development. The NCDC (National Cooperative Development Corporation), in this connection may provide technical and financial assistance on more liberal pattern for the new units. Two additional cooperative jute mills may also be established in the immediate future. The supply department and Food Corporation of India may help in meeting the needs of cooperative rice mills on priority basis.

The Conference suggested the need to set up a regional level organisation of consumer cooperatives with the help of NCCF (National Cooperative Consumers Federation). Likewise, a regional warehouse may also be opened with the joint efforts of the NCCF, state level organisations in the region and the Government of India. The possibility of district level consumer cooperatives in each district in the region may also be explored. In order to be self-reliant, the consumer cooperatives should take up distribution of consumer goods as a normal trade and not depend on retail distribution of controlled and confiscated commodities. The price fluctuation fund available with the N.C.C.F. may be taken advantage of in the region.

Keeping in view the difficult terrain of the region the cooperative education schemes may have to be reoriented and remoulded on the lines of giving education at the door of the member and "inplant" training. The education programme may be conducted in the slack and winter seasons. The State Unions should be equipped with audio-visual equipments etc.

In order to meet the manpower training needs of the area, a Cooperative Training College may be established for the intermediate category of personnel. Such a college may also undertake extension work and act as a clearing house for cooperative movement of the Region. For Senior Officers of the cooperative departments and the institutions, benefit of training facilities provided at the Vaikunth Mehta National Institute of Cooperative Management, Poona, may be availed of in greater measure. The conference suggested the setting up of cadres of cooperative employees on urgent basis. The Government of India might appoint a Committee of Experts to study the cooperative movement in the North-Eastern Region and suggested measures for its speedy development. The cooperative farming may be organised on land of tea gardens declared surplus under the

Land Ceiling Act.

The background papers prepared by the experts on a variety of subjects like cooperative marketing in the North-Eastern Region, are consumers cooperation, cooperative credit, cooperative education and training, etc., were supplied to the delegates. This greatly facilitated the discussions in the conference.

The author participated in the 12th International Cooperative Seminar, arranged by the Swedish Cooperative Centre, in Sweden, Denmark and England, between the 3rd May to 20th June, 1971. The Seminar covered the following subjects:

Agricultural Economy of Sweden, Role of the Cooperative Movement during the Second United Nations Development Decade, Agricultural Cooperative Credit, Marketing and Processing, Dairying and Poultry Cooperatives, Housing Cooperatives, Consumer Cooperatives Cooperative Education and Training, Financial Planning of Cooperative Projects, etc. The salient features of various cooperative development programmes discussed at the Seminar are being studied in this note in brief.

reasons to doubt whether the existence of an official
organisation like the National Cooperative Development
Corporation in the Cooperative sphere, besides the
Department of Cooperation is at all necessary", and
suggested to the Government to remit the foregoing
consideration for detailed expert study and come to a
decision on the necessity for the continuance of the
National Cooperative Development Corporation.

In pursuance of the above recommendation of the Public
Accounts Committee, the Government of India, in the
Ministry of Agriculture (Department of Cooperation)
constituted an Expert Committee under the Chairmanship
of Shri B. Venkatappiah, Member Planning Commission,
Government of India.

It is indeed, distressing that such a major event as
the release of the Report of the Banking Commission
has made virtually no impact on the banking world.
This is the first comprehensive review of the banking
system of the country (India), in 40 years. The last
such review was undertaken in 1931 by the Indian
Central Banking Enquiry Committee in an altogether
different context. This by itself is a sufficient
reason why the report of the Banking Commission ought
to be considered with a little more concern than what
has been displayed so far. This is all the more
necessary because of the fact that during the interven-
ing period (which witnessed the emergence of Independent
India) nearly two dozens of special investigations into
various aspects of banking structure and operations
had been made. These studies have been incorporated
and evaluated by the Banking Commission in its report
with a view to formulating a policy for further action.
Commerce has, therefore, attempted to analyse and
interpret the recommendations of the Commission in a
special survey. We have also tried to indicate the
gaps that the Banking Commission has kept uncovered in
such vital issues as branch expansion, deposit
mobilisation, structure of national banks and their
management. There were three major areas for the
Commission's investigations. One was to examine and
evaluate the structure of the banking system. Another
was to examine and evaluate the role of the broader

financial mechanism which touches the banking system at every point, yet which is distinct from the banking system. Finally, the Commission had to enquire into the international system and procedures, their efficiency and methods of improving it.

Despite the professions of the Commission that various alternatives should be tried out in the Indian context, the fact that the Commission was preoccupied with the Cooperative Banking System has inevitably resulted inadequate attention being paid to the structure of the commercial banking system. The fact that the Commission was fortunate in having a distinguished cooperator as Chairman might have also influenced the report which is at times concerned more with Cooperative Banking than Commercial Banking. Partly this may be attributed to the fact that the nationalisation of banks created an uncertainty as to whether the Commission should go into the question of the nationalised banks or not. It is not surprising, therefore, that the recommendations of the Commission on the proposed structure and mechanism of nationalised banks are the most sketchy and elementary. It will be necessary to undertake further detailed analyses and studies of the scope, potentialities and limitations of the national banking structure for determining the future course of the banking policy.

To what extent is non-recovery attributable to genuine failure of crops? Is non-recovery due to non-production and, if so, is there a diversion of loans for non-productive purposes?
3. In investigating the effectiveness of the existing patterns of linkage between the credit and the marketing structures, the study attempts to unravel

In November 1963, the Indian Society of Agricultural Economics, organized a Seminar on Marketing of Agricultural Commodities. Some basic issues in economics of marketing, such as determination of criteria for assessing marketing efficiency and measurement of marketing margins were examined. Since then many developments in marketing of farm products have taken place. Marketing policies have been readjusted to meet the changing situation. Due to continuing shortages in foodgrains production until recently, a policy of support prices, procurement and zonal restrictions was introduced. The advent of the green revolution has now posed a problem of regional surpluses of food crops and their storage and quick transport. On the other hand, shortages continue to persist in commercial crops like cotton, oilseeds and (periodically in) jute. The policy is increasingly veering round to extension of public sector agencies (as distinct from cooperatives) in the marketing of agricultural commodities.

In view of these developments, it was felt that a detailed discussion of the emerging problems of

marketing of agricultural commodities might yield fruitful results. Accordingly, the Society in collaboration with the Directorate of Marketing and Inspection of the Government of India, organized a Seminar on "Emerging Problems of Marketing of Agricultural Commodities", at Nagpur, in 1971 (18th to 20th February). Following six main themes formed the basis of discussion:

The Green Revolution has brought in its wake a growing awareness among farmers of the utility of mechanised agriculture. This is evident in the recent sharp rise in the use of tractors, power tillers and other agricultural machinery and equipment all over the country. Simultaneously, the demand for suitably located agricultural machinery service and repair centres is growing. Unfortunately such facilities at present, are generally not available in the rural areas. The Farmers who own agricultural machinery have often to travel long distances to get them serviced or repaired.

With the increasing role being played by cooperatives in the distribution of agricultural machinery and implements, the need for establishing centres for servicing and repairs of agricultural machinery in the cooperative sector was felt. Besides, the high cost of bullocks have become a formidable factor for the small cultivators. They are now eager to switch over to tractor cultivation. But the tractors are beyond their reach. Here the cooperatives can play a very significant and beneficial role by providing the small farmers with tractors on hire.

In view of the above considerations, the National Cooperative Development Corporation of the India, took the initiative and in consultation with Union Department of Agriculture evolved a scheme for the establishment of service centres for tractors and other agricultural machinery during the year 1968-69 and circulated it to all the State Governments. It was intended to be in the nature of a pilot scheme, to act as a pace-setter for an extensive programme which could be financed by Banks and other financing institutions. To facilitate quick and easy implementation, the scheme has been split into two parts. The first part envisages the establishment of servicing and repair facilities for tractors and other agricultural machinery, while the second part provides for maintenance of about 5 to 10 tractors with matching equipment for purposes of hiring them out to the agriculturists. Preference is to be given to composite centres over the ones designed to be implemented either in parts or by stages.

The scheme is to be implemented through selected marketing societies, processing societies, service societies or societies specially organised for the purpose or other societies which are already maintaining tractors for hiring them out to the cultivators. While initially the societies selected for implementing the scheme will establish a centre for servicing and repairs of tractors and other agricultural machinery and will also maintain about 5 to 10 tractors with matching equipment for providing on hire basis to the needy cultivators, it is envisaged that in due course the society would diversify and expand its activities to cover other auxiliary farm equipment and spare parts also.

For the implementation of this scheme, proper selection of the area is important. It has, therefore, been emphasised that the selected societies should be in compact areas having substantial irrigation facilities or in command areas of new irrigation projects, in view of the pressing requirement of multiple cropping and intensive agricultural operations in such areas, and in areas taken up under the Small Farmers Development Agency (SFDA), and Marginal Farmers and Agricultural Labourers (MFAL) projects which are specifically intended for the benefit of small farmers. With a view to ensuring the viability of the "servicing" component of the scheme, it has been postulated that the area of operation of the implementing society should have a population of about 300 tractors or equivalent number of other agricultural machinery, like power tillers, power sprayers, diesel engines, pump sets, etc. For purposes of ready calculation, 5 power tillers, or 4 diesel engines or 15 power sprayers are treated as equivalent setup preferably in areas where adequate facilities for servicing repairs do not exist.

The main objectives of the scheme are:

- a. to provide on hire tractors and other agricultural machinery to agriculturists,
- b. establish workshops for undertaking servicing/repair of tractors and other agricultural machinery,
- c. to distribute spare parts of tractors and other agricultural machinery,
- d. to run fuel station/gasolen pump for distribution of diesel and oil and other lubricants, and
- e. provide employment opportunities to engineers and other III trained personnel.

Each centre envisages employment potential for about 30 technical and other personnel. The details of the personnel to be employed with each centre are given in the Annexure-I.

The foundations of Consumers' Cooperative Movement were laid in India in the beginning of the present century. The movement got a fillip in the First World War and a setback from the depression of 1929. Again World War II, proved to be a boon but the post-1952 policy of decontrol administered a blow to the movement. In 1962 the centrally sponsored scheme for consumers' cooperatives was introduced. The author while discussing all these developments has concluded that in spite of all these efforts and the best intentions, the consumers' cooperative movement has miserably failed in achieving its objectives. He suggests that a constructive non-political approach, an adequate information system, an area-wise organisation that educates local consumers and alerts the authorities to local problems, a concern both for price and quality, and a thoroughly professional effort with a missionary zeal involving a sizable investment in personnel and facilities will make the movement effective. The Government should also come forward to see that while the movement does not become a state-managed show, it is properly staffed and equipped with adequate research activity. Ultimately the author pins his hope on the Indian Consumers' Union which may provide a solid base to the movement.






