

PREFACE

"Education is desirable for all mankind. It is the life's necessity for cooperators." This remark was made by Prof.Stuart about a century ago. It however, holds good even today. Education is a constant factor in the ever developing cooperative movement. Even in countries with long social history and well established cooperative organisations, it is the backbone of every effort for further development. Education should be considered as the nerve centre for any new attempt to create cooperatives and develop such movements.

The importance of cooperative education has been well recognised by the I.C.A.Commission on Cooperative Principles. It considered, among other things, education as essential to genuine and effective cooperative practice, both at present and in the future that can be foreseen. The Commission sums up, as follows :

"All the cooperative societies should make provision for education of the members, officers, and employees and of the general public, in the principles and techniques of cooperation, both economic and democratic."

Ever since its inception in 1960, the I.C.A. Regional Office & Education Centre for South-East Asia has been emphasising on education as an integral part of the cooperative work. It has a noteworthy record of achievéments in the field of cooperative education. In the year 1969, the Centres was approached by the Cooperative Union of Malaysia to assign to cooperative movement in the country an expert in cooperative education for formulating and initiating cooperative education programmes during the year 1970.

It is interesting to note that the U.N.First Development Decade was also a period of cooperative development on a planned basis in South-East Asia, especially in Malaysia. During the First Decade, the year 1970 was observed as an International Education Year throughout the world. The same year was a period of intensive activities in the field of cooperative education. It was the most befitting manner in which a cooperative movement could have celebrated this event of great importance.

The undersigned has the privilege of active participation in the planning and implementation of cooperative education programmes, in Malaysia during sixties, specially in 1970. He was assigned by the ICA Regional Office & Education Centre to the Cooperative Union of Malaysia for giving assistance in the planning and initiation of an integrated programme in cooperative education in the country. During the year, the undersigned visited about 30 cooperatives of various types and participated in 36 educational meetings and seminars covering 1,298 cooperative leaders and, rank and file workers.

The cooperative education activities successfully organised in Malaysia may be considered as one of the valuable contributions of the ICA Regional Office & Education Centre towards the International Education Year. The following report mentions in brief what has been done during a cooperative education year in the country, and what more can be done during the seventies which has been declared by the ICA as the Cooperative Development Decade. Some details of the programmes implemented during the year 1970, are given in Appendix-A.

The report does not include the historical background and the present status of the Cooperative Movement and its educational programmes in Malaysia. Nor the details of future developments have been incorporated. It simply gives indicators to be elaborated and followed up by the Malaysian cooperators. The undersigned is confident that the Cooperative Education Committee of the Cooperative Union of Malaysia and others will be able to use the report effectively. Nevertheless, a list of reference material is appended at the end of this report for those who would like to know in greater detail about the Cooperative Movement in Malaysia. A list of books and audio-visual equipment supplied to selected cooperative education institutions in the country is enclosed as Appendix-B. Also enclosed, as Appendix-D, are the specimen of seminar and other educational programmes so as to enable the readers to get a glimpse of the types of work done under the Assignment. Last but not the least, relevant extracts from the proceedings of the I.C.A. Advisory Council Meetings high-lighting the importance of the Assignment are enclosed as Appendix-E.

The main credit for the success of the Assignment in Cooperative Education in Malaysia goes to those cooperators who have put their heads and hearts together for planning the programmes, and worked shoulder to shoulder for its implementation. They are not a few to be counted on one's fingers, but their number is too large to be mentioned individually. However,







ASSIGNMENT IN COOPERATIVE EDUCATION IN MALAYSIA

Part - I.

Introduction

1.1 Since its inception in 1960, the I.C.A. Regional Office and Education Centre has been assisting the Malaysian Cooperative Movement, especially in the field of cooperative education. Just before the Federation of Malaysia was formed the ICA Regional Office and Education Centre had organised in collaboration with the Malaysian Cooperative Movement a national seminar in 1963 on the subject of Cooperative Member Education, at the Cooperative College, Petaling Jaya. The Seminar was organised for officers of the Cooperative Department and local cooperators. The Cooperative Union of Malaysia has since then organised several national seminars on various cooperative subjects with the assistance of the I.C.A. The organisation of these seminars helped the cooperators in Malaysia to think for the development of their cooperative movement. Several oconomic ventures were consequently started by awakened cooperators and active cooperative societies.

1.2 After organising educational activities mainly at the national level for some time, it was folt by the Cooperative Union of Malaysia that cooperative education needs consistent efforts at all levels. Main efforts should concentrate at the local level, so that member education may be integrated with the social, business and investment activities of cooperative societies. In this way, the movement would be able to implement effectively the cooperative principle emphasising that all cooperative societies should make provision for education of leaders, members, prospective members and employees in the techniques of Cooperation, both economic and democratic.

Assignment

2.1 A systematic plan was needed to conduct cooperative activities at different levels. The Cooperative Union of Malaysia, therefore, decided to have its own Education Committee and approached the I.C.A. Regional Office and Education Centre to provide a specialist to assist in developing and initiating cooperative education programmes at the national, regional and local levels. The undersigned was given this assignment by the I.C.A.Regional Office & Education Centre for developing and initiating an integrated plan of cooperative education in Malaysia. The terms of reference drawn for his assignment in Malaysia, were as follows :-

- (i) in general, to formulate, initiate and programme an integrated scheme of cooperative education activities in Malaysia, and
- (ii) in particular, to assist in the following ways, among others:
 - (a) to advise and to help to organise and assist at courses/ seminars at the national level;
 - (b) to assist in the organisation of pilot regional weekend courses in the various States of Malaysia;
 - (c) to follow-up on the courses/seminars jointly organised by C.U.M. and ICA Education Centre as well as the Cooperative College, Malaysia, in the previous year, namely the Cooperative Educators' and the School Teachers' Courses;
 - (d) to assist in developing courses at the Cooperative College;

e)

(e) to train Malaysians to carry out the education programme for C.U.M. (For this purpose the Executive Officer of C.U.M. Mr. Ismail Dervish, was appointed to understudy Dr.Vir besides the voluntary officials.

2.2 To carry out the assignment entrusted to him, the undersigned made three visits to Malaysia during 1970. The period of his visits are given below :-

First visit (Part-I) 2.1.1970 to 10.2.1970 = . 40 days Second visit (Part II) 30.3.1970 to 19.4.1970 = 21 days Third visit (Part III) 6.12.70 to 22.12.1970. = 17 days Total 78 days

The details of the work done by the undersigned during his stay in Malaysia are incorporated in the Programmes enclosed as Appendix-A.

2.3 The undersigned reached Kuala Lumpur on 2.1.1970 and undertook the first part of his assignment in January-February 1970. As a part of his work, he assisted the Cooperative Union of Malaysia in conducting four regional and several local seminars on cooperative education, in the States of Salangor, Penang, Perak, Negri Sambilan and Johore. In addition, the undersigned participated in the seminars organised by the Division of Cooperative Development in Johore State and by the M.C.I.S. at Kuala Lumpur and Batu Pahat. In all about 550 cooperators were covered through these seminars.

2.4 He also discussed with the Principal and other staff members of Malaysian Cooperative College, the possibilities of development in the field of Cooperative Education in Malaysia. The College staff was encouraged to use the books and other teaching aids which were supplied by the I.C.A. from time to time. The need of their training abroad was also discussed. A copy of the programme completed by the undersigned is given as Part-I in Appendix A.

REGIONAL SEMINARS

Some Suggestions:

2.5 In the Seminars and several meetings held in January-February 1970, the following points were emphasized :

- (1) Cooperative Education should be considered as an integral part of the business development of each cooperative.
- (2) All employees and active cooperators should contribute to cooperative education and business development. They should prepare themselves for this task.
- (3) All the cooperative societies and the Regional Cooperative Unions should have Education and Development Committees, programme of education and some funds for educational work.
- (4) The Cooperative Union of Malaysia, Regional Unions and big cooperatives should have Education Departments, equipped with well-trained personnel, educational material and audio-visual equipment such as, coloured slides and films: 16 mm, 8 mm etc.

2.6 During these seminars, sets of selected books on Cooperation and cooperative education were presented to the representatives of the C.U.M.

and its affiliated cooperative unions. These books were for the cooperators and educators and were to form a part of union libraries. A list of books and other material supplied to the movement is enclosed as Appendix B. In addition, several papers on subjects such as I.C.A. and its educational activities, Cooperative Principles, guidance activities, agricultural cooperatives, school cooperatives were widely distributed among seminar participants. Some of these papers have been published in the "Malaysian Cooperator" and included in Appendix-B.

Part - II

3.1 As an immediate follow-up to the first part of his assignment, the undersigned visited Malaysia in March-April 1970, and participated in the following important events:

- (1) National Seminar for Chairmen of Cooperative Societies held at the Malaysian Cooperative College, Petaling Jaya, from April 5-9,1970 (25 participants).
- (2) Two Rural Seminars for local cooperative leaders held in and around Kota Bahru (East Goast) from April 7-9, 1970 (60 participants).
- (3) 32nd All Malaysian Cooperative Conference, and
- (4) The Second Malaysian Cooperative Congress held at Johore Bahru from April 10-12, 1970.

NATIONAL SEMINAR FOR CHAIRMEN

3.2 In the Seminar of the Chairmen of Cooperative Societies, the undersigned circulated a note on his assignment in Cooperative Education in Malaysia and presented a paper on Development of Cooperative Leadership. The suggestions given in his paper were discussed in the Seminar and the participants were made to realise their role as Chairmen in cooperative education activities. The participants were shown coloured slides on Cooperative Education activities in Malaysia. These slides were prepared by the undersigned and Mr.Chong Thin Huatt, Chairman, Education Committee, C.U.M. with the help of the Camera set supplied by the Regional Office & Education Centre.

3.3 <u>Audio-Visual Aids</u>: It may be added that coloured slides on the following subjects have already been supplied to the Cooperative Union of Malaysia, Division of Cooperative Development and the Cooperative College:

- (1) Study Circles in Malaysia prepared by the undersigned.
- (2) 'Farm Guidance & Home Improvement Activities of the Japanese Agricultural Cooperatives' made available by the Central. Union of Agricultural Cooperatives.
- (3) I.C.A. and Cooperative Education in Malaysia prepared by the undersigned.

3.4 As slide shows have been found interesting and useful, it was suggested to the C.U.M. that they should precure more slides and other visual aids for use in cooperative education programmes in Malaysia.

3.5 The undersigned also participated in the two local Seminars organised by the Division of Cooperative Development in the rural areas of Kota Bahru. The Seminars were held at local offices of the Department of Cooperative Development and were well attended. He communicated his ideas about farm guidance and home improvement activities through coloured slides and with the help of an interpreter as the seminars were in the Malay language. The Division of Cooperative Development used a special screen which enabled us to use coloured slides in broad day light. It is suggested that such broad day-light screens should also be used by the Cooperative Union of Malaysia and other organisations engaged in cooperative education.

3.6 Secondly, the participants showed keen interest in the subject of farm guidance activities through agricultural cooperatives. It is therefore suggested that some regional and national level seminars on the subject should be organised by the Division of Cooperative Development and in collaboration with other organisations concerned, such as C.U.M., I.C.A., F.A.O., etc. It may be added that the F.A.O. is already assisting the Government of Malaysia in training of cooperative leaders and personnel especially working in the development schemes of the Federal Land Development Authority (FLDA).

32ND ALL MALAYSIAN COOPERATIVE CONFERENCE (10th and 11th April,1970)

The undersigned also had the privilege of representing the ICA at 4.1 the 32nd All Malaysian Cooperative Conference at Johore Bahru and greet the delegates. The Conference which was inaugurated by the H.M. The Sultan of Johore, attended by over 500 Malaysian cooperators and foreign delegates from Singapore and Thailand. In the inauguration session, sets of selected books on Co-operation (second instalment) were presented by the undersigned to the following organisations :

- (**i**) Cooperative Union of Malaysia.
- (ii) Division of Cooperative Development, Government of Malaysia.
- (iii) Mid-lands Cooperative Union.

- (iv) Perak Cooperative Union.
 (v) Penang Cooperative Union.
 (vi) Regional Cooperative Union, Johore.
- (vii) Regional Cooperative Union, Kedah & Perlis.

Sets of books were also arranged for the delegates to the conference from Singapore and Thailand, for their use in Cooperative Education work.

COOPERATION IN SCHOOLS

The undersigned had participated in the first National Cooperative 4.2 Course for the Sacondary Schools Teachers held at the Cooperative College of Malaysia in 1969. Later on, he visited several School Cooperatives and discussed with the authorities concerned the possibility of organising model School Cooperatives. On his initiative the C.U.M. took in hand the preparation of a Hand Book on School Cooperatives. In addition the paper on Students' Cooperatives and Cooperative Youth Work in different countries, prepared by the undersigned has been widely distributed among cooperative educators and selected school teachers in Malaysia. As a follow-up of previous seminars, he met several participants and himself participated at Ipoh in a State level Seminar on School Cooperatives. The Sominar was attended by teachers as well as students.

As a result of the general awareness created among cooperators, 4.3 it was gratifying to note, that the following resolution was passed by

the Conference in April, 1970 :-

"The 32nd All Malaysian Cooperative Conference resolves that the Government be urged to include an additional subject on - Cooperation in secondary schools in Malaysia."

4.4 Subsequently, Mr. John G. Stephens a member of Education Committee in the C.U.M. participated in the ICA Fellowship Programme, 1970-71, on the subject of "Cooperative Member Education". Under the Programme he made a special study of School Cooperatives in Malaysia and Ceylon and prepared a document "An Attempt at School Cooperatives in Malaysia" for use by cooperative educators in that country.

CONSUMER COOPERATION

5.1 The 32nd All Malaysian Conference resolved that a National Cooperative Super Market Society be established to set up Cooperative Supermarkets in all towns in Malaysia to supply and market consumer goods, particularly the produce of rural cooperators and also to provide all related services required by cooperators in the country. The Cooperative Union of Malaysia approached the ICA Regional Office & Education Centre to assist in the implementation of the above resolution This opened up a new avenue in the field of Cooperative Education and efforts have been made to meet this challenge effectively. Some details of the work done in this field are given in Part IV of the report.

SECOND MALAYSIAN COOPERATIVE CONGRESS: (12TH APRIL, 1970) A UNIQUE RESOLUTION ON COOPERATIVE EDUCATION:

5.2 During his moetings with the President and other office-bearers of the Cooperative Union of Malaysia, the need of sponsoring a resolution on cooperative education at the above Cooperative Congress was emphasised by the undersigned. It was ultimately decided that the MCIS will move the resolution.

5.3 The following resolution, which was unanimously passed by the Malaysian Cooperative Congress, signifies the importance the Malaysian

Cooperators attach to education :-

"The Congress congratulates UNESCO for declaring 1970 as the International Education Year and commends the **efforts** of the U.N. in involving cooperative movement in the Second Development Decade. It notes with satisfaction that the 'Cooperative Union of Malaysia and ICA Regional Contro in New Delhi are making intensive efforts in the field of Cooperative Education and recommends that all cooperative societies should have Education Committees, Educational Programmes and funds for such purposes."

5.4 It is hoped that the initiative taken by the Malaysian cooperators with the active collaboration of the I.C.A. during the International Education Year, to intensify the educational efforts will result in more enlightened loadership and membership and consequently, a stronger cooperative movement.

Part - III

6.1 The undersigned visited the country from 6th to 19th December,1970. This was the third and the last visit during the year of assignment. He participated and assisted in the conduct of the following national seminars held at the Cooperative College of Malaysia, Petaling Jaya.

- (1) National Seminar for Committee Members (of Primary Cooperatives from 7th to 12th December, 1970 (about 75 participants).
- (2) National Seminar for Internal Auditors from 14th to 18th December 1970. (about 35 participants).

6.2 During this final visit, the undersigned was assisted by Mr.R.W.Waite, Training Organiser, Cooperative Federation of Western Australia, who was a participant under the ICA Teachers' Exchange Programme, 1970/71. It may be noted that some cooperators from Singapore also participated in the above seminars.

6.3 Besides, the undersigned had several useful meetings with cooperators concerned with cooperative education in Malaysia for discussing the recommendations formulated by him. He also participated in the Education and Training Committee of the Cooperative Union of Malaysia in which educational work done during 1970 was reviewed and a programme for 1971 was outlined. The Committee decided to have national seminars on the following subjects, with the assistance of I.C.A. Regional Office & Education Centre :

i) How Urban Cooperative Societies can assist Rural Cooperators.

ii) Organisation of Viable Cooperative Societies at Primary Level.

6.4 The national seminars organised for special categories of cooperative personnel such as Managing Committee Members, Secretaries and Chairmen of Cooperative Societies were found very useful. The participants by living together and discussing their problems in a systematic manner during the seminars prepared themselves better for the present and future tasks within the cooperative movements. They also realised the value and role of cooperative education as an integral part of the cooperative business and development activities.

Follow-up

The recommendations related to cooperative education of the national seminars were discussed at the regional and local seminars and vice-versa. Some of these recommendations have been effectively implemented by selected cooperative societies. For example, English Teachers' Thrift & Loan Society, Penang, has set up an education and training committee and subsequently floated new cooperative ventures such as a petrol kiosk. Because of the effective combination of cooperative education and business development, the petrol kiosk received instant patronage by members and made a successful beginning in case of fierce recompetition in this line. Other cooperatives and their business federations should also try a similar approach and thus integrate education with business activities. The Cooperative Unions should provide active assistance in popularising this approach.

Part - IV

A MULTIPLE APPROACH

7.1 In addition to deputing the undersigned, the Regional Office and Education Centre gave the following support to the 'Assignment in Cooperative Education in Malaysia':

- It supplied to the C.U.M. a slide projector and a set of coloured slides for use in Cooperative Education work. One still Camera with some accessories was also supplied to enable the Union to prepare photographs, slides etc, for use in educational and publicity work.
- (2) Efforts were made to strengthen the libraries and reading rooms run for members and employees of the movement. To achieve this end, ten sets of selected books on Cooperation and Management were supplied to the institutions involved in cooperative education work in the country.
- (3) During the year of assignment and later some active cooperative educators from Malaysia were given opportunities of further training abroad under the following programmes :
 - a. ICA Teachers' Exchange Programme, 1969 and 1970.
 - b. ICA Fellowship Programme, 1970-71.
 - c. ' ICA/UNESCO Seminar of Cooperative Education Leaders, held in Switzerland, 1970.
 - d. SCC 11th International Seminar on Cooperative Education held in Sweden and other European countries, 1970, & SCC 12th International Seminar held in Sweden and other European countries, 1971.
 - e. National Seminar on Cooperative Management held in Singapore, 1970.

7.2 By participation in these educational activities, the Cooperative Union of Malaysia has strengthened the work of its Education and Training Committee. In this way a nucleus has been formed in the Union for promotion of Cooperative Education in Malaysia. Mr.Chong Thin Huatt who visited India & Sweden under the I.C.A. and the Swedish Cooperative Centre's programmes made on his return several useful recommendations to the C.U.M. and the Cooperative College of Malaysia for improvement of cooperative education in the country.

7.3 As a result of discussions held in various meetings, it was increasingly realised that the Malaysian movement should enter in a big way in the field of consumer cooperation. The 32nd All Malaysia Cooperative Conference, therefore, resolved to establish a national Supermarket Society. The C.U.M. undertook research and educational activities in the field of consumer cooperation with the assistance of I.C.A. Mr. Ragnar Arvidsson, Specialist in Consumer Cooperation, ICA Regional Office & Education Centre, who was deputed for this work, prepared a feasibility study for the establishment of Supermarkets in Penang and Kuala Lumpur areas. He also assisted in conducting a National Seminar on Planning of Cooperative Supermarkets, in September 1970.

7.4 Realising the importance of consumer cooperation, the I.C.A. Regional Office & Education Centre organised and conducted a Regional Seminar on Shop Planning and Management in Japan during May, 1971. Several Malaysian cooperators participated in the seminar and developed an outline for development of consumer cooperation in Malaysia. Mr. Ragnar Arvidsson and the undersigned who were associated with Seminar could arrange further follow-up of the efforts being made to develop consumer cooperatives on modern lines in Malaysia. More assistance is likely to be provided in this field.

7.5 Mrs. D'Cruz, Woman Assistant (Education) in the Regional Office and Education Centre participated in the Regional Seminar on Development of Cooperative Housing held in Malaysia in October-November 1970. Soon after the seminar, she visited some cooperatives in Perak State and had discussions with several women cooperators. She informed them about industrial cooperative societies in India and elsewhere.

RECOMMENDATIONS


As mentioned earlier, several useful suggestions for 8.1 improving cooperative education were made by the cooperators participating in the national, regional and local seminars. Some suggestions had emerged out of the discussions held with the members of Education Committees, cooperative leaders and government officials. To these, I have added my own suggestions, based on my experience with the cooperative development work in Malaysia. A summary of these suggestions are placed below as recommendations for consideration and necessary action by the Malaysian Cooperative Movement. Several of these suggestions were published in the Malaysian Cooperator and widely discussed during the period of the assignment i.e. 1970. Some of them have already been implemented by the C.U.M. and other cooperative organisations with the assistance of ICA Regional Office & Education Centre. Other recommendations may be tried out on a pilot basis with the help of selected cooperative institutions from different parts of the country.

8.2 The most important recommendation which can be made is the follow-up of the resolution on Cooperative Education adopted in the 2nd All Malaysian Cooperative Congress at Johore Bahru. The Congress recommended that <u>all cooperative societies should have Education Committees</u>, <u>Educational Programmes and funds for such pruposes</u>.

8.3 The Education Committees should also follow up the resolutions related to cooperative education adopted by the 32nd All Malaysia Cooperative Conference. Two of these are on the questions of teaching of Cooperation in Schools and establishment of a Cooperative Supermarket Society in the country.

8.4 To carry out the above recommendations effectively, the Cooperative Union of Malaysia should ensure that the following arrangements are made and necessary activities undertaken with the

help of appropriate agencies :-

- (1) The C.U.M. should initiate and assit in the organisation of Cooperative Study Forums at different levels (national, regional and local) to discuss important developments concerning cooperative movement. These Forums should have regular meetings and membership.

- (2) The C.U.M. should issue regularly a monthly news bulletin and the quarterly magazine. The Union is already issuing 'The Malaysian Cooperator'.
- (3) The C.U.M. and the Cooperative College of Malaysia together should undertake the preparation of study material and organisation of correspondence courses on subjects of common needs and interest e.g., on Cooperative Principles and Practices, Cooperation in Malaysia, Cooperative Management, Kinancing and Investment, Consumer Cooperation, Consumer Protection and Education, Home Economics, School Cooperatives, Malaysian Economy, and Elementary Psychology. Wherever possible, study circles and periodical lectures

may be arranged for the students pursuing correspondence courses and successful candidates be awarded certificates.

- (4) To guide educators and cooperative workers, the C.U.M. should undertake preparation of manuals and popular material, e.g. a Handbook on School Cooperatives, a Manual of Educational Material for teaching Cooperation in Schools, a manual for cooperative educators, case studies of successful cooperative institutions. M.C.I.S. has already brought out some useful material for its employees. A case study on M.C.I.S. will be a useful tool of cooperative education in Malaysia and other developing countries. It may be mentioned that the MCIS is a highly successful cooperative organisation in the Region and has excellent arrangements for employee training and education.
- (5) The time has come when C.U.M. should consider possibilities of preparing and procuring audio-visual aids such as film strips, films, day-light projectors, posters, etc; also of organising study tours and exhibitions. In this

connection, assistance may be sought from Malaysian Cooperative Agencies Society, Kuala Lumpur, and the Asian Mass Media Research & Information Centre, Singapore.

(6) The C.U.M. should undertake translation and adaptation of selected cooperative literature, e.g. Manual for Study Circle Leaders; The Report of the I.C.A. Commission on Cooperative Principles, Handbook for School Cooperatives (under preparation), etc.
(7) The C.U.M. should develop its own libraries and give assistance in developing Library and reading room services in important

cooperatives and all the Regional Cooperative Unions. In this connection it may be mentioned that the

In this connection it may be mentioned that the Cooperative College of Malaysia has been trying to establish a scheme of Loan of books in bulk. The cooperative organisations may make increasing use of this system, which will enrich nucleus libraries to be established in cooperatives and their Unions.

- (8) The C.U.M., the Cooperative College and the Department of Cooperative Development should jointly take initiative and give assistance in organising national, regional and local seminars/ workshops on important subjects, e.g. multipurpose cooperatives, business management, cooperative education and publicity, member communication, school cooperatives, farm guidance and home improvement activities of agricultural cooperatives dairy cooperatives; fishermen's cooperatives, etc.
- (9) Besides having member education activities, it is necessary for the C.U.M. to organise training of trainers and employees of cooperatives. As in Swedish Cooperative Movement short residential courses, on the job training combined with correspondence courses and study circles may be arranged for them. In this respect assistance should be taken from the Cooperative College of Malaysia, and some pilot projects be undertaken in the field of cooperative education. The system of cooperative education thus evolved by the cooperative movement in the country should be effectively linked with the system being evolved at the international level.

- (10) It is very important for the C.U.M. to have provision of research, advisory and related services for member societies in education, communication, management, new development, investment, etc. Research and evaluation activities especially in the field of consumer cooperative education and development should also be undertaken and assistance in this field be sought from the government and relevant international agencies.
- (11) Special sports and cultural activities should be organised for young people. Essay competitions may be organised for students and good essays be published in "Malaysian Cooperator" and other journals. Local cooperatives should give all possible support social and economic to cooperative projects in Schools.
- 8.5 <u>Structural arrangements</u>
 - (1) There should be active Development and Education Committees in all Societies, Regional Cooperative Unions and the Cooperative Union of Malaysia. Among others, such committees should include representatives of youth, women employees and the Board of Directors. The C.U.M., most of the Regional Cooperative Unions, and some of the cooperatives, such as M.C.I.S., Malaysian Railways Thrift and Loan Society, Kuala Lumpur, Government Servants' Thrift & Loan Society, Seremban, English Teachers' Thrift & Loan Society, Penang and other places already have active Education Committees.
 - (2) Education Sections equipped with trained personnel and audiovisual aids and cooperative literature are needed in the C.U.M., the Regional Cooperative Unions and large sized cooperative societies.
 - (3) The in-charge of education in the Unions should preferably be fulltime cooperative educators. They should be well trained in educational methods, member communications and business management. They should have experience in editing, preparing study material and conducting adult education work. Such a cooperative education personnel will be able to

organise systematically educational activities, maintain records and follow-up recommendations made in this report.

(4) There should be a national coordination committee for comprehensive planning and effective implementation of cooperative education programmes in Malaysia.

8.6 <u>Equipment</u>: The following equipment are needed to carry out the programmes efficiently :

- (a) Films and film projectors 8 mm and 16 mm.
- (b) Slides and film strip projector with coloured slides and film strips on cooperative subjects (some supplied by ICA Regional Office & Education Centre).
- (c) Still Camera set for production of photos and slides (already supplied by the ICA RO&EC).
- (d) Sets of books for the nucleus libraries of Regional Cooperative Unions & selected Cooperative Societies (already supplied by ICA RO&EC). For reference please see Appendix B.

8.7 Finances:

(i) As mentioned earlier, the 2nd All Malaysian Congress has recommended that all cooperative societies should have funds for cooperative education. To follow up recommendations made in the present report, it is necessary that the Cooperative Union of Malaysia, Regional Cooperative Unions and their affiliated societies have adequate flow of funds for cooperative education of their leaders, rank and file of members and the employees. This fund has to be separate from contributions to the Cooperative College of Malaysia and funds for education of members' In addition, wherever possible educational activities should children. be treated as a part of business expenditure, or as a long-term investment for development of cooperative societies and their membership. Education can also be treated as a cómmon service to members. In this connection, attention may be drawn to the deliberations of the past cooperative congresses in Malaysia, taken place on the question of education funds. As the cooperators in Malaysia have realised the value of cooperative education it should not be difficult for them to make individual

contributions for such a purpose.

(ii) The cooperative societies and their unions may also raise some funds by selling educational material, stationery and forms for cooperative societies. Cooperative education should be a part of the business of cooperative institutions and it has to be business-like in its approach, methods and contents.

(iii) For specific programme or project in cooperative education the cooperative movement may accept assistance from government or any other fraternal source.

8.8 <u>Incentives to Cooperative Educators</u>:

As the cooperative movement in Malaysia is still at a developing stage, it may not be possible to arrange for full economic compensation for the work of cooperative educators. It is, therefore, suggested that provision should be made for social incentives for such workers.

Cooperative societies and the Unions should organise functions on various occasions such as International Cooperative Day, Annual Day, Wom n's Day, Young Cooperators' Day. These functions may be utilised for cultural and educational activities as well as for honouring cooperative educators. Some certificates and prizes may also be given to those who have actively participated in the educational programmes.

The cooperative societies and their unions should continue to use their general body meetings for education of participating members. It is encouraging to note that most of the cooperatives in Malaysia bring out very informative and attractive reports and **circulate** them widely before the general body meetings. Such a practice should continue, however, more educational material and information about local cooperative educators may be included in such reports.

CONCLUSION.

9.1 As the report indicates, the task attempted by the undersigned was not only to advise and assist in planning but also in initiation of the dooperative education programmes in Malaysia. Under the assignment he tried to develop nuclei of cooperative education activities at the national, regional and local levels. Education Committees have already been formed in the Cooperative Union of Malaysia, Regional Unions and in some big

primary cooperative societies to look after educational and developmental activities. Some of these committees have organised local and regional seminars and other educational activities.

During his assignment the undersigned could visit about 9.2 30 cooperative institutions and conduct 36 educational seminars and other meetings for 1298 cooperators. All this was made possible by the active support of local leaders, members of Education Committees and rank and file members. The Government of Malaysia and the Cooperative College also provided all possible assistance. The undersigned feels that a close coordination between the cooperative education agencies can be brought about for common good of cooperative movement as a whole. Cooperation among cooperatives can have a good beginning through joint educational x activities. The undersigned was provided with a local-counterpart by the Cooperative Union of Malaysia. Efforts were made to train him in methods and techniques. It is very necessary to have a full-time counterpart who can assist a foreign expert and later on follow-up recommendations made by him.

9.3 An assessment of the work done so far has been made by the Education Committee of the Cooperative Union of Malaysia and now efforts are affort to develop specialised education programmes in the fields of Consumer Cooperation, multi-purpose cooperatives, development of cooperative insurance, etc. to be implemented during the Second Malaysia Plan. Last but not the least, the idea of self help and mutual help (Ramai bagi satu - satu bagi Ramai) has been further fostered among the Malaysian cooperators, especially among cooperative educators. 9.4 The financing of cooperative education is still a problem to

be solved by the Malaysian Cooperative Movement. The Malaysian Cooperators should vigorously follow-up the discussions on financing of cooperative education activities already held in the previous cooperative congresses and conferences in the country.

9.5 By working intensively with the Cooperative Movement in Malaysia the undersigned has realised that the potentiality for cooperative development in the country is immense, and cooperative education has to play a vital role in turning it into reality. In fact, in certain sectors such as cooperative insurance, processing, credit and housing the Malaysian Cooperative Movement is so advanced that it should increasingly share its achievements and experience with the cooperative movements in the neighbouring countries. The process of exchange of views and experiences among Malaysian cooperators of Malaysia and those of the neighbouring countries such as Singapore and Thailand has been accelerated during the period of the assignment. We in ICA Regional Office and Education Centre will watch with interest the growth of opportunities for such an exchange of cooperative experience, specially during the Cooperative Development Decade.

9.6 The impact of the cooperative education work done during the period of the assignment and earlier is well reflected in the resolution, which was unanimously passed by the Second Malaysian Cooperative Congress. The resolution reads as follows :

"The Congress congratulates UNESCO for declaring 1970 as the International Education Year and commends the efforts of the U.N. in involving cooperative movement in the Second Development Decade. It notes with satisfaction that the Cooperative Union of Malaysia and ICA Regional Centre in New Delhi are making intensive efforts in the field of Cooperative Education and recommends that all cooperative societies should have Education Committees, Educational Programmes and funds for such purposes."

9.7 On going through the resolution carefully we will find that the resolution loes not cover Malaysia alone; it has relevance to cooperative movements in other countries as well as to international organisations. Still better results can be achieved if suitable coordination takes place among agencies concerned with cooperative education and other development programmes. Nevertheless, the efforts jointly made by the I.C.A. RO&EC and the Malaysian Cooperative Movement during 1970, may be treated as a voluntary contribution to the U.N. International Education Year.

APPENDIX C-1.

EDUCATION AND TRAINING COMMITTEE

31 Dec.1969

Notes of the Education Committee Meeting held on Saturday, 17th May 1969 at 3.00 p.m. at Bangunan MCIS, 36 Jalan Ampang; Kuala Lumpur.

The Meeting was called to order at 3.00 p.m. by the Chairman with the above persons attending. Discussions took place on the following subjects :-

Review of Activities 1969

The Hon.Secretary explained to the Meeting why some of the plans that were meant for 1969, could not take place.

1. Meet the Members Session

The 'Meet the Members Sc sion' did not take place because there was insufficient response to the advertisements and other requests made to members. As a result it was thought not worthwhile to conduct such meeting.

2. Nutrition for Health Campaign

This campaign which was to be organised in the latter part of 1969 did not materialise because of the May disturbances. The Campaign was therefore called off completely.

3. Publicity

The proposal to make a documentary film on the story of MCIS was shelved, as it was considered not possible noneywise. Expenses involved in compariso to the benefits was the main consideration in deciding to put off this idea.

A request to TV Malaysia and Radio Malaysia for time to discuss the MCIS and its activities was not fruitful as it was found that TV Malaysia and Radio Malaysia do not consider individual requests from commercial or such organisations for the purpose of publicity.

Programme of Education for 1970

Activities to promote the interest and intentions of the Society:

It was decided that a seminar for members of the Board of Directors be organised with senior executives of the Staff participating in order to keep Directors up to date with the MCIS activities and also to discuss recent development in cooperative insurance. Participation of senior executives including CDOs was suggested so that there will be a get together on a formal basis of the officials of the Society. It was suggested that the seminar be organised on the third week of March 1970. It is to be a one day seminar.

2. <u>Seminar for Committee Members of all Affiliates</u>

Inother one day seminar was also suggested to be held for the committee members of affiliates of the MCIS. The purpose of this seminar was for affiliate members to discuss MCIS, its promotion and how best the affiliates could help in the further development of the Society. It was also suggested that a film on cooperatives be shown during this seminar.

3. Trade Union and MCIS

It was felt that a seminar be held in September, inviting trade union committee members to discuss and promote cooperation between trade unions and the MCIS which are of mutual benefit. It was thought that this seminar would be a good place and time to explain the benefits offered by MCIS which could be taken advantage of by trade unions at relatively very little cost to them.

4. <u>Study Circles</u>

Discussion took place on the question of participation by members in the education activities of the Society. Since the 'Meet the Members Sessions' had not received the necessary support, it was felt other methods be tried out. In this context, it was decided that study circles methods should be explored for use by the Society in its educational programme. However, it was decided that further thought and discussion be given as how best it could be implemented.

5. Dr. Dharm Vir

The Hon.Secretary explained to the Committee about the secondment of Dr.Vir to the Malaysian Cooperative Movement for the promotion of Cooperative Education in the country. The Committee felt that Dr.Vir should be made available to the MCIS for the purpose of discussing with him the educational activities of the Society. It was therefore decided that a meeting be arranged for the Education Committee to have talks with Dr.Vir and to arrive at activities which are feasible for the promotion of education among the MCIS members.

With no further matters to be discussed, the meeting adjourned at 3 with a vote of thanks to the Chair.

The Secretary chaired the meeting in place of the Chairman of the MCIS Education and Training Committee, Enche Ahmad Hourmain as he was unfortunately unable to attend due to the late notification of the meeting. The Secretary reviewed for the benefit of the members activities that were planned by the MCIS Education and Training Committee in 1969 - most of which were not implemented due to unavoidable circumstances. He then related the objectives for 1970 that were contained in the Minutes of the Meeting held by the MCIS Education and Training Committee in December, 1969. He explained that the main purpose of this meeting was to have discussions with Dr.Vir and to arrive at some activities which the MCIS could pursue in its programme for educating and training the members of the MCIS.

Dr. Vir then addressed the meeting. In the first place Dr. Vir said that he was going to suggest was in fact what had been discussed earlier when he had met the Development Officers of the Society in the morning. At that meeting, he had put forward ideas to the field staff and asked their opinions and views as to what and how much could be implemented. He made it clear that the decision to implement them would have to be made by the Board and Management and that he was relating just the suggestions and his views in support of them.

The first suggestion was that a members' service hour be held every week at every branch office in the country. Dr. Vir said that every development office have an open hour every once a week during which the development officer could clarify and assist members with their problems. Announcements should be made as to when this weekly meeting hour would be and to make clear that the development officer would be present during this hour for this purpose. He also suggested as an extension to this idea the opening up of forums in every major centre in the country for members of the MCIS. These forums could have meetings during which tea and other facilities could be offered to them. During these tea meetings well-known personalities in that area could be approached to make short speeches on subjects of various nature. It could be on income tax to help those who may have some difficulties over this matter. This trik could be given by an income tax expert or income tax officer who may be a member of the MCIS. Any facility that could be offered by these forums which in the first instance could be from the branch office itself e.g. library facilities will encourage members to look to MCIS as their own service organisation.

At the same time, this forum could organise every year a foundation day celebration. On this day, sports activities and other activities could be organised, rounded with a grand gala dinner. Contributions could be received from members in the organising of the dinner and other expenses in connection with the celebrations.

.nother suggestions made by Dr.Vir was the establishing of a well trained corp of officers who could address schools and other meetings on cooperative subjects.

In respect of the MCIS Review, Dr. Vir suggested that an e-say competition among school children could be held where subjects could be given by the editors of the Review and prizes awarded to the best essays. The best essays then could be published in the Review giving publicity to the MCIS Review and the MCIS. Similarly, he suggested that the Review should be issued to every school in the country, if not to every school that has a cooperative functioning within itself.

After making these suggestions, Dr.Vir then elaborated on what he would suggest should be training for development staff to make them better cooperative educators. In the first instance, he suggested that a proper course on cooperation should be formulated based on the book 'Introduction to the Cooperative Movement' by Mr.N.A.Kularajah. He said that this was essential if development staff were to carry out extensively and intensively cooperative work which is definitely a part of their function. Similarly, training programme should include subjects on the study of basic economics and also on the Malaysian economy. He suggested that each and every development_staff must be trained on and be able to talk about the Malaysian economy. 'Business Administration and Management' subjects should also be included in the programme. A further course suggested by him was on'Psychology' since every field man or salesman must be an expert in the understanding of human beings and their attitude.

To bring women into the fold of the MCIS he suggested that 'Home Economics' be a subject which would mean that Development Officers could lecture or address gatherings of women on subjects that interest them. Study of 'Home Economics' would certainly assist in the furtherance of the interest of the MCIS. Others suggested were on Public Speaking and Leadership'. During the discussion that ensued, it was agreed on principle that these were good suggestions and the members in the meeting, particularly, the members from the Board suggested that thought could be given and would be given for implementing whatever that was feasible.

Dr.Vir also made his comments on the application of study circles in the country which was carlier suggested by the Education and Training Committee. He said study circles could not be a success here as much planning and organising had to be put in and it would only be useful as an advance method of education.

In the course of the discussions, Enche G. Dass made a suggestion which was considered by all as a very worthwhile one and which nerits MCIS earnest considerations. He suggested conduct of adult education classes for members' children who have not been able to pass the Lower Certificate of Education Examination. A pilot project could be started and it was agreed that the General Manager present a paper on this to the Board for consideration.

The Meeting then adjourned with a vote of thanks and appreciation to Dr.Dharm Vir.

This is not meant to say that Committee Members of societies to date have not been working as Committee Mombers. However, the intention is to increase your awareness to the development taking place in the cooperative movement from which no cooperative society can remain isolated. We expect from all seminars like these definite and positive results arising from your exposure to modern thinking and methods in management of cooperative societies. In addition, there is also the gain to be made from free mixing among participants who will . realise that problems that exist in their own societies are not different from the others. Only the approach to them and their results vary. To learn in this manner is effective and another reason why we value the seminars that we organise. **4** • 4

I have emphasized and re-emphasized that education and training are the key ... to the rapid and successful growth of our movement. It has to be continuous and is not confined only to a selected few. Every one of us need knowledge without which we cannot have understanding or effective workability. However, a seminar cannot teach you everything. It can guide you by providing the basics. The rest depends on your initiative. For the seventies the Malaysian Movement has considerable plans. The immediate one is the national supermarket society. Everyone of us must contribute to make all these plans a success. The greater responsibilities and expectations lie on officials like you. If you cannot provide the lead then it would be difficult for others to follow. For all these reasons, I am very pleased with the organisation of this sominar and it is needless for me to thank those responsible as it is obvious that a good job is being done. It only requires now for the participants to respond with the same dedication as given by the organisers, and to benefit from it so that they become forceful persons in their respective societies. It is needless for me to say that Committee Members are the living force behind every cooperative society and from them originates much of the ideas and leadership. As such, it is very important that they take advantage of this seminar particularly if they are to play their role effectively. I wish the seminar and the participants every success.
